THEY GAVE ME A DOCUMENT.

I SHARED THAT DOCUMENT WITH COUNCILWOMAN FOWLER.

SHE AND I BOTH TALKED ABOUT IT TODAY.

AND WE FEEL THE EXISTING ORDINANCE DOES WHAT IT'S SUPPOSED TO DO. WE FELT WHAT THEY WERE REQUESTING SPECIFICALLY ACTUALLY MIGHT CREATE MORE LOOP HOLES THAN THE WAY IT IS NOW.

AND I WILL GIVE YOU -- I'LL USE THE EXAMPLES STRAIGHT OFF OF THE METRO PARKS DISCUSSION PAGE THAT WE USED.

AND THAT WOULD BE FOR INSTANCE, TURNING A TENNIS COURT INTO A PICKLE BALL COURT.

NONE OF US ARE GOING TO OBJECT TO THAT AT ALL.

ON THE OTHER HAND, AND NOT ONLY, WHEN THEY BROUGHT THAT UP, NOT ONLY ARE THEY NOT GOING TO OBJECT IT, WE'RE GOING TO DO IT IF WE PAY FOR IT.

I FELT LIKE WHAT THEY WERE GETTING INTO IT CREATING SITUATIONS WHERE THEY DIDN'T HAVE TO ASK.

I THINK WE'RE ONLY GOING TO USE THIS ORDINANCE IN THE MOST DRASTIC OF SITUATIONS AS IT IS.

AND THEREFORE, WHAT COUNCILWOMAN FOWLER WROTE THE FIRST TIME PRETTY MUCH SERVES ITS PURPOSE.

>> I THINK WE ALL AGREE ON THE INTENT OF THE ORDINANCE.

WE WANT TO MAKE SURE WE DON'T MICROMANAGE PARKS, BUT PARKS DON'T MAKE ANY SIGNIFICANT CHANGES WITHOUT OUR SAY.

AS I READ IT AGAIN, I THINK, ESPECIALLY AS I LOOK AT SECTION ONE, WHERE THE AMENDMENT SAYS THAT PARKS MAY NOT REPURPOSE THE LAND OF ANY PARK.

TO ME, I THINK THAT IS, I CAN INTERPRET THAT BROADLY TO MEAN THEY ARE NOT GOING TO SELL THE PARK OFF WHOLE SALE OR SIGNIFICANTLY ALTER THE PARK.

IF EVERYONE ELSE IS COMFORTABLE WITH THAT, BASED ON COUNCIL MEMBER PEDEN'S, I'M FINE WITH THAT.
