>> COLLEAGUES, TONIGHT IT'S A SAD DAY FOR METRO
LOUISVILLE, BECAUSE WE'VE GOT SOMEONE WHO HAS BEEN AT A HEAD ROW
FOR QUITE A WHILE, HELPING LOUISVILLE, HELPING THE RESIDENTS,
HELPING MANY RESIDENTS WHEN THEY ARE IN CRISIS.

HE IS STEPPING BACK AS A LEADER BUT HE WILL HANG
AROUND TO BE A MENTOR.

THIS IS DAN GOYETTE.

HE IS THE CHIEF PUBLIC DEFENDER FOR LOUISVILLE METRO.

AND HE HAS BEEN WITH THE DEFENDER'S OFFICE FOR 36

THERE'S SOME BIG NAMES OUT THERE ON THE OTHER SIDE,
THE BIG MONEY NAMES.

I'VE BEEN OUT SINCE THE BEGINNING OF '13.

I'VE SEEN IN OTHER STATES WHAT HAPPENS WHEN THEY DON'T
HAVE A PUBLIC DEFENDER SYSTEM.

AND IT'S TERRIFYING.

AND DAN HAS ALWAYS REACHED OUT.

WE DISAGREE BUT HE WOULD BE THE FIRST ONE TO SAY LET'S

[LAUGHTER].

THANK YOU, DAN FOR EVERYTHING YOU HAVE DONE.

APPRECIATE IT.

>> WELL TO THE EXTENT THIS WAS A SURPRISE, IT WAS A
MAJOR SUCCESS.

MY STAFF WILL PAY FOR THAT A LITTLE LATER.

[LAUGHTER].

BUT SPEAKING OF, I LEARNED LONG AGO, THAT WHEN YOU ARE
PUT ON THE SPOT IT'S BEST TO HANDLE IT WITH A JIU JITSU MOVE SO
I WILL TURN AROUND AND ASK ALL MY STAFF TO BE RECOGNIZED.

[APPLAUSE].

I'M FOND OF DESCRIBING THEIR EFFORTS AS PUBLIC DEFENDERS, TO PARAPHRASE WINSTON CHURCHILL AS NEVER HAVE SO FEW DONE SO MUCH FOR SO MANY, FOR SO LITTLE.

AND I HOPE THE METRO COUNCIL WILL REMEMBER THAT.

WHEN MY WORTHY SUCCESSOR COMES CALLING YOU NEXT YEAR WITH HIS BUDGET REQUEST.

YOU HAVE BEEN GENEROUS IN THE PAST, AND I HOPE YOU WILL CONTINUE TO DO THAT.

KATHY IS A TEACHER, BY PROFESSION.

SHE HAS SPENT MOST OF THE LAST 20 YEARS AS TEACHER AT THE SACRED HEART MIDDLE SCHOOL.

I KNOW I HAVE RUN INTO A LOT OF VERY TOUGH AND COURAGEOUS LAWYERS IN MY TIME.

BUT NONE COULD TOP THE COURAGE AND DETERMINATION THAT SHE HAS DISPLAYED IN THE FACE OF THIS CHALLENGE.

I GREATLY ADMIRE HER BOTH AS A PERSON AND AS A SPOUSE.

I LIVE ON THE KRISTEN CAMPUS FRIENDSHIP HOUSE.

WE ARE VERY FORTUNATE TO LIVE IN THIS BEAUTIFUL PLACE WHERE OUR NEEDS ARE MET AND WE FEEL SAFE.

ACROSS THE STREET ON FOURTH STREET THERE IS A PARK.

HOMELESS HUMAN BEINGS STAY IN THIS PARK AT TIMES AT NIGHT.

I GROW CONCERNED ABOUT THESE HUMAN BEINGS WHO STAY OUT THERE AT NIGHT.

NOW THAT THE WEATHER IS GETTING COLDER.

IT WAS THE END OF SUMMER AND IT WAS, DAYS ARE GETTING CHILLY, LIKE WE HAVE HAD SOMETIME LATELY, ESPECIALLY AT NIGHT.

I WENT ACROSS THE STREET TO SEE HOW THEY WERE DOING.

I ASKED THIS ONE LADY, HOW ARE YOU DOING?

SHE SAID OKAY.

I SAID WHERE DID YOU SLEEP LAST NIGHT?

SHE SAID I SLEPT ON A CARDBOARD, BUT IT WAS OKAY.

IT WAS LONG AND MY FEET DID NOT STICK OUT OVER THE
EDGES.

WHEN A PIECE OF PAPER COMES ACROSS YOUR DESK THAT EVEN MENTIONS
SHELTER FOR THOSE LESS FORTUNATE, ESPECIALLY FOR THOSE OLDER
THAN OURSELVES, READ IT TWICE.

AND WHEN THAT ALL IMPORTANT NEEDS FOR OUR CITY COMES
ACROSS YOUR DESK, CALL THE BUDGET, RIGHT AT THE TOP OF IT,
SHELTER FOR THOSE LESS FORTUNATE.

THESE ARE ALL VERY IMPORTANT NEEDS THAT OUR CITY HAS.

BUT THE NUMBER ONE NEED THAT WE ALL HAVE TO STAY ALIVE
IS SHELTER FROM THE ELEMENTS.

I THANK YOU FOR YOUR TIME.

>> HELLO, YOU ALL KNOW ME.

TONIGHT IS ABOUT EPILEPSY, I LIVE IN A BEAUTIFUL
BUILDING CATHEDRAL COLUMNS.

ACROSS THE STREET, THE HOTEL CALLED THE OMNI.

THAT OMNI TOOK TWO AND A HALF YEARS TO BUILD.

IT TOOK OUR PARKING LOT BUT IT'S GOT SOME REMNANTS.

BUT DO YOU KNOW WHAT?

WHEN THEY CAME ACROSS THE STREET, THEY USED MY FRONT
BUILDING FOYER AREA.

THEY DON'T HAVE ANTENNAS ON TOP OF THEIR BUILDINGS
LIKE ALL THE HOTELS BECAUSE THEY ARE SO HIGH UP, FOR THEIR
CABLE.

THEY HAD THE ANTENNA AT THE END OF THE ROAD ON LIBERTY
WHERE PAPA JOHNS IS.

AND THEY WENT UNDERNEATH THE GROUND TO PUT THEIR
WIRES.

AND THEY KEPT GOING, KEPT GOING, KEPT GOING AND THEY STOPPED AND THEN THEY KEPT GOING.

AND THEY WENT FROM FRONT OF THE EPISCOPAL CHURCH THAT OWNS OUR BUILDING.

THAT'S THE OLDEST CHURCH IN LOUISVILLE.

THEY WENT FURTHER AND THEN THEY STOPPED AND THEY LEFT A BIG HOLE.

I'D SAY ABOUT THE SIZE OF THIS TABLE RIGHT HERE.

AS A PERSON -- IF YOU LOOK DOWN IT, YOU CAN ACTUALLY SEE THE STREET, THE PIPES ALL THAT DOWN THERE.

I HAD GONE OVER THERE AND ASKED THE PEOPLE, WHAT ARE YOU DOING?

THEY CAME OVER AND FIXED THE REST WHERE THEY FINISHED AND THEY SAID MA'AM, I'M SORRY, WE CAN'T TALK TO YOU, YOU NEED TO LEAVE.

MA'AM YOU NEED TO LEAVE.

SECURITY, GET HER OUT.

SECURITY GET HER OUT.

ALL I WANT TODAY DO WAS TELL THEM WHAT'S GOING ON.

WE WILL HAVE PEOPLE WHO WILL FALL.

WE HAVE BLIND PEOPLE, DISABLED PEOPLE.

CATHEDRAL COMMONS.

THEY TOLD THE CHURCH PEOPLE TO SET THE APARTMENTS UP FOR DISABLED LOW-INCOME.

AND THAT WE ARE.

YOU ALL KNOW ME, I RUN A SUPPORT GROUP FOR EPILEPSY.
WE HAVE PEOPLE IN WHEELCHAIRS, BLIND PEOPLE AND SUCH.
I'M NOT GOING TO USE A NASTY WORD.
THEY DID A BLANKETY BLANK JOB.
THE WOOD CHIPPINGS WITH ALL THE RAIN WE HAVE HAD.
IT'S ALL GOING BLOOP AND WE'VE GOT NOTHING LEFT.
I CALLED M.S.D. THEY SEE THE BIG HOLE.
SO LET'S GET THIS BIG BEAUTIFUL PLACE AND GET THEM TO
GET THEIR, HELLO, REAR END IN GEAR.
WE HAVE TOO MUCH CONVENTIONS COMING.
THANK YOU.
YOU ALL HAVE MY NAME AND NUMBER.
YOU KNOW ME.
>> MR. CLERK: JEREMIAH McCLELLAN.
>> GOOD EVENING, DISTINGUISHED LADIES AND GENTLEMEN.
IT'S AN HONOR BEING HERE TODAY TO ADDRESS YOU, LEADERS
OF LOUISVILLE.
MY NAME IS JEREMIAH McCLELLAN, I AM 42 YEARS OLD.
I STAND BEFORE YOU TODAY TO SAY I AM PRO-CANNABIS,
THAT IS THE CORRECT NAME FOR MARIJUANA.
I'M NEITHER A CONVICTED CRIMINAL OR DRUG ADDICT.
I'M A LAW-ABIDING, TAX-PAYING CITIZEN.
I'M ACTUALLY A BIT OF A SQUARE, I DON'T TAKE PILLS, I
DON'T LIKE DRINKING ALCOHOL OR SMOKING TOBACCO, AND I DON'T
LIKE NEEDLES.

CANNABIS WORKS BEST AS FAR AS HEALTH BENEFITS.

I WATCH MY FATHER USE ALCOHOL AS A RELEASE.

IT TRIED TO KILL HIM AND GAVE HIM LIVER CANCER.

HE HAD TO HAVE A TRANSPLANT AND USED CANNABIS TO AID
IN HIS TREATMENT.

I UNDERSTAND A CITY IS RUN LIKE A BUSINESS, IT NEEDS
REVENUE TO FUNCTION.

I UNDERSTAND LAW ENFORCEMENT IS TASKED WITH FULFILLING
THAT ROLE OF REVENUE FOR THE CITY.

ASK ANY POLICE OFFICER HERE TODAY.

WHO WOULD THEY RATHER ARREST TO FULFILL THIS ROLE?

WOULD IT BE THE POTENTIALLY RAGE VIOLENT-FILLED OPIOID
OR COKE ADDICT OR THE MARIJUANA SMOKER THAT THINKS HE IS DOING
NO WRONG AND CAN EXPLAIN THIS IN COURT AND WON'T FIGHT ARREST?

AS CANNABIS ARRESTS ARE EASIER TO CONDUCT FOR THE
OFFICER AND EASIER TO CONVICT FOR THE STATE, IT BENEFITS WITH
REVENUE.

HOWEVER, WITH CANNABIS LEGALIZATION MOVEMENT, AS OF
NOW LEGAL IN NINE STATES AND MEDICAL CANNABIS LEGAL IN 30
INCLUDING WASHINGTON D.C.

LEGALIZATION OF CANNABIS IS JUST A MATTER OF TIME
UNTIL KENTUCKY JOINS ITS PLACE AMONG OTHER STATES THAT HAVE
EMBRACED THEIR CITIZENS WANTS.

ALL REVENUE GAINED AND REVENUE SPENT AS WELL AS LIVES
OF CITIZENS RUINED IN THE STATE'S PURSUIT OF THIS PLANT WILL
SOON BE FOR NOTHING.

BUT THE CITIZENS WILL REMEMBER.

I AM HERE TO ASK THAT YOU PASS THE CANNABIS ORDINANCE
AND ASSIGN CANNABIS OR MARIJUANA TO ONE OF THE LOWEST LAW
ENFORCEMENT PRIORITIES AND ALLOW THIS CITY TO USE ITS RESOURCES

>> GOOD EVENING AND THANK YOU.

I AM HERE SPEAKING ON BEHALF OF 350 LOUISVILLE AND IN
SUPPORT OF THE 100% CLEAN ENERGY RESOLUTION THAT WAS DRAFTED BY
CITIZENS AND IS NOW BEING SPONSORED BY PRESIDENT JAMES.

I STRONGLY ENDORSE THIS EFFORT AND BELIEVE EVERY
COUNCILMEMBER SHOULD TOO.

WE ONLY NEED TO LOOK AT HURRICANE FLORENCE, THE
WILDFIRES THAT DEVASTATED CALIFORNIA AND NORTHWEST THIS SUMMER
AND FREQUENT FLOODING AND STORMS HAPPENING HERE AT HOME TO KNOW
THAT CLIMATE CHANGE IS REAL AND IT HAS MAJOR HUMAN AND FINANCIAL
IMPLICATIONS.

THE MAIN DRIVER ACCELERATED CLIMATE CHANGE HEAVY
DEPENDENT ON FOSSIL FUELS WHICH MEAN GREENHOUSE GASES, THERE'S
NO CREDIBLE PATH THAT INCLUDES CONTINUED LONG TERM COMBUSTION.

FURTHER MORE, THE COST TO ADDRESS THE CONSEQUENCES OF
MAJOR WEATHER EVENTS WILL ONLY ACCELERATE.

IN ADDITION LOUISVILLE IS MISSING OUT ON THE CLEAN
ENERGY ECONOMY.

WHY TAKE ACTION?

FIRST IT IS THE MORAL AND RIGHT THING TO DO.

FUTURE GENERATIONS AND LOW INCOME AND VULNERABLE
POPULATIONS WILL SUFFER THE WORST CONSEQUENCES OF CLIMATE
CHANGE.

IT'S THE DUTY OF CURRENT LEADERS TO PASS PROMPTLY TO
MITIGATE CLIMATE CHANGE FOR THEIR BENEFIT.

SECOND, WE CANNOT AFFORD NOT TO ADDRESS THIS ISSUE.

I HAD A LINE NUMBER FOR E-5 BASED ARMY GUARD QUARTER
IN THE YEAR 1999 NAMED BASE AIR MAN NUMEROUS TIME AND BASE AIR
MAN OF THE YEAR IN 2000.

CONSIDERED FOR AIR COMBAT COMMAND AIR MAN OF THE YEAR
IN 2000.

THEN A VERY SERIOUS CRIME WAS COMMITTED AGAINST ME

FROM ONE GUNSHOT WOUND.

AFTER SEEKING CARE AT THE VETERAN'S HOSPITAL I WAS PUT ON METHADONE, THAT MEDICINE HAS ROBBED ME OF MY GAL BLADDER AND ALL MY TEETH.

TODAY I TAKE A MERE 5 MILLIGRAMS OF METHADONE A DAY TO
HELP CONTROL CHRONIC PAIN WITH THE HELP OF CANNABIS.

TO CONTROL CHRONIC ABDOMINAL PAIN, P.T.S.D., CHRONIC
ANXIETY, AND DEPRESSION ALL DIAGNOSED WITH THE V.A.

I ASK AFTER EVERYTHING I HAVE DONE FOR MY COUNTRY, WHY
YOU WANT TO MAKE ME A CRIMINAL FOR CANNABIS CONSUMPTION.

I URGE YOU TO PASS THIS ORDINANCE.

THAT THE PHARMACEUTICAL MEDICATIONS HAVE.

HE KNOWS HIS BODY, HIS REACTIONS AND CAN CONTROL HIS
DOSAGE BASED ON THE SEVERITY OF HIS SYMPTOMS.

OUR CHILDREN WERE RAISED TO CARE ABOUT PEOPLE, TO

THIS WAS BROUGHT TO US ABOUT A MONTH AGO IN A ZONING
MEETING.

I WILL GIVE YOU A LITTLE BACKGROUND.

WHEN YOU DEVELOP A SUBDIVISION, IF YOU HAVE OVER 199 LOTS, YOU HAVE TO HAVE TWO ENTRANCES.

THIS DEVELOPMENT, IT LOOKS GOOD ON PAPER.

BUT THERE'S 592 RESIDENTIAL LOTS, AND THERE'S GOING TO BE 350 APARTMENTS.

NOW, TO ME, SOMEWHERE, WE DON'T HAVE IT IN OUR CODE DEVELOPMENT AND WE CAN'T CHANGE IT, ALTHOUGH, TO ME, I THINK THEY ARE GOING TO PAY CONSEQUENCES FOR THIS.

WITH ALMOST 1,000 UNITS, YOU COULD HAVE AS MANY AS 2,000 CARS.

ONE OF THOSE EXITS WILL HAVE AS MUCH AS 1,000 OR MORE CARS, ENTERING AND EXITING EVERY DAY.

I NEVER THOUGHT, I MEAN, YOU ALL HEARD ME TALK ABOUT A GRID AND MAKE SURE WE HAVE CONNECTIONS.

TO ME, I NEVER THOUGHT I WOULD HAVE A SUBDIVISION WITH A TRAFFIC JAM INSIDE OF IT.

AND I THINK THEY ARE GOING TO PAY CONSEQUENCES BECAUSE THERE'S GOING TO BE A LOT OF PEOPLE WHO WILL BE SPEEDING TO GET OUT OF THE SUBDIVISION.

WHAT HAPPENS WHEN YOU HAVE SPEEDING?

YOU ADD SPEED BUMPS.

I COULD SEE PROBABLY AS MANY AS 50 SPEED HUMPS.

I WAS TRYING TO BE CONSTRUCTIVE HELPING THEM, SAYING WE NEED ANOTHER EXIT THAT WOULD HELP THIS DEVELOPMENT.

AND THEY DON'T SEE IT.

THEN I SAID, WELL, ALL OF THIS DEVELOPMENT, THERE'S ABOUT 90 SOME HOUSES.

DEVELOPMENT IS GOING TO GO RIGHT THROUGH THE DEVELOPMENT THAT'S ALREADY BEEN ESTABLISHED, ABOUT TEN YEARS NOW OR MORE.

I WAS HOPING TO TRY TO FIND ANOTHER WAY THEY COULD GO IN WITHOUT ALL THE PEOPLE IN THAT SUBDIVISION SEEING CONCRETE TRUCKS AND DUMP TRUCKS AND BULLDOZERS GOING UP AND DOWN THEIR STREETS.

THEY SAID WELL WE WILL CLEAN IT EVERY DAY.

THAT'S A LOT.

COUNCILWOMAN FLOOD MADE A POINT.

SAID WELL, IT'S EASIER TO MAYBE GO THROUGH THE SUBDIVISION THAN THROUGH THE PARK.

WHERE THEY ARE GOING TO EXIT IN THE PARK, THERE'S NOT THAT MUCH TRAFFIC.

BUT IF YOU COULD THINK GOING THROUGH A SUBDIVISION WITH ALMOST 1,000 UNITS, THERE COULD BE KIDS, PEOPLE BACKING OUT OF THE SUBDIVISION WHATEVER, THERE COULD BE A REAL PROBLEM.

I'M AGAINST THIS.

I WISH I COULD HAVE HELPED DESIGN IT BUT THEY DIDN'T ASK, IT'S NOT MY MONEY.

I WILL SEE IF I CAN CHANGE THE ZONING IF YOU HAVE OVER 300 HOUSES OR 400 HOUSES YOU HAVE TO HAVE ANOTHER ENTRANCE.

YOU SHOULD HAVE MORE ENTRANCES FOR PEOPLE TO EXIT.

I REALLY WOULD THINK IF WE COULD HAVE ONE ROAD THROUGH THIS DEVELOPMENT, A CONNECTOR ROAD TO SOMETHING ELSE, YOU WOULD ONLY NEED ONE.

BECAUSE WHEN A PERSON HITS THE CONNECTOR ROAD WHICH IS 35 MILES AN HOUR, OUT THEY GO.

I COULD SEE PROBABLY 10-15 MINUTES TO GET OUT OF THE SUBDIVISION BEFORE YOU GO ANYWHERE.

THIS IS A PROBLEM.

I WANTED TO TELL EVERYBODY, I'M VOTING AGAINST THIS.

THIS IS NOT GOOD FOR THE DEVELOPMENT, IT'S NOT GOOD FOR THE PEOPLE WHO ARE GOING TO BUY THERE.

EVENTUALLY THEY WILL SAY, I'M MOVING.

THANK YOU, MR. PRESIDENT.

>> PRESIDENT JAMES: THANK YOU, COUNCILMAN.

IS THERE ANY FURTHER DISCUSSION?

COUNCILMEMBER PEDEN?

>> THANK YOU, MR. PRESIDENT.

I WILL CONCUR WITH STEWART NOT SO MUCH ON THIS SPECIFIC DEVELOPMENT.

I HAVE COME REALLY CLOSE TO FILING AN ORDINANCE LATELY WITH THE "M" WORD, MORATORIUM, WHICH IS A GIANT PROBLEM.

AND I CAN'T BRING MYSELF TO DO IT, BUT WHAT I WANT TO AGREE WITH ARE COMMENTS ON CONNECTOR ROADS.

FOR WHATEVER REASON WE DON'T MAKE ANYBODY BUILD THOSE.

I DON'T KNOW IF WE DECIDED WE WILL TAKE THEM AS OUR RESPONSIBILITY AND THEN OBVIOUSLY WE DON'T HAVE THE MONEY.

COOPER CHAPEL ROAD PHASE 2, WHICH IS SUPPOSED TO CONNECT IS ABOUT TEN YEARS BEHIND SCHEDULE.

IF YOU LOOK AT THE KIPDA RECOMMENDATIONS THERE'S SUPPOSED TO BE A CONNECTOR CONNECTING BUHLICHER TO CEDAR CREEK ROAD.

IT DOESN'T EXIST YET.

EVERYONE USES ADAMS RUN SUBDIVISION IN MY DISTRICT TO GET FROM ANYWHERE IN THE SOUTHWESTERN PART OF THE COUNTY TO THE EXIT.

IT'S EVEN GOT TO THE POINT IT'S BAD ENOUGH WHEN TRAFFIC BACKS UP ON BARDSTOWN ROAD WHICH HAPPENS DAILY, THAT GOOGLE TAKES PEOPLE THROUGH THE SUBDIVISION BECAUSE THAT'S THE FASTEST WAY FOR THEM TO GET ANYWHERE WEST.

IF I COULD PROBABLY USE A GREAT EXAMPLE THAT, WELL MOST OF US, IF YOU HAVE BEEN AT HIKE'S POINT, YOU HAVE USED FERMIN AS A CUT-THROUGH.

WHEN FERMIN WAS BUILT 40 YEARS AGO, THAT WAS A NEIGHBORHOOD STREET.

I'M SURE THE PEOPLE WHO BOUGHT ON THAT STREET 40 YEARS AGO ARE NOT PLEASED IT IS NOW OFFICIALLY A CONNECTOR.

BUT THAT'S JUST WHAT WE TURNED IT INTO BECAUSE NO ONE DECIDED TO SET ASIDE ANY LAND OR MAKE DEVELOPERS BUILD THE CONNECTOR.

AND THEN LET THEM BRANCH OFF THAT.

STEWART IS EXACTLY RIGHT.

WHEN WE APPROVED THIS PLAN, OR WHICH EVER BODY APPROVES THIS PLAN BACK IN THE EARLY 2000'S, IT SHOULD HAVE BEEN PART OF IT.

YOU ARE GOING TO BUILD A MAIN 35 MILE AN HOUR ROAD AND YOU CAN BRANCH YOUR 90 HOMES OFF THAT IN ALMOST ANY CONFIGURATION YOU WANT, BUT WE DON'T DO THAT.

AND NOW THIS IS HAPPENING IN ADAMS RUN SUBDIVISION, WE KEEP APPROVING 40 HOMES HERE AND 50 HOMES THERE AND IT'S ALL DIFFERENT TRACTS OF LAND BUT EVERYONE OF THEM ON THE WAY TO WORK IN THE MORNING CUTS THROUGH THAT SUBDIVISION.

YOU WANT TO KNOW HOW I KNOW IT'S THE ONLY WAY THROUGH, BECAUSE THERE'S ALREADY SPEED HUMPS AND THEY STILL USE IT.

IT'S A PROBLEM.

NOT JUST FOR ME BUT WHAT DENTON HAS BEEN TALKING ABOUT CONNECTING OLD HENRY.

WHATEVER STUART IS TALKING ABOUT.

WE NEED TO GET THIS CONNECTOR TAKEN CARE OF.

WHEN IT'S YOUR ONLY OPTION, IT ENDANGERS EVERYONE.

ANYWAY, I GOT TO USE HIS SUBDIVISION TO SAY MY PEACE.

THANK YOU.

NOT LOOKING AT SIX MONTHS, WE ARE LOOKING A LITTLE FURTHER OUT THAN THAT BUT HOPEFULLY REDEVELOPING THE AREA OF DIXIE MANOR, WHICH COULD USE SOME HELP.

ST. PAUL'S HAS SOME AREA BEHIND THE CHURCH THERE.

JONES WAS BORN IN LOUISVILLE TO SADIE AND ODELL JONES; **WHEREAS**, MS. JONES GRADUATED FROM CENTRAL HIGH SCHOOL AND ATTENDED THE LOUISVILLE MUNICIPAL COLLEGE FOR NEGROES, WHICH LATER MERGED WITH THE UNIVERSITY OF LOUISVILLE DURING DESEGREGATION; **WHEREAS**, MS. JONES GRADUATED THIRD IN HER CLASS FROM THE UNIVERSITY OF LOUISVILLE AND WAS ACCEPTED INTO THE UNIVERSITY OF LOUISVILLE LAW SCHOOL BUT TRANSFERRED TO HOWARD UNIVERSITY'S SCHOOL OF LAW AFTER HER FIRST YEAR, AND THERE SHE GRADUATED FOURTH IN HER CLASS; **WHEREAS**, IN 1959, MS. JONES WAS ONE OF THE FIRST AFRICAN AMERICAN WOMEN TO PASS THE KENTUCKY BAR EXAM AND BECOME A MEMBER OF THE KENTUCKY BAR; **WHEREAS**, MS. JONES WAS THE FIRST FEMALE PROSECUTOR IN LOUISVILLE, WHERE SHE WORKED FOR THE JEFFERSON COUNTY ATTORNEY'S OFFICE AND PROSECUTED IN THE DOMESTIC RELATIONS COURT; **WHEREAS**, MS. JONES WAS ALSO CASSIUS CLAY'S FIRST ATTORNEY, AND WAS RESPONSIBLE FOR HAVING HIM TRAIN IN CALIFORNIA UNDER ARCHIE MOORE; **WHEREAS**, MS. JONES WAS A CIVIL RIGHTS ACTIVIST WHO NOT ONLY PARTICIPATED IN THE MARCH ON WASHINGTON AND THE MARCHES IN LOUISVILLE, BUT ALSO RENTED VOTING MACHINES AND HELD CLASSES TO TEACH AFRICAN AMERICANS HOW TO VOTE

FOR THE CANDIDATES OF THEIR CHOICE, AND LATER ESTABLISHED THE INDEPENDENT VOTERS ASSOCIATION; **WHEREAS**, MS. JONES ALSO ESTABLISHED THE JAMES "BULKY" WELCH FUND AFTER YOUNG BULKY WELCH LOST HIS ARMS TRYING TO RETRIEVE HIS DOG FROM UNDER A TRAIN, AND THE FUND RAFFLED OFF A CAR TO PAY HIS MEDICAL BILLS AND PURCHASE PROSTHETIC ARMS; **WHEREAS**, IN ADDITION TO BEING A MEMBER OF THE KENTUCKY BAR ASSOCIATION, MS. JONES WAS A MEMBER OF SEVERAL OTHER ORGANIZATIONS INCLUDING THE AMERICAN BAR ASSOCIATION, THE FALL CITY BAR ASSOCIATION, THE LOUISVILLE BAR ASSOCIATION WHERE SHE SERVED AS SECRETARY, ETA ZETA CHAPTER OF ZETA PHI BETA, AND THE SIGMA CHAPTER OF IOTA PHI LAMBDA; **WHEREAS**, MS. JONES WAS MURDERED IN AUGUST 1965 AND THE CASE REMAINS UNSOLVED TO THIS DAY; AND **WHEREAS**, THE COUNCIL IS GRATEFUL FOR MS. JONES'S SERVICE AND THE CHANGE SHE BROUGHT TO LOUISVILLE, AND REGRETS THAT SHE WAS NOT HERE LONGER KNOWING THAT SHE WOULD HAVE LEFT AN EVEN GREATER MARK ON THE CITY.

WHEREAS, FRANK W. WEAVER WAS BORN ON DECEMBER 28, 1926
IN LOUISVILLE, KENTUCKY, AND DIED ON AUGUST 18, 2018 AT THE AGE
OF 91; **WHEREAS**, AT 18 YEARS OLD, MR. WEAVER WAS DRAFTED INTO THE
UNITED STATES ARMED FORCES, AND AFTER BASIC TRAINING WAS
ASSIGNED TO THE TUSKEGEE ARMY AIR FIELD IN TUSKEGEE, ALABAMA;
WHEREAS, DURING WORLD WAR I, AFRICAN AMERICAN MEN IN THE U.S.
HAD TRIED TO BECOME "AERIAL OBSERVERS," BUT THEY WERE
CONTINUOUSLY REJECTED; **WHEREAS**, ON APRIL 3, 1939, AN
APPROPRIATIONS LAW WAS PASSED TO FUND THE TRAINING OF AFRICAN
AMERICAN PILOTS, AND IN 1941, DURING WORLD WAR II, THE FIRST
AFRICAN AMERICAN U.S. MILITARY PILOTS WERE TRAINED AT THE
TUSKEGEE ARMY AIR FIELD AND TUSKEGEE UNIVERSITY AND BECAME SOME
OF THE BEST PILOTS IN THE U.S. ARMY AIR FORCES DUE TO A
COMBINATION OF PRE-WAR EXPERIENCE AND THE PERSONAL DRIVE OF
THOSE ACCEPTED FOR TRAINING; **WHEREAS**, ALL PILOTS, MECHANICS,
INSTRUCTORS, CREW CHIEFS, COOKS, SERVICE PERSONNEL, ETC. THAT
WERE A PART OF THIS NEW PROGRAM AT THE TUSKEGEE ARMY AIR FIELD
ARE FAMOUSLY KNOWN AS THE TUSKEGEE AIRMEN AND ARE CREDITED WITH
NUMEROUS ACCOMPLISHMENTS AND RECEIVED MANY DISTINGUISHED UNIT
CITATIONS, AWARDS, AND MEDALS; **WHEREAS**, MR. WEAVER WAS AS ONE OF
THE FAMED TUSKEGEE AIRMAN AND SERVED OUR NATION DURING WORLD WAR
II AS HANGER CHIEF AND A B-25 ENGINE MECHANIC; **WHEREAS**, AFTER
THE WAR, MR. WEAVER, LIKE THE OTHER AFRICAN AMERICAN WAR-TIME

HEROES, CONTINUED TO EXPERIENCE RACISM UPON HIS RETURN TO LOUISVILLE AND HAD DIFFICULTY FINDING EMPLOYMENT USING THE EXCEPTIONAL SKILLS HE LEARNED IN THE MILITARY; **WHEREAS**, MR. WEAVER WORKED FOR THE JEFFERSONVILLE QUARTERMASTER DEPOT, AND LATER WORKED FOR GENERAL ELECTRIC WHERE HE RETIRED AFTER 32 YEARS; **WHEREAS**, MR. WEAVER ALSO OWNED A NEIGHBORHOOD GAS STATION WHERE HE PUT HIS MECHANICAL SKILLS TO WORK REPAIRING AUTOMOBILE ENGINES; **WHEREAS**, MR. WEAVER WAS A DEACON AT FIRST BAPTIST CHURCH OF JEFFERSONTOWN, A VOLUNTEER IN THE POLITICAL ARENA, AND A MEMBER OF THE BRIGADIER GENERAL NOEL F. PARRISH CHAPTER OF TUSKEGEE AIRMEN, INC. IN KENTUCKY.; **WHEREAS**, MR. WEAVER WAS MARRIED TO THE LATE JEWEL D. TITUS FOR 58 YEARS AND THEY HAVE TWO CHILDREN (GARY L. WEAVER, SR. AND ANDRE' M. WEAVER), SIX GRANDCHILDREN, AND SEVEN GREAT GRANDCHILDREN; **WHEREAS**, THE METRO COUNCIL WISHES TO CELEBRATE THE LIFE OF MR. WEAVER AND WE ARE GRATEFUL FOR HIS SERVICE TO OUR NATION AS A TUSKEGEE AIRMAN.
