AS WE KNOW IN MARCH OF 2017 IT BECAME NEWS THAT A SEX ABUSE LAWSUIT WAS FILED AGAINST LMPD AND THE CITY OF LOUISVILLE BASED UPON ALLEGATIONS OF SEXUAL ABUSE OF SEVERAL CHILDREN THAT WERE TAKING PART OF A LMPD YOUTH EXPLORER PROGRAM AT THE HANDS OF CERTAIN LMPD OFFICERS. RESOLUTION 031 SERIES 2017 ADOPTED APRIL 13, 2017, PROPOSED A PAY OF \$50,000 TO DICKINSON WRIGHT PLLC FOR PROFESSIONAL SERVICES WITH RESPECT TO MATTERS RELATED TO THE LMPD YOUTH EXPLORE PROGRAM FROM MARCH 17, 2017, THROUGH MARCH 16, 2018. THE RESOLUTION WAS PROPOSED AND PASSED AT THE RECOMMENDATION OF THE MAYOR'S OFFICE. SINCE APRIL 13, 2017, MR. HARVEY HAS BEEN CONDUCTING AN ADMINISTRATIVE INVESTIGATION. ALSO DURING THIS SAME TIME FRAME LMPD PUBLIC INTEGRITY UNIT AND THE FBI HAVE BEEN CONDUCTING A CRIMINAL INVESTIGATION WITH THE

ASSISTANCE OF THE JEFFERSON COUNTY COMMONWEALTH ATTORNEY'S

OFFICE AND THE WESTERN DISTRICT OF KENTUCKY U.S. ATTORNEY'S

OFFICE. THESE INVESTIGATIONS ARE STILL ONGOING. MR. CLERK,

PLEASE READ INTO THE RECORD THE CALL FOR THE SPECIAL MEETING.

CLERK: PURSUANT TO RULE 1.05 AND 3.08 OF THE METRO COUNCIL RULES, WE, THE UNDERSIGNED, CALL FOR A SPECIAL MEETING OF THE LOUISVILLE METRO COUNCIL OF THE LOUISVILLE/JEFFERSON METRO GOVERNMENT TO BE HELD ON WEDNESDAY, JUNE 27, 2018, AT 3:00 P.M. IN COUNCIL CHAMBERS, THIRD FLOOR CITY HALL, 601 WEST JEFFERSON STREET, LOUISVILLE, KENTUCKY. THE PURPOSE OF THE SPECIAL E-MAIL IS REGARD TO THE FOLLOWING E-MAIL COMMUNICATION FROM METRO COUNCIL PRESIDENT DAVID JAMES. FROM LOUISVILLE METRO COUNCIL PRESIDENT DAVID JAMES AND METRO COUNTY ATTORNEY JONATHAN RICKETTS DATED JUNE 22, 2018. COLLEAGUES, THIS E-MAIL IS TO PROVIDE YOU WITH AN UPDATE ON THE LMPD POLICE EXPLORER SEX ABUSE INVESTIGATION AND THE HARVEY INVESTIGATION OF WHO KNEW WHAT, WHEN THEY KNEW IT, AND WHAT THEY DID OR DIDN'T DO ABOUT IT AND A TIME LINE OF EVENTS. OUR ATTORNEY, MR. RICKETTS, HAS HAD MEETINGS AND CONVERSATIONS WITH THE JEFFERSON COUNTY ATTORNEY'S OFFICE AND THE MAYOR'S OFFICE TO MAKE SURE WE ARE ABLE TO HAVE THE INFORMATION RELEASED TO THE METRO COUNCIL AND THE PUBLIC. THIS WEEK THE JEFFERSON COUNTY ATTORNEY'S OFFICE AND MR. RICKETTS TRAVELED TO LEXINGTON TO MEET WITH MR. HARVEY TO VIEW THE REPORT AND ANALYZE IT FOR ANY NEEDED REACTIONS. THEY FOUND

THREE BASIC AREAS OF REDACTIONS. ONE, ITEMS THAT WOULD BE IN CONFLICT TO FEDERAL COURT ORDERS. TWO, ITEMS THAT COULD POSSIBLY HARM CRIMINAL PROSECUTION OR IDENTIFY VICTIMS. THREE, ITEMS THAT WOULD BE IN VIOLATION OF STATE OR FEDERAL STATUTES IF RELEASED. THE UN-REDACTED REPORT IS 90 PAGES IN LENGTH. THE ATTORNEYS ALL AGREED ON WHAT SHOULD OR SHOULD NOT BE REDACTED. THAT DOCUMENT SHOULD BE FINALIZED AND SIGNED OFF ON THIS UPCOMING WEDNESDAY, JUNE 27TH. BECAUSE OF THAT, I LIKE TO CALL A SPECIAL METRO COUNCIL MEETING FOR WEDNESDAY, JUNE 27TH, AT 3:00 P.M. AS YOU KNOW, PER OUR RULES, THIS REQUIRES APPROVAL FROM 18 OF COUNCIL MEMBERS, I WILL BE WORKING TO GATHER THE REQUIRED SIGNATURES BETWEEN NOW AND NEXT TUESDAY. PURPOSE OF THE SPECIAL MEETING: ONE, REVIEW THE FULL REPORT FROM MR. HARVEY. TWO, RECEIVE INFORMATION FROM MR. HARVEY ABOUT THE INVESTIGATION. THREE, RECEIVE INFORMATION FROM METRO COUNCIL ATTORNEY, MR. RICKETTS, AND/OR HIS LAW PARTNER CHRISTOPHER BUSH, REGARDING THE REPORT AND REDACTION RECOMMENDATIONS. FOUR, VOTE YES/NO TO CONCUR WITH THE REDACTIONS RECOMMENDED BY COUNSEL. FIVE, VOTE YES OR NO TO RELEASE THE REDACTED REPORT TO THE PUBLIC. THE OPPORTUNITY TO ASK MR. HARVEY DETAILED OUESTIONS ABOUT THE REPORT WILL COME AT A LATER DATE. THE REPORT WILL BE ASSIGNED TO THE PUBLIC SAFETY COMMITTEE AND COUNCILWOMAN GREEN, WHO WILL SCHEDULE TIME FOR MR. HARVEY TO APPEAR BEFORE THE COMMITTEE TO ANSWER DETAILED QUESTIONS ABOUT THE REPORT. IF YOU HAVE ANY

QUESTIONS, PLEASE FEEL FREE TO CALL. THANK YOU FOR YOUR TIME AND SERVICE, DAVID. COUNCILMAN DAVID JAMES, PRESIDENT LOUISVILLE METRO COUNCIL, DISTRICT 6. THE CLERK'S OFFICE OBTAINED THE REQUIRED CONSENSUS OF 18 COUNCIL MEMBERS VIA SIGNATURE OR E-MAIL FROM COUNCIL MEMBER HOLLANDER, COUNCIL MEMBER REED, COUNCIL MEMBERS KRAMER, BENSON, STUCKEL, JAMES, PEDEN, SEXTON SMITH, BRYANT HAMILTON, WOOLRIDGE, DENTON, BLACKWELL, GREEN, FOWLER, SHANKLIN, LANSHIMA, ENGLE, AND MULVIHILL. READ IN FULL.

WITH THAT BEING SAID, WITH THAT INFORMATION, AT THIS TIME I MOVE THE COUNCIL TO PROCEED IN CLOSED SESSION PURSUANT TO KRS 61.810 SECTION 1, SUBSECTION C AND K, TO DISCUSS THE REDACTION AND PUBLIC DISSEMINATION OF THE REPORT PREPARED BY THE LAW FIRM DICKINSON WRIGHT PLCC REGARDING THE INVESTIGATION. THE REPORT IS AN ATTORNEY-CLIENT COMMUNICATION, WHICH PERTAINS TO PENDING LITIGATION AGAINST METRO GOVERNMENT AND RELATION TO THE LOUISVILLE METRO POLICE DEPARTMENT'S YOUTH EXPLORER PROGRAM. THE REPORT CONTAINS INFORMATION IN PART THAT'S BELIEVED TO BE PROHIBITED FROM PUBLIC DISSEMINATION BY JUDICIAL PROTECTIVE ORDERS ENTERED IN ACTIVE CASES, WHICH ARE CURRENTLY PROCEEDING UNDER SEAL. THE REPORT IS ALSO BELIEVED TO CONTAIN INFORMATION WHICH IS PROHIBITED FROM DISSEMINATION UNDER STATE AND FEDERAL LAWS, WHICH PROTECT JUVENILE RECORDS MAINTAINED BY LAW ENFORCEMENT AND HEALTH CARE INFORMATION. THE REPORT IS ALSO

BELIEVED TO CONTAIN INFORMATION THAT MAY BE SENSITIVE TO ONE OR MORE ONGOING CRIMINAL INVESTIGATIONS. IN CLOSED SESSION, THE METRO COUNCIL WILL BE GIVEN ADVICE AND COUNSEL REGARDING THE EXTEND TO WHICH METRO COUNCIL MAY CHOOSE TO REDACT PORTIONS OF THE REPORT PRIOR TO ANY DISSEMINATION TO THE PUBLIC AND RESPECT TO LAW, ONGOING CRIMINAL INVESTIGATIONS.   DURING THIS VOTE. I BELIEVE THE DOCUMENT SHOULD BE RELEASED TO

  THE PUBLIC. HOWEVER, I COMPLETELY DISAGREE THAT WHEN THIS BODY

  VOTED FOR THE ALLOCATION OF FUNDS TO BEGIN THIS INVESTIGATION

  AND TO HIRE THESE INVESTIGATORS, WE DID SUCH WITH THE ATTITUDE

  WE WERE HIRING INVESTIGATORS. NOWHERE IN THAT APPROPRIATION WAS

  I ASKED TO CONSIDER OR EVEN CONTEMPLATED THAT WE WERE HIRING

  ATTORNEYS FOR ATTORNEY-CLIENT PRIVILEGE, ESSENTIALLY,

  PREPARATION OF LITIGATION, SOMETHING ALONG THE LINES THAT A

  PRIVILEGE WOULD APPLY. IN MY OPINION, WE DO NOT HAVE AN

  ATTORNEY-CLIENT RELATIONSHIP IN THIS MATTER. YES, THE

  INVESTIGATORS HAPPEN TO BE ATTORNEYS, BUT THEY WERE NOT HIRED

FOR LITIGATION PURPOSES. THEY WERE NOT HIRED IN ANTICIPATION OR DEFENSE OF LITIGATION. THEY WERE HIRED TO INVESTIGATE AND INFORM THE PUBLIC AND MY CONSTITUENTS WHAT TOOK PLACE, AND AS SUCH, I DO NOT BELIEVE A PRIVILEGE EXISTS, SO I WILL NOT BE VOTING TO WAIVE SOMETHING THAT I DO NOT BELIEVE EXISTS. BY MY VOTE, IF I VOTED TO WAIVE SOMETHING I DIDN'T BELIEVE EXISTED, I'M COMPLICIT IN CREATING IT ALMOST, SO I'LL BE VOTING PRESENT. PUBLIC, I WANT YOU TO HAVE THIS INFORMATION, BUT I WILL NOT BE VOTING TO WAIVE A PRIVILEGE WHEN I DON'T BELIEVE ONE EXISTS, AND I INVITE THE PUBLIC TO CHALLENGE THAT PRIVILEGE. GO BACK AND WATCH THE VOTE THAT THIS BODY TOOK, THE DISCUSSION INVOLVED WHEN WE APPROPRIATED MONEY. WE APPROPRIATED MONEY FOR AN INVESTIGATION. YOU KNOW, NOW THERE MIGHT HAVE BEEN A SUBSEQUENT CONTRACT BETWEEN THE MAYOR'S OFFICE AND MR. HARVEY THAT SAYS HE'S BEING HIRED AS AN ATTORNEY. I WASN'T INVOLVED IN THAT CONTRACT. I WASN'T CONSULTED ON THAT CONTRACT, AND THAT CONTRACT WAS NOT CONTEMPLATED, THAT LANGUAGE, IF IT EXISTS, WAS NOT CONTEMPLATED BY THE REQUEST FOR THIS APPROPRIATION, NOR MY VOTE TO APPROPRIATE THIS MONEY. AS SUCH, AGAIN, I DO NOT BELIEVE A PRIVILEGE EXISTS, AND SO I WILL NOT VOTE ONE WAY OR THE OTHER TO WAIVE SOMETHING I DO NOT BELIEVE EXISTS IN THE FIRST PLACE. THANK YOU, MR. PRESIDENT.

  IS. THANK YOU.

- >> THIS COUNCIL DID HIRE AN ATTORNEY, AND OUR ATTORNEY IS
  THE ONE WHO DID THE REDACTIONS, AND SO WE DO HAVE AN ATTORNEYCLIENT PRIVILEGE WITH OUR ATTORNEY, AS IN REFERENCE TO THESE
  REDACTIONS. SO THAT'S THE PRIVILEGE -- I WOULD PROPOSE TO YOU
  THAT A MOMENT OF PRIVILEGES, I AT LEAST WOULD THINK WE WOULD
  WAIVE THOSE PRIVILEGES, AT LEAST SPECIFIC TO THESE REDACTIONS,
  WHICH IS EXACTLY WHAT THE MOTION IS ACTUALLY PROPOSING.
  - >> PRESIDENT JAMES: COUNCILWOMAN FLOOD?
- >> THANK YOU, MR. PRESIDENT. SINCE COUNCILMAN ACKERSON

  MENTIONED THAT THE CONTRACT WAS SIGNED WITH THE MAYOR'S OFFICE,

  ALSO DO WE HAVE TO HAVE SOMETHING STATING THAT THE MAYOR IS ALSO

WAIVING HIS RIGHT? TO ATTORNEY-CLIENT PRIVILEGE, OR IS THAT JUST ASSUMED?

- >> SO THIS BODY IS INDEPENDENT OF THE MAYOR.
- >> I UNDERSTAND THAT, BUT HE JUST MENTIONED THAT IT WAS --
- >> PRESIDENT JAMES: AND THEY ARE ALSO GOING TO BE RELEASING
  THE SAME INFORMATION WE ARE RELEASING. DOES THAT ANSWER YOUR
  OUESTION?
- >> I JUST WANTED THAT ON RECORD. IT WASN'T US TRYING TO

  UPSTAGE OR USURP SOMEONE, AND ALSO I JUST WANT TO MAKE A

  STATEMENT THAT I DO BELIEVE AFTER CONVERSATIONS WITH MR. HARVEY,

  THAT HE DID BELIEVE THAT THAT PRIVILEGE EXISTED, SO, THEREFORE,

  I FEEL LIKE IN ALL FAIRNESS THAT WOULD HAVE TO WAIVE THAT RIGHT.
- >> PRESIDENT JAMES: THANK YOU, COUNCILWOMAN. COUNCILWOMAN LEET?
- >> THANK YOU, MR. PRESIDENT. I WOULD ALSO LIKE TO CLARIFY
  THE REDACTIONS WERE A COLLABORATIVE RECOMMENDATIONS AND NOT JUST
  OUR ATTORNEY'S RECOMMENDATION. THIS WAS INCLUSIVE OF THE MAYOR'S
  OFFICE ATTORNEY, MR. MOSELEY, AS WELL AS THE JEFFERSON COUNTY
  ATTORNEY'S OFFICE REPRESENTATIVES, ALONG WITH -- ALONG WITH OUR
  REPRESENTATIVE, AS WELL. SO I JUST WANTED TO CLARIFY THAT FOR
  THE RECORD. THANK YOU.
  - >> PRESIDENT JAMES: THAT IS CORRECT. COUNCILMAN ACKERSON.

- >> YES, MR. PRESIDENT. I JUST WANT TO ALSO, FOR THE VIEWING PUBLIC, CLARIFY ANY VOTE ON THIS PRIVILEGE IS NOT SAYING WE AS A BODY AREN'T SAYING FOR THOSE OF YOU WHO VOTE ON THIS AREN'T SAYING WE WAIVE PRIVILEGE IN TOTALITY. THE PRIVILEGE BEING DISCUSSED IS SOLELY RELATED TO THIS REPORT, A LIMITED PRIVILEGE, SO THERE WILL BE THOSE IN THIS GOVERNMENT THAT COULD POTENTIALLY STILL HIDE BEHIND AND CONCEAL INFORMATION RELATED TO THIS BASED UPON THE CLAIM OF PRIVILEGE. THANK YOU.
  - >> PRESIDENT JAMES: THANK YOU. COUNCILWOMAN GREEN?
- >> THANK YOU, MR. PRESIDENT. TO COUNCILMAN KRAMER'S POINT,
  RESPECTFULLY, I DISAGREE WITH MY COLLEAGUE THERE WOULD BE A
  WAIVER OF ANY PRIVILEGE WITH OUR COUNSEL. OUR COUNSEL DID NOT
  PREPARE THE DOCUMENT. THERE'S NOTHING IN THAT DOCUMENT THAT OUR
  COUNSEL ACTUALLY WROTE. THERE WAS JUST ADVICE THEY GAVE TO US ON
  THE LEVEL OF REDACTIONS, SO I DO NOT BELIEVE IT WOULD BE
  APPROPRIATE TO TAKE A WAIVER OF ATTORNEY-CLIENT PRIVILEGE FROM
  OUR OWN COUNSEL AT THIS POINT. THANK YOU.
- >> PRESIDENT JAMES: THANK YOU. ANY FURTHER DISCUSSION?
  HEARING NONE, THIS IS AN ACTION THAT WILL REQUIRE A ROLL CALL
  VOTE. VOTING IS CLOSING. VOTING IS CLOSED.
- >> MR. CLERK: THERE ARE 20 YES VOTES, ONE PRESENT, AND FIVE NOT VOTING. THE ONE PRESENT IS COUNCIL MEMBER ACKERSON.
- >> PRESIDENT JAMES: THANK YOU. THE MOTION PASSES. AT THIS
  TIME I'D LIKE TO INVITE MR. HARVEY UP TO THE PODIUM, AND PLEASE

IDENTIFY YOURSELF AND I'VE ASKED MR. HARVEY TO -- I'M ASKING MR. HARVEY, TO JUST GIVE US A BRIEF SYNOPSIS OF THE REPORT AND THE PROCESS FOR COMPLETING THE REPORT, IF YOU DON'T MIND, PLEASE.

>> THANK YOU, MR. PRESIDENT, LADIES AND GENTLEMEN OF THE COUNCIL, MY NAME IS KERRY HARVEY, I'M A PARTNER WITH DICKINSON WRIGHT. I'M JOINED HERE TODAY BY MY PARTNER ANDREW SPARKS. AND, FIRST OF ALL, I WANT TO SAY THANK YOU TO ALL OF THE MEMBERS OF THE COUNCIL, AS WELL AS THE MAYOR'S OFFICE, FOR ENTRUSTING US WITH THIS ASSIGNMENT. IT HAS BEEN A DIFFICULT ASSIGNMENT, BUT WE KNOW THAT IT IS IMPORTANT. WE'LL ASSURE YOU THAT WE APPROACHED THIS TASK WITH THE SERIOUSNESS THAT IT DESERVES. WE HAVE TODAY DELIVERED THE REPORT OF OUR FINDINGS TO YOU. I KNOW THAT IT'S OUITE LENGTHY AND YOU CERTAINLY HAVEN'T HAD AN OPPORTUNITY TO REVIEW IT IN ANY DETAIL, SO I DON'T PROPOSE TO GO INTO A LONG DISSERTATION ABOUT OUR FINDINGS. I THINK THAT WOULD PROBABLY NOT BE USEFUL AT THIS TIME. I BELIEVE WE'LL BE COMING BACK TO A PUBLIC SAFETY MEETING IN THE FUTURE, IN MID-JULY, AT WHICH POINT WE WILL HAVE A MORE DETAILED DISCUSSION ABOUT OUR FINDINGS. AS I MENTIONED, MR. SPARKS IS WITH ME HERE TODAY. HE WAS THE CHIEF OF OUR FRAUD AND WHITE COLLAR AND PUBLIC CORRUPTION DIVISION IN THE U.S. ATTORNEY'S OFFICE IN THE ATTORNEY DISTRICT OF KENTUCKY, AND SO HE'S VERY WELL QUALIFIED TO WORK ON THIS PROJECT. WE ALSO BENEFITED GREATLY FROM THE SERVICES OF MR. CLAY MASON, WHO IS A RETIRED FBI AGENT. MR. MASON RAN THE FRANKFURT BUREAU OF THE FBI

FOR MANY YEARS, AND HE ASSISTED US IN THESE ENDEAVORS. WE ENCOUNTERED SOME DIFFICULTIES ALONG THE WAY. SOME WE ANTICIPATED, SOME WE DID NOT, AS WITH ANY INVESTIGATION INTO A COMPLEX MATTER, IT TAKES A LOT OF TWISTS AND TURNS. AT THE END OF THE DAY, WE ASSEMBLED, I THINK, A GREAT VOLUME OF INFORMATION FROM WHICH WE DREW OUR CONCLUSIONS. THERE WAS OTHER INFORMATION THAT WOULD HAVE PERHAPS FURTHER INFORMED OUR CONCLUSIONS THAT SIMPLY WAS NOT AVAILABLE TO US AND COULD CHANGE OUR CONCLUSIONS, BUT THIS IS TRUE IN ANY INVESTIGATION, WHETHER IT'S PRIVATE OR WHETHER IT'S A LAW ENFORCEMENT INVESTIGATION. TYPICALLY, THERE'S INFORMATION THAT YOU WOULD LIKE TO KNOW THAT YOU CAN JUST NEVER FIND OUT. AT THE END OF THE DAY, WE'VE DELIVERED OUR CONCLUSIONS TO YOU. MUCH OF THIS IS IN THE EYE OF THE BEHOLDER. WE'RE JUDGING HUMAN CONDUCT. YOU MIGHT LOOK AT THE SAME FACTS AND COME TO A DIFFERENT JUDGMENT AND, OF COURSE, EVERYBODY HAS THAT RIGHT. I CAN ASSURE YOU, HOWEVER, THAT THE CONCLUSIONS THAT WE REACHED WERE REACHED HONESTLY BASED UPON OUR EXPERIENCE AND WHAT WE LEARNED DURING THE COURSE OF THIS INQUIRY, AND THAT EVERY FINDING IS PLAYED RIGHT DOWN THE MIDDLE. WE PROCEEDED WITH ONLY ONE NORTH STAR IN THIS, AND THAT IS TO GET AS CLOSE TO THE TRUTH OF THIS AS WE POSSIBLY COULD. WE HOPE THAT THE REPORT THAT WE'VE DELIVERED WILL BE USEFUL TO YOU AND TO THE MAYOR'S OFFICE AND TO THE METRO GOVERNMENT IN IMPROVING YOUR OPERATIONS AND HAVING A BETTER, SAFER CITY. AND AGAIN, WE ARE HONORED TO WORK FOR THE

LOUISVILLE METRO GOVERNMENT, AND WE'RE HONORED TO BE HERE WITH YOU TODAY, AND WE APPRECIATE THE SERIOUSNESS OF THIS TASK AND THE SERIOUSNESS WITH WHICH YOU WILL APPROACH YOUR USE OF THE INFORMATION WE'VE DELIVERED TODAY. THANK YOU.
