To rename Crandon Road to Standiford Plaza Drive

## CASE SUMMARY/BACKGROUND

The applicant proposes to rename Crandon Road to Standiford Plaza Drive. Crandon Road is fully contiguous with Standiford Plaza Drive to the north, with no intersection or other divider between the two street names. Crandon Road is approximately 500 feet in length, extending from Hasbrook Drive in the south to where the roadway becomes Standiford Plaza Drive in the north. Standiford Plaza Drive extends approximately ½ mile from Crandon Road in the south to its intersection with Mount Washington Road in the north.

Six properties have addresses from Crandon Road, but none contain structures.

The proposed name has been approved by Metro Emergency Services. The request may be heard in business session of the Planning Commission if no interested party requests a public hearing. The name change does appear to be appropriate given the site context.

 RECOMMEND to Louisville Metro Council to APPROVE or DENY the name change from Crandon Road to Standiford Plaza Drive.




