POWERS

It shall have such powers as may be necessary to promote and develop riverport and river navigation facilities and to attract industrial or commercial operations to the property held as industrial parks. The authority shall establish and fix reasonable rates, charges and fees for the use of the riverport facilities and the authority may acquire any read or personal emperty necessary for establishing, developing, operating or expanding diverport facilities.

REMOVAL

A diverport authority member may be realized by the appointing authority for inefficiency neglect of obty malfeasinon or conflict of interest. The appointing authority stall submit a written stalament to the reviewed authority setting forty the reasons for removal and the stalament shall be read at the next authority meeting which shall be open to the general public. The member so removed shall have the right of appeal in the Circuit Court.

He shall transact a concern a desired expenditure of the authority to the legislative body or bodies by whom the authority was created.

VACANCY APPOINTMENT	the failure of an appointing authority to appoint a successor or if the appointing authority's appointment is subject to the suproval of a legislative body to nominate a successor within sorty (60) day of the expiration of the term of effice of a member of a disinct governing body shall constitute the reappointment of that member for another term of office.
