- >> MY NAME IS CECIL CALHOUN, AND ME AND PRESIDENT JAMES

 EXAMPLE ABOUT GOING TO GET AN APARTMENT. IF YOU LOOK AT THIS
 PAPER, I SHOWED Y'ALL, THEY WENT AND MARKED EVERYTHING, WOULDN'T
 LET ME LOOK AT THE APARTMENT, AND AFTER I LOOKED AT THE
 APARTMENT, UP IN THE CEILING I SEEN WATER STAINS AND CRACKED

THAT WOULD LET Y'ALL KNOW THAT THEY WERE PLAYING WITH MY DIAGNOSIS. I FOLLOWED THE LAW, AND MRS. OSINKA, SHE THINKS THIS IS A GAME. BLACK PEOPLES KILLING EACH OTHER EVERY DAY, AND WHEN YOU PLAY WITH PEOPLE'S MEDICAL RECORDS, THAT'S A BIG THING WITH HOUSING. I'M GOING TO GET OFF HERE SO EVERYBODY HAS TIME TO TALK, BUT IF YOU LOOK AT ONE OF THOSE PAPERS, YOU SEE WHERE I DID NOT SIGN NOTHING TO STEWART POPE TO BE TALKING TO THE DOCTORS. AND, YOU KNOW, ALL I'M SAYING IS, I AM A CITIZEN, AND I'D LIKE TO BE TREATED LIKE A CITIZEN. IF THEY ARE DOING ME THIS WAY, HOW MANY OTHER PEOPLE AROUND HERE THEY DOING THIS WAY? THANK YOU.

>> CLERK: CHRIS BREESMAN. CHRIS BREESMAN. I HOPE I'M SAYING
THAT CORRECTLY. PARDON? OKAY, THANK YOU. DAN SIGN JR.

>> THANK YOU, COUNCIL MEMBERS. DAN SIGN JR. FROM THE 13TH DISTRICT. MARK FOX IS MY COUNCIL REPRESENTATIVE. THANK YOU FOR HEARING THIS. I'LL GET RIGHT TO IT. IN ANY GIVEN YEAR, KENTUCKY IS EITHER NUMBER ONE, TWO, OR THREE IN CANNABIS EXPORTS AND PRODUCTION THROUGHOUT THE UNITED STATES. THE ENFORCEMENT OF MARIJUANA POSSESSION LAWS NEEDLESSLY ENSNARES THOUSANDS OF OTHERWISE LAW-ABIDING CITIZENS INTO THE CRIMINAL JUSTICE SYSTEM

AND WASTES MILLIONS OF KENTUCKY TAXPAYER DOLLARS THAT COULD BE BETTER INVESTED IN OUR COMMUNITIES. WHAT'S MORE, IT'S CARRIED OUT WITH STAGGERING RACIAL BIAS. OUR JEFFERSON COUNTY BLACK CITIZENS ARE ARRESTED AT A SIX TIMES THE RATE FOR POSSESSION OF MARIJUANA, ALTHOUGH THE CONSUMPTION IS RELATIVELY THE SAME. WHEN PEOPLE ARE ARRESTED FOR POSSESSING EVEN TINY AMOUNTS OF MARIJUANA, IT CAN HAVE DIRE COLLATERAL CONSEQUENCES THAT AFFECT THEIR ABILITY FOR PUBLIC HOUSING, STUDENT FINANCIAL AID, EMPLOYMENT OPPORTUNITIES, AND CHILD CUSTODY DETERMINATIONS. MOST OF THE PEOPLE POLICE ARE ARRESTING AREN'T KINGPINS, BUT RATHER PEOPLE WITH SMALL AMOUNTS OF POT. KENTUCKY IS IN THE CANNABIS BUSINESS. WE COLLECT SALES TAX FROM EVERYTHING ASSOCIATED WITH CANNABIS, IN ADDITION TO THE EMPLOYEE TAXES COLLECTED BY HUNDREDS OF EMPLOYEES IN THESE BUSINESSES. HOWEVER, WE PROHIBIT THE PRODUCT LEAVING IT UP TO THE BLACK MARKET TO SUPPLY IT. WE ARE ALLOWING OUR CITIZENS TO PURCHASE PRODUCTS TO CONSUME MARIJUANA, YET WE CRIMINALLY CITE THEM WITH PARAPHERNALIA CHARGES. THERE ARE OVER 125 SMOKE SHOPS IN LOUISVILLE ALONE. GLASS PIPES, METAL PIPES, WOOD PIPES, BONG PIPES, ONE-HITTER PIPES, HERB GRINDERS, DETOX DRINKS, DIGITAL SCALES, ROLLING PAPERS IN EVERY GAS STATION. POSSESSION OF PARAPHERNALIA IS A CLASS A MISDEMEANOR, WHICH IS PUNISHABLE BY A MAXIMUM SENTENCE OF OVER ONE YEAR IN PRISON AND A MAXIMUM FINE OF \$500. GROWERS CAN PRODUCE LIGHTING, HYDROPONICS, CLIMATE CONTROL, SEED

STARTING, PLANT CARE, NUTRIENTS AND ADDITIVES, GROW TINTS, FILTRATION, BOOKS AND VIDEOS ON CULTIVATION. CULTIVATION OF FIVE PLANTS OR MORE IS A CLASS D FELONY FOR A FIRST OFFENSE, WHICH IS PUNISHABLE BY ONE TO FIVE YEARS IMPRISONMENT AND A FINE OF \$1,000 TO \$10,000. WE TAX SALES OF CANNABIS CLOTHING, JEWELRY, ART, ET CETERA. WASHINGTON, D.C., POLICE CHIEF CATHY LANEAR DECRIES THE SYSTEM OF PROHIBITION AND HOW IT TARNISHED COMMUNITY RELATIONS WITH POLICE. LANEAR STATED, ALL THESE MARIJUANA ARRESTS DO IS MAKING PEOPLE HATE US. SHE ADDED, "MARIJUANA SMOKERS ARE NOT GOING TO ATTACK AND KILL A COP. THEY JUST WANT TO GET A BAG OF CHIPS AND RELAX. ALCOHOL IS MUCH BIGGER PROBLEM. ASK ANY OFFICER." WE ASK THAT YOU HELP US WITH LANGUAGE FOR A LOWEST LEVEL ENFORCEMENT POLICY ORDINANCE FOR CANNABIS POSSESSION IN JEFFERSON COUNTY. OUR LAW ENFORCEMENT RESOURCES ARE TOO VALUABLE, AS ARE THE LIVES AFFECTED BY THIS BARBARIC PROHIBITION. THANK YOU.

>> HELLO, MY NAME IS KIM NETHERY. I GREW UP IN SOUTH
LOUISVILLE, GRADUATED FROM PRP, AND HAVE ALWAYS BEEN A PROUD
KENTUCKIAN. THANK YOU TO MY TIME AND ATTENTION TO MY REQUEST FOR
BRINGING CANNABIS REFORM TO OUR GREAT CITY OF LOUISVILLE. I
THINK MOST OF US ARE TIRED OF THE CANNABIS/MARIJUANA TALK, YET
IT'S ONE OF THE TOP-RANKING ISSUES ACROSS THE NATION. AND WHY IS
THAT? IN PART, BECAUSE AS CONSTITUENTS, WE'VE TRUSTED THOSE

VOTED IN OFFICE ARE LOOKING OUT FOR OUR BEST INTEREST, BUT AFTER 70 YEARS OF DESTROYING FAMILIES AND KEEPING MINORITIES A MINORITY, WE REALIZE WE'VE BEEN DUPED BY OUR ELECTED LEADERS, AND WE NEED CHANGE. THIS REQUEST IS NOT PRESENTED OUT OF WANT. I SPEAK TO YOU OUT OF NECESSITY. THE NECESSITY IS, THAT EVERY DAY A LIFE IS HARASSED OVER MARIJUANA. CHILDREN ARE SEPARATED FROM THEIR PARENTS OVER MARIJUANA. MINORITY INDIVIDUALS ARE TREATED DIFFERENTLY IN THIS ONE DRUG CATEGORY, MARIJUANA. AND LET'S NOT FORGET, THE SICK ARE PUNISHED FOR TRYING TO HAVE A BETTER QUALITY OF LIFE WHEN MARIJUANA HELPS. THE WORD MARIJUANA HAS BEEN DEMONIZED, AND SO HAVE THE PEOPLE WHO ARE HELPED FROM ITS OBVIOUS BENEFITS. THE WORD ALCOHOL IS GLORIFIED IN THE STATE OF KENTUCKY. WE CAN HEAR THAT MESSAGE FROM SENATOR STIVERS AND HIS DEFENSE AGAINST MARIJUANA AND GLORIFICATION ON BOURBON. I HAVE NO DEFENSE FOR THAT LINE OF THINKING, AND I ASK THAT YOU COUNCIL MEMBERS NOT MAKE DECISIONS FROM THAT SHORT-SIGHTED VIEW. ALCOHOL'S BEEN PROVEN TO CAUSE VERY VIOLENT BEHAVIOR, AS TO WHERE MARIJUANA ACTUALLY HAS THE OPPOSITE EFFECT. MY GOAL THIS EVENING ISN'T MARIJUANA VERSUS ALCOHOL. MY GOAL IS TO HELP YOU UNDERSTAND WHILE WORKING WITH ADVOCATES ON REFORM AND DECRIMINALIZING MARIJUANA POSSESSION CHARGES IN THE CITY OF LOUISVILLE WILL MAKE GREAT STRIDES IN BEING PREPARED, AS WELL AS SUCCESSFUL, AS MARIJUANA MOVES INTO THE COMMONWEALTH. IN BEING REAL, AND ALMOST QUOTING DAN, CURRENTLY 90% OF CONVENIENCE

STORES IN LOUISVILLE METRO LEGALLY DISTRIBUTE MARIJUANA

PARAPHERNALIA UNDER THE GUISE OF IT'S FOR THE USE OF TOBACCO

PRODUCTS ONLY. WE ARE ALREADY IN THE CANNABIS INDUSTRY. WHETHER

WE SPEAK EASY IN CERTAIN PUBLIC CIRCLES, OR YOU DEAL WITH THE

BLACK MARKET, MARIJUANA HAS BEEN AND WILL ALWAYS BE PRESENT.

JOHN PAUL II CATHOLIC CHURCH. I LIVE IN COUNCIL MEMBER COAN'S

DISTRICT 8 IN THE UPPER HIGHLAND NEIGHBORHOOD, AND THIS YEAR I

PROUDLY ACCEPTED THE POSITION OF CLOUT'S CO-PRESIDENT, SERVING

WITH REVEREND REGINALD BARNES AT CME CHURCH. AT OUR RALLY

TUESDAY EVENING, IN WHICH OVER 200 PEOPLE ATTENDED, WE HEARD

POWERFUL STORIES ABOUT HOW LIVES ARE BEING CHANGED BY THE

AFFORDABLE HOUSING TRUST FUND AND THE LIVING ROOM PROGRAM. A

WOMAN SHARED THE STORY OF HER FRIEND'S SON'S LIFE THAT WAS

LITERALLY SAVED BY THE LIVING ROOM MODEL RECENTLY. SHE'LL BE

COMING BEFORE METRO COUNCIL IN THE NEAR FUTURE TO TELL YOU HER

YOU OVER THE NEXT SEVERAL MONTHS, BUT AS POSSIBLE BUDGET CUTS

NOT JUST ON A PHYSICAL LANDSCAPE, BUT OUR SOCIAL, ECONOMIC, AND HUMAN LANDSCAPE, AS WELL. WE HAVE THE POWER, YOU, THIS METRO COUNCIL HAS THE POWER, TO MAKE THIS DIFFERENCE, NOT JUST ON A THEORETICAL NUMBER, BUT ON REAL HUMAN LIVES. MY PASSION AND COMMITMENT FOR SAFE AND AFFORDABLE HOUSING IS DEEPLY ROOTED IN MY OWN STORY. WHEN I WAS IN THE EIGHTH GRADE, WE LOST OUR HOME. 18 MONTHS LATER IN MY SOPHOMORE YEAR AT DE SALES HIGH SCHOOL, WE WERE EVICTED FROM THE HOUSE WE WERE RENTING. I SPENT THE NEXT YEAR LIVING WITH MY GRANDPARENTS IN GERMANTOWN. DURING THIS TIME, I HAD A SAFE PLACE TO CALL HOME, NOT WORRYING ABOUT PAYING THE RENT. BY THE END OF THAT SOPHOMORE YEAR, I WENT FROM BEING A C-AVERAGE STUDENT TO MAKING ALL AS. AND THE LOVE, SAFETY, AND MOMENTUM OF THAT YEAR OF MY LIFE LED TO MY WINNING A SCHOLARSHIP AT THE END OF MY JUNIOR YEAR FOR MY SENIOR YEAR AT DE SALES. I KNOW HOW SAFE, DECENT, AFFORDABLE HOUSING CAN TRANSFORM LIVES. IT DID MINE. AND IT CAN FOR THE 72,000 FAMILIES IN OUR CITY IN NEED OF AFFORDABLE HOUSING. WE ARE ASKING YOU TO CONTINUE TO SAVE LIVES AND TRANSFORM LIVES BY

PRESERVING FUNDING FOR THE AFFORDABLE HOUSING TRUST FUND AND THE LIVING ROOM. THANK YOU.

>> HELLO. THANK YOU FOR LETTING ME SPEAK. MY COUNCILMAN IS DAVID JAMES. I LIVE AT SAINT JAMES COURT. I AM AN EMT. I'M ALWAYS A CO-CHAIR OF LOUISVILLE METRO HUMAN TRAFFICKING TASK FORCE, AND I'M ALSO ON THE SURVIVORS COUNCIL, AND I'M REALLY CONCERNED ABOUT A LOT OF THE BUDGET CUTS, SPECIFICALLY TO THE OFFICE OF RESILIENCY THAT'S OVER AT EDISON, BECAUSE, BASICALLY, I FEEL LIKE THAT IT'S GOING TO -- OUR RUN VALUE IS GOING TO INCREASE, BECAUSE A LOT OF THESE PREVENTIVE SERVICES ARE REALLY, REALLY IMPORTANT TO MAINTAINING THE HEALTH OF THE COMMUNITY, AND SO WITH THE EDUCATION AND SO ON AND SO FORTH, WITH A LOT OF THE SUPPORT FROM THOSE OFFICES, IT'S -- IT'S VERY, VERY IMPORTANT. >> HELLO. COLLEAGUES, AND THE VIEWING PUBLIC, HOW MANY PEOPLE KNOW THAT WE HAVE A CRICKET, PROFESSIONAL CRICKET CLUB, IN THE CITY OF LOUISVILLE? HE DOES NOW, YES, WELL, I DID NOT KNOW THAT EITHER. COUNCILWOMAN SEXTON SMITH, AS WELL. I DID NOT KNOW UNTIL LAST YEAR, OR ACTUALLY TWO YEARS AGO, WHEN THE CITY OF LOUISVILLE APPROPRIATED \$100,000 TO BUILD A CRICKET FIELD AT HAYES KENNEDY PARK IN THE 16TH DISTRICT, AND AT THAT TIME, THE FIELD WAS DEDICATED TO A GENTLEMAN BY THE NAME OF SUNEIL M. GOVISCAR, WHO I'M TOLD, IS THE MOHAMMED ALI OF CRICKET. IS THAT CORRECT? HE IS. AND HE ACTUALLY CAME TO THE FIELD DEDICATION, AND THIS GENTLEMAN HOLDS RECORDS THAT PROBABLY WILL NEVER BE BROKEN. VERY NICE GENTLEMAN, AND I ALSO GOT TO MEET THESE TWO GENTLEMEN AT THE TIME, AND I'LL BE THE FIRST TO TELL YOU I DO NOT UNDERSTAND CRICKET THAT WELL, BUT THESE GUYS TRIED TO EXPLAIN IT TO ME AS BEST THEY COULD, SO FOR THOSE WHO DON'T KNOW, CRICKET IS A BAT AND BALL GAME PLAYED BETWEEN TWO TEAMS OF 11 PLAYERS ON A FIELD AT THE CENTER OF A 20-METER PITCH WITH A WICKET AT EACH END. NOW, IN BASEBALL WE CALL IT A PITCHER, THEY CALL IT A BOWLER, CORRECT? BOWLER, OKAY. GROUP OF LOCAL CRICKET PLAYING INDIVIDUALS WANTED TO PLAY AND SUPPORT THE GAME, MEMBERS ARE FROM A NUMBER OF COUNTRIES, PAKISTAN, GREAT BRITAIN, AND PROBABLY SOME OTHERS. WE TALKED ABOUT HAYES KENNEDY PARK AND THE FACT THIS BEAUTIFUL CRICKET FIELD, AND MY UNDERSTANDING IS THIS IS ONE OF THE BEST CRICKET FIELDS IN THE COUNTRY. IS THAT RIGHT?

OKAY. LCC FIELDS MULTIPLE TEAMS, PLAY ON A HOME AND AWAY BASIS FROM HERE TO CLEVELAND, AND THE DAY THAT I WAS THERE, IT WAS A TOURNAMENT, AND THEY HAD SEVERAL TEAMS. MANY OF THE LCC MEMBERS ARE ACTIVE IN THE COMMUNITY AND ROUTINELY VOLUNTEER AND DONATE THEIR TIME FOR LOCAL CAUSES, AND WE HAVE KEYSHORE MARINGANTI AND MICHAELE DEO FROM THE TEAM. WE HEREBY CONFER THIS HONOR WITH ALL THE RIGHTS, PRIVILEGES AND OPPORTUNITIES WHEREAS WE CAUSED THESE LETTERS TO BE MADE AND THE SEAL OF THE METRO GOVERNMENT TO BE HEREUNTO AFFIXED ON THIS DAY, MARCH 7TH, 2019, PRESENTED BY ME, COUNCIL MEMBER REED. YES, AND YOU'D LIKE TO MAKE A COUPLE OF COMMENTS.

>> IT IS A GREAT HONOR TO BE STANDING HERE, AND I ACCEPT
THIS PROCLAMATION ON BEHALF OF LOUISVILLE CRICKET CLUB. WE
SINCERELY WOULD LIKE TO THANK MR. COUNCILMAN SCOTT REED, MAYOR

GREG FISCHER, METROPOLITAN OFFICIALS, MR. SAVI GHOST, MRS. DANA KASLER, JASON DEREFROE, MR. MIKE GINTHER. LOUISVILLE, HOME TO ALL MEMBERS OF LOUISVILLE CRICKET CLUB, LIKE MANY OTHERS BEFORE US, OUR MEMBERS HAVE FALLEN IN LOVE WITH THE COMFORTABLE, ATTRACTIVE POWERS OF OUR CITY. OUR MEMBERS COME FROM DIFFERENT PARTS OF THE WORLD AND WORKING IN VARIOUS DIFFERENT FIELDS TOWARDS THE COMMON GOAL OF MAKING LOUISVILLE A BETTER CITY EVERY DAY. SHOULD I SHARE EXAMPLES OF CITIES WHO HAVE SUCCESSFULLY GONE RENEWABLE IN SHORT TIME? ALL THESE THINGS ARE IMPORTANT, AND ALL THIS INFORMATION AND MORE IS AVAILABLE TO YOU, BUT TONIGHT, I WANT TO LIFT UP TWO THOUGHTS. FIRST, THE ESSENTIAL THING NOW IS TO COMMIT TO RENEWABLE ENERGY. WE DO NOT HAVE TO KNOW IN ADVANCE ALL THE DETAILS OF HOW TO ACCOMPLISH THE SHIFT AND EXACTLY HOW TO PAY. SUFFICE IT TO SAY, THAT RENEWABLES ARE DOABLE. IF WE HAVE THE WILL, WE WILL FIND THE WAYS. AS MARTIN LUTHER KING SAID, YOU DO NOT HAVE TO SEE THE ENTIRE STAIRCASE BEFORE YOU TAKE THE FIRST STEP. THE FIRST STEP, THE ONE WE NEED TO TAKE HERE IN LOUISVILLE, IS TO COMMIT TO RENEWABLES. COMMIT TODAY, WITHOUT DELAY. THE REST WILL FOLLOW. THE SECOND THING, TONIGHT, I WANT TO CHALLENGE EACH ONE OF YOU TO ASK YOURSELF A QUESTION. DO YOU LOVE YOUR CHILDREN, YOUR CHILDREN'S CHILDREN,

I WILL SAY I THINK OUR SYSTEM HERE AND OUR LAND USE SYSTEM WORKS THE BEST WHEN WE DEPOLITICIZE LAND USE AS MUCH AS POSSIBLE. THERE ARE PROBABLY NO MORE POLITICAL ISSUES THAN WE DEAL WITH HERE IN THIS METRO COUNCIL AND LOUISVILLE METRO GOVERNMENT, WHETHER IT'S ZONING CHANGES, OR LANDMARKS, OR ANY OTHER THING THAT EXISTS THAN LAND USE DECISIONS, AND CURRENTLY YOU HAVE THE ABILITY TO APPEAR IN PLANNING AND ZONING COMMITTEE IF YOU'RE NOT A MEMBER, AND YOU CAN VOTE, ALTHOUGH YOU CAN'T DO ANYTHING ELSE, AND THE RULES ARE PROPOSING YOU ESSENTIALLY BECOME A DE FACTO MEMBER OF THE COMMITTEE ON YOUR ITEM. SOMETIMES YOU SAY I'M NOT IN THIS COMMITTEE BUT I ASK MY COLLEAGUES TO MAKE A MOTION AND SUCH AND SUCH, AND THAT HAPPENS AND WE DO THAT, BUT WITH RESPECT TO THE ZONING COMMITTEE, I

WOULD BE MORE IN FAVOR OF TAKING AWAY THE RIGHT TO VOTE ON IT ALTOGETHER AND MAKE IT GO THROUGH THE REGULAR PROCESS AND IT GO TO THE FULL COUNCIL IF YOU'RE NOT ON THE COMMITTEE THAN I AM TOWARDS GIVING SORT OF MORE SPECIAL POWERS TO SOMEBODY TO INTERJECT IN THE VERY DELIBERATE LAND USE PROCESS BEFORE THE REGULAR TIME. SO I JUST GENERALLY THINK IT'S BETTER TO DEPOLITICIZE IT AT EVERY OPPORTUNITY, AND SO I'M AGAINST THE CHANGE. THANKS.

- >> THANK YOU, MR. PRESIDENT. DON'T REALLY WANT TO GO

 AGAINST COAN. BRANDON TOO MUCH. I'VE NEVER BEEN ON THE

 DEVELOPMENT -- LAND DEVELOPMENT COMMITTEE, BUT MINE BEING THE

 LARGEST DISTRICT, AND SOMETIMES WHEN YOU CAN BE AT THE COMMITTEE

 WHEN THEY FIRST BRING THE ISSUE TO THE COMMITTEE, IT'S A NICE

 TIME TO MAKE A STATEMENT OF WHAT -- AN AMENDMENT OR SOMETHING

 YOU NEED TO DO INSTEAD OF DOING IT ON THE FLOOR OF THE COUNCIL,

 BECAUSE IF YOU WANTED TO OVERTURN IT, YOU NEED TO STATE SOME

- >> JUST FOR THE RECORD, AS LONG AS I'VE BEEN CHAIR OF
 PLANNING AND ZONING, WHEN ANY OF MY COLLEAGUES WANTS A MOTION
 MADE FOR SOMETHING THEY WANT TO CHANGE, I'VE ALWAYS DONE THAT
 FOR THEM IF THEY SEND IT TO ME AHEAD OF TIME AND READ IT INTO

REPRESENTATION, WHICH IS THE INTENTION OF THE STATUTE, OF IT,

AND WE HAVE TWO OPPORTUNITIES. IF ANN RAMSER IS YOUR PERSON,

WILLIAM TEMPLE IS COMING UP RIGHT AFTER THIS FOR A VOTE. AND I

WOULD ASK THE SUPPORT TO GO BACK TO THE MAYOR AND SAY HE NEEDS

TO SEARCH FOR AND APPOINT SOMEBODY THAT ALSO REPRESENTS THE

OTHER POLITICAL PARTY. THANK YOU.

- >> PRESIDENT JAMES: THANK YOU. COUNCILWOMAN PURVIS.
- >> THANK YOU, MR. PRESIDENT. I JUST WANT TO GO ON RECORD AS SAYING I RESPECT COUNCILMAN PIAGENTINI'S VIEWS ON IT BEING A MORE DIVERSE BOARD. AND I HAVE TO AGREE. I'M NOT HAPPY WITH THE FACT THAT I REALLY DON'T SEE A FAIR REPRESENTATION FROM OTHER DISTRICTS LIKE 3 AND 5 AND 4 AND 6. SO I THINK OVERALL, THE BOARDS NEED TO BE A LITTLE MORE DIVERSE IN PARTY AFFILIATIONS, AS WELL AS DISTRICTS. THANK YOU.

- >> PRESIDENT JAMES: THANK YOU. MOTION TO TABLE. ALL THOSE IN FAVOR OF TABLING, SAY, AYE. ALL OPPOSED?

 EVERY COMMITTEE MEETING, BUT I USED TO DO A TALLY OF HOW MANY

 MALES WERE CHOSEN AND HOW MANY FEMALES, REPUBLICANS AND

 DEMOCRATS, AND HOW MANY INDEPENDENTS AND SO FORTH. IT'S

 INTERESTING TO SEE HOW IT FALLS OUT. ESPECIALLY WHEN YOU ARE

 THINK SOMETIMES SOMEBODY IN THE MAYOR'S OFFICE GOES UP TO THE
 PERSON AND SAYS WOULD YOU LIKE TO SERVE ON THIS COMMITTEE. I
 HAVE BEEN ON THE COUNCIL FOR 16 YEARS. I'M PREJUDICE A LITTLE

- >> THANK YOU, MR. PRESIDENT. THIS IS A FLAWED PROCESS. I'VE CHAIRED AND VICE CHAIRED THIS COMMITTEE. I SPENT YEARS BATING MY HEAD UP AGAINST THE WALL, FIRST WITH COUNCILMAN DOWNARD AND THEN WITH COUNCILWOMAN DENTON TRYING TO FIX THIS PROBLEM. YES, WE NEED MORE DIVERSE CANDIDATES, BUT PART OF IT THERE HAS TO BE A PROCESS FOR PEOPLE WHO DOESN'T HAVE COMPUTER ACCESS, WHERE WE MAKE A CONCERTED EFFORT. THE IDEA OF HOPING AND EXPECTING PEOPLE TO APPLY, THE REALITY IS THAT MANY PEOPLE ARE TAPPED AND HANDPICKED AND TOLD TO SUBMIT THEIR APPLICATION AND ARE SELECTED THAT WAY. >> THANK YOU, MR. PRESIDENT. COLLEAGUES, THIS IS AN INCIDENCE OF KNOWING THE RULES AND READING THE STATUTES. I
BELIEVE FROM MY READ OF THE RULES AND STATUTES, I THINK THE RULE IS OUR COUNCIL RULE 4A IN THERE AND THE STATUTE THE 67C, I WOULD TO HAVE MR. NOBLE FOR THE EXACT RESULT. THE MAYOR APPOINTS WITHIN 90 DAYS. IF HE DOESN'T HAVE A SUCCESSFUL APPOINTMENT AFTER 90 DAYS THE BURDEN FALLS TO THE COUNCIL. AT THE END IF WE'RE NOT PLEASED WITH WHO IS APPOINTED, WE DON'T APPROVE. AND AFTER A PERIOD OF TIME, WE HAVE THE ABILITY TO NOMINATE ANYBODY WITHOUT THE PAPERWORK PROCESS AND THE OTHER THINGS GOING ON HERE. YOU HAVE TO GET TOGETHER THE INFORMATION FOR YOUR COLLEAGUES. AND SO THIS IS NOT AN INSURMOUNTABLE SITUATION WHERE WE CAN PUT PEOPLE ON THESE BOARD. SARAH, IF I'M WRONG, PLEASE SPEAK UP.

>> SARAH MARTIN WITH THE COUNTY ATTORNEY'S OFFICE. THE
APPOINTMENT DOES SHIFT AFTER 90 DAYS. HOWEVER, IF THE MAYOR
MAKES AN APPOINTMENT, THEN THE MAYOR HAS SATISFIED HIS DUTY TO
MAKE AN APPOINTMENT AND IT COMES TO COUNCIL FOR APPROVAL OF THAT
APPOINTMENT.

>> BUT IF WE DON'T APPROVE IT, DOES HIS APPOINTMENT RESTART

A 90-DAY CLOCK? OR DOES IT PUT US IN A POSITION WHERE IF THERE

IS NO SUCCESSFUL APPOINTMENT IN 90 DAYS THAT WE COULD THEN

NOMINATE OUR OWN INDIVIDUALS?

>> NO, THE MAYOR HAS AN OBLIGATION TO MAKE THE APPOINTMENT.

ONCE HE'S MADE THE APPOINTMENT, THEN HE SATISFIED HIS

OBLIGATION. IN FACT, THAT APPOINTEE, THE COUNCIL HAS A DIFFERENT

RESPONSIBILITY IN THOSE BOARD AND COMMISSIONS IN WHICH THE

COUNCIL APPROVES. AND THAT IS TO APPROVE THE APPOINTEE OR REJECT

THE APPOINTMENT. IT GOES BACK TO THE MAYOR IF YOU REJECT AND HE

HAS AN OPPORTUNITY TO APPOINT SOMEBODY ELSE. THAT 90 DAYS IS

- >> I WANT TO MAKE A COMMENT THAT I HAVE KNOWN PEOPLE THAT SERVED ON BOARDS IN THE PAST. AND IT'S ALWAYS BEEN MY KNOWLEDGE

IS IT'S NOT WHAT YOU KNOW BUT WHO YOU KNOW. AND SO IT'S REALLY

BEEN OVER LOOKED BY NOT BEING DIVERSE AND INVITING PEOPLE FROM
ALL PARTIES, MEN, WOMEN AND ALL DISTRICTS AND I'M DONE WITH
THIS. THANK YOU.

>> PRESIDENT JAMES: ALL RIGHT. THANK YOU, COUNCILWOMAN.
COUNCILWOMAN SHANKLIN.

>> THANK YOU, MR. PRESIDENT. AT ONE TIME WHEN I WORKED WITH JUDGE JACKSON, I DID ALTHEA JACKSON'S JOB. I HAD TO GO TO DIFFERENT AREAS AND FIND PEOPLE TO BE ON BOARDS. THE WAY IT WAS LAID OUT THEN, IT WOULD HAVE TO BE SO MANY REPUBLICANS AND SO MANY DEMOCRATS. WHEN YOU GOT THAT BOARD, YOU WOULD SEE THEY NEEDED FIVE REPUBLICANS, SO MANY DEMOCRATS. LISTENING OR WATCHING ON TV OR ANYONE IN THE CHAMBERS LISTENING,
THERE IS A VERY GOOD BOARDS AND COMMISSIONS PAGE ON THE METRO
WEBSITE. ANY CITIZEN IN THIS COMMUNITY CAN APPLY TO BE ON ANY
BOARD OR COMMISSION AT ANY TIME. THERE IS NO BARRIER TO ENTRY

THERE. AND I DON'T THINK THAT THE -- YOU HAVE TO BE SUPER POLITICALLY CONNECTED TO GET APPOINTED TO A LOT OF THE BOARDS THAT DON'T HAVE A LOT OF LIME LIGHT AND REWARD TO THEM.  YOU KNOW, I'M NOT SURE HOW WE'RE GOING TO FIX IT UNLESS WE DRAG

 PEOPLE IN HERE. I THINK WE'VE ALL TRIED. BEING THE LAST ONE IN

>> PRESIDENT JAMES: THANK YOU. MAY I HAVE A MOTION AND A SECOND?

- >> SO MOVED.
- >> SECOND.
- >> PRESIDENT JAMES: THE MOTION IS BEFORE US. IS THERE ANY DISCUSSION? COUNCILWOMAN FLOOD.
- >> THANK YOU, MR. PRESIDENT. THIS IS A CHANGE IN ZONING FOR ONE OF THE PURE REASONS BECAUSE THEY ENJOY EXISTING NONCONFORMING RIGHTS. SO THEY ARE CHANGING THE ZONING TO ACCOMMODATE THAT. THEY HAVE A FOUR-BAY AUTOSERVICE STATION NOW.

 IT'S AN EXPANSION OF AUTO SALES ON THE PROPERTY BUT THERE IS

REALLY NO BIG ADDITION OR EXPANSION OF THE EXISTING BUILDING.

THIS IS IN COUNCIL DISTRICT 10. BUT I WANTED TO MAKE IT CLEAR.

BECAUSE THEY ARE SAYING HE WAS IN AN AREA -- IN IMPROPER ZONING.

BECAUSE HE HAD NONCONFORMING RIGHTS. WHICH MEANS WE PROBABLY

- >> YES. THIS WENT BEFORE THE PLANNING COMMISSION. IT WAS UNANIMOUSLY VOTED TO CHANGE THE ZONING. THE COMMITTEE ALSO FELT THAT WAY. THIS ISN'T A COMMERCIAL AREA. SO SAYING THAT AND HAVING HEARD NO OPPOSITION, I WOULD MOVE APPROVAL. THANK YOU, MR. PRESIDENT.
- >> PRESIDENT JAMES: THANK YOU. ANY FURTHER DISCUSSION?
 COUNCILMAN SHANKLIN.
- >> YES. IN THE COMMITTEE, I DID SAY THAT WAS WHERE THE OLD CAR WASH WAS. BUT I DID DRIVE PAST THERE JUST THE OTHER DAY TO MAKE SURE. BUT THE CAR WASH WAS ABOUT TWO OR THREE BUILDING DOWN. I WANTED TO GET IT IN THE RECORD I DID SAY IT WAS THE OLD CAR WASH BUT THE CAR WASH IS A LITTLE FURTHER DOWN. THANK YOU.

- >> PRESIDENT JAMES: THANK YOU. IS THERE ANY FURTHER
 DISCUSSION? HEARING NONE, THIS IS AN ORDINANCE REQUIRING A ROLL
 CALL VOTE. WILL THE CLERK PLEASE OPEN THE VOTING? WITHOUT
 OBJECTION, THE VOTING IS CLOSING. AND THE VOTING IS CLOSED.
 - >> MR. CLERK: 26 YES VOTES.
- >> PRESIDENT JAMES: THANK YOU. THE ORDINANCE PASSES. MR. CLERK, THE READING OF ITEM 45.
- >> MR. CLERK: AN ORDINANCE AMENDING CHAPTER 42 OF THE LOUISVILLE METRO CODE OF ORDINANCES "LMCO" BY CREATING A NEW SECTION REGARDING MAJOR CHANGES TO ANY METRO-OWNED PARK AND REMOVING REGULATION OF METRO-OWNED PARKS FROM THE SUBSECTION ON GOLF COURSES, AS AMENDED. ITEM READ IN FULL.
- >> PRESIDENT JAMES: THANK YOU. MAY I HAVE A MOTION AND A SECOND?
 - >> MOTION.
 - >> SECOND.
- >> PRESIDENT JAMES: THE ORDINANCE IS BEFORE US. IS THERE ANY DISCUSSION? COUNCILWOMAN FOWLER.
- >> THANK YOU, MR. PRESIDENT. THIS IS AN AMENDED ORDINANCE
 REALLY THAT CREATES A SEPARATE SECTION TO TAKE THIS OUT OF THE
 GOLF SECTION AND PUT IT INTO PARK SESSION. IT WAS PASSED
 UNANIMOUSLY JANUARY 7 BUT THERE WAS CONCERNS WITHIN PARKS ABOUT
 THE LANGUAGE THAT WE HAD TO DO WITH LEASES. WE DIDN'T WANT TO
 MICROMANAGE PARKS AND MAKE SURE WE WEREN'T GOING TO HAVE THIS

COME BEFORE US IF THEY ARE GOING TO LEASE A PAVILION OR BALL FIELD. LIKE I SAID, IT'S IN A COMPLETELY SEPARATE SECTION AND CLEANED UP LANGUAGE AND DEFINITIONS, YOU KNOW. IT WAS ORIGINALLY COUNCIL MEMBER PEDEN'S ORDINANCE. SO I WANTED TO GIVE HIM AN OPPORTUNITY TO SPEAK, IF HE SO CHOOSES.

- >> WHY THANK YOU, MR. PRESIDENT. [CHUCKLING]
- >> PRESIDENT JAMES: YOU'RE WELCOME.

>> AGAIN, IT WAS THE COMMITTEE WORK, NOT JUST MYSELF OR COUNCILWOMAN FOWLER TO ADD AMENDMENTS PARKS WANTED AND AT THE SAME TIME GIVING US ON THE COUNCIL A LITTLE BIT OF SAY. WHEN THE AMENDMENTS FIRST CAME DOWN THE ONLY THING THAT WE WERE GOING TO HAVE SAY ON WERE PERMANENT CLOSURES, TO WHICH I SAID, IF THEY CAME TO YOUR PARK AND SAID THEY ARE GOING TO CLOSE IT FOR 20 YEARS, WOULD YOU NOT SAY ON THAT. IT KIND OF GOT EVERY BODY'S EYES OPEN TO HOW LONG PERMANENT IS. SO THANKS TO COUNCIL MEMBER MULVIHILL AND MS. MARTIN FROM THE COUNTY ATTORNEY'S OFFICE FOR REDEFINING THE WORD PERMANENT TO ONE YEAR OR LONGER. AGAIN, I JOKE THAT ONLY IN GOVERNMENT ARE BINDING ELEMENTS NOT BINDING AND PERMANENT IS ONLY A YEAR LONG. THE OTHER THING, REPURPOSING. AGAIN, I THINK IT MEETS THE INTENT THAT I WANT FROM THE PERSPECTIVE OF IF THEY WANT TO CHANGE THE TENNIS COURT TO A PICKLEBALL COURT YOU MIGHT GET A PHONE CALL. IF THEY WANT TO TURN YOUR ENTIRE PARK INTO IS A GOLF COURSE OR YOUR GOLF COURSE INTO A PARK, WE GET TO VOTE ON THAT. THAT SEEMS TO HAVE KIND OF

THE BREAK-EVEN POINT. EVEN, COUNCILMAN MULVIHILL ADDED SOME THINGS AND I THINK THE ENTIRE COMPLETE WAS IN AGREEMENT. I'M HAPPY WITH WHERE IT IS RIGHT NOW.

>> PRESIDENT JAMES: THANK YOU, COUNCILMAN. COUNCILMAN COAN.

>> THANK YOU, MR. PRESIDENT. I HAVE A COUPLE OF QUESTIONS AND I WANT TO OFFER A COUPLE STYLISTIC FRIENDLY AMENDMENTS AS I WAS READING THIS CLOSELY. I WAS ON THE COMMITTEE WHEN IT CAME THROUGH THE FIRST TIME AND I'VE BEEN INTERESTED IN IT. AND OBVIOUSLY NOW, WE'RE TALKING ABOUT, LOOKING AT THE POTENTIAL REDUCTIONS OR BUDGET CUTS. THERE IS GOLF COURSES LISTED ON THE MAYOR'S SPREADSHEET. SO IT'S A REALISTIC POSSIBILITY THAT AT SOME POINT A GOLF COURSE WILL BE PROPOSED TO BE CHANGED IN SOME WAY. I'M NOT SAYING IT'S GOING TO HAPPEN BUT OBVIOUSLY THE ORDINANCE IN FRONT OF US IS RELEVANT. WITH REGARD TO STYLISTIC POINTS. AN PAGE 4, SECTION 42.44A. THERE IS A SENTENCE THAT NOW READ, NOTICE OF THE PUBLIC MEETINGS MUST COMPLY WITH SATISFIED REOUIREMENTS. IT'S CLEARLY JUST A DRAFTING ERROR. I THINK YOU WANT TO STRIKE, COMPLY WITH. THOSE TWO WORDS. AND ALSO, ON PAGE 5, IN 42.44, SUBSECTION C SUB 1. THE PUBLIC INTEREST REASON METRO PARKS REQUESTS A PERMANENTLY CLOSURE. THE WORD SHOULD BE PERMANENT, NOT PERMANENTLY. I DID HAVE A QUESTION ABOUT IN SUBSECTION D ON THE SAME END OF PAGE 5, WHERE IT SAYS, METRO COUNCIL APPROVAL REQUIRES A MAJORITY VOTE. AND HOW IS THAT -- I THOUGHT EVERYTHING WE DO REQUIRES A MAJORITY VOTE. I WASN'T SURE WHAT I'M MISSING ABOUT SUBSECTION D, IF THAT'S REDUNDANT AND COULD BE STRUCK. OR MEANT TO SAY SOMETHING ELSE. YOU WANT ME TO PAUSE?

- >> PRESIDENT JAMES: MS. MARTIN.
- >> SURE, I CAN ANSWER THAT. THE ORIGINAL LANGUAGE WAS 2/3
 VOTE. SO SOME OF THE LANGUAGE WAS STRUCK TO CHANGE THAT TO A
 MAJORITY. IT'S PROBABLY JUST A HOLD-OVER FROM THAT.

>> OKAY. YOU COULD STRIKE IT BECAUSE THOSE ARE THE RULES FOR HOW IT WORKS IN HERE ANYWAY. OR I GUESS IT MATTER. I WANTED TO MAKE SURE THE INTENT WAS CLEAR. AND I DO HAVE A QUESTION ABOUT THE GOLF COURSE SECTION ON SECTION 42.44 ON SECTION 4. IT LOOKS TO ME LIKE THIS A DISTINCTION BETWEEN PERMANENTLY CLOSING AND SOMETHING WHICH ACCORDING TO THE DEFINITION MEANS YOU ARE PERMANENTLY RESTRICTING PUBLIC ACCESS VERSUS REPURPOSING. WHICH MEANS A MAJOR RENOVATION THAT SIGNIFICANTLY ALTERS THE CHARACTER OF THE PARK, SO ON AND SO FORTH. IT LOOKS TO ME LIKE IN SECTION A, IF YOU WANT TO PERMANENTLY CLOSE A GOLF COURSE IT REQUIRES TWO PUBLIC HEARINGS. IN SECTION B, IF YOU WANT TO JUST LEASE OR SELL IT OR DISPOSE OF IT OR REPURPOSE IT, THERE IS NO PUBLIC HEARING REQUIREMENT. IT REQUIRES METRO PARKS REQUEST APPROVAL FOR THAT. I WANTED TO MAKE SURE THAT WAS THE INTENT. THERE IS PROCESS TO PERMANENTLY RESTRICT PUBLIC ACCESS BUT FOR EXAMPLE IF YOU WANT TO REPURPOSE A GOLF COURSE AND TURN IT IN TO OPEN SPACE THAT IS STILL AVAILABLE TO THE PUBLIC, THEY COULD DO THAT. THEY

JUST HAVE TO ASK. BECAUSE THAT'S HOW I READ THOSE TWO SECTIONS TOGETHER.

- >> MAY I COMMENT?
- >> PLEASE.
- >> ACTUALLY, WHEN YOU SAY THEY HAVE TO ASK, I DON'T -THERE IS NOTIFY US. LIKE, HEY, KIND OF LIKE SNOW ROUTES. HEY,
 WE'RE PLOWING THESE STREETS. YES, WE TECHNICALLY HAD A MEETING
 BUT WE'RE NOT GOING TO TAKE ANY OF YOUR INPUT. OR THERE IS, DO
 WE GET TO VOTE ON THAT? MY QUESTION TO SARAH MARTIN WOULD BE, IF
 THEY ARE GOING TO REPURPOSE A PARK, AND YES, THERE IS THE THINGS
 THAT COUNCILMAN COAN MENTIONED, WHEN THEY HAVE TO ASK, DOES THAT
 MEAN THEY HAVE TO WAIT FOR AN AFFIRMATIVE VOTE FROM US?

 - >> YES, SIR.
- >> AGAIN, WHEN YOU SAID -- DOES IT STILL SAY TWO PUBLIC MEETINGS?
 - >> I'M LOOKING AT THE GOLF COURSE SECTION.
 - >> SORRY, I'M IN THE PARKS SECTION.
- >> LOOKING SPECIFICALLY AT A SCENARIO WHERE A GOLF COURSE

 THAT IS PART OF A PARK, NOT ALL GOLF COURSES ARE PARTS OF PARKS

 AND NOT ALL PARKS HAVE GOLF COURSES, BUT WE HAVE SOME THAT ARE

 BOTH. SO MY BOTH IS A SCENARIO WHERE A GOLF COURSE THAT IS PART

 OF A PARK, LET'S SAY THEY WANT TO FORGET THE GOLF COURSE AND

MAKE IT PART OF THE PARK. AND TO ME, I WOULD READ THAT AS BEING
A REPURPOSING AS OPPOSED TO A PERMANENT CLOSURE. BECAUSE A

- >> PRESIDENT JAMES: YES, SIR.
- >> MY COMMENT WOULD BE NUMBER ONE, COUNCILMAN FOWLER KIND
 OF CRAFTED THE GOLF SECTION. MY PROFESSIONAL OPINION, WHICH
 MATTERS NOT AT ALL IS, THE GOLF COURSE IS AN ACTUAL BUSINESS.
 YOU ARE CLOSING THAT BUSINESS. YES, YOU ARE REPURPOSING THE
 GROUND, BUT YOU ARE CLOSING THE GOLF COURSE AS A BUSINESS. MUCH
 LIKE YOU ARE -- THE PLANNING AND ZONING CASE WE HAD A MOMENT
 AGO. THE GROUND IS STILL THERE BUT WE ARE CHANGING THE USE OF

 - >> AH, DEFINITELY A QUESTION FOR FOWLER OR MS. MARTIN.
 - >> DOESN'T MATTER TO ME.

- >> PRESIDENT JAMES: COUNCILWOMAN FOWLER?
- >> SARAH MARTIN? I DON'T KNOW. I THOUGHT WE HAD COVERED THAT.
- >> THERE REASON THERE ARE TWO SECTIONS, A, IS TO ADDRESS A PERMANENT CLOSURE. ARE THERE TWO HEARINGS. IT'S A THOROUGH PROCESS. AND MY UNDERSTANDING FROM WHEN WE DRAFTED THIS AND IT WENT THROUGH COMMITTEE BACK IN 2018, IS THAT COUNCILWOMAN FOWLER AND COUNCILWOMAN BUTLER WANTED A DIFFERENT PROCESS FOR THE LEASE. AND OF COURSE, SALE OF DISPOSAL GOES THROUGH SURPLUS AND COMES BEFORE COUNCIL ANYWAY. BUT THAT THOSE ARE DIFFERENT PROCESSES AND PARTICIPATION ON BEHALF OF METRO COUNCIL. - >> PRESIDENT JAMES: ALL RIGHT. COUNCILMAN COAN, DOES THAT ANSWER YOUR QUESTION?
 - >> SARAH DIDN'T TALK ABOUT REPURPOSING.
 - >> OH, I'M SORRY.
- >> I'M FINE WITH -- I READ IT SO THAT B., REPURPOSING DOES NOT REQUIRE TWO PUBLIC HEARINGS.
 - >> CORRECT.
- >> THAT'S FINE BY ME. I'M ASKING COUNCILWOMAN FOWLER, WHO WAS INTERESTED IN THE GOLF COURSES AND COUNCILMAN PETE WHETHER THEY ARE OKAY WITH THAT BASICALLY.

>> MY MAIN CONCERN WAS THAT WE WERE AWARE WHEN SOMETHING HAPPENS AND I'M NOT SURE -- I MEAN WE COULD ADD THAT. IF YOU THINK THAT IS SOMETHING THAT IS GOING TO MAKE EVERYBODY HAPPY.

I'M OKAY WITH IT COMING BEFORE US AND WE CHOOSE AT A BODY WHAT TO DO.

- >> AFTER ALL THAT, THE ONLY CHANGES I'M PROPOSING IS A FRIENDLY AMENDMENT, THE STYLISTIC ONES THAT I THINK MAYBE THEY NOTED. SO I WOULD OFFER THAT FRIENDLY AMENDMENT TO MAKE THE DRAFTING CHANGES.
 - >> SO MOVED.
 - >> PRESIDENT JAMES: DO WE HAVE A SECOND?
 - >> SECOND.
- >> PRESIDENT JAMES: THANK YOU. ALL IN FAVOR, SAY, "AYE."
 ALL OPPOSED? THANK YOU. WE'RE BACK TO DISCUSSION UNDER THE
 ORDINANCE. COUNCILMAN PEDEN. NO? COUNCILMAN ACKERSON.

WITH A POOL OR PARKS FACILITY, IS IT GOING TO REQUIRE PUBLIC

HEARINGS?

>> THE QUESTION YOU ASKED PRESENTS DIFFERENT SCENARIOS. AND THERE ARE THREE DIFFERENT PROCESSES FOR PARKS IN THE ORDINANCE.
YOU WILL SEE IN SECTION A, TO PERMANENTLY CLOSE DOES REQUIRE
PUBLIC MEETINGS. TO REPURPOSE OR HAVE A LONG-TIME CLOSURE IS A
DIFFERENT PROCESS. AND TO LEASE ANY METRO PARK IS A SEPARATE
PROCESS. IT DEPENDS. WHEN COUNCILMAN FOWLER PUT THIS TOGETHER,
IT WAS ANALYZED, THE SEVERITY -- THE LEVEL OF COUNCIL
INVOLVEMENT FOR EACH OF THOSE. FOR EXAMPLE, WHEN YOU ASKED ABOUT
A POOL, THAT WOULD FALL UNDER -- AND THE DEFINITION IS ALSO
THERE ON PAGE 2 OF EACH OF THOSE: LEASE, LONG-TERM CLOSURE,
PERMANENT CLOSURE OR REPURPOSE. EACH OF THE EXAMPLES FALLS UNDER
A DIFFERENT CATEGORY. THAT DETERMINES THE LEVEL OF INVOLVEMENT
FOR METRO COUNCIL. TO PERMANENTLY CLOSE AN ENTIRE PARK WOULD
REQUIRE PUBLIC HEARINGS AND COUNCIL APPROVAL.

- >> LET'S SAY CHEROKEE PARK, CHEROKEE GOLF COURSE.
- >> SO THE GOLF COURSE WOULD FALL UNDER SECTION 42.44. AND SO TO PERMANENTLY CLOSE WOULD REQUIRE TWO PUBLIC HEARINGS AND A VOTE BY METRO COUNCIL.
- >> GOTCHA. AND IF THE GOLF COURSE WERE OUTSOURCED? SO IT'S LEASED.

- >> IT WOULD COME BEFORE COUNCIL FOR A VOTE IF IT'S LEASED.

 THERE WOULDN'T BE THE TWO PUBLIC HEARING REQUIREMENTS.
 - >> THANK YOU.
 - >> PRESIDENT JAMES: THANK YOU. COUNCILMAN REED.
- >> THANK YOU, MR. PRESIDENT. ANOTHER QUESTION REGARDING
 REPURPOSING. JUST SO I'M CLEAR. IF METO PARKS DECIDES TO
 REPURPOSE, DOES THIS BODY HAVE THE OPPORTUNITY TO VOTE YES OR
 NO?
 - >> DEPENDS ON THE DEGREE OF REPURPOSE.
 - >> [OFF MIC]
 - >> ARE YOU TALKING ABOUT A PARK OR GOLF COURSE?
 - >> EITHER.
 - >> DEPENDS ON THE DEGREE.
 - >> SHORT ANSWER IS YES.
 - >> WITH NO PUBLIC HEARING?
 - >> CORRECT.
 - >> THANK YOU.
 - >> PRESIDENT JAMES: COUNCILMAN COAN.
- >> I DID WANT TO POINT OUT. GOLF COURSES ARE DIFFERENT THAN OTHER FACILITIES IN THIS PLAN. AND I'M RESPONDING TO COUNCILMAN ACKERSON'S QUESTION. IF YOU LOOK AT THE SECTION ABOUT PARKS ON PAGE 3, PRIOR TO ANY REPURPOSE OR LONG-TERM CLOSURE OF A METRO OWNED PARK, METRO PARKS MUST FILE WITH METRO COUNCIL A MASTER PLAN DETAILING THE MAJOR RENOVATIONS AND THE REASONS FOR IT.

MASTER PLANS TAKE A REALLY LONG TIME AND IN FACT COST MONEY TO DO THEMSELVES. IF THE CITY WAS GOING TO PROPOSE TO CLOSE A SWIMMING POOL, AND I'M NOT ADVOCATING FOR THAT, THIS LAW SAYS THEY WOULD HAVE TO COMPLETE A MASTER PLAN BEFORE THEY COULD DO THAT. WHICH I DON'T THINK CAN REALISTICALLY BE DONE IN THE TIME OF A BUDGET CYCLE. THAT'S A CONCERN FOR ME. BY SAYING THEY HAVE TO DO A MASTER PLAN, THAT'S WHAT WE REALLY MEAN IN THAT SECTION.

- >> I MEAN, I JUST RAISE THAT. IF IT'S NOT A CONCERN FOR ANYBODY ELSE, FINE BY ME.
 - >> PRESIDENT JAMES: OKAY. COUNCILMAN ACKERSON.
- >> THANK YOU. COUNCILMAN COAN, I WOULD AGREE THAT IS A CONCERN FOR ME. BECAUSE AT THE END OF THE DAY, WITH ANY BUDGET CRISIS EVERYTHING IS ON THE TABLE AS FAR AS CONSIDERATIONS, PROFITABILITY AND SERVICES PROVIDE. AND MY CONCERN WOULD ULTIMATELY BE, ARE WE TIEING OUR HANDS HERE WITH BUDGETARY DECISIONS BASED UPON THE RED TAPE WE CREATE THROUGH THIS ORDINANCE. SO I THANK YOU FOR THAT.
 - >> PRESIDENT JAMES: ALL RIGHT.
 - >> CAN I HAVE A POINT HERE?
 - >> PRESIDENT JAMES: COUNCILWOMAN FOWLER.
- >> SO THERE ARE SEVERAL OF OUR PARKS AND MOST OF OUR GOLF
 COURSES HAVE DEED RESTRICTIONS. WE CAN REPURPOSE AS LONG AS IT
 STAYS A GREEN SPACE. AS FAR AS DISPOSING OF OUR GETTING RID OF

THE PROPERTY, OUR HANDS ARE TIED. A LOT OF THE PROPERTY WAS
OBTAINED THROUGH DEPARTMENT TO HAVE THE INTERIOR AND HUD. I
DON'T THINK WE CAN SELL THEM. IF THAT WAS A CONCERN, COUNCILMAN
ACKERSON.

- >> PRESIDENT JAMES: COUNCILMAN ACKERSON.
- >> MY CONCERN ISN'T SO MUCH SELLING OFF THE ASSET. MY CONCERN IS THE POTENTIAL BUDGETARY CONCERN. AND AGAIN, MUCH LIKE COUNCILMAN COAN, I'M NOT ADVOCATING CLOSING A POOL AT THIS TIME OR CLOSING A GOLF COURSE AT THIS TIME. SHOULD THAT BECOME A BUDGETARY ISSUE, PROFITABILITY OF FACILITY, LOCATION OF FACILITY, LOCATION OF OTHER FACILITIES THAT PROVIDE A SIMILAR SERVICE, I DON'T WANT TO TIE MY HANDS TO WHERE I CANNOT SAY --WE MIGHT STILL OWN THE PARK LAND. AND I'LL PICK ON CHEROKEE GOLF COURSE JUST AS AN EXAMPLE THOUGH. SHOULD WE DECIDE THAT ITS PROFITABILITY LEVELS THAT IT LOSES MONEY EVERY YEAR AND THE COST TO MAINTAIN IS SUCH THERE ARE OTHER GOLF COURSES IN THE AREA THAT PROVIDE A SIMILAR SERVICE, THAT'S SOMETHING THAT POTENTIALLY I WOULD WANTED A COUNCIL PERSON TO HAVE THE ABILITY TO SAY I'M GOING TO SHUT IT DOWN WITH ANY RED TAPE TO STAY WITHIN THAT BUDGETARY YEAR. AND MY CONCERN IS THIS ORDINANCE CREATES THE RED TAPE THAT WOULD SLOW ME DOWN FROM MAKING THAT FIDUCIARY RESPONSIBLE DECISION IN LIGHT OF OTHER CUTS THAT I MIGHT BE FACING. THANK YOU, MR. PRESIDENT.

- >> PRESIDENT JAMES: NOW WE'LL GO BACK TO ITEM NUMBER 46.
- >> MR. CLERK: AN ORDINANCE AMENDING LOUISVILLE/JEFFERSON

 COUNTY METRO GOVERNMENT CODE OF ORDINANCES SECTION 116.01(J) AND

 REPEALING AND REPLACING SECTION 116.03(D)(2) REGARDING

 COMMUNICATION SERVICES, AS AMENDED. READ IN FULL.
- >> PRESIDENT JAMES: THANK YOU. MAY I HAVE A MOTION AND A SECOND?
 - >> MOTION.
 - >> SECOND.

>> PRESIDENT JAMES: THANK YOU. THE ORDINANCE IS BEFORE US.
IS THERE ANY DISCUSSION? COUNCILMAN COAN.

>> THANK YOU, MR. PRESIDENT. THIS IS A REPEAL AND REPLACE OF THE ONE-TOUCH MAKE READY ORDINANCE. THIS DID PASS OUT OF PUBLIC WORKS COMMITTEE UNANIMOUSLY. THE REASON IT'S IN OLD BUSINESS IS BECAUSE OF THE AMENDMENT. THE ACTUAL AMENDMENT THAT IS BEFORE US TONIGHT IS SLIGHT. IT'S LOCATED ON PAGE 3 IN SECTION 3 REGARDING EXISTING FACILITIES. IT BASICALLY HAS TO DO ABOUT -- IMPOSES A REQUIREMENT FOR A UTILITY POLE OWNER TO PROVIDE TO ANOTHER UTILITY THAT WANTS TO ATTACH TO THAT POLE ANY INFORMATION THAT THE POLE OWNER HAS WITH RESPECT TO OTHER ATTACHER'S CONTACT INFORMATION. IT'S NONCONTROVERSIAL. IT'S A SMALL DETAIL THAT WRAPS UP A MUCH BIGGER, LONGER-TERM COLLABORATIVE EFFORT ON THIS THIS OF LEGISLATION THAT INVOLVED METRO GOVERNMENT AND UTILITIES BEING REGULATED. AND I WOULD LIKE TO OFFER COUNCILMAN MULVIHILL, WHO CHAIRED THE PUBLIC WORKS COMMITTEE THROUGH THE DURATION OF THE DEVELOPMENT OF THIS ORDINANCE TO COMMENT FURTHER.

>> PRESIDENT JAMES: THANK YOU. COUNCILMAN MULVIHILL.

>> YES. I'LL BE VERY BRIEF. THIS WAS THE INITIAL ORDINANCE WAS DONE ABOUT THREE YEARS AGO. BUT THERE WERE LAWSUITS FILED.

ONE BY AT&T, ONE BY CHARTER COMMUNICATIONS. REALLY BASED ON THE PREEXISTING ATTACHER, THE POLE OWNER. IT KIND OF CLARIFIES AND SETS UP THE PROCESS FOR EVERYBODY FOR A NEW ATTACHER AND

PREEXISTING POLE OWNER AND HOW IT WORKED. THEY TWEAKED IT SOME AND GAVE MORE RIGHTS TO THE POLE OWNER. AND SO I DON'T THINK NEW ATTACHERS CAN ACT AS QUICKLY. BUT IF THE NEW POLE OWNER SITS ON HIS RIGHTS TO DO SOMETHING THEN THE NEW ATTACHER CAN STAY THERE INDEFINITELY. I THINK THAT WAS THE PURPOSE OF THE ORDINANCE TO BEGIN WITH. IN ORDER TO ROLL OUT COMMUNICATION SERVICES, YOU NEED THE ABILITY TO HANG WIRES. AND YOU CAN'T WAIT ALL DAY. WE HEARD HORROR STORIES IN ATLANTA AND NASHVILLE THAT WOULD TAKE UP TO A YEAR TO DO A CITY BLOCK. NOBODY WANTS TO SEE THAT.

ESPECIALLY IF YOU WANT TO ENCOURAGE NEW COMMUNICATIONS SERVICES COMING IN. WE WANT TO RESPECT THE RIGHTS OF EXISTING POLE OWNERS BUT AT THE SAME TIME, ALLOW NEW ATTACHERS TO MOVE PRETTY EXPEDITIOUSLY. AND IF ANYTHING, WANT TO ADD ANYTHING, BUT I

>> PRESIDENT JAMES: THANK YOU. ANY FURTHER DISCUSSION? ALL RIGHT. MR. CLERK, PLEASE OPEN THE VOTING FOR THIS AMENDED ORDINANCE. WITHOUT OBJECTION THE VOTING IS CLOSING. AND THE VOTING IS CLOSED.

- >> THANK YOU, MR. PRESIDENT. I'M GOING TO ASK THE BIRTHDAY

 GIRL TO SPEAK TO THIS ONE BECAUSE COUNCILMAN MULVIHILL SAID HE'S

 BEEN TALKING ABOUT A LOT TONIGHT AND IT'S HER LAST TIME AND I

 THOUGHT I WOULD GIVE HER THE FINAL WORD AS THE SPONSOR OF THE

 ORDINANCE.
- >> YOU MIGHT TELL THE COMPLETE WHAT THE VOTE WAS ON THE ORDINANCE, PLEASE?
 - >> HAPPY BIRTHDAY TO ME.
 - >> WHAT WAS THE VOTE? IT WAS 6-1, CORRECT?
 - >> YES. THANK YOU.
- >> PRESIDENT JAMES: OKAY. COUNCILWOMAN, BIRTHDAY GIRL FOWLER.
- >> THANK YOU, MR. CHAIR. SO THIS IS SOMETHING WE WORKED
 WITH THE BUILDERS ASSOCIATION AND SEVERAL OTHER AGENCIES TO MAKE
 SURE THAT WE WERE TAKING INTO CONSIDERATION SUBCONTRACTORS.

 COUNCILMAN MULVIHILL HAS A GOOD STORY ON HOW THIS EFFECTED HIS
 FAMILY. AND I WOULD LIKE FOR HIM TO SPEAK ON THIS, IF YOU WOULD
 PLEASE. THANK YOU, MR. COAN FOR THE BIRTHDAY GIFT.

>> PRESIDENT JAMES: THANK YOU COUNCILWOMAN FOWLER.
COUNCILMAN MULVIHILL.

>> THANK YOU. I THINK WE DISCOVERED WHEN WE SORT OF LOOKED AT THIS THERE ARE MANY FOLKS THAT PLAY BY THE RULES. THEY GET A LICENSE, THEY GET PERMITS AND INSURED. HOWEVER, THE HORROR STORY I HAVE PERSONALLY IS A FAMILY MEMBER BROUGHT AN ELECTRICAL CONTRACTOR TO PUT IN A NEW ELECTRICAL BOX. THE ELECTRIC CONTRACTOR, THE INITIAL ONE COULDN'T GET TO IT. BUT HAD MARKED SOME THINGS WITH RED TAPE, DON'T TOUCH IT. THEY ARE IN A HURRY TO TRY TO GET IT FIXED. THEY SAID, LET ME BRING IN ANOTHER CONTRACTOR, WHICH THEY DID. AND THEY SHOWED HIM THE BUSINESS CARD AND GOTTEN THIS PERSON'S NAME AND THEY SEEMED REPUTABLE. AND WHEN THEY CAME IN, THEY TOUCHED THE BREAKERS THAT HAD RED TAPE ON THEM. 10 MINUTES AFTER LEAVING, IT CAUSED A FIRE. THANKFULLY IT WAS PUT OUT AND NOBODY WAS INJURED. AFTER THE FACT, THEY DID TRY TO CONTACT THE SAME PERSON WITH THE SAME CARD. AND DID INITIALLY, AND SAY I WOULD LOVE TO SEE YOUR LICENSE AND WERE YOU INSURED. THAT ENDED ABRUPTLY AND THERE WERE NO FOLLOW-UP PHONE CALLS. THEY COULDN'T GET AHOLD OF THE PERSON. WHAT WE DID IN THIS ORDINANCE IN TALKING WITH THE BUILDING INDUSTRY ASSOCIATION AND OTHERS AND BILL SHREK WHO I MENTIONED ON THE COMMITTEE ON COMMITTEES HELPED US. WE NAVIGATED. IT WAS MORE THAN TRYING TO GET EQUITY. BECAUSE WE DO WANT EVERYBODY TO HAVE A LICENSE AND PERMIT. WE WANT EVERYBODY PLAYING BY THE SAME

RULES. SO WE TRIED TO ADDRESS IT THAT WAY. BUT IT'S MORE THAN THAT BECAUSE IT'S A PUBLIC SAFETY ISSUE. IF YOU HAVE SOMEBODY WHO IS NOT NECESSARILY TRAINED AND YOU GO BACK TO TRY TO SAY YOU MESSED UP, DO YOU HAVE INSURANCE? BECAUSE MOST PEOPLE MIGHT CARRY IT. OR WE'RE TALKING A LOT ABOUT INSURANCE THESE DAYS. IF THEY DON'T, IT LEAVES PEOPLE IN THE LURCH. WHAT OCCURRED TO US AND IS WHEN YOU ARE OUT AND THIS OCCURRED TO ME, THE A, B, C SIGNS, THE YELLOW ONES POPPING UP. THERE WAS ONE DOWN THE STREET AND I GOT SIX CALLS AND IT WAS PUT OUT ONE DAY. WE THOUGHT IT WOULD BE HELPFUL TO INSPECTORS AND THE PUBLIC THAT IF WORK IS BEING DONE, ESPECIALLY MORE NOT TOTAL NEW CONSTRUCTION BECAUSE TOTAL NEW CONSTRUCTION OUR INSPECTORS THE PUBLIC CAN SEE. IT'S THINGS LESS THAN NEW CONSTRUCTION UNDER 800 FEET, WE BELIEVE THE SIGNS WILL LET THE PUBLIC KNOW THEY ARE LICENSED AND INSURED. IF YOU SEE A TRUCK AND YOU DON'T SEE THAT SIGN, WE HOPE THEY WILL CALL OUR INSPECTORS AND THEY WILL GO OUT THERE. UNFORTUNATELY, OUR INSPECTORS ARE SO BUSY RUNNING FROM POINT A TO POINT Z, IF THEY SEE A TRUCK THEY ARE NOT STOPPING NOW. IF THEY SEE THERE IS NO BLUE SIGN BUT THEY SEE THE TRUCK, I THINK THAT WILL HELP PROMPT THEM. WE'RE HOPING IT WILL PROMPT THE PUBLIC TO LOOK FOR THESE SIGNS AND LOOK FOR REPUTABLE CONTRACTORS. WITH THAT, I WOULD MOVE APPROVAL. AND IF THE BIRTHDAY GIRL WOULD WANT TO ADD ANYMORE TO THIS, PLEASE FEEL FREE. THANK YOU.

- >> THANK YOU FOR THAT EXPLAINS. I APPRECIATE IT, COUNCILMAN MULVIHILL AND COAN. I MOVE FOR APPROVAL.
 - >> PRESIDENT JAMES: THANK YOU. COUNCILMAN REED.
- >> THANK YOU, MR. PRESIDENT. NORMALLY, I WOULDN'T WANT TO

 VOTE FOR ANYTHING THAT SLOWS THE PROCESS. HOWEVER, THIS CLEARLY

 IS A PUBLIC SAFETY ISSUE AND I'LL BE VOTING IN ITS APPROVAL.

 DISCUSSION? HEARING NONE, THIS IS AN ORDINANCE REQUIRING A ROLL

 LISTENED TO THIS THING. ONE OF MY PROBLEMS IS THAT ONE OF OUR

 JOBS IS TO CONTROL OTHER PEOPLE. SOMETIMES I DON'T KNOW HOW MUCH

 I WANT TO BE CONTROLLED. WE TALKED ABOUT THIS THING QUITE A BIT.

 I WAS WORKING ON IT A LITTLE BIT EARLIER. WHAT WE HAVE DONE IS

 MAKE THIS PLACARD THAT YOU PUT UP IN THE YARD. WHEN THAT GUY

 CAME IN TO THE WIRING OF THAT HOUSE, HE HAD TO HAVE A PERMIT. HE

 HAD TO PULL A PERMIT DOWNTOWN. AND WHEN HE LEFT, HE NEEDED TO

 TAKE THAT PERMIT AND HE HAD TO TELL THE PERSON. THERE IS RULES.

 WE CAN MAKE THINGS SO -- I DON'T KNOW IF YOU WILL EVER MAKE IT

 SO EVERYBODY IS DOING EVERYTHING RIGHT. AND I REALLY CAN'T SEE

 THIS PLACARD -- BUT I WANTED TO DISCUSS IT. AND THAT'S WHAT WE

 HAVE DONE AND THAT'S WHAT WE WANT TO DO. SO THANK YOU VERY MUCH.
