- (F) Form committees or other groups to assist in planning, policy, goal and priority recommendations, and such other functions as the Council deen's necessary. (H) Subject to the Mayor of Louisville/Jelferson County Metro Government, to request way Louisville Jefferson County Matra Government department, information, services, featities and other resistance for the purpose of furthering the objectives of the Council.
