>> I DO. I HAVE MY TWO DAUGHTERS HERE, LIBBY WINKLER AND EMMA WINKLER. LIBBY IS A FIRST GRADER, AND EMMA IS A THIRD GRADER, AND EMMA TURNED 9 ON MONDAY, SO CONGRATULATIONS AND HAPPY BIRTHDAY.

>> AND THEY ARE EXCELLENT RUNNERS. I SEE THEM RUN ALL THE TIME. [APPLAUSE]

>> PRESIDENT JAMES: AND COUNCILWOMAN BARBARA SEXTON SMITH,
I THINK YOU HAVE A SPECIAL INTRODUCTION FOR US TODAY.

>> YES, THANK YOU, MR. PRESIDENT. I HAVE A SPECIAL GUEST WITH US THIS EVENING. LADIES AND GENTLEMEN, THE PAGE IN OUR CHAMBER THIS EVENING IS REPRESENTING METRO COUNCIL DISTRICT 4, AND HER NAME IS JUSTICE LYRIC CASWELL, AND JUSTICE IS A WONDERFUL, EXCITED FOURTH GRADER AT J.B. ATKINSON ELEMENTARY SCHOOL ACADEMY, AND SHE ENJOYS BASEBALL, SINGING, DANCING, AND COMPETING AND PERFORMING IN TALENT SHOWS. ONE OF WHICH I WOULD

HAVE SEEN HAD I NOT SHOWN UP AN HOUR LATE. I IMMEDIATELY WENT TO HER HOUSE, AND THERE SHE WAS PERFORMING ON THE SIDEWALK. WHICH I HAVE SEEN HER DO ON MANY OCCASIONS. AND ALSO IN THE CHAMBER,

JUSTICE IS SURROUNDED BY FAMILY THAT LOVE HER DEARLY. HER

GRANDMOTHER IS TERESA WILLIAMS, HER BROTHER GAGE IS WITH US,

- >> PRESIDENT JAMES: LET ME REMIND THOSE ADDRESSING THE COUNCIL TO PLEASE REFRAIN FROM USING ANY PROFANITY OR MAKING DEROGATORY STATEMENTS TO COUNCIL MEMBERS. MR. CLERK, PLEASE BRING THEM FORWARD.

- >> GOOD EVENING, THANK YOU FOR ANOTHER OPPORTUNITY TO SPEAK
 TO YOU ABOUT THE LIVING ROOM PROGRAM. VERY HAPPY TO REPORT THAT
 SINCE JULY OF 2018, WE HAVE BEEN ABLE TO CHECK IN 2,000 PLUS
 GUESTS WITH DIVERTING 98% OF THOSE GUESTS FROM ANY ADDITIONAL
 INTERVENTION FROM THE POLICE, EMS, OR A HOSPITAL. WE'RE VERY

CONCERNED ABOUT THE ELIMINATION OF THE LIVING ROOM FUNDING FROM THE MAYOR'S PROPOSED BUDGET AND ASK YOU TO CONSIDER RESTORING FUNDING. THE LIVING ROOM WAS DESIGNED BY THE STEERING COMMITTEE HERE IN LOUISVILLE TO BE THE SAFETY NET FOR OFTEN THE MOST VULNERABLE CITIZENS OF THE CITY WITHOUT DUPLICATING SERVICES. THE LIVING ROOM IS UNIQUE AND HAS VALUE IN A VARIETY OF WAYS. TIME IS EXTREMELY LIMITED TODAY, SO I'LL ASK MS. JUSTICE TO PROVIDE YOU WITH AN INFOGRAPHIC TO EXPLAIN HOW LIVING ROOM HELPS TO FILL THE GAPS. THE LIVING ROOM IS NOW OPEN TO THE PUBLIC, THUS MOVING THE EVALUATION OF COST SAVINGS TO A BIGGER PICTURE. THE NUMBER OF COST CHECK-INS HAVE INCREASED 300% SINCE OPENING TO THE PUBLIC, DEMONSTRATING THE LIVING ROOM'S ABILITY TO PROVIDE A NECESSARY SERVICE TO THE COMMUNITY WHILE DIVERTING THOSE PERSONS FROM THE CITY'S EXPENSIVE EMERGENCY RESPONSE SYSTEM. I WOULD LIKE TO CLARIFY SOME INFORMATION ABOUT THE LIVING ROOM. OUR CURRENT CALCULATION OF COSTS AND GUESTS SERVED INDICATES THAT THE COST FOR GUEST ENCOUNTER IS AROUND \$200. WE ARE WORKING ON A REVISED BUDGET THAT WOULD MINIMIZE THE REOUEST OF FUNDING FROM COUNCIL IN THE COMING YEAR. THIS WEEK WE TOOK A CLOSER LOOK AT THE NINE MOST FAMILIAR FACES OF THE LIVING ROOM SINCE THIS YEAR. THOSE NINE EXPERIENCED A TOTAL OF 614 DAYS IN THE LOUISVILLE METRO JAIL ONE YEAR PRIOR TO THEIR FIRST CONTACT WITH THE LIVING ROOM. AFTER USING THE LIVING ROOM, SEVEN GUESTS EXPERIENCED NO ADDITIONAL ARRESTS SINCE THEIR FIRST UTILIZATION

OF THE LIVING ROOM. TWO GUESTS EXPERIENCED A TOTAL OF THREE ARRESTS, FOR A TOTAL OF 79 DAYS IN METRO DETENTION CENTERS. ONE OF THOSE GUESTS EXPERIENCED 78 DAYS OF THOSE 79 TOTAL DAYS THEY EXPERIENCED. 78 DAYS IN JAIL MAY SEEM LIKE A HIGH NUMBER, BUT IN THE YEAR PRIOR TO HIS USE OF OUR LIVING ROOM, THE SAME GUEST AVERAGED 26.5 DAYS IN LOUISVILLE METRO DETENTION CENTER FOR THE YEAR. AFTER COMING TO THE LIVING ROOM FOR THE FIRST TIME, THAT NUMBER HAS MOVED TO 15 DAYS ON AVERAGE PER MONTH. HE HAS A HISTORY OF AGGRESSION AND HAD NOT BEEN WELCOME INTO TREATMENT. THE LIVING ROOM STAFF HAS HELPED HIM TO OBTAIN HIS GOAL OF GETTING A JOB AND WORKING WITH A CASE MANAGER AND A PSYCHIATRIST. HE ACTIVELY MANAGES HIS MEDICATION. OUR HIGHEST UTILIZER WHO CAME TO THE LIVING ROOM ON INVITATION BY THE POLICE, HE WAS HOMELESS AND WANDERING OUR STREETS, BANNED FROM LOCAL RESOURCES. IN 2018, HE HAD A TOTAL OF 295 DAYS IN JAIL AND NINE ARRESTS. SINCE USING THE LIVING ROOM, HE HAS HAD ZERO DAYS IN JAIL AND ZERO ARRESTS. HE, TOO, HAS FOUGHT EMPLOYMENT AND IS SAVING MONEY FOR PERMANENT HOUSING. THERE'S SO MANY STORIES LIKE THIS, AND I COULD SHARE THEM FOR DAYS. WE APPRECIATE THE LIVING ROOM IN OUR COMMUNITY AND HOPE YOU WILL SUPPORT ITS CONTINUED GOOD WORK. THANK YOU.

- >> CLERK: SHAVON THOMPSON.
- >> GOOD AFTERNOON. MY NAME IS SHAVON THOMPSON AND I'M A CAREER SUPPORT SPECIALIST IN THE LIVING ROOM LIVING. I'VE BEEN

WORKING AT THE LIVING ROOM FOR TEN MONTHS AND SEEN HOW IT SAVES LIVES, GIVEN PEOPLE THE TOOLS TO MANAGE THEIR OWN CRISIS WITHOUT HAVING TO INVOLVE THE POLICE. I'M VERY CONCERNED ABOUT THE PROPOSED BUDGET ELIMINATING THE FUNDING FOR THE LIVING ROOM IN JULY. WHAT WILL HAPPEN TO THE 2,000-PLUS PERSONS WHO WILL ACCESS THE LIVING ROOM? WHERE WILL THEY GO WHEN SO MANY OF THE GUESTS ARE NOT WELCOME OTHER PLACES IN THE CITY BECAUSE OF THEIR MENTAL HEALTH SYMPTOMS OR SUBSTANCE ABUSE? WHAT WILL HAPPEN TO THE 12 FULL-TIME EMPLOYEES WHO ARE IN RECOVERY THAT ARE CURRENTLY WORKING IN THE LIVING ROOM? MY RECOVERY JOURNEY HAS BEEN A PLACE OF SUPPORT. MAY HAVE BEEN MUCH DIFFERENT IF THERE HAD BEEN A LIVING ROOM BACK WHEN I WAS GOING IN AND OUT OF THE DOORS IN THE BEGINNING OF MY RECOVERY. JUST SOMEONE WHO COULD RELATE BASED ON MY OWN PERSONAL EXPERIENCE, AS WELL AS THEIRS. PART OF MY OWN RECOVERY NOW INVOLVES HELPING OTHERS AS THEY MOVE ALONG THEIR RECOVERY JOURNEY. THE LIVING ROOM IS UNIQUE IN THAT IT IS TRULY A COMPASSIONATE PLACE IN THE CITY WHERE ALL ARE WELCOME ALL OF THE TIME, AND THE BELIEF THAT EVERYONE IS CAPABLE OF RECOVERY AND RECOVERY IS REAL. AS A PEER SUPPORT, IT IS MY JOB TO HOLD HOPE FOR RECOVERY FOR ALL THE GUESTS AND TO SHOW THEM RECOVERY IS POSSIBLE. RECOVERY TAKES TIME, AND IT ISN'T EASY. THERE ISN'T SOMETHING THAT HAPPENS DURING TRADITIONAL BUSINESS HOURS AND ALL OF A SUDDEN THAT MAKES RECOVERY HAPPEN. RECOVERY IS OFTEN THE PROCESS OF LEARNING AND TRUSTING THAT THERE IS ANOTHER WAY TO

LIVE, THAT THERE ARE OTHERS WHO WANT TO HELP, AND THAT THERE IS SOMETHING WORTH LIVING FOR. FOR EXAMPLE, WE -- FOR EXAMPLE, SORRY, WE HAD A CLIENT THAT CAME IN FROM OUT OF TOWN. HE GOT DROPPED OFF ON THE MEGA BUS AT 2:00 IN THE MORNING. HE WAS COMING FOR RECOVERY HELP. HE JUST NEEDED SOMEWHERE TO BE UNTIL THE RECOVERY HELP OPENED. THE POLICE BROUGHT HIM TO THE LIVING ROOM, AND WE HELPED HIM TO GET TO HIS RECOVERY HOUSE THE NEXT MORNING. WE CURRENTLY HAVE A CLIENT THAT'S NINE WEEKS PREGNANT. SHE DOESN'T HAVE ANYWHERE TO GO. SHE HAS A CASE MANAGER, AND SHE HAS A GUARDIAN. THEY ARE BOTH WORKING ON HOUSING FOR HER, BUT IN THE MEANTIME, SHE'S SLEEPING IN A PARKING GARAGE. SHE'S CURRENTLY STAYING AT THE LIVING ROOM. THE LIVING ROOM DOES HELP PEOPLE CHANGE THEIR LIVES WHILE SAVING CITY RESOURCES. IN CLOSING, THANK YOU FOR PROVIDING ME THE OPPORTUNITY TO WORK IN THE LIVING ROOM. IT HAS CHANGED MY LIFE AND THE LIVES OF SO MANY IN OUR CITY. I ASK YOU FIND A WAY TO KEEP IT FUNCTIONING FOR ALL THOSE THAT NEED IT IN THE FUTURE BY INCLUDING CONTINUED FUNDING TO THE BUDGET FOR THE COMING YEAR. THANKS. [APPLAUSE]

>> GOOD EVENING. MY NAME'S GREG BANNEN, AND MY FULL NAME IS
JOHN GREGORY BANNEN, BUT I'VE ALWAYS GONE BY GREG. I'M A 17-YEAR
RESIDENT OF LOUISVILLE, AND PROUD TO CALL IT HOME. I WANT TO
THANK PRESIDENT JAMES AND THE REST OF THE COUNCIL MEMBERS FOR
THE OPPORTUNITY TO ADDRESS COUNCIL. THE SUBSTANCE OF MY

DISCUSSION IS LOUISVILLE'S LARGE UNFUNDED PENSION LIABILITY AND THE CURRENT CRISIS AND IMPACT ON THE COMMUNITY. PLEASE NOTE THAT I SAID LOUISVILLE'S PENSION LIABILITY, NOT THE STATE, OKAY, THEY ARE SEPARATE AND DISTINCT. TO PREPARE FOR THIS, I RESEARCHED THE FOLLOWING, NUMEROUS NEWSPAPER AND TELEVISION STORIES ON THE MATTER, LOUISVILLE'S COMPREHENSIVE ANNUAL FINANCIAL REPORTS FOR THE YEARS 2012-2018, A DOCUMENT TITLED "LOUISVILLE FACES DEVASTATING BUDGET SHORTFALLS" FROM THE LOUISVILLEKY.GOV WEBSITE, VARIOUS OTHER WEBSITES AND COMMUNICATIONS AND ALSO REVIEWED "OVERVIEW OF THE KENTUCKY RETIREMENT SYSTEM" FROM THE KENTUCKY ASSOCIATION OF COUNTIES. SO I WANT TO PREFACE MY REMARKS BY SAYING I'M A CPA, LICENSED IN THE STATE OF MICHIGAN, NOT KENTUCKY. I'VE LED TURNAROUNDS OF CORPORATE ORGANIZATIONS AND FINANCIALLY TROUBLED ORGANIZATIONS, SO I HAVE SOME OVERRIDING PRINCIPLE. FIRST, NUMBER ONE IS, TAKE PERSONAL AND ORGANIZATIONAL RESPONSIBILITY FOR THE CIRCUMSTANCES LEADING TO THE PROBLEM. TWO, TAKE PERSONAL RESPONSIBILITY FOR TAKING CORRECTIVE ACTION. THREE, DO NOT, AND I SAY DO NOT, BLAME OTHERS UNLESS THERE'S A COMPELLING REASON TO DO SO. AND IT REALLY TROUBLES ME, IS THAT EVERYWHERE I READ, EVERY QUOTE I READ, SEEMS TO BLAME THE STATE FOR LOUISVILLE'S PENSION PROBLEM. THE STATE ADMINISTERS THE PENSION PROGRAM, BUT -- IN FACT, I WANT TO BRING YOUR ATTENTION TO EXAMPLES OF THAT. THIS DOCUMENT IS ON THAT -- ON THE LOUISVILLE'S WEBSITE, SAYS "ESTIMATED STATE

PENSION-DRIVEN PENSION DEFICIT." IT'S NOT -- THE STATE'S

ASSOCIATED IN THAT IT ADMINISTERS THE PROGRAM, BUT IT'S NOT

THEIR DEFICIT. AND THEN WDRB ARTICLE ON MARCH 4TH TITLED

"ANALYSIS: JUST HOW BIG IS LOUISVILLE'S PENSION-DRIVEN CRISIS."

AND A QUOTE BY THE MAYOR, ABOUT THE MAYOR, "AS HE PUSHES FOR

QUICK APPROVAL OF A PERMANENT TAX INCREASE, MAYOR GREG FISCHER

HAS BEEN SAYING FOR WEEKS THAT LOUISVILLE METRO GOVERNMENT HAS

BEEN FACING A STATE-DRIVEN BUDGET CRISIS BECAUSE OF MANDATORY

CONTRIBUTIONS TO STATE-RUN RETIREMENT PLAN." OKAY, SO, YOU KNOW,

THE CURRENT LIABILITY IS \$957 MILLION IN THE PENSION AS OF 2018,

AND THERE'S AN ADDITIONAL \$345 MILLION FOR OTHER BENEFITS FOR

RETIREES, AND ALL I WANT IS FOR THE COUNCIL, THE MEDIA, AND THE

MAYOR TO ACCEPT RESPONSIBILITY FOR LOUISVILLE -- IT'S

LOUISVILLE'S EMPLOYEES, AND IT'S LOUISVILLE'S EMPLOYEES AND

LOUISVILLE'S RETIREES, NOT THE STATE. SO THANK YOU.

- >> CLERK: DEACON LUCIO CARUSO.
- >> ITALIAN, IT'S LUCIO. THAT'S OKAY. I WON'T SING. BUT I'M
 HERE ON BEHALF OF CATHOLIC CHARITIES OF LOUISVILLE AND THE
 ARCHDIOCESE OF LOUISVILLE IN SUPPORT OF THE LIVING ROOM FOR A
 NUMBER OF DIFFERENT REASONS. PART OF MY WORK WITH A LOT OF
 COMMUNITY PARTNERS HAS BEEN IN THE AREA OF PRISON JAIL, BOTH
 MINISTRY INSIDE, BUT A LOT OF RE-ENTRY WORK WITH COMMUNITY
 PARTNERS, AND WE'RE ALL WELL AWARE OF THE HIGH PERCENTAGE OF
 INCARCERATED ARE RELATED TO SUBSTANCE ABUSE AND MENTAL ILLNESS.

I'M ALSO WORKING ON AN INITIATIVE STATEWIDE ON CRIMINAL JUSTICE REFORM, WHICH REALLY TARGETS THE RE-ENTRY DIVERSION PART OF THAT. YOU KNOW, WE TALK ABOUT RE-ENTRY, BUT PRE-ENTRY, WHAT HAPPENS BEFOREHAND, WHAT CAN WE DO TO DIVERT PEOPLE COMING INTO THE SYSTEM, AND I DO BELIEVE THAT THE LIVING ROOM IS ONE VEHICLE OF THAT DIVERSION IN PRE-ENTRY. WE ALSO DO A COMMUNITY MINISTRY, SOME OF YOU ARE FAMILIAR WITH THE SISTER VISITORS CENTER. WE RECENTLY DID A SURVEY OF OUR CLIENTS THERE ABOUT THE ISSUES THAT CONCERN THEM, AND THE NUMBER ONE ISSUE IS SUBSTANCE ABUSE. BOTH IN TERMS OF HOW IT RESULTS IF IT'S A FAMILY MEMBER THAT BECAUSE OF THAT LOSES JOB AND INCOME, AND, THEREFORE, THEY ARE COMING TO OUR COMMUNITY MINISTRIES FOR ASSISTANCE, BUT ALSO THE CAUSE OF A LOT OF THE CRIME AND VIOLENCE IN THEIR NEIGHBORHOODS THAT THEY SPEAK OF. SO WE'RE GRATEFUL THAT WE'RE KEEPING THE PROPOSED ACM FUNDING INTACT, BUT WE'D LIKE TO GET TO SOME OF THE ROOT CAUSES FOR THE NEED FOR ASSISTANCE. I ALSO REPRESENT THE CATHOLIC CAMPAIGN FOR HUMAN DEVELOPMENT, WHICH IS A FUNDING COLLECTION OF THE UNITED STATES CATHOLIC CHURCH THAT SUPPORTS PROJECTS AND EFFORTS FOR SYSTEMIC CHANGE, AND WE PROVIDED IN THE LAST COUPLE YEARS A NATIONAL GRANT TO THE CITIZENS OF LOUISVILLE ORGANIZED UNITED TOGETHER, ESPECIALLY AROUND ITS WORK IN THE LIVING ROOM, THE ARCHBISHOP WAS ESPECIALLY GRATEFUL FOR THAT EFFORT AND REALLY IS IN STRONG SUPPORT OF THAT. AND ALSO AT CATHOLIC CHARITIES, WE HAVE A MOTTO. IT'S NOT EXACTLY LIKE THE LIVING

ROOM, BUT IT'S SIMILAR IN OUR ANTIHUMAN TRAFFICKING PROGRAM THAT WE DO STATEWIDE. WE HAVE WORKED WITH LAW ENFORCEMENT OVER THESE YEARS TO THE PLACE NOW WHERE IF A PERSON IS PICKED UP FOR PROSTITUTION, SOME TYPE OF SEX CRIME, RATHER THAN BEING BROUGHT TO JAIL, CRIMINALIZED, THEY ARE CONNECTED TO ONE OF OUR CASE MANAGERS SO THAT THEY ARE SCREENED AND, OBVIOUSLY, OFTEN WE FIND THAT THEY ARE A VICTIM OF TRAFFICKING, NOT A PERPETRATOR. SO I WOULD SUGGEST THAT MANY WE HAVE ARE VICTIMS OF ADDICTION AND MENTAL ILLNESS RATHER THAN BEING PERPETRATORS. SO THE CATHOLIC CHURCH SUPPORTS THE LIVING ROOM FOR THE FACT NOT JUST THAT IT CAN SAVE THOUSANDS OF DOLLARS IN JAIL AND HOSPITAL COSTS, BUT IT'S A SETTING TO START THE PROCESS OF BRINGING HEALING AND WHOLENESS TO THE BROKEN LIVES OF OUR SISTERS AND BROTHERS, TO HELP RESTORE THEIR HUMAN DIGNITY SO THAT THEY CAN BECOME PRODUCTIVE MEMBERS WITHIN OUR COMMUNITY. SO PLEASE JOIN THE LMPD AND OTHER GREAT HUMAN SERVICE PROVIDERS IN OUR COMPASSIONATE CITY TO KEEP THE LIVING ROOM LIVING. THANK YOU. [APPLAUSE]

>> CLERK: JOHN B. GROSS, JR.

>> HELLO, MY NAME IS JOHN GROSS. I'VE LIVED IN LOUISVILLE
MY ENTIRE LIFE. THE LONGEST I WAS AWAY WAS WHEN I WAS IN
VIETNAM. WHEN I FIRST STARTED OUT, I WAS ABLE TO BUY A HOUSE FOR
\$13,500. A FEW YEARS LATER I WAS ABLE TO SELL THAT HOUSE FOR
\$65,000. NOT ONLY HAVING A SAFE AND AFFORDABLE HOUSING, BUT
BEING ABLE TO BUILD THAT EQUITY WAS A HUGE BENEFIT THAT HAS

SERVED ME MY ENTIRE LIFE. BUT SINCE THAT, I'VE SEEN HOUSING IN OUR COMMUNITY SHIFT FAR FROM BEING AFFORDABLE, WHICH MEANS IT'S MORE THAN 30% OF SOMEONE'S INCOME. I'VE SEEN MY SONS BREAK THE BANK TO AFFORD LOW-QUALITY HOUSING. I'VE SEEN MY SON STRUGGLE UNDER THE STRESS OF TRYING TO PAY RENT OR MORTGAGES, EVEN WITH A GOOD JOB, EVEN WITH A GOOD EDUCATION, AND EVEN WITH A ROOMMATE. STABLE, AFFORDABLE HOUSING GAVE ME THE ABILITY TO BUILD UP SAVINGS. IT GAVE ME THE ABILITY TO FOCUS AT WORK AND BE PRESENT WITH MY FAMILY. IT GAVE ME A SENSE OF HOME AND DIGNITY. HOUSING IS -- THE OPPOSITE IS TRUE WHEN YOU TAKE THAT AWAY. WHEN IT ISN'T AVAILABLE, PEOPLE AREN'T ABLE TO SAVE. PEOPLE CAN'T FOCUS AT WORK, THEY CAN'T ALWAYS BE PHYSICALLY AND MENTALLY PRESENT AT HOME, AND IT STRIPS AWAY THEIR DIGNITY. HOUSING ISN'T AN ADVANTAGE, IT IS A RIGHT. THE \$5 MILLION IN THE BUDGET FOR THE LOUISVILLE AFFORDABLE HOUSING TRUST FUND IS A GOOD START, BUT IT NEEDS TO BE RAISED IN THE FULL FUNDING LEVEL SET FORTH IN THE ORDINANCE OF \$12 MILLION. WE CANNOT TAKE A YEAR OFF OF FULLY FUNDING THE TRUST FUND, BECAUSE THE HOUSING CRISIS ISN'T GOING TO TAKE A YEAR OFF. IT'S ONLY GOING TO GROW. THERE ARE 72,000 FAMILIES PAYING MORE THAN 30% OF THEIR INCOME. 12 YEARS AGO, IT WAS 60,000. WE ARE FACING THE REALITY OF MANY CUTS TO GOOD AND IMPORTANT PROGRAMS, BUT CUTTING FUNDING TO AFFORDABLE HOUSING KNOCKS THE LEGS OUT FROM AN ALREADY VULNERABLE POPULATION, THE PEOPLE WHO WILL BE HURT THE MOST. HOUSING IS A RIGHT, AND IT

NEEDS TO REMAIN A PRIORITY. THE TRUST FUND NEEDS FULL FUNDING.

THANK YOU. [APPLAUSE]

GREENE, I KNOW THAT'S IN YOUR DISTRICT, BECAUSE I WANT EVERYBODY HERE TO KNOW THAT THIS TOURNAMENT IS NOT A BLACK TOURNAMENT, IT'S NOT A WEST END TOURNAMENT, IT'S A CITYWIDE TOURNAMENT. 50 YEARS AGO, I WAS 19 YEARS OLD. BEN MIGHT HAVE BEEN 22, NO, 20 -- OKAY. AND WE WERE PARK SUPERVISORS AT ALGONOUIN PARK AND THE BODY THAT GOVERNED US WAS LOUISVILLE PARKS AND RECREATION. THIS IS ALSO YOUR LEGACY. WE WERE FUNDED AND RAN THROUGH THE CITY GOVERNMENT, PARKS AND RECREATION. WE WERE PARK SUPERVISORS. I DON'T KNOW WHY WE DON'T HAVE PARK SUPERVISORS ANYMORE, BUT THAT'S OKAY. WHAT WE'RE HERE TO SAY IS EVERYTHING IS IN PLACE. WE HAVE THE TIP-OFF FATHER'S DAY IN ALGONOUIN PARK. WE'RE GOING TO HAVE A CHAMPIONSHIP SUNDAY IN SHAWNEE PARK ON AUGUST 11TH. COUNCILWOMAN SEXTON SMITH, WE'RE GOING TO BE AT THE FRASER MUSEUM FOR A RECEPTION, BANOUET AND AWARDS CEREMONY ON AUGUST 25TH. WE'D LOVE FOR YOU TO DO A WELCOME, BUT I'M NOT TRYING TO CALL PEOPLE OUT WHILE I'M HERE. I JUST WANT YOU TO KNOW THAT WE GOT BANNERS THAT WE WANT TO PROMOTE, FLAGS ALL OVER THE CITY. WE WANT YOU TO FIND SOMETHING. WE KNOW THAT THE PIGGY BANK IS SHAKING AT THE BOTTOM, BUT THE GOOD NEWS IS, WE DON'T NEED A WHOLE LOT OF MONEY, BUT WE DO NEED YOUR HELP FROM MAYBE YOUR NEIGHBORHOOD DEVELOPMENT FUNDS TO HELP US EITHER DO SOME BANNERS, SOME T-SHIRTS, THE LANDMARK, TABLES FOR ALL THE YOUTH THAT ATTEND AND PARTICIPATE IN THIS YEAR'S DIRT BOWL, SO THEY CAN COME TO THIS BANQUET FREE OF CHARGE. THE ORDINANCE IS BEFORE US. IS THERE ANY DISCUSSION? COUNCILMAN COAN.

>> THANK YOU, MR. PRESIDENT. THIS ORDINANCE ACTUALLY PASSED UNANIMOUSLY OUT OF OUR PUBLIC WORKS COMMITTEE, TOO. IT'S ON OLD BUSINESS, BECAUSE WE HAD TO MAKE A TECHNICAL AMENDMENT. IF YOU LOOK, YOU CAN SEE WE ADDED THE WORDS "STREETS AND SIDEWALK" IN PLACES OF LITTERING. BRIEFLY, LITTERING IS A CLASS A DEMEANOR IN THE STATE OF KENTUCKY, WHICH CARRIES WITH IT A PENALTY OF UP TO 90 DAYS OR 12 MONTHS IN JAIL AND A FINE OF \$100. THIS IS ONE OF THE RARE AREAS OF KENTUCKY LAW WHERE FRANKFURT ALLOWS LOCALTIES TO ELECT TO HAVE LOCAL CONTROL OR NOT. WHAT I MEAN IS, WE CAN CHOOSE TO MAKE LITTERING A CIVIL VIOLATION INSTEAD OF A CRIMINAL OFFENSE. I BECAME INTERESTED IN THIS BECAUSE I'M VERY ANTILITER AND I'M LOOKING AT DIFFERENT WAYS POLICY AND PROGRAMMATIC TO DEAL WITH T AND I THOUGHT MAKING THE POLICY CHANGE TO CIVIL INFRACTION WOULD BE SOMETHING THAT WOULD BE BENEFICIAL TO THE

OVERALL SYSTEM IN A COUPLE OF WAYS. ONE, I WAS HOPING THAT IF LITTERING WAS A CIVIL INFRACTION, OUR POLICE OFFICERS AND OTHER CODE OFFICERS WILL BE MORE WILLING TO WRITE A TICKET, MUCH LIKE PEOPLE ARE MORE LIKELY TO WRITE A PARKING TICKET THAN ARREST SOMEBODY. TWO, THERE'S NO NEED FOR THESE CASES TO GO THROUGH OUR COURT SYSTEM. THREE, IF IT'S A CIVIL VIOLATION, IT WILL COME TO THE GENERAL FUND AND WITH PENALTIES OF \$125 TO \$250 AND AN AVERAGE OF 100 ARRESTS AND CITATIONS OVER THE PAST THREE YEARS, THAT'S FIVE DIGITS WORTH OF REVENUE FOR THE CITY THAT WE COULD, OBVIOUSLY, USE AT THIS TIME. THE DEFINITION OF LITTERING SUBSTANTIALLY MIRRORS THE STATE STATUTE, SO REALLY THE ONLY EFFECTIVE PART OF THE LAW HERE IS THE ELECTIONS FOR THE CITY TO MAKE A CIVIL VIOLATION, AND THEN WHERE IT SPELLS OUT THE PENALTIES. I THINK THIS IS A USEFUL TOOL FOR OUR LAW ENFORCEMENT TO HAVE ANOTHER OPTION. THEY STILL, OBVIOUSLY, RETAIN THE ABILITY TO ARREST SOMEBODY UNDER THE STATE STATUTE, IF THERE'S A REASON FOR DOING THAT, BUT I THINK THIS IS A GOOD TOOL TO HAVE IN THE TOOL BELT, SO I'LL ENTERTAIN ANY QUESTIONS, AND THANK YOU VERY MUCH.
