## Summary of Neighborhood Meeting

The meeting to discuss this development proposal was held on Tuesday, December 11, 2018, at 6:00 pm.

The Meeting was held at First Cumberland Church, 4610 Manslick Road, Louisville, Kentucky, 40216.

Eight people were in attendance including the applicants and the applicant's representative.

Mark Madison representing the applicant introduced himself and then the applicant "Mike Seidenfaden".

Mr. Madison presented the concept site plan depicting the existing conditions, the proposed parking layout and the proposed Church building and the multi-use building.

The following is a summary of the questions, responses and comments made at this meeting.

*Resident: How will this development have access?*

*Mr. Madison: The only access the Church will have is coming directly off of St. Andrews Church Road.*

*Resident: So this project will not have cars or trucks accessing the property from Fordhaven Road?*

*Mr. Madison: The subject property does not adjoin Fordhaven Road, nor does it have an access easement to Fordhaven Road. The Applicant has no plans to attempt or interest to gain access to Fordhaven Road.*

*Resident: When will the project be started?*

*Mr. Madison: The applicant plans to begin construction fall of 2019, provided they receive all approvals by then.*

*Resident: When will the project be finished?*

*Mr. Madison: The applicant is planning to build the Church building and parking fall of 2019. The multi-use building (a.k.a. fellowship Hall) will be built sometime after that based on funding.*
