#### Nanny Goat Strut:

Before you submit for any alleys to be funded, Louisville Downtown Partnership has a streetscape project in the design phase now and I am wanting to review to see what the planned work consists of and if I should revise my estimates below accordingly. Also, I need to get my contractor on-site as this is an 8 ft wide alley. I have concerns that the alley may be too narrow for regular equipment so I want to confirm that no additional costs would be encountered completing the paving project. Below is a list of all segments reviewed and preliminary recommendations and estimates:

Section from dead end to Hancock was replaced in the recent past. Not sure if it is brick pavers or stamped concrete, but rides smooth and would recommend nothing be done to this section.

Section from Hancock to Clay is in poor condition especially from about the middle of this block to Clay. The area is brick pavers which has been overlaid with 1-2 inches of asphalt. I recommend that the asphalt be removed and 2 inches of fiber reinforced asphalt be installed. There may be some base failure reconstruction necessary with the completion of this section which I estimate at 10% of the overall area. I believe this was the worst section and estimate repairs at \$22,500.00 which includes ramp replacement as necessary.

Section from Clay to Shelby was in a better condition than the previous section. Again, it appeared that the section got worse about half way extending towards Shelby. Also, it was observed that this is brick pavers overlaid with asphalt pavements. I recommend the same attention be given as mentioned in the section from Hancock to Clay. I would expect the costs for this to be about \$22,500.00 if replaced.

Section from Shelby to Campbell was the second worst section observed and will also be the most expensive since it is all exposed brick pavers. If would recommend that the brick pavers be removed and replaced with full depth asphalt. It needs to be confirmed that this stretch of alley does not fall into a historic preservation district as there are a few structures which abut the alley that are marked as historic preservation district. If the alley must be replaced with brick pavers, preliminary budgetary numbers would be between \$100k and 250k. If it is allowed to be replaced with 4 inches of asphalt, I would estimate that the costs would be about \$50,000.00 plus whatever the salvage price incurred for brick pavers which I do not currently have in my contract.

Section from Shelby to Wenzel was in fairly good condition. It appears that semis and other larger vehicles use this alley and it is better maintained by those businesses. I believe this to also be a brick paver alley overlaid with asphalt. At this time I do not recommend doing anything to this section of alley.
