Wanda,

We need to confirm that Russell Alley is in fact Metro ROW. Assuming it is, below is my recommendations and estimate:

Russell Alley appears to be concrete overlaid with asphalt. I suggest milling 2 inch of asphalt max (or all asphalt off of the concrete if concrete is shallower than 2 inches deep) and repave wit 2 inches of fiber reinforced asphalt.

The Kahn Aly side is very narrow and it is uncertain at this time if our contractor can get proper equipment into the area. If they cannot we will try other equipment, but we may need to ask our folks in house to use their hot box in this area. I also assume that we will need to spend 4-5 hours removing brush in this section to have proper vertical clearances if we can get a paver into this section of the alley. This does not appear to be asphalt overlaid on concrete, but I do recommend we follow the same treatment as above in which we mill 2 inches and replace with 2 inches of fiber reinforced asphalt.

Both outlets of the alley will have sidewalk ramps which will need to be updated to meet ADA specifications.

I estimate this alley to cost \$25,000.00.
