Councilwoman Sexton-Smith -

After careful consideration and consultation I am going to have to respectfully decline your offer to appropriate funds for Metro Parks and Recreation to take kids from District 4 to KY Kingdom.

Because of the nature of the trip and the fact that we do not currently program in District 4, this could be an uncomfortable and awkward situation for staff and participants due to a lack of familiarity which each other. Also, I do not have staff available specifically to chaperone a field trip.

One possible solution I would like to offer would be to provide those passes (25 each) to AMPED and LCCC. Both of those organizations are based in District 4 and would offer some geographic diversity (Shelby Park and Beecher Terrace) to the distribution.

Ms. Johnson,

In light of the issues TMG experienced earlier this week in distributing their Kentucky Kingdom season passes to low-income children in the community, Councilwoman Shanklin has decided to again pursue the deal that we had worked out with you all a month or two ago. At least two, possibly three, additional councilmembers are also intending on participating as well. I have been doing my best over the past couple of days trying to nail down how many kids these other councilmembers intend to send, and what their plans are as far as dates to send them/chaperones/transportation/etc. However, I am still waiting on some of this information.

Still, I wanted to go ahead and reach out to you now to inform you of our intentions, and to start a paper trail so that I may begin the process of getting funds moved around (and to you all) as soon as possible.

The deal as we understand it currently is:

- Discounted group tickets from Kentucky Kingdom will be made available by the park for council districts to purchase and distribute to lower-income children within their individual districts. These tickets will be made available to for the 1/discounted price of \$25.00 par child which will include one full day's admission to the park, as well as a catered buffet- style meal to be eaten at the park.
- Kentucky Kingdom CEO Ed Hart requested that children receiving these discounted group passes come as a group on buses on a pre-planned week day with chaperones to ensure that the kids behave and are safe throughout the day. As a notation, not all districts will have to send their kids on the exact same day, and chaperones will receive free entry to the park for the day. The coordination effort will fall on each district to ensure that the most needy/deserving children get access to the tickets, and that chaperones are found and are present with the children throughout the day at the park. Each participating councilmember will ensure that these stipulations are met.
- In order to pay for the expense of the tickets, we are intending to move money to Metro Parks from our districts, and they will be the entity paying Kentucky Kingdom.

If this all sounds accurate and acceptable to you, if you would please send me back an email confirming these details, I would appreciate it greatly. I will also be in further contact with you as soon as I have final ticket numbers and any additional information you may need from the Metro Council to get the ball rolling on this as soon as possible.

Thank you so much for your help and patience with us through this process. We truly appreciate Kentucky Kingdom and all that you all have done for us in our joint attempt to help out the lower-income children in our community.

Hi Caleb -

Dr. Shanklin and I did speak briefly about this matter which has my support.

That being said, I would like to meet with the Councilpersons to make sure we are all on the same page and this gets planned, communicated and executed properly. Though I was out of town when it occurred, I am aware that there was some confusion regarding another attempt to support families with KY Kingdom passes earlier this week.

Without going into too much detail I'll tell you why that is so important for us.

- In District 1 we have a community center (Southwick) hosting a Summer Camp.
- In District 2 we have a community center (Newburg) which is not hosting a Summer Camp.
- In District 4 we do not have any community centers since Baxter has closed due to the Russell Revitalization.

There is no way we can make one announcement and not address those three significantly different situations without seriously confusing the public.

We are interested in being a part of the solution, we just want it to be a solution that doesn't create more confusion and disappointment.
