
President & Chief Executive Officer

Served as President and CEO for Centerstone of Kentucky (CKY), the regional behavioral health, prevention, and developmental services center for Bullitt, Henry, Jefferson, Oldham, Shelby, Spencer, and Trimble counties of Kentucky. Responsible to the Board of Directors and Centerstone of America for all fiscal, strategic, and operational aspects of the organization. With a budget of \$125,000,000 and management responsibility for an additional \$70,000,000 of services, CKY employed more than 1,800 staff and serves more than 36,000 persons each year at 25 locations and more than 150 schools and other partnership sites throughout the region. CKY was the largest non-hospital, not-for-profit corporation in metropolitan Louisville and one of the region's 25 largest employers. Accomplishments include:

- Led merger with Uspiritus, a \$20mm provider of children's residential and foster care services. Led the Boards through planning, negotiations, and the development of a final merger agreement. By my departure, the merger had been functionally completed and Uspiritus was fully managed by CKY. Final signatures on merger documents were scheduled for December, 2018 pending final name changes on licenses and managed care contracts.
- Completed successful affiliation with Centerstone of America. This affiliation created the largest non-profit community behavioral health company in the United States and strengthened CKY's ability to manage the rapid changed occurring in healthcare.
- Planned and initiated with Board of Directors a successful Chapter 11 filing in Federal Court designed to provide relief from unsustainable state-imposed pension rate rising to 48% of wages by FY17. CKY's case raised unprecedented questions regarding public pensions and states' rights and required extraordinary legal, political, operational, and communications management. CKY was released from bankruptcy in 2015 and won an appeal by the state to federal District Court in 2016. CKY is still waiting for a final decision to a further appeal by the state to the 6th Circuit Court of Appeals.
- Led the development of CKY's first comprehensive strategic plan in more than a decade.
- Implemented open access and collaborative documentation across all locations. Reduced outpatient no-show rate from 44% to 11% in some locations. Decreased time from first call to first non-medical appointment from an average of more than 15 days to less than 5 days in some locations.
- Reduced Joint Commission findings in the 2018 survey by over 70% compared to the 2009 survey.
- Implemented new financial and related software including general ledger and HR information system. Selected new electronic health record software in April 2014 which went live for every CKY service in July 2015.
- Expanded integrated health care services by partnering with medical providers to implement physical health/primary care integration projects in multiple locations. Implemented lab services at all large location. Supported by a grant from SAMHSA, implemented one of the nation's first health homes for people with opioid addiction.
- Developed Kentucky's first forensic ACT team and Living Room based pre-arrest diversion service.
- Expanded the use of other evidence-based practices for people with severe mental illnesses including supported employment,

supported housing, integrated dual diagnosis services, wellness management and recovery, and integrated primary care.

- Developed successful truancy reduction program Louisville public schools.
- Developed innovative services in response to the nation's opioid crisis including services for pregnant and parenting mothers, medication assisted treatment integrated with a comprehensive array of recovery services, employment and housing services, peer supports, and integrated primary care services.
- Developed exceptional services for children including wrap around services for foster care that allowed 90% of children with long histories of placement failure to succeed at that level of care and crisis services that diverted 96% of children from higher levels of care.
- Served Co-Chair of the Bounce Coalition, a citywide group implementing philanthropically supported resilience and trauma services in Louisville public schools.
- Partnered with the Board to strengthen Board effectiveness. Initiatives included recruiting new members, expanding Board size, organizing first Board retreats in several years, conducting first Board self-assessment, and streamlining Board committee structure, policies, and procedures.
- Managed CKY's implementation of Medicaid managed care. Negotiated contracts with five Medicaid managed care organizations.
- Initiated a concierge primary care practice as a new staff benefit. This novel benefit increased staff morale, improved health care quality and access, and reduced health insurance costs.

THRESHOLDS, Chicago, IL

Served as CEO for Thresholds, an internationally known provider of psychiatric rehabilitation services. Responsible to the Board of Directors for all fiscal, strategic, and operational aspects of the organization. Services provided by Thresholds included assertive community treatment, residential services, employment, educational, psychiatry, and other clinical and rehabilitation services for adults and adolescents with severe mental illnesses. Thresholds provided sophisticated services for special populations with co-occurring conditions including homelessness, substance abuse and dependence disorders, medical illnesses, and deafness. With a consolidated budget of \$48,000,000 and 800 staff, Thresholds was the largest provider of its kind in Illinois. Accomplishments include:

- Led Thresholds through Illinois' unprecedented FY 08-11 fiscal crisis. Rapid and decisive cost reduction efforts and efficiency improvements were made to protect essential services and preserve financial flexibility. In spite of state payment delays that sometimes exceeded 16 weeks, Thresholds was this crisis without delaying payrolls or using lines of credit.
- Provided extensive support and advice to plaintiffs and the state in a successful Illinois Olmstead lawsuit which will reduce the use of nursing homes for people with severe mental illnesses. The settlement was certified in November 2010 and by 2011 Thresholds had begun moving class members into the community.
- Led the conversion of Thresholds' grant-based processes to a Medicaid based fee-for-service system. This included establishing staff productivity standards and performance management structures, developing new management and reporting systems, and creating stronger compliance and quality systems.
- Developed exciting new services including a program for adolescents with serious mental illness transitioning towards adulthood, community re-entry from corrections services, Illinois' first peer directed program, services to assist people leaving long-term nursing home care, services for veterans with severe mental illnesses, and housing and employment services for individuals with criminal histories and severe mental illness.
- Developed and expanded the use of high fidelity, evidence-based practices including integrated dual disorders treatment, supported employment, wellness management and recovery, smoking cessation, and assertive community treatment.
- Partnered with a Federally Qualified Health Center (FQHC) to open innovative integrated care clinics in two Thresholds locations.
- Restructured the Research Department as The Thresholds Institute. Working closely with the Dartmouth Psychiatric Research Center, the Institute's active translational research portfolio included more than a dozen projects in areas including supported employment, integrated dual disorders treatment services, smoking cessation, stigma, and jail and prison re-entry. From 2006 to 2011, Thresholds staff were authors on more than 45 published articles and book chapters. The Institute organized the first national conference on recovery and evidence-based practice which attracted more than 450 attendees.
- Reorganized and strengthened fund development resulting in doubling philanthropic revenue between 2003 and 2011 despite the 2008 to 2011 recession.
- From 2005 to 2011, Thresholds programs or staff received more than 40 awards including the American Psychiatric Association's Silver Achievement Award (for mental health/substance abuse services), the American Psychiatric Association's Gold Achievement Award (for supported employment), The Hitachi Foundation/ Annapolis Coalition's Pacesetter Award (for staff development), and two Substance Abuse and Mental Health Services Administration's

Science to Service Awards (for evidence based practice implementation). Thresholds was also designated as one of *Chicago's 101 Best & Brightest Companies to Work For* by the National Association of Business Resources for six consecutive years.

- Strengthened information systems with the installation of a new electronic medical records system in 2005, replaced fund development software, improved IT disaster recovery planning, and deployed an organization-wide voice over internet phone system.
- Hosted visitors from many states as well as from Germany, Mexico, Tanzania, Canada, Singapore, England, New Zealand, Australia, Japan, India, Taiwan, Canada, the Netherlands, and Israel. Established consulting relationships with organizations in Singapore and Pakistan.

Promoted to COO for the largest, non-profit behavioral health provider in Massachusetts, with a budget of over \$70,000,000, 200 program sites, and 1,400 employees. Accomplishments included:

- Increased revenues by \$9.5mm in first year as COO.
- Selection of Vinfen as the national model for behavioral health residential services by the National Mental Health Association.
- Development of Vinfen's first non-Massachusetts based programs. Increased revenues in this subsidiary by 66% in its first two years of operation.
- Development of Vinfen's first comprehensive risk management system, resulting in significant reductions in adverse incidents (e.g., a 50% reduction in worker days lost to injury and a 33% reduction in medication errors). Vinfen received the prestigious Negley Award for its work in this area.
- Development of several innovations, including: a nationally recognized peer education model for people with severe mental illness, a psychosocial rehabilitation oriented inpatient program, intensive crisis stabilization programs, and patented comprehensive, web-based client database.
