## REQUEST(S)

• Change-in-Zoning from R-6, Multi-family Residential to C-1, Commercial

- Waiver of Land Development Code, section 10.2 to reduce the width and planting material of the LBA between the proposed structure and adjacent residential property
- Detailed District Development Plan

#### **CASE SUMMARY**

A change in zoning from R-6 to C-1, Commercial for proposed mixed-use development has been requested. The subject property is located on Goss Avenue roughly ½ mile northwest of Eastern Parkway along a mixed-use corridor within a well-connected urban neighborhood. Goss Avenue is an arterial roadway and public transit is within walking distance from the subject site. Portions of an existing shotgun home will be retained. A commercial storefront will be provided and the rear will contain 4 dwelling units between 2-stories.

## **STAFF FINDING**

The proposal conforms to the land use and development policies of Plan 2040. The development plan and landscape waiver have each been adequately justified based on staff's analysis contained in the standard of review. A mixed-use development will be provided consistent with traditional approaches to mixed-use where commercial is provided along the frontage with residential to the rear and on the second level. The proposed district encourages vitality and a sense of place as it is located along an arterial roadway in a walkable urban neighborhood served by public transit.

## STANDARD OF REVIEW FOR ZONING DISTRICT CHANGES

Criteria for granting the proposed form district change/rezoning: KRS Chapter 100.213

- 1. The proposed form district/rezoning change complies with the applicable guidelines and policies Plan 2040; **OR**
- 2. The existing form district/zoning classification is inappropriate and the proposed classification is appropriate; **OR**
- 3. There have been major changes of an economic, physical, or social nature within the area involved which were not anticipated in Plan 2040 which have substantially altered the basic character of the area.

## STAFF ANALYSIS FOR CHANGE IN ZONING

The Following is a summary of staff's analysis of the proposed rezoning against the Land Use and Development Policies of Plan 2040:

#### The site is located in the Traditional Neighborhood Form District

This form is characterized by predominantly residential uses, by a grid pattern of streets with sidewalks and often including alleys. Residential lots are predominantly narrow and often deep, but the neighborhood may contain sections of larger estate lots, and also sections of lots on which appropriately integrated higher density residential uses may be located. The higher density uses are encouraged to be located in centers or near parks and open spaces having sufficient carrying capacity. There is usually a significant range of housing opportunities, including multi-family dwellings. Traditional neighborhoods often have and are encouraged to have a significant proportion of public open space such as parks or greenways, and may contain civic uses as well as appropriately located and integrated neighborhood centers with a mixture of mostly neighborhood- serving land uses such as offices, shops, restaurants and services. Although many existing traditional neighborhoods are fifty to one hundred twenty years old, it is hoped that the Traditional Neighborhood Form will be revitalized under the new Comprehensive Plan. Revitalization and reinforcement of the Traditional Neighborhood Form will require particular emphasis on (a) preservation and renovation of existing buildings in stable neighborhoods (if the building design is consistent with the predominant building design in those neighborhoods), (b) the preservation of the existing grid pattern of streets and alleys, (c) preservation of public open spaces

The proposed district would result in a slight expansion into an existing residential area. Despite this expansion, it would not appear that the neighborhood would experience a loss of housing, nor would traffic be increased beyond an acceptable limit as the site is along an arterial roadway in a walkable urban neighborhood. A mixed-use development will provide residential to the rear and retail along the frontage consistent with traditional approaches to mixed-use. Access to the subject site is through areas of mixed-intensity. The zoning change does not prevent the site from achieving a high level of design which is compatible with the surrounding area.

The proposed district is located along an arterial roadway in a walkable urban neighborhood served by public transit. Adequate infrastructure to serve the use appears to be available. The proposed districts encourages a mixture of compatible land uses in order to reduce traffic congestion by requiring fewer trips, support and enhance alternative modes of travel, and encourage vitality and a sense of place as the site is located along an arterial roadway in a walkable urban neighborhood served by public transit. Residential and office uses above retail and other mixed-use multi-story retail buildings are capable of being, and will be, provided on site. The proposal will not entail the demolition an existing structures that contribute the character of the area.

## STANDARD OF REVIEW AND STAFF ANALYSIS FOR WAIVER

(a) The waiver will not adversely affect adjacent property owners; and

STAFF: The waiver will not adversely affect adjacent property owners as the setback is consistent with existing setbacks and consistent with setbacks for corner commercial/mixed-use property throughout the neighborhood.

(b) The waiver will not violate specific guidelines of Cornerstone 2020; and

STAFF: Guideline 3, Policy 9 of Cornerstone 2020 calls for the protection of the character of residential areas, roadway corridors and public spaces from visual intrusions and mitigate when appropriate. Guideline 13, Policy 4 calls for ensuring appropriate landscape design standards for different land uses within urbanized, suburban, and rural areas. The character of residential areas are preserved as the proposal revitalizes and expands an existing structure and provides for appropriate screening without reducing plant material and/or trees.

(c) The extent of the waiver of the regulation is the minimum necessary to afford relief to the applicant; and

STAFF: The extent of the waiver of the regulation is the minimum necessary to afford relief to the applicant as the setback is consistent with existing setbacks and consistent with setbacks for corner commercial/mixed-use property throughout the neighborhood. The landscape buffer unreasonably restricts the reuse and revitalization of mixed-use development in walkable urban areas that are well-connected to transit.

#### (d) Either:

(i) The applicant has incorporated other design measures that exceed the minimums of the district and compensate for non-compliance with the requirements to be waived (net beneficial effect); **OR** 

(ii) The strict application of the provisions of the regulation would deprive the applicant of the reasonable use of the land or would create an unnecessary hardship on the applicant.

STAFF: The strict application of the provisions of the regulation would create an unnecessary hardship on the applicant as the landscape buffer unreasonably restricts the reuse and revitalization of mixed-use development in walkable urban areas that are well-connected to transit and all tree, screening and plant material will be provided.

## STANDARD OF REVIEW AND STAFF ANALYSIS FOR DETAILED DISTRICT DEVELOPMENT PLAN

a. The conservation of natural resources on the property proposed for development, including: trees and other living vegetation, steep slopes, water courses, flood plains, soils, air quality, scenic views, and historic sites;

STAFF: The conservation of natural resources on the property proposed for development, including: trees and other living vegetation, steep slopes, water courses, flood plains, soils, air quality, scenic views, and historic sites will be provided. The site was previously developed and the proposal will revitalize and expand the existing structure and provide tree canopy as required by the Land Development Code.

b. The provisions for safe and efficient vehicular and pedestrian transportation both within the development and the community;

STAFF: Provisions for safe and efficient vehicular and pedestrian transportation within and around the development and the community are provided as the site is located along an arterial roadway in a walkable urban neighborhood served by public transit.

c. The provision of sufficient open space (scenic and recreational) to meet the needs of the proposed development;

STAFF: open space is not required of the development and parks and other amenities for leisure are provided with this urban neighborhood.

d. The provision of adequate drainage facilities on the subject site in order to prevent drainage problems from occurring on the subject site or within the community;

STAFF: The Metropolitan Sewer District has approved the preliminary development plan and will ensure the provisions of adequate drainage facilities on the subject site in order to prevent drainage problems from occurring on the subject site or within the community.

e. The compatibility of the overall site design (location of buildings, parking lots, screening, landscaping) and land use or uses with the existing and projected future development of the area;

STAFF: The development tis compatible with existing land uses and the future growth of the area as the proposal will not entail the demolition of an existing structure that contributes the character of the area. A mixed-use development will be provided consistent with traditional approaches to mixed-use where commercial is provided along the frontage with residential to the rear and on the second level.

f. Conformance of the development plan with the Comprehensive Plan and Land Development Code. Revised plan certain development plans shall be evaluated for conformance with the non-residential and mixed-use intent of the form districts and comprehensive plan.

STAFF: The proposed development plan conforms to the Comprehensive Plan. The proposal is located along an arterial roadway in a walkable urban neighborhood served by public transit. Adequate infrastructure to serve the use appears to be available. The proposal encourages a mixture of compatible land uses in order to reduce traffic congestion by requiring fewer trips, support and enhance alternative modes of travel, and encourage vitality and a sense of place Residential and office uses above retail and other mixed-use multi-story retail buildings are capable of being, and will be, provided on site. The proposal will not entail the demolition an existing structure that contribute the character of the area

- RECOMMEND to the Louisville Metro Council that the change in zoning from R-6, Multi-family Residential to C-1, Commercial on property described in the attached legal description be APPROVED or DENIED

## 4. **Proposed Binding Elements**

- The development shall be in accordance with the approved district development plan, all
  applicable sections of the Land Development Code (LDC) and agreed upon binding elements
  unless amended pursuant to the Land Development Code. Any changes/additions/alterations of
  any binding element(s) shall be submitted to the Planning Commission or the Planning
  Commission's designee for review and approval; any changes/additions/alterations not so
  referred shall not be valid.
- 2. Before any permit (including but not limited to building, parking lot, change of use, site disturbance) is requested:
  - a. The development plan must receive full construction approval from Develop Louisville, Louisville Metro Public Works and the Metropolitan Sewer District.
  - b. Encroachment permits must be obtained from the Kentucky Transportation Cabinet.
  - The property owner/developer must obtain approval of a detailed plan for screening (buffering/landscaping) as described in Chapter 10 prior to requesting a building permit. Such plan shall be implemented prior to occupancy of the site and shall be maintained thereafter
  - d. The materials and design of proposed structures shall be substantially the same as depicted in the rendering as presented at the July 18, 2019 Planning Commission meeting. A copy of the approved rendering is available in the case file on record in the offices of the Louisville Metro Planning Commission.
- 3. A certificate of occupancy must be received from the appropriate code enforcement department prior to occupancy of the structure or land for the proposed use. All binding elements requiring action and approval must be implemented prior to requesting issuance of the certificate of occupancy, unless specifically waived by the Planning Commission.
- 4. The applicant, developer, or property owner shall provide copies of these binding elements to tenants, purchasers, contractors, subcontractors and other parties engaged in development of this site and shall advise them of the content of these binding elements. These binding elements shall run with the land and the owner of the property and occupant of the property shall at all times be responsible for compliance with these binding elements. At all times during development of the site, the applicant and developer, their heirs, successors; and assignees, contractors, subcontractors, and other parties engaged in development of the site, shall be responsible for compliance with these binding elements.
- 5. Construction fencing shall be erected when off-site trees or tree canopy exists within 3' of a common property line. Fencing shall be in place prior to any grading or construction to protect the existing root systems from compaction. The fencing shall enclose the entire area beneath the tree canopy and shall remain in place until all construction is completed. No parking, material storage or construction activities are permitted within the protected area.

## 3. Proposed Binding Elements

- 1. The development shall be in accordance with the approved district development plan, all applicable sections of the Land Development Code (LDC) and agreed upon binding elements unless amended pursuant to the Land Development Code. Any changes/additions/alterations of any binding element(s) shall be submitted to the Planning Commission or the Planning Commission's designee for review and approval; any changes/additions/alterations not so referred shall not be valid.
- 2. Before any permit (including but not limited to building, parking lot, change of use, site disturbance) is requested:
  - a. The development plan must receive full construction approval from Develop Louisville, Louisville Metro Public Works and the Metropolitan Sewer District.
  - b. Encroachment permits must be obtained from the Kentucky Transportation Cabinet.
  - The property owner/developer must obtain approval of a detailed plan for screening (buffering/landscaping) as described in Chapter 10 prior to requesting a building permit. Such plan shall be implemented prior to occupancy of the site and shall be maintained thereafter
  - d. The materials and design of proposed structures shall be substantially the same as depicted in the rendering as presented at the \_\_\_\_\_ Planning Commission meeting. A copy of the approved rendering is available in the case file on record in the offices of the Louisville Metro Planning Commission.
- 3. A certificate of occupancy must be received from the appropriate code enforcement department prior to occupancy of the structure or land for the proposed use. All binding elements requiring action and approval must be implemented prior to requesting issuance of the certificate of occupancy, unless specifically waived by the Planning Commission.
- 4. The applicant, developer, or property owner shall provide copies of these binding elements to tenants, purchasers, contractors, subcontractors and other parties engaged in development of this site and shall advise them of the content of these binding elements. These binding elements shall run with the land and the owner of the property and occupant of the property shall at all times be responsible for compliance with these binding elements. At all times during development of the site, the applicant and developer, their heirs, successors; and assignees, contractors, subcontractors, and other parties engaged in development of the site, shall be responsible for compliance with these binding elements.
- 5. Construction fencing shall be erected when off-site trees or tree canopy exists within 3' of a common property line. Fencing shall be in place prior to any grading or construction to protect the existing root systems from compaction. The fencing shall enclose the entire area beneath the tree canopy and shall remain in place until all construction is completed. No parking, material storage or construction activities are permitted within the protected area.

Change-in-Zoning from R-6, Multi-family Residential to C-1, Commercial

• Detailed District Development Plan

#### **CASE SUMMARY**

A change in zoning from R-6 to C-1, Commercial for proposed mixed use development is requested. The subject property is located on Goss Avenue roughly ½ mile northwest of Eastern parkway along a mixed-use corridor within an urban neighborhood. Goss avenue is an arterial roadway and public transit is within walking distance from the subject site.

#### **STAFF FINDING**

The density and intensity of the proposed district are appropriate based on locational and neighborhood conditions. It is located along an arterial roadway in a walkable urban neighborhood served by public transit. The district encourages a mix of complementary neighborhood serving businesses and services to encourage short trips easily made by walking or bicycling. A high level of compatible design should be provided to transition between residential areas and the arterial, mixed-use corridor.

#### **TECHNICAL REVIEW**

The design of the project should strive to achieve compatibility with the surrounding residential neighborhood and nearby commercial development (Goal 1, Policy 4, 9, 11, 12, 20; Goal 2, Policy 2, 3; Goal 4, Policy 1, 2, 3). Renderings will be needed to demonstrate compliance with Chapter 5, parts 5 & 6. The plan should demonstrate the separation between uses on-site, as well as their overall integration. Doors and windows shall be provided to face the primary street. There shall be no blank walls facing public streets, sidewalks, and adjacent front yards of residential uses. Ground floor facades at these locations shall be articulated to provide visual interest and a human scale that is representative of the form district. Such facades shall employ the use of windows, columns, pilasters, piers, variation of material, entrances, storefront windows, and other animating features along no less than 75 percent of their length. A consistent style of design should be provided on all sides as the site faces public streets and residential property.

The subject structure is potentially eligible for the National Register of Historic Places. This site will be subject to the requirements of the Wrecking Ordinance Subsection 150.110 and a potential 30-day hold on the permit. Staff recommends new construction that is compatible with the size, scale, color, material and character of the property and the neighborhood. Taking cues from the surroundings is a good way to ensure sensitive new construction in the district.

## STANDARD OF REVIEW FOR ZONING DISTRICT CHANGES

Criteria for granting the proposed form district change/rezoning: KRS Chapter 100.213

- 1. The proposed form district/rezoning change complies with the applicable guidelines and policies Plan 2040; **OR**
- 2. <u>The existing form district/zoning classification is inappropriate and the proposed classification is appropriate;</u> **OR**
- 3. There have been major changes of an economic, physical, or social nature within the area involved which were not anticipated in Plan 2040 which have substantially altered the basic character of the area.

#### STAFF ANALYSIS FOR CHANGE IN ZONING

The Following is a summary of staff's analysis of the proposed rezoning against the Land Use and Development Policies of Plan 2040:

#### The site is located in the Traditional Neighborhood Form District

This form is characterized by predominantly residential uses, by a grid pattern of streets with sidewalks and often including alleys. Residential lots are predominantly narrow and often deep, but the neighborhood may contain sections of larger estate lots, and also sections of lots on which appropriately integrated higher density residential uses may be located. The higher density uses are encouraged to be located in centers or near parks and open spaces having sufficient carrying capacity. There is usually a significant range of housing opportunities. including multi-family dwellings. Traditional neighborhoods often have and are encouraged to have a significant proportion of public open space such as parks or greenways, and may contain civic uses as well as appropriately located and integrated neighborhood centers with a mixture of mostly neighborhood- serving land uses such as offices, shops, restaurants and services. Although many existing traditional neighborhoods are fifty to one hundred twenty years old, it is hoped that the Traditional Neighborhood Form will be revitalized under the new Comprehensive Plan. Revitalization and reinforcement of the Traditional Neighborhood Form will require particular emphasis on (a) preservation and renovation of existing buildings in stable neighborhoods (if the building design is consistent with the predominant building design in those neighborhoods), (b) the preservation of the existing grid pattern of streets and alleys, (c) preservation of public open spaces

The proposed district would result in a slight expansion into an existing residential area. Despite this expansion, it would not appear that the neighborhood would experience a loss of loss of housing or traffic would be increase beyond an acceptable limit as the site is along and arterial roadway in a walkable urban neighborhood and a mixed-use development to provide residential to the rear and approve retail is proposed. The zoning change does not prevent the site from achieving a high level of design which is compatible with the surrounding area.

The proposed district encourages a compact development pattern that results in efficient land use and cost-effective infrastructure investment of mixed-uses within an urban neighborhood. The proposed district is located along an arterial roadway in a walkable urban neighborhood served by public transit. Adequate infrastructure to serve the use appears to be available. Traffic or noise would not appear to be increase beyond limits appropriate for the site based on neighborhood conditions. The density and intensity are appropriate based on these conditions.

The proposed district encourages a mix of complementary neighborhood serving businesses and services to encourage short trips easily made by walking or bicycling as the site located along an arterial roadway in a walkable urban neighborhood served by public transit. The site is located on within close proximity to public transit; thus reducing automobile trips as a means of achieving air quality standards and providing transportation and housing choices.

The proposed district allows an increase in the flexibility of provisioning for housing within proximity to multi-modal transportation corridors providing safe and convenient access to employment opportunities, as well as within proximity to amenities providing neighborhood goods and services.

A checklist containing staff's complete analysis of the Land Use and Development Policies of Plan 2040 is attached to the end of this staff report. The Louisville Metro Planning Commission is charged with making a recommendation to the Louisville Metro Council regarding the appropriateness of this zoning map amendment.
