# **PROFESSIONAL EXPERIENCE**

#### **Executive Director and State Historic Preservation Officer, Kentucky Heritage Council / State Historic Preservation Office**

For more than two decades, provided direction and leadership to a dynamic, award-winning state historic preservation office. Responsibilities included supervising a staff of 24 in three divisions:

- Site Protection and Archaeology Comprising the agency's professional archaeology component and federally mandated protection of historic properties listed in or eligible for the National Register of Historic Places
- Site Identification and Registration Responsible for managing the state's comprehensive inventory of historic sites, National Register nominations, planning and ongoing survey of historic resources
- Site Development Providing education and training, incentives such as the federal and state historic
  preservation tax credit programs, and technical and design assistance to encourage protection of and investment
  in Kentucky's historic places

As state historic preservation officer, responsible for implementing provisions of the National Historic Preservation Act, quarterly meetings of the Kentucky Historic Preservation Review Board, drafting the federal annual plan and progress reports. As executive director, responsible for implementing agency policies, achieving annual goals and objectives and overseeing grant programs. Other responsibilities included meeting with and advising grassroots and local preservation organizations, legislators and elected officials, community leaders and individuals; preparing and administering the agency's budget; overseeing a biennial state historic preservation conference; representing the agency at national conferences; and hiring and reviewing employees.

- Successful track record of outreach and developing partnerships with state and federal agencies and other organizations to achieve preservation goals
- Established the Kentucky Main Street Program, the oldest statewide Main Street program in the nation, based on the National Trust Four-Point approach and now serving more than 100 communities
- > Introduced Kentucky's first statewide rural preservation initiative
- > Worked in partnership with national, state and local organizations to emphasize military sites preservation
- Established the Kentucky Civil War Sites Preservation Program, a partnership that along with local "friends" organizations – has helped preserve more than 60 Civil War sites across the state
- Created the Kentucky Archaeological Survey, a partnership between the Kentucky Heritage Council and the University of Kentucky Department of Anthropology
- Led Kentucky to achieve the rank of fourth in the nation in the number of properties listed in the National Register of Historic Places, totaling nearly 3,200 districts, sites and structures encompassing 41,000 resources
- Kentucky also continues to be ranked Number One in the Preserve America program, whose honorary chair is First Lady Laura Bush, with 65 designated Preserve America Communities, three Preserve America Neighborhoods and one historic district.

# Manager, Site Development Program, Kentucky Heritage Council

Responsibilities included supervising a staff of three, expanding the Kentucky Main Street Program, overseeing the federal historic rehabilitation tax credit program, and administering historic preservation grants and technical assistance programs. Additional responsibilities included assisting the director in the development of policies related to these program areas, preparing federal and state reports and representing the agency at public functions.

#### **Preservation Planner, Kentucky Heritage Council**

Hired as the agency's first preservation planner. Duties included assisting local communities and organizations with preservation issues, working with Kentucky area development districts to include historic preservation in regional land use and zoning plans, assisting with the federal historic rehabilitation tax credit program and assisting the
