SUBURBAN HOSPITAL FROM COMMUNICATIONS OF A DISEASE, MYELOMA.

DIED AFTER BEING ELECTED PRESIDENT FOR THE FIFTH CONSECUTIVE TIME WHILE NOT BEING PRESENT FOR THE ELECTION. I HAVE SAID BEFORE, OUR FAMILY WILL BE FOREVER GRATEFUL FOR THAT. YOU SEE HE WATCHED THAT ELECTION IN NORTH SUBURBAN ANGRY BECAUSE WE WOULD NOT BRING HIM DOWN HERE. THE FIRST TIME I ADDRESSED THIS COUNCILS ABOUT THIS WAS FIVE YEARS AGO. I TOLD THE METRO COUNCIL WOULD BE MADE UP OF PEOPLE WHO NEVER KNEW JIM KING. 12 OF THE 26 MEMBERS ON THIS COUNCIL HAVE BEEN ELECTED SINCE MY BROTHER'S DEATH. IT'S HARD FOR ME TO BELIEVE IT'S BEEN ALMOST FIVE YEARS. SO MUCH HAS CHANGED. NOT ONLY TO MAKEUP OF THIS COUNCIL, BUT HIS HOME, CARS, FARM, THEY HAVE ALL BEEN SOLD. I SPEAK ABOUT ALL OF THIS BECAUSE WHEN IT COMES DOWN TO IT, IT DOESN'T MATTER HOW MUCH MONEY, POWER YOU HAVE OR HOW MANY THINGS YOU, IT MATTERS HOW YOU TREAT PEOPLE AND HOW YOU MAKE THEM FEEL. PEOPLE WILL ALWAYS REMEMBER WHEN A PERSON MAKES THEM FEEL GOOD. JIM MADE PEOPLE FEEL GOOD. WELL SOME PEOPLE HE DID. HE MADE THEM FEEL SAFE. HE MADE THEM FEEL LIKE EVERYTHING WAS GOING TO BE OKAY. I TELL YOU THIS BECAUSE IT'S IMPORTANT. IT'S IMPORTANT TO REMEMBER THE JOURNEY WE'RE ALL ON TOGETHER. JIM DIED AT THE AGE OF 63. AT A TIME WHERE HE FOUND HIS STRIDE. HE LOVED COMING HERE. HE WORKED HERE. HE WAS MAKING A DIFFERENCE IN OUR COMMUNITY. THIS BRINGS ME TO TONIGHT. WE CAN MAKE A DIFFERENCE TONIGHT. I AM ONCE AGAIN ASKING FOR YOUR SUPPORT. AS THE CURRENT BOARD CHAIR OF THE KENTUCKY CHAPTER OF THE LYMPHOMA SOCIETY, I'M HERE TO ASK YOU TO JOIN ON OCTOBER 10, 2019, THE WALK BEGINS AT 5:00. LOUISVILLE MAKE AS DIFFERENCE IN MANY PEOPLE'S LIVES. I CHOSE TO BE INVOLVED IN THIS EVENT AND THIS ORGANIZATION FOR TWO REASONS. ONE, BECAUSE IT HELPS LOCAL FAMILIES. SECOND, BECAUSE IT'S MAKING A DIFFERENCE GLOBALLY. AND THE PREVIOUS FOUR YEARS THE EVENT HAS RAISED ALMOST \$2 MILLION. I'M PROUD TO SAY THE KING TEAM RAISED ALMOST \$200,000. IN FISCAL YEAR '18, THE KENTUCKY AND SOUTHERN INDIANA CHAPTER DISTRIBUTED A MILLION TO PATIENT AND PATIENT CARE. OUR MONEY IS GOING BACK TO OUR COMMUNITY. PEOPLE WITH CANCER IN GENERAL MISS MORE WORK AND NEED MORE HELP. KENTUCKY IS STILL NUMBER ONE IN BLOOD CANCERS DIAGNOSED AND DEATHS. EVERYONE HAS LOST SOMEONE CLOSE. THIS DISEASE HAS GOTTEN SO BIG IT HAS BECOME PART OF LIFE. WE HAVE ACCEPTED IT AS PART OF OUR LIFE. REIMAGINE CHILDHOOD CANCER CURES. THE LATEST INITIATIVE FROM LLS. THERE ARE ONLY FOUR DRUGS SPECIFICALLY FOR KIDS WITH CANCER. AND NONE HAVE BEEN FOUND SINCE 1980. LLS IS INVESTING \$25 MILLION TO DO THE FIRST EVERY PEDIATRIC MASTER CLINICAL TRIAL. NO LESS THAN A WHOLE SHIFT IN THE STANDARD OF CARE, MOVING FROM TOXIC CHEMOTHERAPIES THAT LEAVES LIFE LONG HEALTH CHALLENGES TO SAFE TREATMENTS THAT PRECISELY TARGET CANCER WITHOUT HARMING THE REST OF THE CHILD'S BODY. THE PEDIATRIC TRIAL WILL SIMULTANEOUS TEST MULTIPLE, EXCUSE ME, I'M SORRY, MULTIPLE TARGETED THERAPY, MULTIPLE SITE AROUND THE UNITED STATES AND WORLD. IN 2018 OVER 350 RESEARCH PROJECTS. 48

NEW TREATMENTS APPROVED BY THE FDA IN 2018. 41 OF THOSE WERE FUNDED BY LLS. BLOOD CANCER IS AN ACTUAL OPPORTUNITY KILLER. -EQUAL. YOUNG, OLD, BLACK, WHITE, MALE, FEMALE, DEMOCRATIC OR REPUBLICAN. RELATIVE, FRIEND OR FAMILY MEMBER WHO HAVE SUFFERED FROM
DISEASES. USUALLY THOSE THAT WE KNOW CORRELATE, THEY UNDERSTAND.
EVERY ONCE IN A WHILE, WE COME ACROSS THINGS NOT SO KNOWN AND
SOMETIMES WE CAN USE THIS PLATFORM TO EDUCATE CONSTITUENTS,
FRIENDS AND NEIGHBORS AND ALSO HEALTH CARE PROFESSIONALS. AND SO
I KNOW THAT SEVERAL OF OUR CITIZENS MAYBE SUFFER FROM SYMPTOMS
LIKE GASTROPARESIS BUT THEY ARE UNAWARE OF THE NAMES FOR THE

DISEASE, THEY MAYBE MISDIAGNOSED. HE WAS UNAWARE FOR FIVE YEARS. WE WANTED TO MAKE AUGUST GASTROPARESIS MONTH SO PEOPLE AREN'T MISDIAGNOSED. AND SO WHILE WE DO HAVE SO MANY DIFFERENT GROUPS THAT WORK WITH DIFFERENT FORMS OF CANCER AND OTHER THINGS BROUGHT TO OUR ATTENTION. I THOUGHT IT WAS IMPORTANT FOR MR. TEWSLEY FOR COMING FROM AND THANK HIM FOR BRINGING THE INFORMATION. AND AUGUST HEREBY BE PROCLAIMED GASTROPARESIS MONTH. TO READ INTO THE RECORD. TO ALL WHOM THESE LETTERS SHALL COME KNOW YE, LOUISVILLE METRO PROCLAIMS AUGUST GASTROPARESIS MONTH. 4% OF THE POPULATION SUFFERS FROM THIS AND MILLIONS MORE GO UNDETECTED DUE TO SIMILARITIES AMONG OTHER KNOWN DIGESTIVE DISEASES. THE NATIONAL INSTITUTE OF DIABETES AND KIDNEY DISEASES REPORT 50% AND 30 TO 50% FROM TYPE 2 DIABETES SUFFER FROM GASTROPARESIS. WILL LEAD TO AN IMPROVED OUALITY OF LIFE FROM THOSE SUFFING FROM GASTROPARESIS. THE ONE AND ONLY, CEO OF THE DERBY FESTIVAL COMMITTEE. AND MIKE RECENTLY ANNOUNCED HIS RETIREMENT. AND THAT HE'S GOING TO TURNOVER THE HELM OF THE DERBY FESTIVAL. THAT MAKES US NERVOUS SO YOU KNOW. YOU HAVE DONE AN OUTSTANDING JOB OVER THE YEARS AS THE CEO OF THE DERBY FESTIVAL COMMITTEE AND DERBY FESTIVAL. IN OCTOBER OF 2015 I MET WITH GOVERNMENT STAKEHOLDERS TO TEST ONGOING ISSUES. IN 2017 DOWNTOWN RESTAURANTS HELD A SERIES OF MEETINGS AND THE COUNCIL PERSON, COUNCIL MEMBER. IN JUNE OF 2017 TWO LOCAL FOOD TRUCK OWNERS REPRESENTED SUED LOUISVILLE METRO ON A CONSTITUTIONAL CHALLENGE TO THE VENDING ORDINANCE. WE WON THE LAWSUIT. LOUISVILLE REPEALED PARTS OF IT IN 2018 AND ENTERED INTO A CONSENT DEGREE. A NEW VENDING ORDINANCE WAS INTRODUCED, IT WILL EFFECTIVELY PUT US OUT OF BUSINESS. PUBLIC SENTIMENT WAS ON OUR SIDE. LOUISVILLE METRO RECEIVED 736 COMMENTS WITH 99% OF RESPONDENTS FAVOR ACTION THE OPERATION. THAT PROPOSED ORDINANCE EXPIRED, ANOTHER WAS INTRODUCED. THE REASON, IN NOVEMBER OF 2018 THE INSTITUTE FOR JUSTICE FILED OPEN RECORDS REQUEST RELATED TO FOOD TRUCKS AND RESTAURANTS. COUNCILMEMBERS MADE NONE OF THE 8,300 RESPONSIVE DOCUMENTS AVAILABLE UNTIL THE KENTUCKY GENERAL RULED THE OPEN RECORDS ACT WAS VIOLATED AND I, FILED SUIT TO ENFORCE THE KENTUCKY DECISION. THE EMAILS REVEALED WHAT WE

EXPECTED. RESTAURANTS BELIEVE FOOD COMPETITION WAS THE REASON
THEY NEEDED TO KEEP THE TRUCKS AWAY. IN MARCH OF 2018 THEY ASKED
FOR NO FOOD TRUCK PARKING SIGNS. THEY FOLLOWED UP IN AN EMAIL.
AS SOON AS WE WERE ASKED TO POST THE SIGNS WE DID JUST THAT. I'M
PREPPED TO DO MY PART. THE MUNICIPALITY HAS THE LEGAL RIGHT TO
PROTECT SAFETY AND WELFARE. THIS IS DESIGNED TO MAKE FOOD TRUCKS
WORK HARDER AND MORE EXPENSIVE. TERMS ARE UNREFINED AND WE
BELIEVE VIOLATES THE CONSENT DECREE. WE HOPE YOU WILL NOT BE
INFLUENCED BY OUR COMPETITOR'S DESIRE TO HARM OUR BUSINESS. LAST
OCTOBER THIS ORDINANCE HAS BEEN A SOLUTION IN SEARCH OF A
PROBLEM. WE URGE YOU TO LISTEN TO PUBLIC WORKS FOR DENIAL. THIS
ORDINANCE DESERVES TO BE [INDISCERNIBLE] THANK YOU. [ APPLAUSE ]

>> LOUISVILLE METRO COUNCIL RECENTLY BALANCED PROTECTION OF FREE SPEECH WITH SAFETY FOR SIDEWALK USERS BUT TOUGH TO ENFORCE PEDESTRIAN SAFETY ORDINANCE. PLEASE GIVE THE SAME CONSIDERATION TO THE SIDEWALK OUTSIDE OF BMW ON WEST MARKET STREET IN DISTRICT 4. FALLS ON THE SIDEWALK ARE NOT UNCOMMON THIS YEAR A PROTESTER WAS HOSPITALIZED AFTER AN INCIDENT IN THE PROPOSED SAFETY ZONE AREA. IN A DISTURBING NEW TREND DRIVERS ARE PULLING CARS ONTO THE SIDEWALK TO MINIMIZE LOVED ONES EXPOSURE TO CROWDS WHEN ARRIVING AT APPOINTMENTS. THIS PUTS EVERYONE ON THE SIDEWALK IN GREAT DANGER INCLUDING SMALL CHILDREN. VISITORS, LIKE THE INTERNATIONAL CONVENTION CENTER, OFTEN STEP INTO MARKET STREET

TO AVOID THE PROTEST AND SHIELD CHAIR CHILDREN. MOVING THE PROBLEM TO THE ALLEY IS NOT A SOLUTION. SAFETY ZONE SAY A 10-FOOT ZONE WILLEN HINDER SPEECH. THEY CAN DEMONSTRATION ON THE REST OF THE SIDEWALK, THE COMMON WEALTH COUNSELING, WAITING PERIODS AND ULTRASOUNDS FOR EACH PATIENT. A SAFETY ZONE IS NOT TO APPROVE ABORTION ACCESS, IT IS A PUBLIC SAFETY MEASURE. OUR 10-FOOT ZONE IS MODELED AFTER THE TEMPORARY ZONE ENFORCED BY FEDERAL MARSHALS FOLLOWING A BLOCKADE IN 2017. THE 10-FOOT ZONE HAS BEEN ENFORCED BY THE KENTUCKY AND LOUISVILLE HEALTH LMPD ENFORCE THIS AND EXISTING LAWS. I LOOK FORWARD TO TALKING WITH MORE OF YOU ABOUT THE INFORMATION IN THE PACKET. EMW PATIENTS, I WAS TERRIFIED, THEY WERE BUMPING INTO ME. THE PRESSURE OF THE CROWD MADE ME NEARLY STUMBLE AND TRIP AS I TRIED TO ENTER. THEY WOULD NOT LEAVE ME ALONE WHEN I ASKED THEM TO. I WAS NERVOUS THE GUY CHANTING, KKK, HAD A GUN. THAT MEAN PEOPLE TRYING TO STOP ME FROM MY CHOICE IS SCARY. YOU CAN'T TELL IF THEY MAY ATTACK. WHO KNOWS HOW VIOLENT THE PERSON IS GOING TO BECOME. IT FELT LIKE A TERRIBLE INVASION OF PRIVACY. BEAID RAIDING A PERSON. TRYING TO CREATE AN OUTCOME THEY HAVE NO IDEA ABOUT. MY PERSONAL SPACE WAS INVADED. MY ACCESS WAS IMPEDED. THE SCREAMS WERE MORE THAN I CAN HANDLE AT THE AGE OF 18. THE INTIMIDATION REACHED ME INSIDE THE CLINIC. THE MEGAPHONES PENETRATING THE WAITING AREA. I FELT THE PROXIMITY WAS PUTTING US ALL IN DANGER. ESPECIALLY CONSIDERING THE VIOLENCE OUTSIDE. THEY KEPT ME FROM RETURNING FOR MY FOLLOW- UP APPOINTMENT. I HAVE NEVER BEEN MORE FRIGHTENED THAN I WAS THAT DAY. [ APPLAUSE ]

THE OPERATING BUDGET IS IT PREDICATED ON THIS RATE ADJUSTMENT. IN MANY YEARS, THAT 4% ALLOWED GROWTH REQUIRES A REDUCTION IN PROPERTY TAX RATES. AND BECAUSE OF THOSE REDUCTIONS, RATES ARE ACTUALLY LOWER IN THE COUNTY AND THE URBAN SERVICES DISTRICT THAN WHEN MERGER OCCURRED. THIS YEAR AS PREDICTED WHEN WE PASSED THE BUDGET, THE ALLOWED GROWTH REQUIRES A MODEST UPWARD ADJUSTMENT WITH A RATE OF 12.58 CENTS PER \$100 OF ASSESSED EVALUATION AND 3 CENTS 5.77 CENTS PER \$100 AS VALUATION IN THE USD. PUBLIC SAFETY UNIT, THE FIRE, EMS, THEY HAVE TO GET BACK HERE. AND I'M NOT SAYING IT'S IMPASSABLE YET BUT WE'RE GETTING THERE. IN AN ARRANGEMENT WITH THE CONDO ASSOCIATION THEY ARE PUTTING UP HALF, I'M PUTTING UP HALF OUT OF THE MDF. IF WE CAN FIND A CONTRACTOR TO CHIP IN, THAT WOULD BE GREAT. I'M HOPING WE CAN GET THE DEVELOPER THAT HAS AN AGREEMENT WITH PUBLIC WORKS TO PUT THIS IN. SOME INFORMATION RECENTLY ABOUT OVER A STUDY THAT IS CONDUCTED RELATED TO OUR PEDESTRIAN AND BICYCLE COLLISIONS WITHIN JEFFERSON COUNTY. AND IN THE LAST SEVEN YEARS, THERE HAVE BEEN 4,188 COLLISIONS WITH PEDESTRIANS AND/OR BICYCLISTS. THAT HAS BEEN MAPPED OUT AND SHOWN HOW MANY COLLISIONS HAVE BEEN IN EACH OF THE 26 METRO COUNCIL DISTRICTS. 882 OF THOSE 4188 ARE IN THE DISTRICT 4, WHICH IS THE DISTRICT I REPRESENT. SO WHEN I SAW THAT, I IMMEDIATELY THOUGHT OF SOME FOLLOW-UP QUESTIONS AND I HAVE SOUGHT INFORMATION. I'LL BE VOTING FOR THIS THIS EVENING. IF AND WHEN I RECEIVE ANSWERS TO MY QUESTIONS, COLLEAGUES, I'M GOING TO BE SHARING THIS ADDITIONAL DATA WITH YOU. THE QUESTIONS THAT I ASKED WERE. OF THE 882 COLLISIONS IN DISTRICT 4, WHICH COMPRISES OF THE CENTRAL BUSINESS DISTRICTS, I ASKED FOR THE RESIDENTIAL ZIP CODE OF THE INDIVIDUAL OR INDIVIDUALS WHO WERE COLLIDED WITH. BECAUSE, I KNOW THAT MORE THAN 70,000 PEOPLE ON ANY GIVEN DAY DRIVE INTO THE CENTRAL BUSINESS DISTRICT SIMPLY TO GO TO WORK. I NOT THAT YOU ALL MIGHT APPRECIATE KNOWING HOW MANY OF THE 882 IN THE 4THDISTRICT WERE ACTUALLY RESIDENTS LIVING IN ANY OF YOUR DISTRICTS. THE SECOND PIECE OF INFORMATION I HAVE REQUESTED AS WE TRY TO APPROACH AN ANSWER THE EQUITY QUESTION, I ASK IF WE COULD GET THE INFORMATION OF THE AGE AND THE RACE OF THE INDIVIDUALS WHO WERE PART OF THE COLLISION. I'M STILL WAITING FOR THAT INFORMATION. AND MR. PRESIDENT, WHEN I RECEIVE THAT, IF AND WHEN I DO RECEIVE THAT, I'LL BE MORE THAN HAPPY TO

SHARE THAT WITH MY COLLEAGUES. THANK YOU FOR SPONSORING THIS.

  MILES PER HOUR. I'M JUST CURIOUS, WILL THE BIKE LANE BE ON THE
  ROADS? OR WILL IT BE A BIG SIDEWALK IN THE GRASS OR RIGHT-OF-WAY
  NEXT TO THE BUSY ROAD WHERE THE SPEED LIMIT IS OVER 25. AND THE

  AREAS -- CERTAIN STREETS LIKE JOHNSONTON ROAD, WHERE YOU SHARE

  THE ROAD. AND I DON'T KNOW IF THEY CONSIDER THOSE BIKE LANES.

  IT'S MARKINGS ON THE ROAD WITH ARROWS AND A BICYCLE THAT, YOU

KNOW, YOU SHARE THE ROAD. JUST LIKE BEFORE. WITH ALL OF THE MARKERS.

IN THIS CHAMBER, OBVIOUSLY MOST OF KNOW THE AREA BIKE LANES, WHETHER OR NOT THEY ARE DRAWN OR NOT, WE DO THAT TO COMPETE FOR ECONOMIC DEVELOPMENT AND OTHER THINGS WE'RE TRYING TO BRING CORPORATIONS AND COMPANIES IN. PART THAT IS TO ACHIEVE THAT. WE DON'T ADVERTISE BUT WE KNOW THAT. PEOPLE WHO ARE RIDING BIKES ARE PERMITTING TO USE THE ROAD. WHEN THERE ARE DRAWN, YOU ARE RIGHT, COUNCIL MEMBER PARKER, PEOPLE ARE PREOCCUPIED. AND IT'S DANGEROUS. I HAD ANOTHER INJURY CASE FOR SOMEONE ON A BICYCLE. SOMEONES THEY HELP BRING AWARENESS TO THAT. IF THE BIKERS LET KNOW THEM. I DON'T THINK THIS --OBVIOUSLY, IT REQUIRES THE BIKE LANE TO BE DRAWN OR ON THE SIDE OF THE ROAD. WE KNOW IN TIGHT ECONOMIC TIMES, IT'S VERY UNLIKELY WE'RE GOING TO BE LIKE DENVER AND OTHER CITIES WHERE THEY HAVE SEPARATE BIKE LANES OR LIKE THE DIXIE HIGHWAY PROJECT. BUT THROUGHOUT THE METRO LOUISVILLE, IT'S LIKELY IN THE NEAR FUTURE. I THINK WE'RE TRYING TO ACHIEVE THAT FIRST WE HAVE THE BIKE LANES SO WE CAN COMPETE WITH CITIES THAT ARE KICKING OUR BUTT. AND THE OTHER PART IS TO DRAW THE ATTENTION WE HAVE PEOPLE RIDING BIKES ON THE STREET. SO PEOPLE DON'T END UP LIKE MY CLIENT. CRIPPLED.
  - >> PRESIDENT JAMES: THANK YOU. COUNCIL MEMBER PIAGENTINI.

>> THANK YOU, MR. PRESIDENT. I APPRECIATE THE INTENTION OF THIS ORDINANCE. I THINK IT'S WISE PUBLIC POLICY TO APPROACH INFRASTRUCTURE DEVELOPMENT. AND I'VE BEEN PREACHING SINCE THE BEGINNING OF THE BUDGET ISSUE THAT THIS CITY NEEDS TO GET BACK TO BASICS. AND BASICS IS INFRASTRUCTURE DEVELOPMENT. IT IS NOT THE ALBEIT, WHEN IN CASH TIMES -- I SUPPORT AN IDEA THAT IS DEVELOP NEW ROADS OR SUFFICIENTLY RECONSTRUCT THEM. WE WILL LOOK AT THEM IN THEIR TOTALITY IN THE TOTALITY OF MOVEMENT, WAYS THAT PEOPLE MOVE IN THEIR NEIGHBORHOODS AND THROUGH THOSE AREAS. AND THINGS EVEN LIKE BIKE LANES AS MUCH AS I THINK THEY ARE AN INTERESTING, LIKE A POLITICAL FOOTBALL, THAT TERM. BUT THEY ARE VERY APPLICABLE IN CERTAIN AREAS, NEIGHBORHOODS THAT DEMAND IT, THAT REASONABLY EXPECT IT. OTHERS WHERE THEY ABSOLUTELY DON'T. AND I DON'T KNOW IF I WAS MAYBE MISUNDERSTANDING MY COLLEAGUE, I'VE BEEN DOING DEVELOPMENT MOST OF MY LIFE. I CAN TELL YOU ALTHOUGH BUSINESSES WANT A CITY THAT HAS THE AMENITIES TO ATTRACT TALENT, THE NUMBER-ONE REASON BUSINESS MOVES TO A CITY IS HOW MUCH MONEY THEY MAKE PERIOD. THEY DO NOT DO A CALCULATION ON BIKE LANES. THERE IS PLENTY OF CITIES THAT ARE HEAVILY CAR DEPENDENT THAT DON'T HAVE BIKE LANES THAT ARE ABSOLUTELY EXPLODING IN ECONOMIC DEVELOPMENT. WITH THAT SAID, IT'S NOT TO IGNORE IT. AND I'M A HUGE SUPPORTER OF THE LOUISVILLE LOOP AND THE CONTINUED DEVELOPMENT IN MY DISTRICT AND THROUGHOUT THE CITY, MULTIUSE PATHWAY INCLUDING BIKES BUT OFF THE STREET. TO

COUNCIL MEMBER PARKER'S POINT WE HAVE TO EXPLORE THIS CONCEPT BUT WE CAN'T, IN A MODE THAT BIKE LANES MEANS STRIPING PART OF THE ROAD, WHICH I AGREE. I THINK COUNCIL MEMBER YATES SAID IT. COUNCIL MEMBER PARKER EXPRESSED HER CONCERN. IT'S NOT NECESSARILY IN SOME AREAS THE RIGHT SOLUTION TO COMING BOTH MODES OF TRANSPORTATION. THERE ARE OTHER WAYS TO ACCOMPLISH IT. MULTIMODAL SIDEWALK SITUATION. WHAT I WILL TELL YOU I'M GOING TO DO IS SUPPORT THIS AT THIS POINT. I THINK THE INTENTION IS RIGHT. BUT I THINK WE NEED TO LOOK AT THIS LIKE OTHER WELL-INTENTIONED, WE HAVE TO CHECK THE OUTCOMES OF THESE RESOLUTIONS AND ORDINANCES OVER TIME AND SEE WHAT THE ACTUAL IMPACT AND EFFECT IS AND BE READY TO REPEAL THOSE LAWS AND ORDINANCES IF WE DON'T FIND THEM ACCOMPLISHING THE GOAL OR GETTING IN THE WAY OF OTHER PROGRESS. AT THIS POINT, I THINK I APPRECIATE THE INTENTION, WE'LL SEE WHERE IT GOES. I SHARE SOME OF THE CONCERNED WITH THIS. AND READY TO EVALUATE THIS IN A YEAR OR OTHER REASONABLE PERIOD OF TIME TO SEE IF IT'S MET THE INTENTION. I WOULD ENCOURAGE PEOPLE TO REEXAMINE AND LOOK TO APPEAL.

- >> PRESIDENT JAMES: THANK YOU. COUNCIL MEMBER COAN.
- >> I SUPPORT THIS FOR MY COLLEAGUES ESPECIALLY, ONE OF THE CHEAPEST AND EASIEST WAYS TO MAKE THE STREETS SAFER AND MORE COMPLETE AND REDUCE FATAL INJURIES IS TO LOWER THE SPEED LIMIT. I THINK IT'S A FINE POLICY, YOU DON'T NEED BIKE LANES ON STREETS

WHERE IT'S 25 MILES PER HOUR. WE SHOULD LOWER MANY STREETS WHERE IT'S A SPEED LIMIT OF 35 TO 25. THE DIRECTOR OF PUBLIC WORKS HAS THE AUTHORITY TO DO THAT. TO THE EXTENT, I'VE DONE THAT, ON A STREET IN MY AREA. IT WAS PRETTY DANGEROUS. WE REDUCED IT FROM 35 TO 30. I COULDN'T GET DIRECTOR BURNS TO MAKE IT 25. IT'S DRAMATICALLY CHANGED IN THIS CASE, IT WAS COMBINED SPEED-RADAR SIGNAGE. THIS DRAMATICALLY CHANGED HOW SAFE PEOPLE ON THE STREET. IT COSTS THE PRICE OF SIGNAGE. AND I CAN'T REMEMBER THE STATISTICS. SO FORGIVE ME BUT IF YOU GET HIT BY A CAR AT 20 MILES PER HOUR, YOU ARE LIKELY TO SURVIVE. IF YOU GET BY A CAR AT 40 MILES AN HOUR, YOU ARE LIKELY NOT TO SURVIVE. THERE IS ANOTHER SOLUTION THAT SUPPORTS THIS WITHOUT BURDENING OURSELVES WITH INFRASTRUCTURE COST.

- >> PRESIDENT JAMES: COUNCIL MEMBER REED.
- >> THERE IS A MAJOR ROAD IN MY DISTRICT THAT IS SCHEDULED
  TO BE REPAVED IN THE NEXT COUPLE OF YEARS WHERE WE DON'T CONTROL
  THE SPEED LIMIT. THE SPEED LIMIT IS 45. WHEN IT IS REPAVED THEN
  WE WILL HAVE TO CREATE BIKE LANES. AND ON THAT ROAD, YOU HAVE
  MULTIPLE PINCH POINTS. I THINK YOU ARE CREATED A REALLY
  DANGEROUS SITUATION. MY QUESTION IS, 45 MILES AN HOUR BEING
  REPAVED, WE HAVE TO CREATE BIKE LANES? IS THAT THE WAY I'M
  UNDERSTANDING THIS? AN EXPLANATION PLEASE.
  - >> PRESIDENT JAMES: COUNCIL MEMBER YATES.

>> I BELIEVE, IT'S MY UNDERSTANDING THE COMPLETE STREET IS MAKING SURE PEOPLE HAVE MOBILITY. SOMETIMES WE RENAME THEM TO THE BIKE LANES. THE WAY IT MOVES IN AND OUT. BUT THEY STILL ARE ABLE TO TAKE INTO ACCOUNT. THAT WAS MY EXPLANATION WE TALKED ABOUT JOHNSON. SOME ROADS WILL ALWAYS BE DANGEROUS FOR BIKES. FOR INSTANCE, YOU HAVE NEVER HAD A BIKE LANE ON TO FREEWAY OR STATE ROADS. OBVIOUSLY, EACH ONE WILL BE TAKEN INTO ACCOUNT. YOU WANT TO MAKE SURE ON STREETS WHERE THERE IS MOBILITY, LIME SCOOTERS OR BIKES, YOU WANT TO MAKE SURE IT'S BROUGHT TO THE ATTENTION FOR THE CARS THAT THEY ARE GOING TO BE THERE. THIS IS THEIR AREA TO BE USED AND CREATE THIS OVERALL SAFER PLAIN. WITH THAT, METRO LOUISVILLE, WE'RE PERFECTLY LINED UP. THE COST OF LIVING IS LOW. BUT WE GET OUR BUTTS KICKED ON A LOT OF OTHER AREAS. AS COUNCIL MEMBER PIAGENTINI STATED, SOMETIMES WE GET A BETTER RETURN ON INVESTMENT. WHEN I SERVED AS PRESIDENT AND CONTINUED ON AS THE ECONOMIC DEVELOPMENT LIAISON AND GOING THROUGH AND LOOKING AT IT, WHEN WE FALL SHORT BECAUSE WHEN WE ATTRACT TALENT, THE REAL TALENT, IT'S HARD TO KEEP THEM. IT'S HARD TO BRING THEM AND KEEP THEM IN LOUISVILLE. WE'RE BENDING OVER BACKWARDS TO DO WHATEVER IT TAKES FOR THE MAJOR COMPANIES TO LOCATE HERE. THEY CAN MAKE MONEY BUT THEY CAN'T IF EMPLOYEES WILL NOT MOVE HERE. WE MAKE SURE IT'S MOBILE. WE MAKE SURE IT'S SAFE. AND SO THESE ARE ALL THINGS THAT GO INTO IT. WHEN WE LOOK AT THE COMPREHENSIVE PLANS, WE LOOK WITH THAT, IT IMPROVES OUR

COMPOSITION, IF IT MAKES WE CAN MAKE ENDS MEET, I'M FOR IT.

ESPECIALLY RIGHT NOW. WE NEED ANOTHER HUMANA. UNTIL WE CREATE

AND BECOME MORE COMPETITIVE. WE HAVE TO MAKE SURE WE'RE A PLACE

THAT THE EMPLOYEES, THE BEST EMPLOYEES WANT TO LIVE AND STAY. I

JUST WANT TO PLUG THAT IN IN DEFENSE OF THE EARLIER ARGUMENT.

THE EXPLANATION, COUNCIL MEMBER REED, THAT'S HOW IT WAS

EXPLAINED TO ME. I THROUGH A FIT ABOUT STREETS I THOUGHT IF YOU

PUT THE BIKE LANES THERE, PEOPLE RIDING BIKES WOULD THINK IT IS

APPROPRIATE. I THINK IT SENT THE WRONG MESSAGE. I WAS EXPLAINED,

NOT ALL STREETS.

>> THAT SORT OF ANSWERS MY QUESTION. AGAIN, THIS PARTICULAR ROAD IS SCHEDULED TO BE REPAVED IN THE NEXT COUPLE OF YEARS.

IT'S A ROAD THAT A LOT OF PEOPLE USE AND BIKE ON. IT'S DEBATABLE WHETHER OR NOT IT'S SAFE TO BIKE ON IT BUT THEY DO. ONCE IT'S REPAVED ARE WE GOING TO HAVE TO NARROW THE TWO LANES GOING IN BOTH DIRECTIONS BY SIX FEET TO CREATE BIKE LANES, PEDESTRIAN WALK WAY, WHATEVER. YOU CANNOT WIDEN THE ROAD. IT'S IMPOSSIBLE.

- >> PRESIDENT JAMES: COUNCIL MEMBER YATES.
- >> WE'RE REQUIRED ON THE STREETS, THERE IS MINIMUM

  REQUIREMENTS ON THE WIDTH. SO SOMETIMES WE'LL BE SHARED USES.

  MORE TO BRING ATTENTION. MAYBE ABLE TO ANSWER ON WHAT WOULD WE

  REQUIRED. WE COULD NOT REDUCE THE LANE SIZE BELOW THE MINIMUM

  REQUIREMENT. I DON'T THINK THERE IS ANYTHING WE CAN DO AT A

LOCAL LEVEL THAT WOULD ALLOW US TO BE IN VIOLATION OF A LAW. THE COUNTY ATTORNEY CAN ANSWER IF THEY WOULD RATHER.

>> PRESIDENT JAMES: THANK YOU. COUNTY ATTORNEY, DO YOU WISH TO SPEAK?

>> ASSISTANT COUNTY ATTORNEY, CAN YOU RESTATE THE QUESTION?
I THINK YOU WERE ASKING ABOUT PREEMPTION?

>> IT'S COUNCIL MEMBER REED'S QUESTION. AND SO HE MAY BE
ABLE TO ANSWER MORE THOROUGHLY. I THINK COUNCIL MEMBER REED WAS
ASKING, HE HAS A ROAD HE BELIEVES IS TOO DANGEROUS TO BE ON
BIKES AND DRIVE. IT'S GOING TO BE REPAVED IN THE NEXT YEAR OR
TWO. HE WANTS TO KNOW IF THEY HAVE TO BE STRIPED WITH A BIKE
LANE. MY UNDERSTANDING IS WE CAN NEVER REDUCE THE SIZE OF THE
LANE LOWER THAN MANDATED AT THE STATE LEVEL. WE'VE BEEN
PREEMPTED. SO WHAT DO WE DO IN THIS SITUATION?

>> PRESIDENT JAMES: PLEASE IDENTIFY YOURSELF?

>> I WORK AUTOLOUISVILLE METRO OFFICE OF ADVANCED PLANNING
AND SUSTAINABLE. THERE ARE MINIMUM WIDTHS. THE WAY THIS
ORDINANCE IS WRITTEN, A GENERAL REPAVING WOULDN'T REQUIRE
COMPLETE STREETS. IT'S ONLY A CHANGE TO THE GEOMETRY. WHEN THAT
HAPPENS, IT WOULD BE FORCED TO BE UNDER CONSIDERATION FOR
COMPLETE STREETS. ONE REALLY IMPORTANT POINT TO COUNCILWOMAN
PARKER'S QUESTION, WHEN WE ADOPTED THIS IN 2008 THIS WAS A
COMPLETE STREET DESIGNS MANUAL. WITH THIS ORDER BEFORE YOU NOW,
WE'RE NOT UPDATING THE DESIGN MANUAL YET. WE'RE LOOKING TO DO

THAT IN THE FUTURE. AND THAT IS THE DOCUMENT THAT WILL DICTATE

THE EXACT DESIGN AND ACCESSIBILITY HOW COMPLETE STREETS WILL BE

IMPLEMENTED. DOES THAT MAKE SENSE?

- >> JUST CONSIDERATION. NO MANDATION?
- >> CORRECT. EVERY ROAD NEEDS TO BE CONSIDERED FOR COMPLETE STREETS. THERE IS SPECIFIC EXCLUSIONS WRITTEN INTO THE ORDINANCE. THE COMPLETE STREET DESIGN MANUAL IS WHERE RUBBER WILL HIT THE ROAD.
  - >> PRESIDENT JAMES: THANK YOU. COUNCIL MEMBER REED?
  - >> FOR MY EDIFICATION, DEFINE GEOMETRY?
- >> ANY WIDENING OF THE ROADWAY. THIS IS SOMETHING AS WE
  DEVELOP THIS PROPOSED AMENDMENT AND THE LANGUAGE IN IT, WE WORK
  VERY SPECIFICALLY WITH THE DEPARTMENT OF PUBLIC WORKS BECAUSE OF
  THE COST OF CONSTANTLY HAVING TO ADD BIKE LANES OR SIDEWALKS.
  CHANGING OF GEOMETRY WOULD BE ADDING WIDTH AND A TURN LANE OR
  SOMETHING LIKE THAT. THAT WOULD ALTER THE GEOMETRY OF THE
  ROADWAY. IF YOU ARE CHANGING THE GEOMETRY. IF YOU REPAVE IT
  EXACTLY, IT WOULD NOT.
  - >> THAT ANSWERS MY QUESTION. THANK YOU.
  - >> SURE.
  - >> PRESIDENT JAMES: THANK YOU. COUNCIL MEMBER BLACKWELL.
- >> THANK YOU, MR. PRESIDENT. I WOULD LIKE TO ENCOURAGE MY COLLEAGUES TO SUPPORT THIS TONIGHT. WE HAD THE CONVERSATION AT OUR LAST MEETING ABOUT OUR PEDESTRIAN SAFETY ORDINANCE. IN THAT

DISCUSSION WE WERE TALKING ABOUT ALL THE DIFFERENT WAYS, EVEN IF WE PASS THE PEDESTRIAN SAFETY ORDINANCE, ALL THE DIFFERENT WAYS THE PEDESTRIANS STILL ARE UNSAFE, INCLUDING A LOT OF THE ROADS THAT LEAD TO SOME OF THE MORE HEAVILY USED ARTERIALS. DIXIE HIGHWAY, WHILE WE'RE DOING SOME IMPORTANT WORK ON DIXIE HIGHWAY IN TERMS OF PEDESTRIAN SAFETY, WE HAVE LOTS OF ROADS WHERE PEOPLE WALK IN THE ROAD AS OPPOSED TO ON SIDEWALKS IN EFFORTS TO GET TO A SAFER DIXIE HIGHWAY AND CATCH A BUS. THERE IS A LOT OF WORK TO BE DONE, PARTICULARLY IN THE AREAS THAT ARE, UNINCORPORATED AREAS WHERE THE STREETS WERE NOT DEVELOPED AND THE SIDEWALKS WERE NOT DEVELOPED. AND A LOT OF OUR FOLKS AREN'T USING CARS. AND SO IT IS IMPORTANT FOR US TO AT LEAST CONSIDER AS WE GO, I DO LIKE -- THERE IS NOTHING WORSE THAN TO SAY, NO MATTER WHAT THIS HAS TO BE DONE. BECAUSE SOMETIMES IT DOESN'T MAKE SENSE. WE CONSIDER AND LOOK FOR WHAT IS THE SAFEST ROUTE AS WE'RE DOING THIS, WHAT MAKES THE MOST SENSE. I THINK OUR CONSTITUENTS WILL BENEFIT FROM THIS POLICY. ENCOURAGE OUR SUPPORT.

- >> PRESIDENT JAMES: THANK YOU. COUNCIL MEMBER PEDEN.
- >> THANK YOU, MR. PRESIDENT. I STARTED OFF WITH QUESTIONS.

  BY THE TIME IT ROLLED AROUND TO ME, I HAVE TAKEN NOTES. TO

  START, I HAVE A QUESTION FOR ANYONE WHO IS AN EXPERT, MR.

  BALTIMORE IN THIS CASE. MOST OF MY ARTERIALS ARE STATE ROADS.

  ARE THEY EXEMPT IN ANYWAY? I MEAN, AM I GOING TO BE MINIMALLY

IMPACTED, THE SAME, IS IT DIFFERENT IF THERE IS PAVING VERSUS A DEVELOPER WHO BUILT A SUBDIVISION. I'M THINKING CEDAR CREEK ROAD, OR MAN SLICK ROAD, WHICH I HAVE THE EASTERN END OF MAN SLICK, AND I THINK MR. BLACKWELL HAS THE WESTERN END. I'M NOT SURE. ARE THOSE ROADS INCLUDED, I MEAN, AGAIN, JUST THE DIFFERENCE BETWEEN STATE ROADS AND COUNTY ROADS I GUESS IS WHAT I'M ASKING.

- >> YES, IT WOULD BE INCLUDED.
- >> WANTED TO MAKE SURE. AND THEN WOULD THAT BE TAKEN CARE
  OF AT THROUGH THE PLANNING AND ZONING, YOU HAVE TO SHOW WHERE
  YOU ARE FOLLOWING THIS?
  - >> PER THIS POLICY, YES.
- >> THAT'S FINE. I WANTED SOME OF THESE I ACTUALLY READ

  MYSELF. I WANTED TO MAKE SURE. NUMBER TWO, I THINK I BROUGHT

  THIS UP WHEN WE ADOPTED SOME BIKE LANE PROGRAMS SEVERAL YEARS

  AGO. IF SOMEBODY WANTS TO KNOW HOW TO DO BIKE LANES RIGHT, THERE

  ARE A LOT OF OTHER CITIES AROUND THE COUNTRY. IF ANYBODY WANT TO

  KNOW WHO IS AN EXPERT, YOU NEED TO GO TO THE NETHERLANDS. I'M

  TALKING ABOUT THE 1400S VERSION OF AMSTERDAM, ALL THE WAY TO THE

  RURAL AREAS I'M NOT SUGGESTING WE GO ON A GLIDE TRIP THERE. I'M

  TELLING YOU, EVEN IF YOU PULLED UP AMSTERDAM ON GOOGLE MAPS AND

  LOOKED AT THE SATELLITE PHOTOS, YOU KNOW WHERE THE BIKE LANES

  ARE. THERE ARE DIFFERENT COLORS. THEY ARE CURBED OFF. RED

  ASPHALT FOR THE BIKE LANE AND DIFFERENT COLOR FOR THE PEDESTRIAN

SECTION. YOU KNOW WHAT'S GOING ON. NOW, WHY IS THAT? BECAUSE THEY HAVE PARKING GARAGES THAT HOLD 10,000 BIKES. THAT'S WHY. BECAUSE THAT'S THEIR LIFESTYLE. DON'T EVEN THINK WE'RE GOING TO GET THAT WAY. BUT I'M SAYING, WE DON'T HAVE TO MAKE THIS UP FROM SCRATCH. THERE IS LOTS OF PLACES THAT DO THIS BETTER TO THE POINT IT DOESN'T BECOME A JOKE LATER ON SOCIAL MEDIA ABOUT BIKE LANE THIS AND BIKE LANE THAT. AND AGAIN, I'M GOING TO ECHO WHAT COUNCIL MEMBER BLACKWELL SAID, WHICH IS I WOULD HAPPY WITH SIDEWALK THIS AND THAT. FOR THE LAST 50 YEARS WE HAVE BEEN ALLOWING THE NEXT FEET OUTSIDE THE WHITE LINE IS DEDICATED TO DRAINAGE AND DITCHES. WHEN I WANT A SIDEWALK, IT'S ABOUT \$100,000 FOR A SIDEWALK, IT'S \$200,000 TO PIPE AND GUTTER AND EVERYTHING ELSE THAT GOES ALONG WITH THAT. THAT'S A PROBLEM IN NEED OF A SOLUTION BEFORE WE START TALKING ABOUT WIDENING ROADS AND ADDING BIKE LANES. I'M GOING TO FINISH UP WITH AND SOUND LIKE COUNCIL MEMBER BENSON FOR A MOMENT AND HE'S NOT HERE. PART OF THE OTHER ISSUE IS A TOTAL LACK OF CONNECTOR ROADS OUT IN THE SUBURBS CONNECTING DIXIE HIGHWAY TO TERRI OR CONNECTING BEULAH CHURCH ROAD WHERE THE FREEWAY ONRAMP TO CEDAR CREEK WHERE WE PUT IN 2 OR 3,000 HOUSES AND EVERYBODY HAS THE AREA. I'M GOING TO USE PIAGENTINI'S AREA FOR A MOMENT. IF IT WERE DONE CORRECTLY, NOT 30 YEARS AGO BUT LAKE FOREST PARKWAY WHICH RUNS FROM SHELBYVILLE TO OLD HENRY SHOULD HAVE BEEN A 35 MILES PER HOUR CONNECTOR ROAD AND EVERY OTHER ROAD BRANCHES OFF OF THAT. AND

NOBODY'S DRIVEWAY WOULD COME OUT ONTO THAT CONNECTOR ROAD. BUT WE DON'T MAKE PEOPLE DO THAT WHEN THEY FILE THESE PLANS. IT'S ALL 25 MILES PER HOUR RESIDENTIAL AND YOU WILL HAVE 10 MILES OF THAT. IF WE'RE NOT GOING TO INSIST ON A GRID SYSTEM LIKE YOU HAVE IN THE HIGHLANDS OR DOWNTOWN, WE'RE GOING TO HAVE TO DO SOMETHING. THAT'S ONE OF THE REASONS WE'RE HAVING THIS TALK RIGHT NOW. BECAUSE WE'RE RETROFITTING WHAT HAS BEEN BAD DESIGNS AS OF LAST WEEK. IT'S NOT EVEN LIKE WE CAN SAY WE FIXED IT AND WE'RE GOING BACK. WE'RE STILL APPROVING PLANS THAT AREN'T QUITE MULTIMODAL IN NATURE. AND SINCE HE MADE UP A WORD, I'M GOING TO USE MULTIMODAL.

>> PRESIDENT JAMES: THANK YOU, COUNCIL MEMBER PEDEN.
COUNCILWOMAN FLOOD.

>> [ OFF MIC ] EARN THE DOCUMENT LIKE THE ANNUAL REPORTING
THAT WILL COME TO US TO TELL US WHERE WE ARE IN THE PROCESS AND
THE PROCEDURES. BUT I WANT TODAY READ SINCE WHAT IS THE
DEFINITION OF COMPLETE STREETS? A COMPREHENSIVE AND CONNECTED
TRANSPORTATION NETWORK DESIGNED TO IMPLEMENT, OPERATED TO ALLOW
FOR SAFETY BY ALL YOU USERS, AGERS, INCOMES AND ABILITIES.
COMPLETE STREETS DESIGN STANDARDS FACILITATES THE DEVELOPMENT OF
A SAFE, RELIABLE, EFFICIENT, INTEGRATED AND CONNECTED MULTIMODAL TRANSPORTATION SYSTEM THAT PROMOTES ACCESS, MOBILITY FOR
USERS. SAFETY AND CONVENIENCE OF ALL USER OF THE TRANSPORTATION
SYSTEM ARE ACCOMMODATED, INCLUDING PRIVATE VEHICLES, PUBLIC

TRANSPORTATION, BICYCLISTS, THOSE ARE ASSISTED DEVICES,
WHEELCHAIRS, OR OTHER TYPES OF MOBILITY THINGS. I THINK YOU HAVE
TO TAKE INTO CONSIDERATION, I'M GOING TO ASK FOR THIS, IF I'M
BUILDING A BOX DOOR ON THE CORNER, SAY THERE IS A SIDEWALK IN
FRONT OF ME. NOW, THERE SHOULD BE A SIDEWALK FOR PEDESTRIANS OR
FOR THOSE WHO NEED WHEELCHAIRS TO GO FROM THE SIDEWALK FROM THE
STREET ALL THE WAY UP TO THAT NEW DEVELOPMENT. IS THAT CORRECT?

- >> THAT'S IN THE LAND DEVELOPMENT CODE.
- >> YOU CAN GET TO FROM A BUS STOP TO A MEDICAL OFFICE

  SAFELY WITHOUT HAVING TO GO THROUGH THE PARKING AREA. THESE ARE

  THE THINGS WE NEED TO -- WE HAVE A VERY AGING POPULATION. THERE

  IS MORE OF US THAT ARE GOING TO NEED DIFFERENT TYPES OF

  ASSISTANCE TO GET AROUND. THANK YOU.
  - >> PRESIDENT JAMES: THANK YOU. COUNCIL MEMBER HOLLANDER.
- >> THANK YOU, MR. PRESIDENT. I'M AN ENTHUSIASTIC SUPPORTER
  OF THIS ORDINANCE. IN MY DISTRICT, THE NUMBER-ONE ISSUE I HEAR
  ABOUT FROM CONSTITUENTS IS SPEEDING, WHICH CARS AND OTHER
  VEHICLES MOVE ON THE STREET AND THE DANGER IT CAUSES TO
  PEDESTRIANS, TO PEOPLE LIVING ON THE STREET. I ALSO SEE PEOPLE
  ON BIKES. EVERY DAY WHEN I LEAVE MY HOUSE, I SEE PEOPLE ON
  BIKES. TYPICALLY, YOUNG PEOPLE WITH BACKPACKS GOING TO WORK OR
  TO SCHOOL. AND SO, THE IDEA THAT WHENEVER WE REDESIGN A ROAD, WE
  WOULD LOOK AT A WAY TO MAKE IT SAFER FOR THOSE PEDESTRIANS AND
  FOR THOSE BICYCLISTS, IS SOMETHING I ABSOLUTELY WANT TO DO. ONE

OTHER COMMENT, IT GOES TO COUNCIL MEMBER PIAGENTINI'S POINT, I
ABSOLUTELY AGREE WE SHOULD REVIEW OUR EFFORTS ON A REGULAR
BASIS. ONE OF THE BENEFITS OF THE ORDINANCE, FOR THE FIRST TIME
WE'RE REQUIRING SPECIFIC PERFORMANCE MEASURES THAT WILL ALLOW US
TO DO THAT. WHICH IS NOT IN THE CURRENT COMPLETE STREETS
ORDINANCE. I THINK IT IS A REAL ADDITION TO OUR ORDINANCES AND I
URGE YOUR SUPPORT. THANK YOU.

- >> PRESIDENT JAMES: THANK YOU. COUNCILWOMAN FOWLER.
- >> THANK YOU, MR. PRESIDENT. MY PRESIDENT HAS DIXIE HIGHWAY FROM THE COUNTY LINE-UP TO WHERE IT MEETS GREEN WOOD ROAD IN COUNCIL MEMBER BLACKWELL'S DISTRICT. THERE ARE MORE PEDESTRIANS KILLED ON THAT STRETCH OF ROAD THAN ANYWHERE IN THE STATE. I'M IN FULL SUPPORT OF THIS. AND I WOULD HOPE THAT THE POWERS TO BE WITHIN PUBLIC WORKS AND WHOEVER COULD DO SIDEWALKS WOULD MAKE SURE THAT SOMEWHERE ALONG THE LINE THAT WE LOBBY WITH THE STATE TO GET THE GREENWOOD ROAD AND JOHNSONTON ROAD FINISHED TO DIXIE HIGHWAY SO PEOPLE CAN GET TO THE BRT. IT'S CRAZY. IT'S BEEN 15 YEARS THOSE BOTH WERE DONE. LIKE THE SIDEWALK TO NOWHERE. IT DID HELP WITH SOME OF THE SCHOOLS. IT'S JUST SO IMPORTANT. I HOPE WE'RE MOVING FORWARD ON THAT. THANK YOU.
  - >> PRESIDENT JAMES: THANK YOU. COUNCIL MEMBER KRAMER.
- >> I'M ABSOLUTELY ON BOARD. I THINK IT'S A GOOD IDEA TO

  TAKE A LOOK AND LOOKING OVER MY TENURE, I'VE BEEN ACTIVE IN

  ADDING SIDEWALKS TO MAKE THINGS SAFER. TO COUNCIL MEMBER PEDEN'S

POINT, TOO MANY OF US THAT LIVE IN THE SUBURBAN AREAS, WHEN WE ALLOW, WHEN THE COUNTY ALLOWED PAVING, THERE WE WANT MUCH THOUGHT GIVEN TO SIDEWALKS IN CERTAIN PLACES. IT IS A CHALLENGE. I HAVE A QUESTION, COULD THIS ORDINANCE BE USED TO REDUCE A DRIVING LANE IN ORDER TO CREATE A COMPLETE STREET INCLUDING SIDEWALKS? MORE SPECIFICALLY, RESPONDING TO THE QUESTION THAT COUNCIL MEMBER REED ASKED. THERE IS A STREET HE KNOWS IS GOING TO BE REPAVED. EXCLUSION. A SIMPLE REPAVING WOULD NOT MANDATE CONFIGURATION.

>> I BELIEVE I KNOW THE ANSWER. BUT I WANT TO BE CERTAIN I
HAVE A RIGHT. IF WE'RE TALKING ABOUT A STATE ROAD, WHICH I
BELIEVE THE ROAD THAT COUNCIL MEMBER REED WOULD BE TALKING ABOUT
WOULD BE, IT IS CURRENTLY FOUR LANES OF DRIVING TRAFFIC. I WOULD
THINK WE'RE NOT IN A POSITION TO REDUCE THE NUMBER OF LANES ON
THE STATE ROAD. IS THAT ACCURATE?

>> WE'RE NOT. WE WOULD WORK WITH KYTCC TO MAKE SURE WE DO THE BEST DESIGN.

- >> PRESIDENT JAMES: THANK YOU. COUNCIL MEMBER YATES.
- >> MR. PRESIDENT, I WOULD LIKE TO CALL THE QUESTION.

- >> PRESIDENT JAMES: THANK YOU. DO I HAVE A SECOND?
  >> SECOND.
- >> PRESIDENT JAMES: ALL IN FAVOR, SAY, "AYE." OPPOSED? AYES HAVE IT. THANK YOU, MR. KING. ALL RIGHT. THE AMENDED ORDINANCE IS BEFORE US. MR. CLERK, WOULD YOU PLEASE OPEN THE ROLL CALL FOR VOTING? WITHOUT OBJECTION THE VOTING IS CLOSING. AND THE VOTING IS CLOSED.
- >> MR. CLERK: 22 YES VOTES. ONE NO VOTE. THREE NOT VOTING.
  THE ONE NO IS COUNCIL MEMBER PARKER.
- >> PRESIDENT JAMES: THANK YOU, THE ORDINANCE PASSES. THE KENTUCKY ADVOCATES, I SEE YOU OUT THERE. THANK YOU, AARP, I SEE YOU OUT THERE. THANK YOU. AMERICAN HEART, SHANNON, GREAT JOB. THANK YOU, EVERYBODY. MR. CLERK, READING OF ITEM 54.
- >> MR. CLERK: AN ORDINANCE CHANGING THE ZONING FROM FROM R-6 MULTI-FAMILY RESIDENTIAL TO C-1 COMMERCIAL ON PROPERTY LOCATED AT 998 GOSS AVENUE CONTAINING 0.132 ACRES AND BEING IN LOUISVILLE METRO (CASE NO. 19ZONE1021). READ IN FULL.
- >> PRESIDENT JAMES: THANK YOU. MAY I HAVE A MOTION AND A SECOND? MOTION BY COUNCIL MEMBER YATES, SECONDED BY COUNCILWOMAN SEXTON SMITH. THE ORDINANCE IS BEFORE US. ANY DISCUSSION? COUNCIL MEMBER FLOOD.
- >> TO ALLOW A MIXED-USE DEVELOPMENT CONSISTING OF FOUR
  RESIDENTIAL UNITS TO THE REAR AND ON THE SECOND FLOOR WITH
  COMMERCIAL ON THE FRONTAGE OF THE BUILDING. THERE IS A SHOTGUN

HOUSE ON THE PROPERTY NOW. AND IT WILL REMAIN AND BE PART OF THE NEW DEVELOPMENT. IT'S ACROSS FROM WHAT WAS CALLED THE OLD HARDWARE STORE ON THE CORNER OF GOF AND GEORGE HAWK WAY. IN COUNCIL MEMBER MULVIHILL'S DISTRICT. HE MAY WANT TO ADDRESS.

- >> PRESIDENT JAMES: THANK YOU, COUNCIL MEMBER MULVIHILL.
- >> THANK YOU. THAT IS A GREAT EXPLANATION. IT'S UP IN

  GERMANY TOWN, BEFORE THE DEIGNY CONTEST WAS HELD THIS PAST JULY.

  IT DIDN'T HAVE ANY OPPOSITION AT THE PLANNING COMMISSION. IT WAS

  UNANIMOUSLY VOTED OUT OF COMMITTEE. I WOULD URGE APPROVAL. THANK

  YOU.
- >> PRESIDENT JAMES: THANK YOU. ANY FURTHER DISCUSSION?
  HEARING NONE, MR. CLERK, PLEASE OPEN THE VOTING. WITHOUT
  OBJECTION, THE VOTING IS CLOSING. AND THE VOTING IS CLOSED.
  - >> MR. CLERK: THERE ARE 23 YES VOTES. AND THREE NOT VOTING.
- >> PRESIDENT JAMES: THANK YOU. THE ORDINANCE PASSES. MR. CLERK, A READING OF ITEM 55.
- >> MR. CLERK: AN ORDINANCE AMENDING SUBSECTION 72.083, 72.085(A), AND REPEALING 115.350-369 AND REPLACING THEM WITH A REVISED 115.350-362 OF THE LOUISVILLE METRO CODE OF ORDINANCES (LMCO) TO IMPROVE UPON THE REGULATIONS OF ITINERANT VENDORS, PEDDLERS AND SOLICITORS (AS AMENDED). READ IN FULL.
- >> PRESIDENT JAMES: THANK YOU. MAY I HAVE A MOTION AND A SECOND? MOTION BY COUNCIL MEMBER TRIPLETT, SECONDED BY COUNCILWOMAN FOWLER. AND COUNCIL MEMBER MULVIHILL, COULD YOU

COME HERE FOR ONE MOMENT PLEASE? THANK YOU. LET THE RECORD REFLECT THAT COUNCIL MEMBER MULVIHILL IS ASSUMING THE CHAIR.

- >> MR. CLERK: SO NOTED.
- >> PRESIDENT JAMES: AND THE ORDINANCE IS BEFORE US. ANY DISCUSSION? COUNCIL MEMBER COAN.

>> THANK YOU, MR. PRESIDENT. THIS IS THE VENDOR'S ORDINANCE COLLEAGUES. WE TALKED A LITTLE BIT ABOUT IT IN OUR CAUCUS MEETINGS. IT'S ALMOST EIGHT YEARS AGO TO THE DAY THAT I CAME OVER TO THE PUBLIC SAFETY COMMITTEE. I WORKED IN THE MAYOR'S OFFICE AT THIS TIME. COUNCIL MEMBER PEDEN WAS THE CHAIR, COUNCIL MEMBER JAMES WAS THE VICE CHAIR. I BELIEVE COUNCIL MEMBER YATES AND FLOOD SERVED ON THAT COMMITTEE. I CAME FROM THE ADMINISTRATION TO AMEND CHAPTER 115, WHICH IS A VENDOR'S PEDDLER'S AND SOLICITORS LAW AS IT EXISTED AT THAT TIME TO CREATE RULES FOR FOOD TRUCKS, MOBILE FOOD UNITS. TO CREATE A REGULATORY SCHEME SO A NEW KIND OF BUSINESS COULD OPERATE LEGALLY, SAFELY AND AFFORDABLY IN LOUISVILLE. PRIOR TO PASSAGE OF THE LAW, ENTREPRENEURS WERE TRYING TO BOOTSTRAP TO SELL WHATEVER IT WAS THEY SOLD. PAYING \$75 AND HAVING TO MOVE EVERY TWO WEEKS FOR EVERY LOCATION THEY WERE IN. THEY HAD TO BE 400 FEET AWAY FROM EACH OTHER. AND A VARIETY OF OTHER RULES THAT MADE IT UNTENABLE FOR THEM TO DO BUSINESS. WE PASSED SECTION 115369 AND OTHER AMENDMENTS TO THE ORDINANCE. AND AT THE TIME, PEOPLE WERE WORRIED IT WAS A HUGE PROBLEM. ON FACEBOOK, THEY

SAID, THESE ORDINANCES KILL EVERY FOOD TRUCK. THEY END THE --DUE TO THE NEW ORDINANCE FOR FOOD TRUCKS WE CANCELED OUR PUBLIC EVENTS FOR THIS AND NEXT WEEK. I THINK TIME PROVED THE PANIC WAS UNWARRANTED. IN 2018 THERE WAS A RECORD 91 FOOD TRUCKS, IN ADDITION TO 7 MOBILE VENDORS AND 33 PUSH CARTS LIKE HOT DOGS, AND 123 VENDORS THAT HAD TEMPORARY LICENSES. IN THE LAST EIGHT YEARS MULTIPLE FOOD TRUCK OWNERS HAVE GONE ONTO OWN RESTAURANTS, CREATE PRODUCT LINES, BE FEATURED ON NATIONAL TV AND SERVE HUNDREDS OF THOUSANDS OF PEOPLE. IT WAS A TOTAL SURPRISE IN JUNE OF 2017 WHEN THE CITY OF SERVED OVER PORTIONS OF OUR LAW. WE DIDN'T LOSE THE LAWSUIT. WE SETTLED IT AND AGREED TO CHANGE LANGUAGE IN TERMS OF DISCRIMINATING AGAINST VENDORS THAT SOLD ONE PRODUCT VERSUS ANOTHER. WHAT WE DID IN CONJUNCTION WAS TO TAKE A LOOK AT THE ENTIRE ORDINANCE TO SEE IF ANYTHING ELSE NEEDED AMENDING EIGHT YEARS END SINCE THE INDUSTRY WAS LARGER THAN IT WAS AT THE TIME. GOT TOGETHER WITH PUBLIC WORKS, CODES AND REGULATIONS, THE PEOPLE WHO GOVERN THIS AREA AND TRIED TO SEE IF THERE WERE PUBLIC SAFETY, HEALTH, WELFARE ISSUES OF CONCERN. ANY LICENSING OR PERMITTING ISSUES OF CONCERN. WE TALKED ABOUT PARKING AND WHAT WAS FAIR. AND HOW THE ECONOMY WAS WORKING. AND WE CAME UP WITH SOME IDEAS FOR HOW TO AMEND THE ORDINANCE. WE THEN TOOK THE EXCEPTIONAL STEP, AS YOU KNOW, FOR 99% OF THE LEGISLATION WE COME UP WITH, IT GOES THROUGH THERE REGULAR COMMITTEE PROCESS WITH NO REAL PUBLIC INPUT. WE KNOW

THIS WAS SOMETHING THE PEOPLE WOULD BE INTERESTED. WE HELD PUBLIC HEARINGS, "CREATED A WEBSITE WITH AS MUCH INFORMATION, TOOK COMMENTS ONLINE AND WE DEBATED THE FIRST DRAFT OF THE ORDINANCE IN OUR PUBLIC WORKS COMMITTEE. WHEN WE HEARD FROM A LOT OF PEOPLE THAT SOME OF OUR IDEAS, THEY DIDN'T LIKE THEM. SO WE CHANGED THEM. AND CONTINUED TO WORK ON THIS ORDINANCE FOR THE LAST YEAR UNTIL WE HAVE THE FORM THAT IS IN FRONT OF YOU TODAY. AND I WILL SAY THE ORDINANCE ACTUALLY CAME OUT OF OUR COMMITTEE WITH A 4-3 RECOMMENDATION TO DENY THE CHANGES. YOU HEARD EARLIER TODAY FROM THE SPEAKER THIS WAS A -- THESE ARE CHANGES DESIGNED TO MAKE IT HARDER AND MORE EXPENSIVE FOR FOOD TRUCK AND OTHER VENDORS TO OPERATE AND THAT IS NOT TRUE. THIS ORDINANCE IS DESIGNED TO MAKE THE EASIER LICENSE REQUIREMENTS EASIER APPLICATION OF RENEWAL TO GIVE VENDORS NEW ACCESS TO OFFICE ZONED DISTRICTS WHICH CURRENTLY THEY ARE PROHIBITED FROM. TO ALLOW THEM TO BE CLOSER TO RESIDENTIALLY DISTRICTS THAN TODAY. AND PUT IN THE FEW IMPORTANT SAFETY PROVISIONS, INCLUDING RULES PERTAINING TO GENERATORS AND FUEL TANKS AND PARKING. IT SEEMS SOME CONFUSION ABOUT PEOPLE DISLIKING PARTS OF CHAPTER 115, SPECIFICALLY, THE VENDORS, PEDDLERS AND SOLICITORS ORDINANCE. WHY ARE WE LUMPING THEM IN ONE ORDINANCE? THAT IS HOW THE LAW IS TODAY. WHY ARE WE REQUIRING CRIMINAL BACKGROUND CHECKS FOR LICENSEES AND MAKING THEM PROVIDE CERTAIN INFORMATION PERTAINING TO THEIR PAST THAT MAY OR MAY NOT BE RELEVANT TO THEIR BUSINESS

TODAY. THAT'S IN THE ORDINANCE AS WRITTEN. WHAT WE ATTEMPTED TO DO IN A FEW KEY WAYS TO REDUCE THE BURDENS. GIVE THEM THE ABILITY TO OPERATE IN OFFICE ZONED ON PRIVATE OR PUBLIC PROPERTY. WE WANT TO REDUCE THE BACKGROUND CHECKS SO INSTEAD OF LOOKING AT 10 YEARS WORTH OF CONVICTIONS FOR ANY KIND OF VIOLATION, IT'S LIMIT TODAY FIVE YEARS AND TO SEXUAL CRIMES AND PECUNIARY. WE'RE -- LPL ON PRIVATE PROPERTY AHEAD OF TIME. WE'RE GIVING THEM THE RIGHT TO HAVE THINGS THEY ASKED FOR LIKE SIMPLE SIGNAGE. WE'RE TAKING AWAY REQUIREMENTS LIKE YOU HAVE TO HAVE A 30-GALLON GARBAGE CAN. WE'RE PUTTING IN WHAT I IER THREE KEY PUBLIC SAFETY. YOU CAN'T PUT FUEL TANKS ON THE STREET. IT'S CLEARLY A HAZARD. I DON'T THINK WE SHOULD WAIT FOR A TRAGEDY TO HAPPEN. THERE IS RULES PERTAINING TO DECIBEL LIMITS FOR GENERATORS. IT'S ALSO A PUBLIC SAFETY ISSUE. AND THEN WITH RESPECT TO PARKING, THE ORDINANCE SAYS THAT VENDORS ARE ALLOWED TO PARK ANYWHERE THAT IN THE PUBLIC RIGHT-OF-WAY THAT YOU ARE ALLOWED TO PARK WITH THREE NARROW EXCEPTIONS. ONE. THEY HAVE TO PARK SO THEY SERVE TO THE CURB SIDE. YOU CAN'T PARK TO SERVE INTO THE ROADWAY. YOU CAN'T SERVE IN THOSE DIAGONAL PARKING SPACES THAT EXIST AROUND THE CITY. THINK OF EAST MARKET STREET FOR THE DOUGLAS LOOP OR OTHER PLACES WHERE DIAGONAL PUBLIC PARKING HAS BEEN DESIGNED AND PROHIBITS PARKING IN ALLEYS. OTHERWISE, THE MAJORITY OF THE ORDINANCE IS A CLEAN-UP JOB OF SECTION 115. IT SHORTENS THE ORDINANCE BY 7 SECTIONS. AND IT

DOES NOT CREATE ANY NEW RESTRICTIONS ON THE ABILITY TO DO BUSINESS. WHAT'S NEW AND HAS BEEN CONSIDERED IN CONJUNCTION WITH CHAPTER 115 IS CHAPTER 72 THAT HAS TO DO WITH PARKING. THIS IS NOT SOMETHING THAT DATES BACK TO THE 2011 ORDINANCE, THIS IS SOMETHING WE LOOKED AT IN THE PAST COUPLE OF YEARS THAT HAS TO DO WITH RESERVING PARKING METER SPACES. AS THE LAW IS WRITTEN, VENDORS WHO ARE SELLING THINGS ARE THE ONLY COMMERCIAL INTEREST OR PRIVATE PROPERTY INTEREST IN THE CITY OF LOUISVILLE THAT ARE ALLOWED TO RESERVE PARKING METERS. IF YOU WANT TO SELL TACOS OUT OF YOUR TRUCK, YOU CAN RESERVE A PARKING METER AND DO THAT. IF YOU ARE AN ACCOUNTANT, YOU CAN'T. IF YOU ARE A RESTAURANT, YOU WANT TO RESERVE A PARKING METER FOR YOUR CLIENTELE, YOU CAN'T. IF YOU ARE A PRIVATE CITIZEN, YOU CAN'T DO THAT. I HAPPEN TO THINK THAT WAS UNFAIR AND AN OUTDATED PERMISSION CONTEMPLATED BEFORE OUR ECONOMY TODAY. IN A FAIR SYSTEM, EITHER EVERYONE SHOULD HAVE ACCESS OR NOBODY SHOULD. BUT OUR COMMITTEE DID NOT LIKE THAT. THE COMMITTEE DID NOT WANT TO PUT ANY CAP ON THE NUMBERS OF SPACES THAT CAN BE RESERVED. SO THE ONLY CHANGE BEFORE YOU TODAY WITH RESPECT TO CHAPTER 72 IS, TWO THINGS. ONE, SOMETHING THAT LIMITS ONE PERSON FROM RESERVING MORE THAN TWO METERS ON A BLOCK FOR VENDING PURPOSES. ALSO, CLEAN-UP LANGUAGE THAT UPDATES THERE IS LANGUAGE CURRENTLY THAT SAYS IF THE METER IS FLASHING YELLOW OR RED, IT SHOWS YOU ARE IN VIOLATION OF PARKING RULES. THAT'S OUTDATED BECAUSE THE TECHNOLOGY DOESN'T

WORK LIKE THAT. THOSE ARE THE CHANGES THAT ARE GENERALLY BEING PROFFERED IN THE ORDINANCE, WHICH CONSIDERS CHAPTER 72 AND 115. I THINK THESE ARE COMMON-SENSE CHANGES. THE PEDDLERS, VENDORS AND SOLICITORS ORDINANCE HAS BEEN AMENDED SEVERAL TIMES OVER THE DECADE SINCE ON THE BOOKS IN THE MID-80S. LIKE WE DO OFTEN TIMES, WE REVISIT THINGS AS THEY CHANGE. I'M HAPPY TO TAKE ANY QUESTIONS OR HEAR ANY COMMENTS ABOUT THE ORDINANCE. I THANK EVERYBODY WHO IN THE PUBLIC WHO TOOK TIME TO SUBMIT COMMENTS. AND EVERYBODY THAT WORKED ON THE PUBLIC WORKS COMMITTEE TO WORK ON THIS DIFFICULT PIECE OF LEGISLATION OVER THE PAST YEAR PLUS.

- >> PRESIDENT JAMES: THANK YOU. COUNCIL MEMBER SHANKLIN.
- >> THANK YOU, MR. PRESIDENT. I WOULD LIKE TO MAKE A MOTION TO INVOKE THE 90-MINUTE RULE.
  - >> SECOND.
- >> PRESIDENT JAMES: ALL IN FAVOR, SAY, "AYE." OPPOSED?

  THANK YOU. 90-MINUTE RULE IS IN FORCE AT 8:20. COUNCIL MEMBER

  WINKLER.
- >> THANK YOU, MR. PRESIDENT. AND I APPRECIATE ALL OF THE WORK THAT THE COMMITTEE HAS DONE AND THAT'S GONE INTO THIS AND THE DESIRE TO IMPROVE EXISTING LEGISLATION. I THINK THAT THERE ARE SEVERAL OPPORTUNITIES AND SEVERAL THINGS IN HERE THAT ARE -- COULD REQUIRE FURTHER, THE LIST EARLIER TO COUNCIL MEMBER COAN, INCLUDING THE DEFINITION OF PEDDLERS. IT INCLUDES ANY BUSINESS TO BUSINESS ORGANIZATION IN THE CITY THAT HAS SALES PEOPLE THAT

GO AS A NORMAL COURSE OF BUSINESS AND CALL ON CUSTOMERS. THOSE ARE DEFINED AS PEDDLERS AND REQUIRE A LICENSE. I DON'T THINK THAT'S THE INTENT OF THE ORDINANCE. I THINK WE SHOULD CLEAN IT UP. I THINK THERE ARE CONCERNS WITH THE WAY THAT MULTIPLE THINGS IN HERE ARE WRITTEN. THE PARKING RESTRICTIONS BEING PULLED OUT I THINK IS A CONCERN. TRYING TO BALANCE APPROPRIATE REGULATIONS AND THE FREE MARKET. AND I ENCOURAGE US TO SEND IT BACK TO COMMITTEE, TAKE ANOTHER LOOK AND DEFINE SOME OF THESE TERMS. I MAKE A MOTION TO SEND IT BACK TO COMMITTEE.

- >> SECOND.
- >> PRESIDENT JAMES: I HAVE A MOTION AND SECOND. COUNCIL MEMBER COAN.
- >> YEAH. OKAY. AGAIN, YOU KNOW, WE'VE WORKED ON THIS FOR A LONG TIME. WE'VE INCLUDED PUBLIC PROCESSES. IT'S SEEN MULTIPLE YEARS, MULTIPLE COMMITTEE CHAIRS. EVERYBODY IN THIS ROOM HAS HAD AN OPPORTUNITY TO LOOK AT THIS MANY, MANY TIMES. AND SO I'M NOT SURE WHAT THE BENEFIT OF SENDING IT BACK TO COMMITTEE IS. AND I GUESS IF YOU SEND IT BACK TO COMMITTEE, I WOULD EXPECT SOME RECOMMENDATIONS FROM PEOPLE. NO LAW IS PERFECT. NOT ONE IN THE LOUISVILLE METRO CODE OF ORDINANCES OR ANYWHERE ELSE. WE DO OUR BEST TO BALANCE ALL THE INTERESTS. AND TO MAKE RULES THAT ARE CONSTITUTIONAL AND EQUITY AND FAIR. AND WE REVISIT THEM AS WE NEED TO PURSUANT TO THE PROCESSES WE HAVE. WE'VE SPENT A LONG AMOUNT OF TIME ON THIS. IF WE'RE GOING TO SEND IT BACK TO

COMMITTEE, THEN I THINK WE NEED TO DO THAT WITH INTENTIONALITY

AND TIME LIMIT IN TERMS OF WHAT'S REQUIRED TO GET IT IN FRONT OF

THE BIGGER BODY FOR ATTENTION. THAT'S WHY WE VOTED OUT OF

COMMITTEE IN THE FIRST PLACE. WE COULD HAVE KEPT IT IN COMMITTEE

AND ARGUED ABOUT IT ALL DAY LONG. AFTER WE SYSTEMATICALLY WENT

THROUGH LINE BY LINE, THEY VOTED ON IT WITHOUT ANY QUESTIONS.

- >> PRESIDENT JAMES: THANK YOU. COUNCIL MEMBER WINKLER.
- >> I APPRECIATE YOUR POSITION. AND I AGREE AND COMMIT TO WORKING WITH YOU ON THIS. I DO THINK THERE ARE A NUMBER OF TERMS THAT ARE OVERLY VAGUE THAT REQUIRE ADDITIONAL DEFINITION. I QUESTION WHETHER THE ORDINANCE REALLY ACCOMPLISHES WHAT WE SET OUT TO ADDRESS. AND I DON'T THINK WE HAVE THAT APPROPRIATE BALANCE. LIKE I SAID, COMMIT TO WORKING WITH YOU ON COMMITTEE.
  - >> PRESIDENT JAMES: THANK YOU. COUNCIL MEMBER ACKERSON.
- >> THANK YOU, MR. PRESIDENT. WE TALKED ABOUT THIS IN
  CAUCUS, IN THE COMMITTEE OF THE WHOLE. A NUMBER OF FOLKS HAD
  QUESTIONS. COUNCILWOMAN SEXTON SMITH POINTED OUT, MOST
  LEGISLATION NEGOTIATION -- IN DOING SUCH I HOPE TO SEE THE FOLKS
  WHO RAISE QUESTION AND HAD CONCERNS WILL ATTEND THE COMMITTEE
  AND HELP COME UP WITH A BETTER PRODUCT. YOU KNOW, VERSUS SENDING
  IT BACK DO THE EXACT SAME LAPSE IT'S BEEN DOING. I CAN SUPPORT
  IT. IN DOING SO, I HOPE TO SEE A NUMBER OF YOU ALL ON THAT
  COMMITTEE. AND PUTTING YOUR TWO CENTS IN. THANKS.
  - >> PRESIDENT JAMES: THANK YOU. COUNCILWOMAN GEORGE.

>> THANK YOU, PRESIDENT. I WANT TO ECHO MY COLLEAGUES. I
WANT TO CLARIFY THERE HAS BEEN A PROCESS WE WENT LINE BY LINE
AND WHERE THERE IS BEEN SOLICITATION FOR SUGGESTED LANGUAGE. IF
IT WERE AS SIMPLE AS SENDINGS IT BACK FOR A RESOLUTION, WE CAN
AGREE, WE WOULD HAVE DONE THAT. CAN AGREE TO SEND IT BACK. CAN
WE HAVE A TIMELINE. WE HOPE TO SEE THE FOLKS WHO HAVE CONCERNS
HAVE REAL INPUT IN SUGGEST LANGUAGE IN MOVING FORWARD.

>> PRESIDENT JAMES: THANK YOU. COUNCIL MEMBER HOLLANDER.

>> AS A MEMBER OF THE COMMITTEE, I SUPPORT SENDING IT BACK.

AND I COMMIT TO WORKING ON IT. I COMMIT, I CERTAINLY -- OTHER

MEMBERS OUGHT TO. I REALLY WANT TO SPEAK ON SOMETHING THAT

COUNCIL MEMBER GEORGE SAID. I WANT TO SPEAK TO THE PEOPLE

[INDISCERNIBLE] FOOD TRUCKS. AND I THINK IT'S IMPERATIVE YOU NOT

SAY WE DON'T WANT CHANGES. BECAUSE I THINK YOU DO. BUT I ALSO

THINK THAT IF THIS IS SENT BACK TO COMMITTEE THERE NEEDS TO BE A

REAL DISCUSSION AND INPUT. I THINK YOU NEED TO BE WILLING TO

PARTICIPATE IN THAT CONVERSATION. THANK YOU.

>> PRESIDENT JAMES: THANK YOU. COUNCIL MEMBER HOLLANDER.

THE MOTION ON THE FLOOR RIGHT NOW IS TO SEND THIS LEGISLATION

BACK TO COMMITTEE. ALL IN FAVOR, SAY, "AYE." OPPOSED? AYES HAVE

IT. LEGISLATION WILL GO BACK TO COMMITTEE. MR. CLERK, READING OF

ITEM 56.

- >> MR. CLERK: A RESOLUTION DETERMINING CERTAIN PROPERTY AS SURPLUS AND NOT NEEDED FOR A GOVERNMENTAL PURPOSE AND AUTHORIZING ITS TRANSFER (AS AMENDED). READ IN FULL.
- >> PRESIDENT JAMES: THANK YOU, MAY I HAVE A MOTION AND A SECOND?
  - >> MOTION.
  - >> SECOND.
- >> PRESIDENT JAMES: MOTION BY COUNCIL MEMBER YATES,

  SECONDED BY COUNCIL MEMBER BLACKWELL. IT'S PROPERLY BEFORE US,

  IS THERE ANY DISCUSSION? COUNCIL MEMBER YATES?
- >> YES, MR. PRESIDENT. THIS IS THE INFAMOUS, 814 STREET
  PROPERTY. ALL OF US HERE HAVE HAD DISCUSSION AND INFORMATION.
  THIS WAS ORIGINALLY SPONSORED AND SUPPORTED BY COUNCILWOMAN
  SEXTON SMITH. AND THE ITEM WAS HELD NO BUSINESS, HELD FOR MANY,
  MANY MONTHS IN THE COMMITTEE. REQUESTS A SPONSOR. HEARD ON
  7/30/19 AND AMENDED AT THE REQUEST OF THE SPONSOR. AND
  ADDITIONAL FRIENDLY AMENDMENT AND APPROVED IN THE COMMITTEE ON
  8/13/19 AFTER A VERY IN-DEPTH REVIEW AND DISCUSSION. THE BROUGHT
  FORTH A DETAILED TIMELINE. AND JUST -- I'LL HAND THIS OVER TO
  THE PRIMARY SPONSOR. IN DOING SO AS CHAIR OF THE COMMITTEE I
  THINK I CAN SAY WE WERE PUT INTO A BAD POSITION AT A COUNCIL. WE
  HAD TO PICK BETWEEN TWO BAD CHOICES BUT ULTIMATELY, THIS PASSED
  UNANIMOUSLY FROM LABOR AND ECONOMIC DEVELOPMENT. BECAUSE AFTER
  THE LONG DISCUSSION APPEARED IT MAY BE THE BEST NEXT MOVE FOR

LOUISVILLE METRO REGARDLESS. WITH THAT, IF IT PLEASES THE OFFICER PRESIDENT, I'LL PASS IT OVER TO BARBARA SEXTON SMITH.

>> PRESIDENT JAMES: THANK YOU. COUNCILWOMAN SEXTON SMITH.

>> THANK YOU, MR. PRESIDENT AND MR. CHAIR. SO AS THE PRIMARY SPONSOR FOR THIS SURPLUS RESOLUTION, WHEN I ORIGINALLY FILED THIS RESOLUTION IN FEBRUARY, IT WAS LITERALLY MOMENTS, IF NOT JUST A FEW HOURS LATER THAT ADDITIONAL INFORMATION WAS BROUGHT TO MY ATTENTION. I WANT TODAY SHARE WITH MY COLLEAGUES THE REASON WITHIN DAYS OF MY FILING THE ORIGINAL RESOLUTION, I REACHED OUT TO PRESIDENT JAMES AND CHAIR YATES, SEEKING THEIR COOPERATION AND SUPPORT OF ME TO TABLE THIS OR TO NOT HAVE THIS EVEN CALLED UP IN COMMITTEE FOR DISCUSSION UNTIL I RECEIVED AS MUCH INFORMATION AS I COULD POSSIBLY GARNER SO WE WOULD MAKE AN INFORMED DECISION. THE ADDITIONAL INFORMATION THAT WAS BROUGHT TO MY ATTENTION WAS THAT FOR 814 VINE STREET, TWO SEPARATE AGREEMENTS HAD BEEN SIGNED BY LOUISVILLE FORWARD WITH TWO SEPARATE DEVELOPERS. AND ALTHOUGH, THAT WAS WITHIN THE LEGAL RIGHTS TO DO SO, I DID NOT THINK THAT IS GOOD BUSINESS. I DIDN'T THINK IT WAS A SOUND WAY TO APPROACH THIS PARTICULAR DEVELOPMENT AND THIS RESOLUTION. DURING THAT TIME, THERE HAVE BEEN TWO SETTLEMENT AGREEMENTS THAT HAVE BEEN SIGNED. AND I WOULD LIKE TO READ THE AMENDMENT, ALTHOUGH IT IS AVAILABLE. ALL MY COLLEAGUES HAVE IT. I WANT TODAY MAKE SURE FOR THE VIEWING PUBLIC, EVERYONE HEARS WE MADE AN AMENDMENT IN THE COMMITTEE PROCESS TO MAKE IT

ABUNDANTLY CLEAR WHAT ACTUALLY HAD TRANSPIRED AND THE REFERENCE TO THE TWO SETTLEMENT AGREEMENTS. ONE, THERE WERE TWO AGREEMENTS ON ONE PIECE OF PROPERTY. AND I WAS MADE AWARE OF THAT IN FEBRUARY OF 2019. FROM FEBRUARY OF 2019 UNTIL WHERE WE ARE TODAY, THIS PROPOSED RESOLUTION AS AMENDED IS PREDICATED ON TWO SETTLEMENT AGREEMENTS. THE CURRENT SETTLEMENT AGREEMENTS ARE AS AMENDED IN THIS IS RESOLUTION. PURSUANT TO THE SETTLEMENT AGREEMENTS, THE \$500,000 OPTION PAYMENT FROM PARAPRESERVATION TRUST AS WELL AS \$150,000 IN CARRYOVER FUNDS FROM LOUISVILLE FORWARD, FY19 CHAPTER BUDGET WILL BE PAID TO DEVELOPERS TO COMPENSATE FOR A PORTION OF THE COST IT INCURRED IN CONNECTION WITH THE PROPERTY. AND WHEREAS, THE SETTLEMENT AGREEMENTS ARE CONTINGENT UPON PASSAGE OF THE SURPLUS RESOLUTION. I FELT IT MY JOB, ONE PRIORITY WAS TO PROTECT THE TAXPAYERS MONEY AT EVERY TURN. AND I FEEL THAT ALTHOUGH, THIS IS NOT THE ULTIMATE AGREEMENT I WANTED TO SEE US MOVE FORWARD IT, ALL FOUR PARTIES ARE IN AGREEMENT AND THE TWO SETTLEMENT AGREEMENTS INDICATE THAT. THE FOUR PARTIES ARE: LOUISVILLE METRO GOVERNMENT, MARION GROUP, SOUND PRESERVATION TRUST. AND THE KENTUCKY CENTER FOR THE ARTS. MR. PRESIDENT, THAT'S ALL THE STATEMENTS THAT I WANTED TO MAKE AT THIS TIME.

>> PRESIDENT JAMES: THANK YOU VERY MUCH. COUNCIL MEMBER PIAGENTINI.

>> THANK YOU, MR. PRESIDENT. THIS DID PASS OUT OF COMMITTEE. I VOTED TO PASS IT OUT OF COMMITTEE AND I ENCOURAGE EVERYBODY TO DO SO. THERE IS A FEW THINGS I WOULD LIKE TO SAY. I SAID IT IN COMMITTEE. I WANT TO ADDRESS THIS WITH THE LARGER BODY BECAUSE WHAT I SEE HERE IS A VERY UNFORTUNATE TREND WITH HOW DEVELOP LOUISVILLE AND MORE BROADLY LOUISVILLE FORWARD HANDLES THESE PROPERTY DEALS, THE PROFITS OF THE PROPERTY DEALS, AND WE HAVE UNFORTUNATELY, WHAT I THINK IS INSUFFICIENT OVERSIGHT INTO THE PROCESS. I'M GOING TO ASK FOR YOUR ASSISTANCE. BOTH PARTIES, THE TWO MAIN PARTS ARE IN THE GALLERY TODAY. I WOULD LIKE TO SAY TO THEM AND THE TAXPAYERS WHO ARE GOING TO FOOT THE BILL FOR \$150,000 ARE FROM THE CAFRS FROM OUR TAXPAYERS, THIS ADMINISTRATION AND ITS MISTAKES FAILED THEM AND TAXPAYERS. THESE FOLKS WILL BE OUT OF MONEY AND TIME. THERE IS OPPORTUNITY COSTS THAT HAVE BEEN LOST. DIRECT COST THAT HAS BEEN LOST. SETTLEMENT AND TAXPAYER FUNDS THAT ARE GETTING TO MOVE BECAUSE OF MISTAKES BY THIS ADMINISTRATION. THIS IS NOT AN ISOLATED INCIDENT. I MET WITH MANY MEMBERS OF THIS COUNCIL. WE TALKED ABOUT PUBLICLY AND PRIVATELY A MULTITUDE OF INCIDENTS WHERE WE'VE SEEN SIMILAR SURPLUS PROPERTY MOVEMENTS AND/OR DEVELOPMENT OPPORTUNITIES THAT HAVE, LET'S CALL IT QUESTIONS ABOUT HOW THE DECISIONS WERE MADE RELATED TO THOSE DEVELOPMENTS, WHO MADE THOSE, WHY THEY WERE MADE, MISTAKES MADE IN THE PROCESS. DEVELOPERS WHO MADE -- WHO WERE GIVEN THE OPPORTUNITY

BY THE CITY TO MAKE MONEY WITHOUT DOING ANY WORK ON CERTAIN PROPERTIES. EGREGIOUS ABUSE OF THE PUBLIC PROJECT. I'M GOING TO ASK YOU TO COME ON AND SUPPORT THIS. WE ENGAGE IN MUCH MOREOVER SIGHT OF THIS PROCESS AND HOW IT WORKS. IN A SECOND, AS SOON AS WE VOTE, WE'RE GOING TO VOTE ON ANOTHER SURPLUS RESOLUTION. SO IN THIS PARTICULAR INCIDENT, WE HAVE A PIECE OF PROPERTY THAT WE SURPLUSSED FOR A DOLLAR, RIGHT, INTENDED FOR PPT OR KENTUCKY CENTER. WE THEN DOUBLE COMMITTED TO ANOTHER ORGANIZATION, TO THE MARION GROUP. THAT MISTAKE PUT US AT RISK. RIGHT? BUT THAT PIECE OF PROPERTY, AN ASSET THAT WAS THE CITIES IS OUT, PLUS WE'RE OUT OF MONEY AND ORGANIZATIONS ARE OF MONEY. WE'RE GOING TO VOTE ON A DIFFERENT SURPLUS PROPERTY TO A WONDERFUL ORGANIZATION. A FRATERNITY WHO WILL USE THE PROPERTY, DEVELOP IT, USE IT AS MEETING SPACE. AND THEY ARE PAYING \$50,000 FOR THAT PIECE OF PROPERTY. THIS PIECE OF PROPERTY HAD VALUE. THE PVA ORIGINALLY VALUED IT AT \$70,000. I DON'T KNOW HOW THAT WAS ESTABLISHED OR ASSUMED. WHEN NOW WE HAVE DIFFERENT GROUPS NOW PUTTING UP HUNDREDS OF THOUSANDS OF DOLLARS TO DEFEND THAT PROPERTY. CLEARLY, THERE IS SIGNIFICANT VALUE OR WAS, IN THAT PROPERTY. BETWEEN THAT, MAKING THOSE DECISIONS, HOW THOSE WERE MADE, ADD ON WHAT I SEE A MULTITUDE, AND THAT WAS SPELLED OUT, I WILL SAY, COMPLIMENT LOUISVILLE FORWARD. THEY CAME FORWARD WITH A TIMELINE OF ACTIVITY THEY READ THROUGH DURING THE COMMITTEE MEETING ASKED BY CHAIRMAN YATES. TO SPECIFICALLY GO THROUGH WHAT HAPPENED HERE

AND THE MISTAKES MADE. BUT WE NEED TO CORRECT IT AND WE NEED TO TAKE THE LEADERSHIP ON OVERSIGHT RELATED TO THIS DEPARTMENT AND WHAT THEY ARE DOING. WE HAVE MORE VISIBILITY AND MORE COMFORT TO DEFEND DECISIONS TO OUR CONSTITUENTS. THIS IS TOUGH FOR ME TO SWALLOW. I DON'T KNOW HOW TO DEFEND THIS, I THINK THE COST WILL BE WORSE IF WE DON'T MOVE FORWARD. WE'RE PUT THERE BY THE MISTAKES MADE BY THE ADMINISTRATION. AND I THINK WE NEED TO PUT A STOP TO IT. THANK YOU.

>> PRESIDENT JAMES: THANK YOU. COUNCIL MEMBER SHANKLIN.

>> THANK YOU, MR. PRESIDENT. I TOO FEEL THE SAME WAY THAT ANTHONY DOES. BECAUSE THE SAME THING HAPPENED IN MY DISTRICT. WE HAD A MASTER PLAN, THE COMMUNITY DID. AND THE ADMINISTRATION SAW IT OUT FROM UNDER THE MASTER PLAN. WE HAVE BEEN FIGHTING FOR THREE OR FOUR YEARS. THEY ARE TRYING TO PUT 20 SOMETHING HOUSES ON A HALF OF A BLOCK, AND A CHURCH. AND WE HAVE TO GO, YOU KNOW, GO ALONG, IT'S IN REVERSE IN MY DISTRICTS. IT'S NOT LIKE IN THE OTHER DISTRICT WHERE THEY ARE TRYING TO DO SOMETHING GOOD. THIS COMPANY IS TRYING TO PUT 21 HOUSES IN LESS THAN A BLOCK AND A HALF. PLUS, A CHURCH. IT HURTS OUR COMMUNITY BUT THE ADMINISTRATION EVEN THOUGH WE HAD A MASTER PLAN AND EVERYBODY LAID OUT AND COPIES OF THE MASTER PLAN AND WHAT THE COMMUNITY WAS GOING TO DO. ON TOP OF THAT IS THE WETLAND. SO THAT'S THE BAD PART ABOUT THE WHOLE THING. THANK YOU.

- >> PRESIDENT JAMES: THANK YOU. IS THERE ANY FURTHER

  DISCUSSION? HEARING NONE, THIS IS A VOTE REQUIRING A ROLL CALL

  VOTE. WILL THE CLERK PLEASE OPEN THE VOTING? -- OR A RESOLUTION.
  - >> MR. CLERK: I KNOW IT'S A RESOLUTION.
- >> PRESIDENT JAMES: WITHOUT O THE VOTING IS CLOSING.

  OBJECTION -- AND THE VOTING IS CLOSED.
  - >> MR. CLERK: 23 YES VOTES. AND THREE NOT VOTING.

  COUNCILWOMAN DORSEY, HER CONCERN WAS THE SAME AS COUNCIL MEMBER

  PIAGENTINI'S. HOWEVER, THIS IS A PROCUREMENT PROCESS. WITH THAT,

  BIDDING IS INVOLVED A BID WILL BE AWARDED TO THE MOST RESPONSIVE

  BIDDER. IF WE HAD ENTERTAINED ANYTHING DIFFERENT FROM WHAT

MUCH BUSINESS AND SERVICE TO THIS COMMITTEE. IT IS MY HOPE THAT WE WILL DEFINITELY APPROVE THIS THIS EVENING. HOWEVER, SINCE WE'RE ALL WEIGHING IN TO CHANNEL COUNCILWOMAN KEISHA DORSEY A LITTLE BIT THIS EVENING, I WOULD LIKE TO RESTATE A COMMENT SHE MADE TO ME.
