## REQUEST(S)

Conditional Use Permit to allow a private institution

## **CASE SUMMARY/BACKGROUND**

In a Chabad house, the rabbi and his wife host programs, activities, and services for the local Jewish community. The residence is both the Rabbi's personal home as well as the synagogue. The Chabad of Prospect serves on average ten families and the activities are as follows:

- A Jewish camp which has a total of 14 campers
- Communal Sabbath services twice on Friday nights a month from 7:00 p.m. to 9:00 p.m. The sanctuary is set up in a way to hold a maximum amount of 28 people.
- Holiday services and programming (as Jewish holidays arise)
- Chabad Hebrew School a Sunday bible school which meets on Sunday from 10:00 a.m. to 12:00 p.m.
- Adult bible study once a week starting at 8:00 p.m. to 9:00 p.m. which on average 5 people attend.

### STAFF FINDING / RECOMMENDATION

There are five listed requirements and item A. will be met. The applicant will be asking for relief from item C. to allow of-street parking to be located in front of the building. Item E. can be implemented by the Board of Zoning Adjustment if necessary. The applicant will need to discuss item B., and D. Based upon the information in the staff report and the testimony and evidence provided at the public hearing, the Board of Zoning Adjustment must determine if the proposal meets the standards established in the LDC for a Conditional Use Permit.

#### **TECHNICAL REVIEW**

There are no outstanding technical review items.

#### **INTERESTED PARTY COMMENTS**

A neighborhood meeting was held in September of 2018, but we don't know how many attended and May 14, 2019 which eleven people attended.

#### STANDARD OF REVIEW AND STAFF ANALYSIS FOR CONDITIONAL USE PERMIT

- 1. <u>Is the proposal consistent with applicable policies of the Comprehensive Plan?</u>
  - STAFF: The proposal meets all applicable policies of the Comprehensive Plan.
- 2. <u>Is the proposal compatible with surrounding land uses and the general character of the area including factors such as height, bulk, scale, intensity, traffic, noise, odor, drainage, dust, lighting and appearance?</u>
  - STAFF: When appropriately managed, the proposed use is compatible with surrounding development and land uses.
- 3. <u>Are necessary on-site and off-site public facilities such as transportation, sanitation, water, sewer, drainage, emergency services, education and recreation adequate to serve the proposed use?</u>
  - STAFF: The subject property is served by existing public utilities and facilities. Transportation Planning and MSD have reviewed and approved the proposal.
- 4. Does the proposal comply with the following specific standards required to obtain the conditional use permit requested?

Private institutional uses, except for such uses specifically regulated elsewhere in this LDC, may be allowed in the R-R, R-E, R-1, R-2, R-3, R-4, R-5, and U-N zoning districts upon the granting of a Conditional Use Permit and compliance with the listed requirements:

- A. Except in the R-R zoning district, all structures, except fencing, and all off-street parking shall be at least 30 feet from any property line adjacent to an existing residential use or residential zoning district. In the R-R zoning district all structures, except fencing, shall be at least 150 feet from any property line and all off-street parking shall be at least 30 feet from any property line. *The applicant has been informed of this requirement.*
- B. The applicant must demonstrate that the impact of the traffic generated by the use can be mitigated. *The applicant will discuss the traffic and any mitigation.*

- C. Off-street parking not located within a driveway shall be located to the side or rear of the building(s). The number of required off-street parking spaces shall be determined by the Planning Director in consultation with the Director of Public Works based on the standards for the closest comparable use and on the particular parking demand and trip generation characteristics of the proposed use. *The applicant will be asking for relief to allow off-street parking to be located in front of the building. The applicant states that there are sixteen parking spaces along the circular drive.*
- D. All activities shall be in compliance with the Metro Noise Ordinance (LMCO Chapter 99). *The applicant has been informed of this requirement.*
- E. The Board of Zoning Adjustment may set hours of operation for the institutional use in order to minimize potential negative impacts on surrounding residential properties. *The applicant has been informed of this requirement.*





# 3. Conditions of Approval

1. The site shall be developed in strict compliance with the approved development plan (including all notes thereon). No further development shall occur on the site without prior review and approval by the Board.

2. The Conditional Use Permit shall be "exercised" as described in KRS 100.237 within two years of the Board's vote on this case. If the Conditional Use Permit is not so exercised, the site shall not be used for a private institution until further review and approval by the Board.
