

PETITION

The Homeowners and Residents of the 1800 block of Date St. We are actively pursuing today and opposing the conditional use permits case numbers 18CUP1090 for 1830 Date St. We have numerous reasons and concerns towards the objection of issuing or granting these permits.

First and foremost, there is inadequate parking available, on many occasions multiple cars can and have been parked in front of Homeowners and Residents on Date St. This is an ongoing struggle for the Residents within a 25-yards radius. The three homes in questioning have been operating up to 2 years without a CUP. Residents on Date St return home from a hard day's work, forced to park several houses away and walk home. Angie Fenfro knows each of her neighbors owns vehicles and disrespectfully has not addressed our concerns. Questionable if Angie Renfro even cares or value any of the Residents parking concerns. LMPD has been dispatched several times to address situations dealing with Carol Cloud. Fenfro has called law enforcement regularly on Carol Cloud which has resulted in her being handcuffed and escorted away. Carol Cloud seems to return weeks later, one occasion after returning Carol was strapped down like an animal in front of the Date St. Residents. Cloud has Multiple Scleroses and doesn't appear to threaten anyone, she can barely walk without shaking. Cloud symptoms doesn't suggest that she has been involved in any trafficking or drug related issues. The reasons for her being placed in these homes are unknown. Angie Fenfro has complete control of Cloud's finances, Cloud has retired and previously worked in Law Enforcement. Carol Cloud told the police that her entire retirement check was confiscated by Renfro and she requested it back before the officers took her away during a disturbance. LMPD has engaged in several evictions and disturbance runs to the housing under Angie Renfro control. Carol has undergone physical, mental, verbal abuse and witness's have observed these actions. Primarily this type of abuse takes place when the ladies that occupy the housing are being kicked out into the streets without the opportunity to recovery their belonging. Renfro has been seen placing items out in the trash and on the porch later. These evictions have led to the increase of human trafficking on Date St. Angie Renfro can best describe and explain the enormous LMPD calls to the housing under her control.

Residents have witness and heard Angie Renfro embarrassing and humiliating these already fractured women many times. Renfro has been asked not to address these ladies in public and conduct her business professionally indoors but to no avail. I was told by one of her occupants (Ashley) that living in the homes under Angie Renfro was comparable to living in hell. Another source provided information that Renfro take control, confiscate the lady's financial assets and uses for personal gain. Renfro knows Ashley very well, there could be criminal activity on behalf of Angie Renfro but without any oversight and the occupancies 'fear of retaliation Ashley last name is omitted.

Again, these properties go completely unsupervised, no oversight provided for the ladies living in these houses. Angie Renfro goes home to her personal home every evening. Renfro does not live in any of these houses. Renfro will state that the houses are attended by Ms. Bee when she is not present, however we disagree and find it impossible that one person could oversee 3 houses with 5-10 occupants. Ms. Bee resides across the street from 2 of the houses and there is no way possible she could supervise these properties the entire night.

We the Residents of Date St. must endure constant disturbing activities. Examples: Car traffic pulling in and out late into the night. Occupants running out to these vehicles mimicking some form of exchange, maybe drug trafficking. Picking up occupants on the corners indicating illegal soliciting, especially since this doesn't take place legitimately in front of where some of these ladies reside. Renfro does not bear witness nor have made any attempt to alleviate the revolving human trafficking that takes place. These homes supposed to be a haven for these ladies, it is clearly not. Katrina Powell and her daughter stayed in these houses, the two were seen behind the house smoking crack in the alleyway. The Powell's are not human trafficking victims.

We the Date St. Homeowners and Residents believe that the Christy Love Foundation is a complete fraud. This foundation does not represent LOVE. Angie Renfro will probably provide witnesses to speak on her behalf, non-credible. Angie Renfro will confront this committee and shed tears which lack the true compassion required to run her foundation. She has exhibited these types of action during past interviews and in front of key members of the community. Mayor Greg Fisher, Councilwoman Barbara Sexton, and Attorney General Andy Beshear.

Residents of Date St. are witness to the true off camera Angie Renfro, we have seen this act many times before in the past. The true off camera Renfro has displayed hurtful, disrespectful, emotionless, mental and physical abuse toward the occupants under her guidance.

All the reasons stated above we the Homeowners and Residents of Date St. ask that these CUP's be denied for the foundation.

street Date we are tired of it

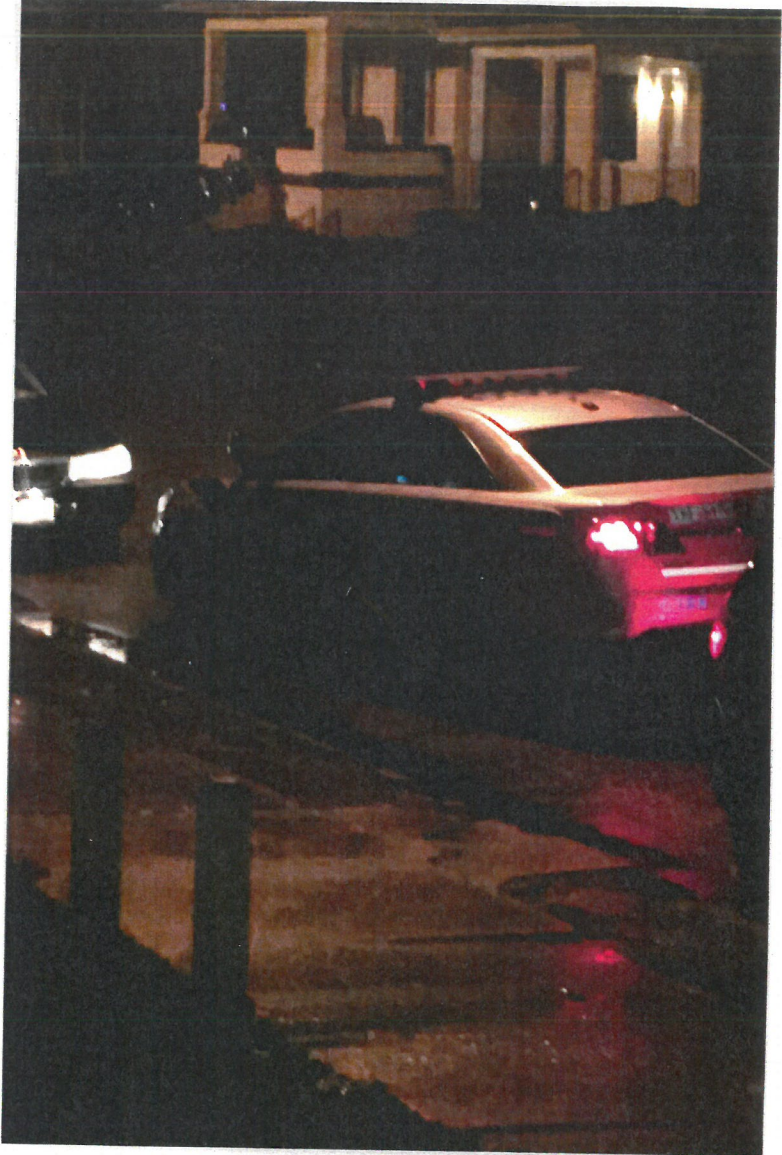
