Re: Summary of the meeting for the Conditional Use Permit for Fisherville Baptist Church parking lot expansion

Dear Case Manager,

A neighborhood meeting was held for this project on Tuesday, April 25th, 2019 at 6:00 pm at Fisherville Baptist Church located 14910 Taylorsville Road. Discussed at the meetings were the process for a Conditional Use Permit Application and the Pre- Application Plan that was filed. During the meeting neighbors expressed the following concerns:

- If any trees were going to be removed with this plan.
 - o No trees would be removed or added with this plan.
- Would there be any new lights in the parking lot expansion.
 - o The existing light poles are sufficient and no new lights would be added.
- Would the rear of the building be hidden with plantings
 - o The church would need to meet to make a determination, not part of plan
- Would the church possibly paint the back of the building
 - o The church would need to meet to make a determination, not part of plan
- They were worried that a sidewalk would interfere with existing trees on the site and did not want to lose any trees
- No one had any problems with the expanded parking and proposed restriping.
