Neighborhood Meeting 1036 Lampton Conditional Use Permit for Short Term Rentals Property Owner: Shannon P Higgins Musselman

Gant Hill introduced Jonathan Klunk, facilitator of the meeting and the prospective property manager of the property in question. Jonathan has over 70 units, handles community relations, occupant conversations, ground maintenance, cleanliness, etc.

Jonathan

 Gave overview of what short term rentals are, what the ordinance requires / limits / allows, and where 1036 Lampton is in the process. Encouraged everyone to speak up as notes were being taken and would be included in the case review. Also told everyone that letters of opinion could be filed and would be on the record.

Concerns / Opposition

- There are illegally operating short-term rentals in the neighborhood that are poorly managed. These properties cause disturbances. Will this property be like those?
 - Jonathan asked if the neighbors had called 311 to report those disturbances and the residents said they had not. He told them the process and encouraged them to report the illegal activity.
 - o Jonathan reiterated that this would be a legal, professionally managed short-term rental. His company has a 24/7-call center that residents can communicate with if there are issues; he shares his contact information so neighbors can get in touch with him in real time if there is an issue. In this case the owner is also actively involved so there are two sets of eyes on the property.
 - o The owner also has security cameras on the property.
- Added traffic from Paristown Hall is making parking tight in the neighborhood. How will this property add to that problem?
 - Jonathan answered that this property is allotted 1-2 vehicles legally on the street due to local zoning and that the owner is planning to lease an additional space from the parking lot behind the house.

Support

- There are legally operating short-term rental properties in the next neighborhood over and the homeowner does not allow parties. We have no issues with the short-term rentals. He has a certain age minimum and minimum night stay. There are people up the street closer to the objecting resident that do not follow these rules.
- Yes, parking on Lampton is tighter with Paristown Hall, but there is still plenty of parking in the neighborhood, especially on Vine Street, which is where I live. It isn't going to hurt to walk an extra block when there is a concert. It's good for the neighborhood.
