| WHEREAS, LLC is engaged in the refurbishing and re- opening of the former Paper Mill, including without limitation the construction and renovation of the Property, acquisition and installation of new equipment, and updating of technology (the "Project") which will accommodate industry and create jobs in County, Kentucky (the "County"); and |

| WHEREAS, the County Fiscal Court, for the reasons above stated, desires to support the request of Simple for up to Simple for the Project from the Kentucky Economic Development Cabinet through the Economic Development Fund ("EDF") program, which funding will enable substantial employment for residents of the County; and |
| WHEREAS, it is appropriate that this Resolution be adopted in order to evidence such support. |
| NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE FISCAL COURT OF COUNTY, KENTUCKY AS FOLLOWS: |
| Section 1. It is hereby found, determined and declared that the statements of fact set forth in the preamble to this Resolution are true and accurate in all respects, and the preamble |

and all of the recitals therein are incorporated in this Resolution by reference, as if set forth verbatim herein.

Section 2. The County Fiscal Court hereby supports the request of LLC for funding from the Kentucky Economic Development Cabinet through the Economic Development Fund for the refurbishing and re-opening of the former Paper Mill. Furthermore, the County Fiscal Court agrees to be responsible for administering the funds awarded from the Economic Development Fund and shall make disbursements thereof in accordance with guidelines of the Economic Development Fund.

Section 3. This Resolution shall be in full force and effect from and after its adoption.
