 TONIGHT. MY NAME IS STEVEN, I'M A RESIDENT OF DISTRICT SEVEN AND
 A MEMBER OF THE COMMONWEALTH. I'M HERE IN SUPPORT FOR IMPROVING
 RIGHTS FOR RESIDENTS AS A WHOLE. SEVERAL NEIGHBORHOODS AROUND
 THE CITY THERE'S A LOT OF PRESSURE BEING PLACED ON RESIDENTS WHO
 ALREADY LIVE HERE. WE SEE THIS IN LARGE INCREASES OF RENT. THE

RISING NUMBER OF PEOPLE LIVING ON THE STREETS. I SEE IT PERSONALLY IN OUR HALL OF JUSTICE. WHEN THESE EVICTIONS ARE COMBINED WITH THE VITAL SERVICES THAT THE CITY PASSED THIS LAST YEAR. THE RUG IS BEING PULLED OUT. IN THIS PARTICULAR CASE, THE CITY IS HELPING SPEAR HEAD, WHETHER THROUGH TAX INCENTIVE THIS REQUIRES THE CITY TO BE EXTRA VIGILANT. AT A COUNCIL MEETING A COUPLE MONTHS BACK WE HEARD HOW RESIDENTS ARE FALLING THROUGH THE SYSTEM AND BEING EVICTED AFTER REPORTING CODE VIOLATIONS IN THEIR HOUSES. THIS ISSUE HAS COME UP TOO OFTEN. I KNOW FOR THE PUBLIC THIS PROCESS WAS A BIT DISJOINTED BUT I CAN TELL YOU FROM THE STREET LEVEL, IT'S GOVERNMENT AND ACTION. THIS WAS A BIPARTISAN PIECE OF LEGISLATION. THE ADMINISTRATION AND COUNCIL WORKED TOGETHER TO GET US TO WHERE WE ARE TODAY. I'M VERY PROUD OF THAT. THANK YOU MADAM CHAIR I COMMEND YOU AND I'LL BE VOTING FOR THAT.
- >> THANK YOU. I THINK WE NEED A SECOND ON THE AMENDMENT SUBSTITUTION. SO WE CAN HAVE A VOTE. ALL IN FAVOR. WE'RE GOOD. ALL RIGHT. THANK YOU.
- >> THANK YOU, MR. PRESIDENT. I ENTERED THIS DISCUSSION

 ABOUT GOLF COURSES IMMEDIATELY AFTER THE DISCUSSION LAST YEAR

 ABOUT THIS TIME. A LITTLE BIT LATER THAN THIS, MARCH OR APRIL

WHEN THE MAYOR CAME OUT AND SUGGESTED WE WERE GOING TO HAVE A HUGE-FOLLOWING THE BUDGET. THE MAYOR PUT IN THE BUDGET LANGUAGE THAT MADE IT CLEAR THAT OUR GOLF COURSES WOULD BE FUNDING IN JANUARY. WE WOULDN'T BE ABLE TO RUN GOLF IN THE WAY THAT WE HAD. THE PLAN-THE STATE PLANNED TO HIRE SOMEONE HOPEFULLY AN OUT SIDE FIRM. THE COUNCIL MADE IT CLEAR THAT THAT WAS SOMETHING WE DID NOT WANT TO HAPPEN. THE MAYOR MADE IT CLEAR THAT ENCOURAGING THE GOLF COURSES AND THAT WAS NOT SOMETHING WE WERE INTERESTED IN. DID NOT KNOW UNTIL AFTER THE DECISION WAS MADE THAT WE WOULD BE CLOSING LIBRARIES AND SCHOOLS. THIS WAS THE ONE THING HE TOLD ME. WHEN WE MADE IT CLEAR THAT MOVING IN THAT DIRECTION WAS NOT SOMETHING THE COUNCIL WAS INTERESTED IN THEN, AND ONLY THEN DID THE MAYOR START THE INTERACTION AND CONVERSATION WITH US ON THE COUNCIL'S SIDE OF THE STREET. MUCH OF THE WHAT THE ADMINISTRATION FOUND THEMSELVES STRUGGLING WITH WAS HOW TO CONTRACT WITH PROFESSIONALS IN A WAY THAT'S CONSISTENT WITH THE ORDINANCES THAT WE WROTE BECAUSE WE WERE VERY CONCERNED ABOUT WHAT WAS COMING. THE CONTRACT THAT WE HAVE BEFORE US ARE MUCH BETTER ATTEMPT AT BEING REVENUE NEUTRAL. THEY ARE MUCH BETTER CONTRACTS FOR US MOVING FORWARD. IF YOU LOOK AT WHAT IT MEANS FOR THE PROS. IT SOUNDS LIKE IT'S BETTER FOR US. THE PROS ARE SOMEHOW LOSING IN THE DEAL-THAT'S ACTUALLY NOT TRUE. IF YOU LOOK OVER THE YEARS AND BALANCE IT OUT. IT DEPENDS ON THE WEATHER AND A COUPLE OTHER THINGS. WHO GOES UP AND WHO GOES DOWN. IT'S

REALLY PRETTY CLOSE. BUT FOR US IT MAKES THIS A NEAR REVENUE NEUTRAL VENTURE. IN THAT SENSE I COULDN'T BE MORE PLEASED WITH WHAT WE'VE BEEN PRESENTED AND THE CONTRACTS THAT WE HAVE. THAT BEING SAID, THERE ARE TWO OUTSTANDING CONCERNS. ONE, THE PROCESS THAT WE WENT THROUGH TO GET HERE DOESN'T FEEL IT'S FAIR-THAT PROCESS WAS NOT ONE THAT THE COUNCIL WAS INVOLVED. WE WERE TOLD AFTER THE FACT HOW THEY HAD DONE IT. WE WERE GIVEN SOME INFORMATION OF HOW IT UNFOLDED. THAT WAS DISCOURAGING AT BEST. EVEN IF YOU CAN GET PASSED THAT. THERE ARE SIX CONTRACTS NOT NINE. THERE ARE NINE COURSES. OUR ORDINANCES SAY THAT ALL NINE COURSES, TEN-THAT WE ARE SUPPOSED TO HAVE CONTRACTS FOR. IT SAYS THAT THE MAYOR DOESN'T HAVE A CONTRACT FOR ALL NINE AND THE METRO PARKS THAT CONTINUE TO RUN THOSE. I BELIEVE IT SAYS FOR THREE MONTHS. THE PROBLEM IS AT THE END OF THOSE THREE MONTHS IF THERE'S NOT A PRO IN PLACE, WHAT IS THE EFFECT? THEY HAVE TO GET A PRO. WE PUT IN THE BUDGET IN THE SUMMER, LANGUAGE THAT SAID YOU HAVE TO OPEN THE LIBRARY. YOU PUT MONEY IN THE BUDGET TO MAKE THAT POSSIBLE. IT TOOK FOUR MONTHS TO OPEN THE MIDDLE TOWN BRANCH. IT'S STILL NOT RUNNING IN THE SAME WAY OR ON THE SAME HOURS AS THE REST OF THE LIBRARY SYSTEM. WE WERE TOLD WE DIDN'T PUT ENOUGH IN TO OPEN IT BACK UP TO THE SAME AMOUNT. BECAUSE WE DIDN'T OPEN THE LIBRARY FOR FOUR MONTHS. WE PUT FOUR MONTHS IN THE BUDGET THAT WASN'T USED. THERE'S NO REASON THAT IT SHOULDN'T BE OPENED THE WAY IT WAS AND IT'S STILL NOT. SPECIFICALLY WE

WOULD WORK TOGETHER WITH THE CITY OF MIDDLE TOWN AND TRY TO FIND A RESOLUTION SO WHEN THE CONTRACT ON RENT ENDED IN MAY OR JUNE WE'LL BE ABLE TO MOVE THE MIDDLE TOWN LIBRARY DESPITE THE MAYOR'S BEST EFFORTS, WE HAVE NOT BEEN ABLE TO REACH AN AGREEMENT. I WORRY THAT WHEN HAD THE RENT-WHEN THE CONTRACT RUNS OUT THE LIBRARY IN MIDDLE TOWN WILL CLOSE AGAIN. NOT BECAUSE THERE'S NO MONEY FOR IT BUT BECAUSE THE MAYOR DECIDED IT WOULD CLOSE AND WHEN THE CONTRACT WAS OPENED IT, HE DID IT BEGRUDGINGLY. I'M NOT CONFIDENT, I'M NOT CONVINCED THAT SHOULD WE PASS THIS LEGISLATION TONIGHT, THOSE OTHER THREE COURSES WILL EVER GET PROS. I WORRY VERY MUCH THAT THE MAYOR WHO MADE IT VERY CLEAR THAT HIS INTENTION TO CLOSE AT LEAST ONE OF THE NINE HOLE COURSES AND HOPEFULLY TWO OR THREE. IF WE DON'T HAVE A PRO IN PLAY AT THOSE THREE COURSES IT DOESN'T GUARANTEE THEIR CLOSURE BUT IT CERTAINLY DOESN'T GUARANTEE THEIR CONTINUING OPERATION. WHAT THE MAYOR SAID ABOUT LIBRARIES AND GOLF COURSES IT'S HARD FOR ME TO IMAGINE A FUTURE WHERE THOSE THREE COURSES ARE EVER RETURNED TO THE LEVEL OF PLAY, TO THE LEVEL OF QUALITY, TO THE CARE THEY HAD AND THE PROS THEY HAD HAD BECAUSE THERE WILL BE NO REASON FOR THE MAYOR TO MOVE ON THAT. THREE MONTHS FROM NOW HE'LL COME BACK TO TELL US THE SAME THING HE HAS ALREADY TOLD US. WE CAN'T FIND PROS TO DO THIS, WE TRIED. MY FEAR IS WE WILL BE ASKED AND-TO ACCEPT THE FACT THAT IT'S SOMETHING WE CAN'T AFFORD. JUST LIKE WE COULDN'T AFFORD LIBRARIES, SCHOOLS, OR A

POLICE CLASS. WHO KNOWS? I'M GOING TO END MY TALKING POINTS. I
REALLY AM STRUGGLING WITH A YES OR NO VOTE. A YES VOTE MEANS I
FEAR THERE WILL BE THE THREE NINE HOLE COURSES WILL GO. A NO
VOTE WILL MEAN THAT ALL OF OUR COURSES WILL GO. THERE ARE SOME
GOOD CONTRACTS. THERE ARE SOME GOOD CONTRACTS. WE WANTED TO PLAY
GOLF AND WE DID. I'M AFRAID THAT ACCEPTING THESE CONTRACTS IS
ACCEPTING THE CLOSURE OF THOSE COURSES. THANK YOU.

>> THANK YOU, COUNCIL MEMBER.

>> THANK YOU, MR. PRESIDENT. IT MAY TAKE A LITTLE WHILE TO RESPOND TO BECAUSE FRANKLY I'VE BEEN SAVING-WE DID NOT ADD ANY MONEY TO THE BUDGET FOR THE GOLF COURSES. THE MAYOR ONLY FUNDED GOLF THROUGH JANUARY. WE HAD TO ADD MONEY-[INDISCERNIBLE]. THE SAME AMOUNT THAT WAS IN THE BUDGET PRESENTED BY THE BUDGET STATED THE BUDGET FOR A GOLF COURSE. SECONDLY, I FEEL REALLY STRONGLY ABOUT THIS, BECAUSE I FEEL IT'S MISLEADING. WE HAVE AN ORDINANCE THAT SAID IF THE CRESCENT HILL GOLF COURSE DOES NOT HAVE A PRO IT WILL REMAIN RUN BY METRO PARK. IT DOES NOT SAY FOR THREE MONTHS. THERE'S NO STATEMENT IN THERE. THAT IS SIMPLY FALSE. IT WILL HAVE TO CONTINUE TO BE RUN BY METRO PARK. WE ALSO HAVE AN ORDINANCE THAT SAYS NO GOLF COURSE CAN BE CLOSED OR REFURBISHED BY THE METRO COUNCIL. WE HAVE PROTECTIONS THAT HAVE BEEN BUILT IN THROUGH THE WORK OF COUNCIL MEMBERS. I THINK TO SCARE THE PUBLIC THAT IF WE DON'T VOTE FOR THIS THE GOLF COURSES ARE GOING TO CLOSE. THEY WON'T CLOSE UNLESS WE VOTE FOR THEM. I

CAN'T IMAGINE A WORSE OUTCOME FOR GOLF IN THE COMMUNITY IF WE

TURN DOWN SIX CONTRACTS THAT WE ALL THINK ARE GOOD AND WE DO

THAT BECAUSE WE'RE MAD ABOUT THREE OTHER CONTRACTIONS WHEN THERE

ARE PROTECTIONS IN PLACE. THE LAW REQUIRES THAT THEY CONTINUE TO

BE IN OPERATION UNLESS WE VOTE TO CLOSE THEM.

>> THANK YOU. COUNCIL MEMBER YAITS.

>> THANK YOU, MR. PRESIDENT. I WANT TO THANK YOU FOR YOUR EFFORT AND ADVICE THAT YOU PUT INTO THIS. THIS IS IMPORTANT WORK FOR ME. NOT JUST BECAUSE I PLAY GOLF BUT CHILDREN WITH DEVELOPMENTAL DISORDERS. I WANT TO ASSURE ANYBODY LISTENING OUT THERE THAT MY COLLEAGUES AND I HAVE MADE A DECISION, IT WON'T CLOSE. IT WILL REINVEST. IT WOULD HAVE TO TAKE THE VOTES OF THIS COUNCIL. WE'RE MEETING WITH THE ECONOMIC DEVELOPMENT TEAM TO LOOK FOR WAYS TO INCENTIVIZE AND MAKE IT MORE ATTRACTIVE. WE SEE THE GOLF COURSE NOT JUST AS A GAME BUT AS A VERY IMPORTANT PART OF THE COMMUNITY. SIMILAR TO OUR PARKS AND THE CLUBHOUSES AND THE THINGS THAT MAKE IT BEAUTY STRONG. IT PROTECTS THE NEIGHBORHOODS AROUND. WE'VE MOVED INTO AN AREA LIKE OUR SIDEWALKS AND ROADS AND THINGS THAT ARE VERY IMPORTANT. MY COLLEAGUE WILL TELL YOU WE HAVE OUR PRIMARY DUTIES. WE HAVE PUBLIC SAFETY FIRST AND INFRASTRUCTURE. WE HAVE TO MAKE SURE THAT WE DO THAT. WE ALSO HAVE TO MAKE SURE THAT OUR AMENITIES ARE A SAFE PLACE SO WE CAN REINVEST IN OUR PUBLIC SAFETY. BECAUSE I'VE HAD HAD A DOZEN PHONE CALLS, I WANTED TO MAKE SURE

GOLF AND THE GOOD THOSE EVENTS BRING TO THE COMMUNITY. IT BRINGS THE COMMUNITY TOGETHER. IT'S SO IMPORTANT. I WANT TO REITERATE THAT ALTHOUGH IT'S NOT IN MY DISTRICT I'LL BE FIGHTING TOOTH AND NAIL TO ENSURE IT DOESN'T CLOSE. YOU HAVE MY DEDICATION TO MAKE SURE THAT DOESN'T HAPPEN. I WANT TO THANK THE PEOPLE FROM THE PURCHASING DEPARTMENT AND THE PARKS DEPARTMENT AND NEGOTIATIONS AND I STILL LIKE TO SEE PERCENTAGES THAT CAME ABOUT IN THOSE NEGOTIATIONS ENDED UP BEING PRETTY CLOSE TO WHAT THEY WERE GETTING BEFORE, THE GOLF BUSINESS IS NOT AS LUCRATIVE AS WE ONCE THOUGHT IT WAS A FEW MONTHS BACK. IT WAS THREE TO FIVE THOUSAND DOLLARS ON ONE OF THE AVERAGE COURSES IS WHAT THE CITY IS GOING TO REALIZE. PROBABLY LESS THAN A HUNDRED THOUSAND DOLLARS. I APPLAUD YOU ON THAT WORK. AND WE WORK REALLY HARD, THE BODY CAME TOGETHER IN NOVEMBER WE WORKED FOR MONTHS TRYING TO GET THE PROPER LEGISLATION TO MAKE SURE THAT IT WASN'T A STRAIN ON THE CITY ANY LONGER. BASED ON THE TWO HUNDRED THIRTY THOUSAND ROUNDS OF GOLF THAT WERE PLAYED LAST YEAR, WE DECIDED THAT FIVE DOLLARS ACROSS THE BOARD. THAT'S GOING TO BRING US IN A MILLION DOLLARS IF WE ARE CONSERVATIVELY

SAY THAT WE WANT TO DO TWO HUNDRED THOUSAND. WE HAVE A LITTLE BUFFER THERE. WE DID THINGS LIKE DYNAMIC PRICING. I WANT TO THANK THE BODIES FOR THEIR SUPPORT WITH THAT LEGISLATION. IT WAS VERY IMPORTANT FOR WHERE WE'RE AT AND GETTING THAT RFP AND EVERYTHING IS THROUGH THE COUNCIL. THAT BEING SAID, I HAVE A REAL PROBLEM WITH HOW THIS PROCESS WENT DOWN. I THOUGHT-WE HAD NINE COURSES THAT WE NEEDED PROS FOR. WE HAD NINE APPLICANTS THAT WERE ABLE TO FILL THOSE SPOTS THAT A COUPLE OF THE LONG TIME PGA PROS THAT HAD FORTY AND FIFTY YEARS ESPECIALLY IN CITY GOVERNMENT TO HELP RUN THOSE COURSES, I FEEL LIKE THEY HAVE BEEN DISRESPECTED. I THINK OUR CITY OWES THEM AN APOLOGY. THEY SHOULD HAVE HAD THE-THE CITY SHOULD HAVE HAD TO BE CALLED IN AND SAY GREAT JOB. THANK YOU TO YOUR SERVICE TO THIS CITY BUT THAT'S NOT WHAT HAPPENED. THEY WERE TOLD THEIR SERVICES WERE NO LONGER NEEDED. THEY WEREN'T INNOVATIVE ENOUGH AFTER GETTING INDUCTED ONE OF THEM TO THE PGA HALL OF FAME JUST THIS PAST FALL. AND PUTTING FORTY YEARS OF HIS BLOOD AND SWEAT INTO THAT COURSE. I HAVE TO SAY ESPECIALLY KNOWING THE CONDITION OF SUN VALLEY COURSE THAT IT'S HARD FOR HIM TO GET EXCITED WHEN HE HAS BEEN BEG FOR TWENTY YEARS TO HAVE SOME SORT OF IMPROVEMENT TO THE GRASS AND FRONT LINE GREENS AND NOTHING HAS BEEN DONE. I DON'T KNOW WHAT THEY WANTED HIM TO SAY THAT HE COULD DO TO MAKE PLAY BETTER AT THAT COURSE. IN REALITY WHEN YOU HAVE TO PAY THE SAME AMOUNT FOR A GREEN FIAT ONE COURSE AS AT OTHERS AND ONE COURSE

IS IN MUCH BETTER SHAPE, MOST PEOPLE UNLESS THEY'RE LOYAL TO THAT PRO IS GOING TO GO TO THE OTHER COURSE. GOING FORWARD, I HOPE WE AS A CITY CAN DO A BETTER JOB OF APPRECIATING THE PEOPLE THAT HAVE PUT FORTY AND FIFTY YEARS INTO THE CITY GOVERNMENT. I'VE JUST GOT TO SAY TOO THAT MAINTENANCE WORKERS, NOBODY CAN EVEN GIVE THEM AN OPPORTUNITY TO FEEL COMFORTABLE THAT THEY WERE NOT GOING TO LOSE THEIR JOBS. I ASKED THAT A LETTER BE WRITTEN TO THEM AND TELL THEM THAT WE VALUE YOU AS AN EMPLOYEE. PLEASE DON'T LEAVE THE CITY. WE'LL FIND YOU A JOB. THAT LETTER WAS NEVER WRITTEN BECAUSE WE HAVE NO RESPECT FOR THE EMPLOYEES IN THIS CITY AND IT MAKES ME SICK. THAT'S ALL I'M GOING TO SAY. I'M DISAPPOINTED. I'M HAPPY THAT WE HAVE SIX COURSES THAT WE HAVE WITH A GOOD CONTRACT. AND WE'LL GO FORWARD TO DO THE BEST WE CAN TO MAKE SURE THAT THE THREE NINE HOLES ARE TAKEN CARE OF AND MAINTAINED HOPEFULLY THROUGH THIS TIME OF INACTIVITY SO THE GREENS ARE STILL USABLE WHEN WE FINALLY GET SOMEBODY IN THOSE COURSES. I DID HAVE A OUESTION AND I STILL DON'T KNOW THE ANSWER TO THIS. AND I DON'T KNOW, IS IT OUT OF ORDER FOR ME TO ASK A QUESTION?

- >> I'LL LEAVE THAT FOR ANOTHER TIME. I GUESS THAT'S ALL.
- >> THANK YOU, COUNCILWOMAN.
- >> THANK YOU, MR. PRESIDENT. I JUST WANTED TO STATE THAT

 I'M VERY MUCH IN FAVOR OF THIS THIS EVENING. I THINK IT'S THE

RIGHT THING TO DO AT THE RIGHT TIME. IT HAS BEEN A VERY DIFFICULT PAST FOR ALL OF US. AS WE ALL SIT HERE THIS EVENING AND KNOW THAT SOMEWHERE ACROSS THIS COUNTY THERE ARE CHILDREN WHO ARE WATCHING US. WE ALL KNOW THAT BECAUSE WHEN WE VISIT THE SCHOOLS, AS I BELIEVE ALL OF US DO FROM TIME TO TIME. THE STUDENTS IN THESE ELEMENTARY OR MIDDLE OR HIGH SCHOOLS SAY I SAW YOU ON TV OR HERE AND THERE, THEY TALK ABOUT THE GUY WITH ALL THE FLAGS BEHIND HIM ALL THE TIME. THAT WOULD BE SOMETHING THAT EACH AND EVERY ONE OF US TRY TO DO OURSELVES. MR. PRESIDENT AND MADAM CHAIR, I COMMENT YOU FOR THE WORK AND LEADERSHIP THAT YOU STAYED THE COURSE. EVERYBODY MAY NOT GET EVERYTHING THEY WANT IT MAY NOT BE A PERFECT SOLUTION THIS EVENING. AS WE KNOW A GOOD DECISION TODAY IS BETTER THAN WAITING FOR A PERFECT DECISION TOMORROW. LIVES ARE BEING DEVELOPED THIS EVENING RIGHT BEFORE US AS WE DELIBERATE. I WILL BE IN FAVOR OF THIS. THANK YOU.

- >> I WAS SOMEWHAT CONFLICTED. BOTTOM LINE IS I AM GOING TO VOTE FOR THIS. I'VE HEARD ENOUGH FROM MY COLLEAGUES ON HOW MUCH THEY ARE GOING TO FIGHT FOR THE OTHER THREE COURSES THAT I'M CONVINCED-THE OTHER THING I WANT TO SAY TO WRAP THIS UP QUICKLY. IF I MAY BE SO BOLD TO CORRECT MY COLLEAGUE WHO USED THE TERM WE IN MANY INSTANCES TALKING ABOUT HOW GOVERNMENT WAS TREATING SOME OF THESE METRO EMPLOYEES AND GOLF PROS. MAINTENANCE WORKERS. I DISAGREE WITH THE USE OF THE WORD WE. THAT'S BECAUSE YOU ALL-THE REST OF MY COLLEAGUES HERE WANTED THOSE LETTERS WRITTEN AND WANTED PEOPLE TO FEEL VALUED. IT WAS THE EXECUTIVE BRANCH OF THIS GOVERNMENT THAT DIDN'T SEND THAT LETTER. THAT INSTILLED FEAR IN THOSE WORKERS AND DIDN'T RESPECT SOME OF THE GOLF PROS WHO DEDICATED DECADES OF SERVICE. THAT PART I COMPLIMENT. AT THE SAME TIME HE TOLD US THE GOLF COURSES HE WAS WILLING TO SEEK-I COME IN ABOUT THE THREE MONTHS, I APOLOGIZE I MAY HAVE CHOSEN BAD LANGUAGE OR USED THE WRONG WORDS. I COME WITH A CONCERN OF MINE THAT RUNNING THE COURSE AFTER THREE MONTHS, LOOK IT'S COSTING THIS MUCH MONEY. WE CAN'T DO THIS. IT'S A STRAIN ON THE BUDGET WHICH IS WHAT THEY TOLD US IN THE FIRST PLACE. THE REALITY IS, IF WE'RE GOING TO BE HONEST ABOUT THIS, ALL YOU HAVE TO DO IS GO OUT TO THE COURSES AND SAY LOOK, THEY HAVE NOT BEEN MAINTAINED. THEY ARE NOT BEYOND REPAIR. NO NEED TO SUGGEST THAT THE SKY IS FALLING. DURING THE WINTER TIME WHETHER IT WAS A GOOD IDEA TO STAY OPEN FOR THREE MONTHS WHEN THEY WEREN'T GETTING HARDLY ANY PLAY TO MAKE THAT SUSTAINABLE. THE MAYOR USED THAT ORDINANCE THAT WE WROTE TO CLOSE THE COURSE. HE DIDN'T MANAGE THOSE COURSES BASED ON WHETHER OR NOT IT WOULD BE POSSIBLE. THAT WAS NEVER THE INTENT OF THE ORDINANCE. >> YOU KNOW, I PLAN TO INTRODUCE AND MOVE FORWARD WITH LEGISLATION THAT WILL ADDRESS SOME OF THE NEEDS FOR THOSE COURSES AND I'M HOPING THAT-IT OPENS THE DOOR FOR-I DON'T THINK THAT THE ASSOCIATION, THE PERCENTAGES ARE GOING TO BE AS HIGH FOR THE CITY AS I SEE THESE CONTRACTS BEING BECAUSE NINE HOLES IS A DIFFERENT ANIMAL THAN EIGHTEEN HOLES. LIKE I SAID, THERE'S NOT LEGISLATION ON THE WING-I KNOW THAT DOESN'T SATISFY WHAT YOU'RE ASKING. I WOULD LOVE TO HAVE ASSURANCES AS WELL FROM THE ADMINISTRATION TO SAY WE'RE-THEY WERE GOING TO AT LEAST IN GOOD FAITH TRY TO FIND PROS TO OPERATE THE COURSES. >> THANK YOU, MR. PRESIDENT. CLEARLY WE'RE LOOKING FOR
CONTRACTS FOR THREE GOLF COURSES. WE HAVE SIX. THEY MIGHT STILL
TRY TO FIND THE OTHER THREE. WE HAVE SIX GOOD CONTRACTS THAT
PRIOR TO THIS MEETING ALL THOUGHT-[INDISCERNIBLE]. WE'RE NOT
HERE TO COMMIT TO THE REVENUES. I DON'T KNOW. I'M JUST BEING
ASKED TO IT APPROVE SIX GOOD CONTRACTS TO GET THE BALL MOVING.

 WORDS BEEN UTTERED. I AGREE 100%. I WOULD ONLY ADD THAT THE
 ADMINISTRATION DID AT LEAST ADD-I WOULD ACCEPT THAT AS AN ACT OF
 GOOD FAITH. I DON'T KNOW WHAT MAY OR MAY NOT HAPPEN. I WOULD
 LIKE TO VOTE ON WHAT IS BEFORE US. THIS IS WHAT WE HAVE TO VOTE
 ON. AT LEAST THESE SIX.
- >> I JUST WANT TO FOLLOW-UP ON MY COLLEAGUE'S-SINCE YOU
 BROUGHT IT UP. I WASN'T GOING TO BRING IT UP. SORRY. I HOPE THAT
 GOING FORWARD THAT WE CIRCLE BACK WITH A YOUNG MAN THAT ASKED
 FOR SOME PROVISION BE PUT INTO HIS CONTRACT AND IT IS BECAUSE

- >> THERE IS NO ONE ELSE IN THE QUEUE. I THINK WE'RE READY TO VOTE.

 - >> WE'RE GOING TO VOTE.
- >> WE HAVE HAD A VOTE-WE HAD ON THE FLOOR-THERE WAS A CALLING OF THE QUESTION. WE VOTED ON THE CALLING OF THE QUESTION. IT WAS AN AFFIRMATIVE VOTE BY THE BODY. NOW WE'RE GOING TO VOTE ON THE AMENDMENT BY SUBSTITUTION. THE AMENDMENT BY SUBSTITUTION IS BEFORE US. MR. CLERK, PLEASE OPEN THE FLOOR TO VOTE.
 - >> MR. PRESIDENT MAY I PLEASE EXPLAIN MY VOTE.

- >> A RESOLUTION FOR CLEAN 100% ELECTRICITY. OPERATIONS BY
 TWENTY THIRTY FIVE. CLEAN ENERGY COMMUNITY WIDE BY TWENTY FORTY
 AS AMENDED READ IN FULL.
- >> THANK YOU. WE HAVE A MOTION. SECONDED. RESOLUTION IS BEFORE US. OPEN FOR DISCUSSION.
- >> THANK YOU. THIS-WE HAVE HAD A COUPLE OF THESE BEFORE US.

 THE LAST YEAR AND A HALF, MAYBE A LITTLE LONGER. IT MIGHT HAVE

 BEEN ALMOST TWO YEARS. WE HAVE WORKED ON THIS ONE. IT'S VERY

 CLOSE TO BEING A DEADLINE. I WAS GLAD THAT WE WERE ABLE TO GET

 IT TO WHERE IT NEEDS TO BE AND GET IT PASSED THROUGH COMMITTEE.

WITH IT BEING A RESOLUTION IT'S REALLY NOT BINDING BUT IT'S A STEP IN THE RIGHT DIRECTION. SUSTAINABLE GREEN ENERGY FOR THE CITY. I STILL HAVE A LITTLE CONCERN ABOUT HOW WE WILL FUND IT BUT THAT REMAINS TO BE SEEN.

>> LEADING BY EXAMPLE FOR THE COMMUNITY AT LARGE FOR RENEWABLE ENERGY. WE HAD A PRETTY ROBUST PUBLIC HEARING FOR THIS RESOLUTION AS WE DO IN SOME CASES OF LEGISLATION IF PEOPLE ARE INTERESTED IN THE COMMUNITY. WE HAVE HEARD FROM ADVOCATES. WE HAD THE ENERGY MANAGER OF THE CITY OF CONNECTICUT REALLY FIRING AN EDUCATIONAL TESTIMONY ABOUT THE EFFORTS OF THAT CITY. I THINK WE LEARNED ALLOT ALONG THE WAY. WE HAVE MADE SEVERAL AMENDMENTS. FINAL AMENDMENTS FROM MY COLLEAGUES. IN SECTION THREE, VERY SHORT ORDINANCE. WE ADDED JUST FOUR WORDS ABOUT THE PRIORITIES. WE'RE SAYING ADDS TO ITS PRIORITIES AS METRO BUDGET ALLOW. PEOPLE HAVE OUESTIONS ABOUT HOW MUCH DOES IT COST TO TRANSITION TO CLEAN RENEWABLE ENERGY OVER THE COURSE OF A GENERATION. IT'S OBVIOUSLY NOT A SIMPLE MATH PROBLEM WHEN IT COMES DOWN TO AUDITS. THINGS CHANGE ADD THE WORLD IS GOING TO BE DIFFERENT FOR YEARS TO COME. OBVIOUSLY WE ALL WANT TO UNDERSTAND THAT IF WE PASS THE RESOLUTION WE SHOULD TAKE STEPS TOWARDS THE GOALS IMMEDIATELY. IN TERMS OF TRYING TO WRAP OUR HEADS AROUND WHAT IT WILL LOOK LIKE IN THE SHORT TERM, THE ADMINISTRATION IS GOING TO TAKE THREE STEPS AND CONDUCT AN ENERGY AUDIT, FIRST AND FOREMOST. WE KNOW THERE'S A LOT OF SUBMISSIONS AND SPENDING A

LOT OF MONEY ON ENERGY. FROM SOME OF THE SAVINGS THAT THEY
ANTICIPATE FINDING FROM THE AUDIT, THEY CLAIM TO BE HIRING AN
ENERGY MANAGER. ONE WHO WILL WATCH OUR BILLS. WITH SOME SAVINGS
THEY FIND THERE, THEY INTEND TO LESSEN RFP FOR REAL CONVERSION
SETS. ROAD MAP FOR-THAT'S WHAT THIS LOOKS LIKE FINANCIALLY. I'LL
REITERATE THE LONG STANDING RESOLUTION. BY VOTING IN FAVOR OF
THIS. I CERTAINLY DON'T FEEL THE NEED TO FACE CLIMATE CHANGE, WE
ALL WATCH FIRES IN AUSTRALIA, THOSE SORTS OF THINGS. YOU KNOW,
IN ANY CASE, I JUST WANTED TO IT POINT OUT THAT WE'RE JOINING A
COALITION OF CITIES AROUND THE COUNTRY. I THINK THE NUMBER WAS
ONE HUNDRED FIFTY THROUGH SIMILAR GOALS ALONG THEIR PATH.
CERTAINLY AROUND THE WORLD. THIS RESOLUTION ISN'T GOING TO SOLVE
OUR PROBLEMS BY ANY MEANS BUT POINTS US IN THE RIGHT DIRECTION.

- >> THANK YOU. COUNCILWOMAN GEORGE.
- >> THANK YOU. AFTER HEARING FROM THE VOTE, THE ADVOCATE,
 THE INDUSTRY AND SOMEONE FROM OUR CITY. THERE WAS SOME
 INDISCERNING FROM THAT PROCESS. THE METRO COUNCIL'S DECISION TO
 DETERMINE WHAT THE FUTURE SHOULD LOOK LIKE, I'M THANKFUL THAT
 OUR COLLEAGUES HIGHLIGHTED THE DEVASTATION IN AUSTRALIA. I WANT
 OUR FUTURE FOR THE CITY TO BE ONE THAT WORKS PROACTIVELY TO MAKE
 A CENTRAL INVESTMENT TO YIELD A LONG TERM SAVINGS. WITH THAT IN
 MIND I WOULD ALSO URGE MY COLLEAGUES TO VOTE YES.

 - >> THANK YOU, MR. PRESIDENT. FOR THOSE THAT KNOW ME AND MY

FAMILY. MY WIFE IS AN ENVIRONMENTAL SCIENTIST. WE DEBATE REGULARLY ABOUT THE DIFFERENCE BETWEEN REAL CHANGE, REAL SCIENCE, AND WHAT IS MOST COMMONLY HORRIBLE PUBLIC POLICY. IF THIS RESOLUTION WAS SIMPLY SECTION TWO-URGING METRO GOVERNMENT TO COME FORWARD WITH AN ACTION PLAN. PARTICIPATE AND PRIORITIZE IT WITH THE PROCESS. SECTION THREE ADD TO THE PRIORITY AS THE BUDGET WOULD ALLOW. JUST SO EVERYBODY KNOWS IN AN EAST END DISTRICT IN THE CITY WE HAVE ONE OF THE FASTEST GROWING ADHERENCE FOR GREEN ENERGY IN THE COUNTRY. I SUPPORT AND LOVE THE WORK THEY DO. IF THESE WERE THE ONLY THINGS THAT WE WERE VOTING-LOOKING AT ENERGY RESOURCES, BENEFITS, LOW INCOME RESIDENTS. SECTION ONE IS INCREDIBLY SCARY. FOR ANYONE THAT KNOWS WHAT IT TAKES TO CREATE CODE-THE GOAL OF NET ZERO OR NET POSITIVE ENERGY, WATER, AND WASTE. WATER-MY WIFE WORKS-CURRENTLY DOING WORK ON THINGS LIKE THIS. IT IS INCREDIBLY UNPRECEDENTED. IT IS AN UNFAILABLE TERM. IT DOESN'T SAY IT RECOMMENDS, HOPES, PRAYS. IT SAYS THAT WE SUPPORT BOTH THE REVISION OF ALL BUILDING CODE FOR NEW CONSTRUCTION TO REOUIRE ENERGY EFFICIENT CONSERVATION TOWARDS THE GOAL OF NET ZERO WATER. IF YOU REPRESENT A DISTRICT WHO IS UNDERDEVELOPED AND YOU EXPECT ANYBODY TO INVEST MONEY IN YOUR COMMUNITY AFTER WE MAKE THOSE CHANGES, FUEL EFFICIENT VEHICLES COST. ANYONE ON THIS COUNCIL POST THE NET ZERO. I WOULD VENTURE TO SAY THE ANSWER IS NONE. I REALIZE YOU SAY THIS IS JUST A RESOLUTION. WHY VOTE FOR IT?

IN TEN YEARS, BY THE TIME YOU FINISH THAT STUDY, HOW MUCH TIME DO YOU HAVE LEFT? HOW QUICKLY DO WE THINK WE'RE GOING TO BE ABLE TO PULL THIS OFF A MIDST ALL THE OTHER THINGS WE'RE WORKING TOWARDS. WE NEED TO HAVE THIS BROUGHT FORTH SO THAT WE CAN HOPEFULLY RUN A MORE EFFICIENT GOVERNMENT. I'M NOT TALKING ABOUT ONE OF THE BUILDINGS THAT WAS MENTIONED WAS THE LIBRARY. THE VAST MAJORITY WAS RAISED BY PRIVATE FUNDING. THAT'S GREAT. SOMETHING I TOTALLY APPLAUD. MYSELF AND MY OWN WIFE, ARE WE GOING TO OBEY NET ZERO IN TEN YEARS. WHO DO YOU THINK IS GOING TO PAY FOR THE BUILDING CODE. WHEN THEY CHANGE THE BUILDING CODE IN AN UNDER INVESTED COMMUNITY IN AN UNDER INVESTED COUNTY. WHO IS GOING TO WANT TO PAY FOR IT. I WOULD URGE MY COLLEAGUES TO VOTE AGAINST THIS. I'M VOTING AGAINST THIS NOT BECAUSE-CLIMATE CHANGE IS REAL. IT

EXISTS. HOW MUCH HUMAN CONTRIBUTE TO IT. STILL FIGURING THAT

OUT. WE CONTRIBUTE AND WE NEED TO-TOTALLY BELIEVE IT. WE SHOULD

MOVE IN THAT DIRECTION. THESE GOALS, I DON'T SUPPORT MANDATED

CHANGING BUILDING CODES SO THAT WITHIN TEN YEARS THE CITY,

TWENTY YEARS THE ENTIRE COMMUNITY WITHOUT ANY SENSE OF WHAT IT'S

GOING TO COST. WE HAVE NO IDEA. I'M VOTING AGAINST THIS. I WOULD

URGE MY COLLEAGUES TO VOTE AGAINST THIS. NOT BECAUSE I DON'T

APPRECIATE-BUT BECAUSE WE CAN'T STAND BY IN THE DEFENSE OF IT'S

A RESOLUTION. STOP. THE RESOLUTION THAT THIS COUNCIL PASSED

PRIOR TO THIS HAVE RESULTED IN TENS OF MILLIONS OF DOLLARS. I

ROAD MAP. UNLESS WE HAVE A ROAD MAP, I CAN'T SUPPORT IT.

>> I WANT TO PREFACE MY STATEMENT FIRST BY SAYING THAT THE CONCERNED CITIZEN AND VOLUNTARILY I DO THINK THAT-I DRIVE-I DO NOT DRIVE A GAS GUZZLING CAR. I LIMIT MY WATER USAGE. I'M A BIG SUPPORTER OF PLANTING TREES. I TRY TO DO THE THINGS REALLY TO BE CONSERVATIVE. A REPUBLICAN CONSERVATIVE THAT IS CONSERVING ENERGY. IT'S NOT MANDATED ON ME. IT'S FORCED ON ME. WHEN HAD WE STARTED HAVING TALKS EVEN PEOPLE ON THE OTHER SIDE OF THE AISLE WERE QUESTIONING AND VERY CONCERNED ABOUT THE COST OF WHAT THIS

COULD DO TO PRIVATE CITIZENS. WHAT IT WOULD MEAN FOR OUR GOVERNMENT. WE'VE SET 100% GOAL. 100% IS NOT RATIONAL OR ACHIEVABLE. WE SET A TIME LINE. A DEFINITIVE TIME LINE OF TEN YEARS. THAT'S PROBABLY NOT RATIONAL OR FEASIBLE. WE HEARD THE MOST RECENT MEETING THAT THEY WERE GOING TO HIRE AN ENERGY MANAGER. HERE WE GO AGAIN SPENDING MONEY HIRING MORE PEOPLE WITH BIG SALARIES. WE ALSO HEARD AT THAT MEETING WHERE DOES THE MILLIONS COME FROM. IT WASN'T SAVINGS OF MILLIONS. IT WAS LOOKING FOR GRANT MONEY FROM THE FEDERAL GOVERNMENT. I ALSO CITED A RESEARCH ARTICLE FROM THE UNIVERSITY OF MARYLAND THAT SOLAR FARMS ALSO-THEY ACTUALLY CREATE WHERE THEY ARE LOCATED A HEAT ISLAND EFFECT. I'M NOT GOING TO SUPPORT BECAUSE JUST AS MY PEER SAID, IT'S GOING TO BE HELD OVER-WE'RE GOING TO PLAN THE PRIVATE SECTOR, NEW TAXES, STIMIED BUSINESS GROWTH. PEOPLE TRYING TO START A GREAT BUSINESS WHICH IS GREAT FOR MILLENNIALS WOULD BE EASIER AND BECAUSE OF ALL THE WATER REGULATIONS, DRAINAGE REGULATIONS. PUTTING IN RETENTION AND WHATNOT. YOU'RE GOING TO TELL PEOPLE NOT-NOT TELL PEOPLE, WHAT TO DO AND

REGULATE, WHAT KIND OF CAR TO DRIVE, WHAT SIZE HOME TO HAVE. I

KNOW THERE ARE PEOPLE SITTING IN HERE THAT HAVE BIG HOMES AND

DRIVE BIG TRUCKS AND THEY ARE GOING TO VOTE FOR THIS ORDINANCE.

I'M FOR DOING THE THINGS THAT ARE RATIONAL AND COMMON SENSE THAT

- >> I'D LIKE TO START BY INVOKING THE-CAN I HAVE A SECOND.
- >> ALL IN FAVOR SAY AYE. ALL OPPOSED.
- >> I'D LIKE TO-I KNOW SEVERAL THINGS HAVE BEEN SAID. THE
 ORDINANCE HAS NO TIME BOUNDS OF WASTE WATER. IT SAYS WE WILL
 LOOK AT THE POOL. THERE IS NO BOUNDS AROUND THAT WHATSOEVER. THE
 ONLY THREE COMPONENTS FOR CLEAN ENERGY GOAL. THOSE ARE THREE
 TIME BOUND ELEMENTS. REGARDLESS, THERE IS NO TIME BOUND ELEMENT,
 COMPLETE THE STANDARD. SOME WILL SAY ALL RIGHT, YOU CAN'T GET-WE
 SHOULDN'T SHOOT FOR SOMETHING SO HIGH. I MADE THIS ARGUMENT

IF TWENTY YEARS AGO YOU SAID WE'RE GOING TO HAVE HIGH SPEED INTERNET ALL OVER THE CITY OR STATE. YOU WOULD SAY THAT'S IMPOSSIBLE. THE RATE OF CHANGE ACCELERATES. TECHNOLOGY CHANGES MARKETS.
