Brief Biography David J. Beyer

David J. Beyer graduated with honors in Police Administration from the University of Louisville in 1977 and received his Juris Doctor degree from the University of Louisville in 1981. From 1981 to 1985, Mr. Beyer was an Associate in the Louisville Law Firm of Nold, Mosley, Clare, Hubbard and Townes. In 1985, he joined the Federal Bureau of Investigation. After 4 months of training at the FBI Academy in Quantico, Virginia, he was transferred to the Oklahoma City Office of the FBI where he was assigned to a Criminal Squad. In this assignment, he handled complex white collar crime investigations as well as bank robberies and drug investigations.

In 1989, he was promoted to Supervisor-Assistant General Counsel and transferred to FBI Headquarters in Washington, D.C. where he served in the Office of General Counsel for two years. There he was responsible for providing legal advice to FBI Headquarters (HQ) executives and field office personnel on criminal law, criminal procedure, electronic surveillance, undercover operations and employment law matters. This assignment included the review for legal sufficiency of all documents submitted by the field requesting authority to conduct wiretaps (electronic surveillance pursuant to Title III). He also served as counsel to the Criminal Undercover Review Committee which is composed of high-level FBIHQ and Department of Justice personnel. This Committee reviews all sensitive FBI undercover operations proposals submitted by offices throughout the country. He was later transferred to the Undercover and Sensitive Operations Unit at FBI HQ where he supervised and provided legal advice on nationwide undercover operations.

In 1993, Mr. Beyer was selected as the Chief Division Counsel for the Kentucky Office of the FBI. As Chief Division Counsel, Mr. Beyer was responsible for providing legal advice to the Agents and management of the Kentucky FBI on both civil and criminal law matters including employment law. He also served as the spokesperson for the Louisville FBI. In 2009, he was selected to be co-case agent on a high-profile case involving a prominent person who had been the victim of an extortion attempt. The subject was convicted and served seven years in prison.

In addition, Mr. Beyer has been a speaker at the FBI Academy on the topics of Undercover Operations and Electronic Surveillance. He has also been a guest instructor at the International Law Enforcement Academy in Budapest, Hungary as well as an instructor at international training initiatives sponsored by the U.S. State Department in Kristinau, Moldova and Bucharest, Romania. Mr. Beyer has

been an instructor at numerous law enforcement conferences and Continuing Legal Education seminars throughout Kentucky on a variety of legal matters including criminal law and procedure, Search and Seizure law, the U.S. Patriot Act, Electronic Surveillance Law, among many other topics.

Mr. Beyer retired from the FBI in November of 2011 and became General Counsel of the Kentucky Board of Dentistry (KBD) where he oversaw investigations of complaints filed against dentists and dental hygienist in Kentucky. He was later promoted to Executive Director of the KBD where he oversaw and was responsible for investigations, developing budgets, and supervising personnel along with liaison with state government officials.

In 2016, Mr. Beyer was selected as the Assistant Chief of Police for the St. Matthews, Kentucky Police Department where he was responsible for police patrol services, investigations, and administrative matters. He served as Acting Chief upon the retirement of the prior chief.

Mr. Beyer currently serves as Of Counsel for the Louisville Law Firm of Pence and Whetzel where he is involved in both criminal and civil litigation including employment law matters. In addition, he is an Adjunct Professor at the University of Louisville where he teaches Civil Liability and Employment Issues for Police Administrators.
