>> PRESIDENT JAMES, ON BEHALF OF THE WOMEN AND MEN OF THE METROPOLITAN SEWER DISTRICT, OBVIOUSLY, WE'RE VERY HONORED TO RECEIVE THIS RECOGNITION AND THIS PROCLAMATION. IN MOST SENSES, I THINK RECOGNITION BY THIS PUBLIC BODY IS PROBABLY JUST AS IMPORTANT AS THE NATIONAL AWARD WE WON LAST YEAR FOR THE SHAWNEE BASIN PROJECT AND THE OHIO RIVER INTERCEPTOR PROJECT ON MAIN STREET. ON THE SHAWNEE PROJECT, AS YOU ALL KNOW, IT'S A VERY PROMINENT PARK SYSTEM IN WEST LOUISVILLE. WE HAD TO WORK WITH THE OLMSTED PARKS, WE HAD TO WORK WITH METRO GOVERNMENT, WE HAD TO WORK WITH LOUISVILLE PARKS, AND WE ALSO HAD TO WORK WITH VARIOUS COUNCIL MEMBERS TO BE ABLE TO PULL THAT PROJECT OFF. AND WE'RE VERY PROUD THAT WE WERE ABLE TO COMPLETE A 20-MILLION-GALLON STORAGE BASIN IN THE GREAT LAWN OF SHAWNEE PARK AND DO THE PROJECT WITH A DESIGN THAT NOT ONLY BENEFITED MSD'S SYSTEM, BUT WE WERE ABLE TO LEAVE SOME AMENITIES FOR THE SHAWNEE PARK, AS FAR AS REFURBISHED BASKETBALL COURTS FOR THE 50th YEAR OF THE DIRT BOWL, AND ALSO WE REPAVED THE INNER PARK SYSTEM, AND ALSO WE BUILT A RECREATIONAL AREA AND HAD A LOT OF OTHER AMENITIES THAT WERE PART OF THAT PROJECT. SO WE'RE VERY PROUD OF THAT PROJECT, AND AS FAR AS THE OHIO RIVER INTERCEPTOR PROJECT, A LOT OF YOU PROBABLY DON'T KNOW THAT WAS A PROJECT THAT WAS IN THE MIDDLE OF MAIN STREET, TEN-FOOT DIAMETER CONCRETE PIPE, WHERE BECAUSE OF INSPECTION, WE WERE ABLE TO REACT PROACTIVELY TO BE ABLE TO DO A FIVE-BLOCK REPAIR OF THAT SEWER WITHOUT CLOSING

MAIN STREET FOR NINE MONTHS. SO WE WORKED TO BRING IN AN INNOVATIVE APPROACH TO MAKE THE REPAIR, AND EVEN THOUGH WE DID HAVE SOME LANE RESTRICTIONS, WE WERE ABLE TO GET THAT PROJECT DONE AND WITHOUT AFFECTING THE ECONOMIC CENTER OF OUR CITY. SO THE WOMEN AND THE MEN THAT YOU SEE STANDING HERE WERE VERY INVOLVED IN ALL OF THOSE PROJECTS AND BRINGING THOSE FORWARD, AND WE DO THAT EVERY DAY. NOT JUST ON THE BIG PROJECTS, BUT ON ALL PROJECTS, AND, AGAIN, WE APPRECIATE ALL OF YOUR SUPPORT, AND JUST KNOW THAT WE ARE KEEPING OUR HEAD DOWN AND DOING WHAT'S BEST FOR THE COMMUNITY. AGAIN, THANK YOU VERY MUCH. [APPLAUSE]

- >> THANK YOU. THIS RECOGNITION IS FOR CHRISTIAN MILLER. AND IT'S A PROCLAMATION. HE IS BEING AWARDED THE YOUNG ENGINEER OF THE YEAR BY THE KENTUCKY SOCIETY OF PROFESSIONAL ENGINEERS, AND I JUST WANTED TO TAKE THIS OPPORTUNITY TO RECOGNIZE HIM FOR THAT ACCOMPLISHMENT, BECAUSE, YOU KNOW, I'M JUST AMAZED. SO I JUST WANTED TO SAY CONGRATULATIONS AND THANK YOU VERY MUCH. [APPLAUSE]

>> I GOT THE MEMO, TODAY'S THE DAY OF PROCLAMATIONS. BOTH OF MY PROCLAMATIONS TODAY RECOGNIZE INDIVIDUALS WHO GIVE THEIR LIFE TO HEALING THOSE OF OTHERS. THEY DO IT IN VERY DIFFERENT WAYS, BUT THE SAME CONCLUSION, THEY HELP MAKE OTHER CITIZENS, OTHER PEOPLE, THEY MAKE THEM BETTER. MY FIRST AWARDEE IS MY FRIEND, JEREMY HARRELL. HE'S A U.S. ARMY COMBAT VETERAN, HAVING SERVED IN IRAQ. HE FOUNDED THE VETERAN'S CLUB IN 2017 WITH THE GOALS OF LOWERING VETERAN SUICIDE, WITH LOWERING VETERAN UNEMPLOYMENT, LOWERING VETERAN HOMELESSNESS, WITH STRENGTHENING MILITARY FAMILIES, WHILE BETTERING THE LARGER COMMUNITY. BETWEEN THERAPY, SUBSTANCE ABUSE CLASSES, LIFE SKILLS CLASSES, AND BARBECUE, BROUGHT JOY AND STABILITY, NOT ONLY TO THOSE PEOPLE, TO THEIR FAMILIES, AND TO OUR COMMUNITY. CURRENTLY WORKING ON \$3.6 MILLION VETERAN HOUSING CALLED CAMP RESTORATION. SOME OF YOU HAVE SEEN THIS IN THE NEWS, HEARD ABOUT IT. NOT JUST THE COUNTRY. IN DENMARK, AS WELL. THIS IS THE FIRST ONE. THIS WILL BE A PILOT PROJECT. IF DONE RIGHT, MAY BE AN ANSWER FOR SO

MANY PEOPLE WITHOUT AN ANSWER. SO WITH THAT, I'M HONORED TO BE ABLE TO RECOGNIZE MY FRIEND JEREMY HARRELL WITH THIS. TO ALL WHOM THESE LETTERS SHALL COME GREETINGS, KNOW YEE THAT THE LOUISVILLE METRO COUNCIL HEREBY RECOGNIZES MR. JEREMY HARRELL, WHEREAS MR. HARRELL IS A U.S. ARMY COMBAT VETERAN AND DISTINGUISHED CITIZEN OF OUR COMMUNITY, DEDICATING HIS CIVILIAN LIFE TO ENHANCING THE LIVES OF HIS FELLOW VETERANS BY ESTABLISHING VETERAN'S CLUB IN 2017. AND WHEREAS THROUGH VETERAN'S CLUB, HE'S PROVIDED CONNECTION, HEALING, RECOVERY, HOUSING, AND UNEMPLOYMENT TO OVER 3,000 KENTUCKY VETERANS AND GROWING. SO I KNOW YOUR IMPORTANCE BY WORKING WITH YOU OF THE SAFETY OF THE CITIZENS OF LOUISVILLE. SO I'M NOT SPEAKING FOR ME. I'M SPEAKING FOR A NINE-MONTH-OLD WHO CAN'T SPEAK FOR ITSELF. COUNTERPRODUCTIVE, AND I'VE ALWAYS SAID IF I CAN PROVE DRUG
TESTING DOESN'T WORK FOR PILOTS, I CAN PROVE IT DOESN'T WORK FOR
ANYONE. I URGE YOU TO FORM THIS TASK FORCE, AND LET'S BRING
JUSTICE TO AMERICA. THANK YOU.

>> HELLO, I'M SARAH BRINLEY, AND I'M HERE TODAY TO SPEAK IN SUPPORT FOR THE SAFETY ZONE TO PROTECT ACCESS TO HEALTH CARE IN LOUISVILLE. TODAY I'LL BE READING ON BEHALF OF SOMEONE WHO RECENTLY ACCESSED CARE AT THE EMW WOMEN'S SURGICAL CENTER. THEY FELT A STRONG CONVICTION TO SHARE THEIR EXPERIENCE BUT WISH TO REMAIN ANONYMOUS. I QUOTE, "THE MOMENT I PULLED INTO THE ALLEY OF 2nd AND MARKET, I ASKED DIRECTIONS TO THE PUBLIC PARKING GARAGE FROM ONE OF THE CLINIC'S ESCORTS IN AN ORANGE VEST. A DIFFERENT WOMAN WALKED UP TO MY CAR, TALKING OVER THE ESCORT, TRYING TO CONFUSE US, WHILE SHOVING PAMPHLETS INTO MY CAR. ONCE

WE PARKED, WE HEARD THE OVERWHELMING SCREECHING OF THEIR MEGAPHONES SCREAMING ABOUT OUR BEING BABY MURDERERS. ON THE WALK TO THE ENTRANCE WITH THE CLINIC ESCORT, I HAD A MAN WALKING BEHIND ME SO CLOSELY, THAT HE WAS WHISPERING INTO MY EAR, AGAIN, ABOUT ME BEING A BABY MURDERER. I KNEW I WAS MAKING THE RIGHT DECISION. I KNEW IT WAS WHAT I HAD TO DO, AND I KNEW THAT THEY DIDN'T CARE ABOUT ME DYING IN THE PROCESS, HOWEVER, IT DIDN'T MAKE IT ANY EASIER. AS I GOT CLOSER TO THE DOOR, ANOTHER MAN STARTED TO PUSH ME AWAY FROM MY FIANCE AND THE ESCORT. HE PUSHED ME AWAY FROM THE DOOR AND INTO THE CROWD OF THOSE SCREAMING OVER THE LOUD SPEAKER, SAYING EVERYTHING IN THEIR POWER TO CONVINCE ME TO CHANGE MY MIND. I EVENTUALLY GOT INSIDE, AFTER WADING THROUGH THE CROWD AND SCREAMING MYSELF THAT I WAS MAKING THE BEST DECISION FOR ME AND MY FAMILY. ONCE I GOT HOME FROM THE CLINIC, I BEGAN THE NIGHTLY ROUTINE OF GETTING MY SON TO BED. WHEN I HELD HIM IN MY LAP, I BEGAN TO SOB AS EVERYTHING SCREAMED INTO MY FACE, WHISPERED INTO MY EAR, AND FORCED INTO MY HEAD CAME FLOODED BACK. I PUT MY SON INTO HIS BASSINET. LUCKILY, MY MOTHER WAS STAYING OVER TO WATCH MY SON WHILE I WAS AT THE CLINIC AND HELP WITH HIM AFTERWARDS. I WENT RIGHT TO HER AND SOBBED INTO HER ARMS, SO OVERWHELMED FROM HAVING STRANGERS PUSH ME AND SCREAM IN MY FACE. I SIT HERE WRITING, CRYING AS I RECALL EVERYTHING, BECAUSE I WAS ONE OF THE MANY IN NEED OF A SAFETY ZONE. I TALKED TO OTHERS IN DIFFERENT STATES, AND THEY SAY WHAT

I EXPERIENCED IS AGAINST THE LAW IN THEIR STATE. HOW CHANTING IN
THE DISTANCE WAS THE WORST THEIR PROTESTERS COULD DO. I KNOW I'M
JUST ONE VOICE, BUT I WANT MY VOICE TO BE HEARD, BECAUSE WHAT'S
BEING ALLOWED TO HAPPEN BY THE NEGLIGENCE OF THIS METRO COUNCIL
IS WRONG. NO ONE SHOULD BE HIT, SHOVED, HARASSED, YELLED AT, OR
FOLLOWED BECAUSE THEY ARE SEEKING MEDICAL CARE IN LOUISVILLE. IT
SHOULD NOT BE ALLOWED TO CONTINUE." AND SPEAKING FOR MYSELF, I'M
FOR ALL OF YOU, AS LEADERS OF THE COMMUNITY, COME OUT AND SEE
FOR YOURSELF. STAND SIDE BY SIDE WITH ESCORTS, BECAUSE UNTIL YOU
SEE IT WITH YOUR OWN EYES, YOU DO NOT KNOW. AND TO CONTINUE
OFFERING US HALF-COCKED SOLUTIONS WHILE REMAINING IGNORANT IS
IRRESPONSIBLE AND DISINGENUOUS. THANK YOU. [APPLAUSE]

SOMEBODY ELSE RUN THEM AND GET THEM UP TO SPEED AS QUICKLY AS
POSSIBLE. SO THAT'S THE REASON OF THE EMERGENCY. AND I WOULD
MOVE APPROVAL. THIS CONTRACT IS WITH GEORGE DENLING, WHO WE
RECOGNIZED IN DECEMBER GETTING IN THE KENTUCKY HALL OF FAME.
THANK YOU.

>> THANK YOU. COUNCILMAN HOLLANDER, IT'S IN YOUR DISTRICT IF YOU'D WISH TO SPEAK.

>> I'M VERY HAPPY, THANK YOU, MR. PRESIDENT. I'M HAPPY TO
SEE THIS CONTRACT EXECUTED AND SEE MR. DENLING'S INTEREST IN

MANAGING CRESCENT HILL, AND I'D URGE COUNCIL MEMBERS TO VOTE
AFFIRMATIVELY.

- >> THANK YOU, MR. PRESIDENT. YEAH, I JUST WANTED TO SAY
 THANK YOU TO COUNCILMAN MULVIHILL. COUNCIL MEMBER FOWLER, WHICH
 NOT SURE WHERE SHE WENT.
- >> SHE'S NOT HERE THIS EVENING. THAT'S WHY I'M HAVING TO SPEAK FOR HER.
- >> THANK YOU. JUST BECAUSE MR. DENLING HAS BEEN THE GOLF
 PRO AT LONG RUN IN MY DISTRICT. WE HAVE A NEW GOLF PRO OUT
 THERE, ONE OF THE CONTRACTS WE JUST APPROVED LAST MEETING, BUT
 I'M EXCITED TO SEE HIS EXPERIENCE CONTINUE WITHIN THE GOLF
 COMMUNITY. I WANT TO SAY THANK YOU TO ALL AND EVERYONE INVOLVED
 AND KEEPING HIM INVOLVED IN GETTING IN THIS NEW CONTRACT. HE'S A

 ADOPTED. MADAM CLERK, A READING OF ITEM NO. 50.
- >> AN EMERGENCY RESOLUTION TO INITIATE AN INVESTIGATION
 INTO ALLEGATIONS OF SEXUAL HARASSMENT AND OTHER MISCONDUCT AT
 TARC. READ IN FULL.
 - >> MOTION TO APPROVE.

>> MOTION BY COUNCIL MEMBER ENGLE, SECONDED BY COUNCIL MEMBER PEDEN. ANY DISCUSSION? COUNCIL MEMBER PIAGENTINI.

>> THANK YOU, MR. PRESIDENT. I DON'T THINK I HAVE TO ELABORATE OR TALK MORE ON WHAT WE'VE ALL SEEN ON THE NEWS, IT'S MADE HEADLINES THROUGH SEVERAL NEWS OUTLETS, AND THAT'S THE INCREDIBLY, I'LL JUST USE THE LANGUAGE DISGUSTING, HORRIBLE, ALLEGATIONS OF SEXUAL HARASSMENT OF SEVERAL FEMALE EMPLOYEES AT OUR PUBLIC TRANSIT SYSTEM TARC. WHEN I WAS MADE AWARE OF THESE, I DID WHAT ANY NORMAL PERSON IN GOVERNMENT WOULD DO, WHO WANTED TO UNDERSTAND WHAT WAS GOING ON, AND SORT OF GET TO THE BOTTOM OF THINGS. AND MORE AND MORE INFORMATION KEPT POURING IN, AND WHAT BECAME ABUNDANTLY CLEAR TO ME IS TO BE REMINDED OF WHAT IT IS WE DO HERE. WE HAVE A COMMITTEE, GOVERNMENT ACCOUNTABILITY, FOR WHICH I'M VICE CHAIR. COUNCILMAN ACKERSON IS CHAIR, WHOSE RESPONSIBILITY AS THE CO-EQUAL BRANCH OF GOVERNMENT THAT WE ARE, IS TO EXECUTE OVERSIGHT OF FUNCTIONS OF GOVERNMENT WHEN THINGS ARE BROKEN. SO I'M NOT GOING TO BELABOR THIS TOO MUCH. I'M GOING TO HIGHLIGHT A FEW OF THE WHEREAS CLAUSES IN THE RESOLUTION THAT YOU HAVE IN FRONT OF YOU. I THINK THEY DO AN OUTSTANDING JOB IN OUTLINING PRECISELY WHY I'M CHAMPIONING THIS, AND I WOULD LOOK FOR ADDITIONAL COSPONSORS, AS WELL AS WIDESPREAD BIPARTISAN SUPPORT. WE ALREADY HAVE BIPARTISAN SUPPORT IN THE COSPONSORING OF THIS. THE FIRST WHEREAS STATEMENT ESTABLISHES WHAT I JUST MENTIONED, THE ALLEGATIONS REGARDING WIDESPREAD SEXUAL

HARASSMENT AT TARC AND THAT THEY SHOULD BE THOROUGHLY INVESTIGATED TO UNDERSTAND WHAT HAPPENED AND WHAT PREVENTIVE MEASURES MIGHT BE TAKEN GOING FORWARD. WE CAN'T ERASE THE PAST, UNFORTUNATELY, AND I'M SURE THE VICTIMS, WHICH MUST BE THE FOCUS OF THIS PROCESS, THAT THERE ARE MULTIPLE WOMEN, MANY EMPLOYEES OF THIS GOVERNMENT WHO HAVE BEEN VICTIMIZED, AND PART OF THAT VICTIMIZATION IS A BREAKDOWN OF PROCESS. IT IS INCUMBENT UPON US TO UNDERSTAND THE PROCESS AND FIX THE PROCESS SO THIS IS ELIMINATED AND THIS NEVER HAPPENS AGAIN WITHIN THIS METRO GOVERNMENT. ANOTHER WHEREAS CLAUSE THAT SEEKS TO UNDERSTAND THE EXISTING PROCESS THAT TARC INTENDED TO PROTECT AND SUPPORT ITS EMPLOYEES. I KNOW WHEN I HEARD THE ALLEGATIONS, I KNOW I TOOK A PERSONAL SWEAR THAT I'M NOT GOING TO GO ANOTHER DAY, AND I'M NOT GOING TO WORK ANOTHER DAY FOR THIS METRO GOVERNMENT WITHOUT TAKING ACTION. TO PROVIDE AN ENVIRONMENT FREE OF SEXUAL HARASSMENT AND INTIMIDATION. SOMETHING WE SHOULD ALL EXPERIENCE WHEN WE GO INTO WORK. AND TO PROVIDE FULL TRANSPARENCY INTO HOW TARC FUNCTIONS. IN ADDITION TO THESE METRO COUNCIL MEMBERS, US, HAVING INSIGHT AND DOING A FULL INVESTIGATION INTO THIS, IT'S NOT GOOD ENOUGH THAT WE KNOW. IT'S IMPORTANT THAT THE PUBLIC UNDERSTANDS, AND THE PUBLIC HAS REASSURANCE FOR A MYRIAD OF REASONS, NOT THE LEAST OF WHICH THEY PAY FOR IT. THIS IS THE REPRESENTATIVES -- WE ARE THE REPRESENTATIVES OF THEM IN LOCAL GOVERNMENT, BUT ALSO SO AS WE RECRUIT, AS WE'RE LOOKING FOR

TALENT, RIGHT, WE WANT THE BEST. WE WANT PEOPLE TO FEEL THAT WHEN THEY COME HERE TO WORK, THEY ARE WORKING IN A GREAT ENVIRONMENT WITH A GREAT TEAM, WITH GREAT LEADERSHIP. AND THAT IS SOMETHING ELSE WE CAN PROVE THROUGH THIS PROCESS THAT, YES, SOMETHING WAS BROKEN. CLEARLY, WE CAN SEE THAT. WE WILL DO THE RIGHT INVESTIGATION. WE WILL GET TO THE BOTTOM OF THINGS, AND WE NEED TO, AS THE OVERSIGHT ORGANIZATION, TAKE ACTION AND MAKE CHANGE. SO THE RESOLUTION THE REST OF YOU HAVE BEFORE YOU, I AM GOING TO TAKE A MOMENT TO MAKE AN AMENDMENT TO THIS RESOLUTION. ONE OF THE MOST IMPORTANT THINGS THAT WE START WITH IS ESTABLISHING AND GIVING THOSE THAT HAVE BEEN VICTIMIZED THE OPPORTUNITY TO EXPRESS TO HAVE A VOICE, WHERE THROUGH THIS VICTIMIZATION, ONE OF THE THINGS IS THEY DIDN'T, RIGHT? THAT IS THE NATURE OF VICTIMIZATION, NOT BEING ABLE TO HAVE A VOICE AND NOT BEING HEARD. WITH THAT SAID, THESE ARE INCREDIBLY SENSITIVE TOPICS, AS MY COLLEAGUES WE DISCUSSED IN THE COMMITTEE OF THE WHOLE, AND I COULDN'T AGREE MORE. SO ON PAGE 3 OF THE RESOLUTION, THIRD BULLET POINT DOWN, ABOVE THE FIRST SUB BULLETS, THE AMENDED SENTENCE WILL READ, "FOR PURPOSES OF EXPLANATION AND NOT LIMITATION, IT IS PRESENTLY CONTEMPLATED THAT INVESTIGATIVE ACTIONS SHALL INCLUDE IDENTIFYING AND INTERVIEWING ALL PERSONS," WE WILL INSERT THE FOLLOWING LANGUAGE, "WHILE PROTECTING AND PRESERVING VICTIMS' RIGHTS, PRIVACY, AND ANONYMITY." IN PARENTHESES, "UNLESS OTHERWISE

REQUIRED BY STATUTE OR LAW," END PARENTHESES, AND THEN GO ON WITH THE REST OF THE RESOLUTION, "AND/OR BODIES WHO EITHER; MOVE FORWARD." SO, FIRST, I'D LIKE TO MAKE A MOTION TO AMEND THE SCOPE OF THE INVESTIGATION SO THAT WE ARE ABLE TO GIVE THE VICTIMS A VOICE, AND, AT THE SAME TIME, PROTECT THEIR INNOCENCE. I MAKE THAT IN A MOTION.

- >> SECONDED BY COUNCILMAN ENGLE. ANY DISCUSSION? HEARING
 NONE, ALL THOSE IN FAVOR OF THE AMENDMENT SAY AYE. OPPOSED? AYES
 HAVE IT. CONTINUE ON.
- >> THANK YOU, MR. PRESIDENT. AND THE LAST THING I SAY, I
 WILL SAY, IS THERE HAVE BEEN, JUST SO EVERYBODY'S AWARE FROM A
 TECHNICAL, STRAIGHT TECHNICAL POINT OF VIEW, DOES NOT REQUIRE
 AMENDMENTS, WE'VE ALREADY BEEN DISCUSSING WITH THE COUNTY CLERK
 AND THE APPROPRIATE ATTORNEYS, THERE ARE, FOR EXAMPLE, IN THE
 TITLE, THE WORD "INVESTIGATION" IS MISSPELLED. WE UNDERSTAND
 THAT. TECHNICAL AMENDMENTS, TECHNICALITIES LIKE THAT DON'T
 REQUIRE AMENDMENTS, BUT THEY ARE UNDERSTOOD AND WE'LL CLEAN
 THOSE UP, AS WE WERE QUICKLY TRYING TO TAKE ACTION SO THAT,

- >> THANK YOU, MR. PRESIDENT, AND I WOULD LIKE TO OFFER MYSELF AS A COSPONSOR. COUNCILMAN PIAGENTINI, AND I DID BRIEFLY READ OVER THE BIOGRAPHY OF THE GENTLEMAN THAT'S GOING TO BE CONDUCTING THE INVESTIGATION, AND IT APPEARS TO ME HE'S IMMINENTLY QUALIFIED, SO WITH THAT I'D LIKE TO OFFER MY COSPONSORSHIP.
 - >> THANK YOU, COUNCILMAN REED. COUNCILMAN ENGEL?
- >> THANK YOU, MR. PRESIDENT. I'D LIKE TO BE ADDED AS A COSPONSOR, THANK YOU.
 - >> THANK YOU, COUNCILMAN ENGEL. COUNCILMAN BENSON?
 - >> THANK YOU, MR. PRESIDENT. I'D LIKE TO BE A SPONSOR ALSO.
- >> THANK YOU, COUNCILMAN BENSON. COUNCILWOMAN PARKER. THANK YOU, COUNCILWOMAN. ANY OTHER DISCUSSION? HEARING NONE, THIS IS A RESOLUTION ALLOWING FOR A VOICE VOTE. I'M SORRY -- I'M HAVING COMPUTER PROBLEMS ON MY END. COUNCILWOMAN SEXTON SMITH.
- >> YES, THANK YOU, MR. PRESIDENT. AND I AM NOT SEEKING TO BE ADDED AS A COSPONSOR, AND I DO NOT WANT THAT TO BE MISUNDERSTOOD OR MISINTERPRETED THAT I DO NOT TAKE SERIOUS THE ALLEGATIONS THAT HAVE BEEN PRESENTED TO ALL OF US, AND I JUST WANTED TO MAKE A STATEMENT FOR THE RECORD THAT THIS IS AN INCREDIBLY COMPLICATED AND VERY SERIOUS SET OF ISSUES AND MATTERS. SEXUAL HARASSMENT IN THE WORKPLACE AND A HOSTILE WORK ENVIRONMENT MUST BE TAKEN VERY SERIOUSLY AT ALL TIMES EVERYWHERE. MY CONCERN ABOUT THIS PARTICULAR RESOLUTION IS MORE

ABOUT PROCESS AND WHAT THAT MAY SAY TO THE LARGER COMMUNITY, AND WHAT THAT MAY SAY TO THE VICTIMS. WE DO NOT KNOW HOW MANY VICTIMS THERE ARE. WE JUST KNOW THE NUMBER THAT HAS BEEN STATED PUBLICLY, AND FROM MY OWN EXPERIENCE OF BEING IN THE WORKPLACE, THIS IS PROBABLY JUST THE TIP OF THE ICEBERG. AND THIS INVESTIGATION MAY LEND ITSELF TO REVEALING THAT. WE DON'T KNOW THAT. I WAS VERY CONCERNED WITH THE EMERGENCY NATURE THAT'S BEEN PLACED UPON, AND IT'S ALSO IN THE TITLE OF THIS RESOLUTION AND THE NEXT ONE WE'RE GOING TO BE DISCUSSING MOMENTARILY. WHAT HAPPENS WHEN WE PUT THE WORDS "EMERGENCY" AND WE USE LANGUAGE WHERE WE HAD A QUICK REVIEW STAND OVER THE DOCUMENTS, WE HAVE AN 11-PAGE AGREEMENT THAT WAS PRESENTED TO US THIS EVENING. WE HAVE A SEVERAL-PAGE BIO OF MR. BEYER THAT WAS PRESENTED THIS EVENING. WE HAVE A MULTIPLE-PAGE RESOLUTION PRESENTED TODAY. IT'S A LOT OF INFORMATION, MR. PRESIDENT, TO REVIEW, TO DIGEST, AND TO FULLY UNDERSTAND, AND TO GET TO THE POINT WHERE WE NEEDED TO AMEND IT ON THE FLOOR, I DO APPRECIATE THAT AMENDMENT. I JUST WANTED TO SAY THAT I'M TAKING THIS VERY SERIOUSLY. AND I WOULD HAVE PREFERRED THIS TO GO THROUGH THE LEGISLATIVE BODY'S NORMAL PROCESS, FROM MY PERSPECTIVE, WHICH WOULD HAVE BEEN HANDLED BY CHAIR ACKERSON AND THE GOVERNMENT OVERSIGHT AND ACCOUNTABILITY COMMITTEE, OF WHICH I AM A MEMBER, AND HE HAS LED THAT COMMITTEE DURING THE YEARS I'VE BEEN ON COUNCIL THROUGH SOME VERY DIFFICULT CONVERSATIONS. AND HE'S DONE HIS JOB VERY WELL. I

WOULD HAVE HAD FULL FAITH AND CONFIDENCE HE WOULD HAVE BEEN ABLE TO ADDRESS THIS AND THEN BRING THIS BEFORE THE COMMITTEE OF THE WHOLE FOR FILING AND CONSIDERATION FOR COMING TO THE FULL COUNCIL FOR SPECIAL LEGISLATION. I ALSO WANTED TO BE ON RECORD AS STATING THAT I'M VERY CONCERNED ABOUT THE MULTIPLE INVESTIGATIONS THAT WILL BE ONGOING RELATED TO THESE ALLEGATIONS. THERE ARE ATTORNEYS HIRED BY SOME, DON'T KNOW HOW MANY OF THE VICTIMS. THERE WILL BE INVESTIGATIONS POSSIBLY DONE INTERNALLY AT TARC, THE ADMINISTRATION OF LOUISVILLE METRO HAS STATED THAT THEY HAVE HIRED COUNSEL, OUTSIDE COUNSEL AWAY FROM JEFFERSON COUNTY ATTORNEY'S OFFICE, AND NOW OUR INVESTIGATION. SO WITH THAT, THE VICTIMS ARE GOING TO BE QUESTIONED EXTENSIVELY, AND THEY ARE GOING TO BE ASKED TO SPEAK IN SOME VERY DIRECT, CLEAR TERMS ABOUT WHAT HAPPENED AND WHAT DID NOT HAPPEN, AND HOW THEY FELT, AND WHAT THAT DID TO THEM, HOW THAT DESTROYED THE WORKPLACE, WHERE THEY HAD TO GO EVERY DAY FOR THEIR LIVELIHOOD SO THEY COULD PAY RENT, MORTGAGES, INSURANCE, PUT FOOD ON THE TABLE, BUY SCHOOL SUPPLIES, WHO KNOWS? THEY HAD TO DO THAT AND THEY HAD TO ENDURE THAT. THAT'S AN AWFUL THING TO HAVE TO ENDURE. IT NOT ONLY DESTROYS THAT WORK ENVIRONMENT. IT DESTROYS THE FAMILY, AND IT DESTROYS SOCIAL CIRCLES. IT DESTROYS EVERYTHING WITHIN YOUR SPHERE OF INFLUENCE. THIS HAS TO BE TAKEN SERIOUSLY, AND IT IS COMPLICATED. I WANT TO IMPLORE MY COLLEAGUES, SHOULD THIS PASS, AND SHOULD THIS INVESTIGATION

BEGIN AT THE LOUISVILLE METRO COUNCIL LEVEL IN COMMITTEE, WE MUST STAY IN THE LANE WHICH WE HAVE THE POWER AND AUTHORITY TO DO. AND, COLLEAGUES, PLEASE, LET'S DO NOT PARADE THESE VICTIMS BEFORE US OR THROUGH US IN ANY WAY THAT MAY UNINTENDEDLY REVEAL THEIR IDENTITY, WHICH WE HAVE AMENDED THE RESOLUTION. AND I HATE TO HAVE TO PROCEED AND HOPE THAT WE ALL ABIDE BY THIS. THERE ARE 26 OF US. WE WILL HAVE TO WORK VERY CAREFULLY AND VERY INTENTIONALLY. MY PREFERENCE WOULD HAVE BEEN THAT THE INVESTIGATION BY OUR COMMITTEE AND THIS BODY WOULD HAVE BEEN CONTAINED ONLY TO THE HIRING PROCESS, THE VETTING PROCESS, THE PERSONNEL, POLICIES, AND PROCEDURES, THE PROCEDURES THAT ARE AVAILABLE TO EMPLOYEES TO ISSUE COMPLAINTS AND HOW THOSE ARE HANDLED AND DEALT WITH. I WOULD HAVE PREFERRED TO LEFT OUT ALL OF THE INVESTIGATION AT THIS LEVEL OF SEXUAL HARASSMENT AND THESE SPECIFIC ALLEGATIONS AND THE NATURE OF THOSE. THAT IS WHERE I'M CONCERNED THAT WE COULD GO AWRY. I WILL NOT BE SEEKING COSPONSORSHIP. THANK YOU, MR. PRESIDENT.

- >> THANK YOU, COUNCILWOMAN. COUNCILWOMAN GREEN.
- >> THANK YOU, MR. PRESIDENT. I'M LITERALLY SICK TO MY
 STOMACH OF THE ALLEGATIONS. IT'S SOMETHING THAT PERSONALLY JUST
 MAKES ME COMPLETELY IRATE. I HAVE SPOKEN WITH CHAIRMAN ACKERSON
 AND COUNCILMAN PIAGENTINI, AND THEY BOTH HAVE ASSURED ME THAT
 THIS IS NOT GOING TO TURN INTO AN EXPEDITION WHERE VICTIMS ARE
 FURTHER REVICTIMIZED. IT IS IMPORTANT ENOUGH TO ME THAT I THINK

WE AS A COUNCIL INDEPENDENTLY INVESTIGATE WHAT, WHEN, WOW, WHY,
THAT THIS PIECE OF LEGISLATION NEEDS TO PASS, WITH THE
PARTICULAR CAVEAT THAT WE BE VERY SENSITIVE TO THE WOMEN
INVOLVED IN THIS MATTER, SO I AM REQUESTING TO BE ADDED AS A
COSPONSOR. THANK YOU.

- >> THANK YOU, COUNCILWOMAN. COUNCILWOMAN DORSEY?
- >> I SHOULD NOT BELABOR EVERYTHING THAT'S BEEN SAID. I
 SHALL BE SUPPORTING THIS, BUT THERE'S ONE THING I DO WANT TO
 ECHO, WHICH ARE THE SENTIMENTS OF COUNCILWOMAN SEXTON SMITH,
 WHICH IS WE STAY IN OUR LANE IN THIS REGARD, AND THERE'S ONE
 THING I DO WANT TO FURTHER ITERATE, IS THAT THE RECOMMENDATIONS
 OR THE LESSONS LEARNED COMING OUT OF THIS INVESTIGATION REALLY
 NEED TO BE APPLIED ACROSS ALL GOVERNMENT AGENCIES AND ALL QUASI
 AGENCIES SO WE USE THIS AS A SPRINGBOARD NOT JUST FOR
 UNDERSTANDING WHAT HAPPENED AT TARC, BUT WE NEED TO PUT POLICIES
 IN PLACE ACROSS THE BOARD FOR ALL GOVERNMENT AND QUASI AGENCIES.
 FOR THAT REASON, I THINK THE LESSONS LEARNED COMING OUT OF THIS
 WILL GIVE US A GOOD FOUNDATION FOR MOVING FORWARD. FOR THAT
 REASON, I WILL BE SUPPORTING THIS.
 - >> THANK YOU, COUNCILWOMAN. COUNCILWOMAN PURVIS?
- >> THANK YOU, MR. PRESIDENT. I JUST WANT TO GO ON RECORD

 AND STATE THAT I WILL BE COSPONSORING THIS, AS WELL, AND I JUST

 WANTED TO MAKE SOME BRIEF COMMENTS ABOUT THIS WHOLE SITUATION. I

 CAN JUST SAY IT SIMPLY AS IT'S BEEN A REALLY, REALLY NASTY

EVENT, AND I REALLY, REALLY FEEL BAD ABOUT THE VICTIMS, AND SO I FEEL LIKE THAT WE NEED TO SEND A MESSAGE THAT WE ARE TRYING TO PROTECT THEM AND OTHERS THAT COULD POTENTIALLY BE VICTIMIZED.

SO, THEREFORE, I AM COSPONSORING THIS.

- >> THANK YOU, COUNCILWOMAN. COUNCILMAN HOLLANDER?
- >> THANK YOU, MR. PRESIDENT. I SHARE THE CONCERN ABOUT
 MULTIPLE INVESTIGATIONS, AND I WAS PLEASED TO HEAR YOU, MR.

 PRESIDENT, SAY AT OUR CAUCUS MEETING TODAY THAT THERE IS A
 MEETING SCHEDULED ON WEDNESDAY TO DISCUSS THE OTHER

AS YOU MAY KNOW, WE HAD TO, BECAUSE OF POTENTIAL CONFLICT ISSUES WITH THE COUNTY ATTORNEY, THE COUNTY ATTORNEY'S REFERRED US TO OUTSIDE COUNSEL TO ACT IN THE FUNCTION OF COUNTY ATTORNEY FOR US IN THIS MATTER. YOUR CONCERN REGARDING CONFIDENTIALITY BETWEEN THE INVESTIGATOR

AND THIS BODY. AND IN THE DRAFT THAT WE PREPARED AND SENT TO MR.

BEYER, IT DID CONTAIN SPECIFIC LANGUAGE WITH REGARDS TO

CONFIDENTIALITY. THE ONLY OTHER COMMENT I WOULD MAKE IS I DO

BELIEVE IN ADDITION TO WHAT IS CONTAINED WITHIN THE DOCUMENT

THERE, I DO BELIEVE THAT MR. BEYER ALSO WOULD BE BOUND BY THE

ATTORNEY-CLIENT PRIVILEGE. SO THAT IS MORE OF AN ETHICAL

OBLIGATION IMPOSED BY THE KENTUCKY SUPREME COURT, THE RULES THAT

HE'S AGREED TO ABIDE BY, BY VIRTUE OF HIS LICENSE HERE IN THE
