- >> PRESIDENT JAMES: THANK YOU. COUNCILMAN BENSON. I THINK YOU HAVE SPECIAL GUESTS THIS EVENING.
- >> YES, SIR, THANK YOU. THANK YOU, MR. PRESIDENT, AND
 MEMBERS OF THE COUNCIL. TONIGHT, IT'S MY HONOR TO RECOGNIZE KURT
 MASON FOR AN OUTSTANDING ACHIEVEMENT FOR US IN OUR COMMUNITY FOR
 USDA NATIONAL RESOURCES. 17 YEARS BEING ON THE COUNCIL, I'VE
 NEVER MET A PERSON THAT WOULD HELP ME MORE WITHOUT NECESSARILY HE'S ALWAYS DOING THE RIGHT THING. I DON'T HAVE TO WORRY ABOUT
 HIM DOING SOMETHING I WANT HIM TO DO, HE'S GOING TO DO THE RIGHT
 THING. AND OUR COMMUNITY, OUR PARKS, WE GET GRANTS FROM THE USDA

- >> YES, THANK YOU, MR. PRESIDENT. AND COUNCILMAN BENSON, THANK YOU SO MUCH FOR DOING THIS. I DON'T KNOW KURT VERY WELL, BUT KURT CROSSED MY PATH AT A TIME WHEN I WAS SPONSORING LEGISLATION THAT I REALLY DIDN'T UNDERSTAND AND DIDN'T KNOW WHAT TO DO WITH IT AND HOW TO PROCESS IT, AND KURT MADE IT SO SIMPLE AND EASY TO UNDERSTAND, BECAUSE IT WAS LEGISLATION THAT WAS INVOLVING TRANSFERRING LAND FROM AN OLD COUNTY PROPERTY INTO THE ENVIRONMENTAL LAND TRUST IN JEFFERSON COUNTY, AND THANKS TO COUNCILMAN BILL HOLLANDER FOR ENCOURAGING ME ALONG THE WAY AND LETTING ME KNOW THIS IS SOMETHING POSITIVE, AND HE ASKED IMMEDIATELY IF KURT WAS INVOLVED, AND WHEN I SAID YES, HE SAID, YOU HAVE NOTHING TO WORRY ABOUT. WALKED US THROUGH HOW WE COULD DO THAT, AND WE WANTED TO DO A
COMMUNITY GARDEN. I WAS SO IMPRESSED AT THAT TIME BY THE LEVEL
OF TIME AND PATIENCE YOU TOOK WITH US, HAVING NEVER TAKEN ON
THAT TYPE OF ENDEAVOR, WALKING US THROUGH WHAT WE NEEDED WITH

UNDERESTIMATE WHAT KURT HAS DONE FOR JEFFERSON COUNTY. I TOOK A
LOOK AT HIS RESUME WHEN HE WAS TRANSITIONING OUT. I LOOK AT WHAT
HE HAS DONE, AND I WILL GUARANTEE YOU, EVERY DISTRICT IN THIS
CHAMBER, KURT HAS LEFT HIS FOOTPRINT. WE ARE ALL INDEBTED FOR
KURT FOR THE WORK HE HAS DONE. WHEN YOU TALK ABOUT WATER, BEAR
GRASS CREEK, FLOYD'S FORK, OHIO RIVER, MSD, WE ARE ALL INDEBTED
TO KURT FOR THE WORK THAT HE'S DONE AND HIS FOOTPRINT WILL BE
HERE FOREVER. THANKS A MILLION.

>> I'M GOING TO BE SHORT. WHEN I CAME HERE 1980, I TOLD MY WIFE, I SAID, WE'RE GOING TO MOVE TO LOUISVILLE FROM MT.

STERLING, KENTUCKY. AND I GREW UP IN SKY COUNTY. I SAID WE'RE GOING TO BE HERE PROBABLY TWO YEARS, AND THEN I WANT TO GO TO WESTERN KENTUCKY, WHERE THERE'S LARGE CORN AND CROPFIELDS, BECAUSE MY BACKGROUND IS DIRT. I SAID, MAYBE TWO YEARS. FELL IN LOVE WITH THIS GREAT CITY. IT HAS EVERYTHING THAT ANYBODY IN KENTUCKY AND OTHER STATES WANTS TO SEE. WE HAVE ONE CHANCE TO DO THINGS RIGHT WITH NATURAL RESOURCES AND WITH THE WORK THAT OUR COMMUNITY DOES, AND THAT'S BEEN MY MESSAGE TO URBAN, TO RURAL, AND SUBURBIA, IS THAT THE THINGS THAT WE LOSE FROM NATURE, THE THINGS THAT WE LOSE FROM NATURE, THE

BACK. SO THINK THROUGH IT AND DO IT RIGHT. THANK YOU. [APPLAUSE

>> PRESIDENT JAMES: THANK YOU, COUNCILMAN BENSON. NEXT WE HAVE A SPECIAL GUEST FROM FUND FOR THE ARTS. MR. J.P. DAVIS.

>> THANK YOU SO MUCH. THANK YOU. THANK YOU. NO, IT'S ALWAYS A PLEASURE TO JOIN ALL OF YOU. AS MANY OF YOU KNOW, I'M USUALLY HERE TO ASK SOMETHING, BUT TONIGHT I'M HERE TO JUST SAY THANK YOU AND CELEBRATE OUR AMAZING PARTNERSHIP THAT WE'VE HAD TOGETHER THIS PAST YEAR. JUST A FEW THINGS, UPDATES, YOU HAVE SOMETHING IN FRONT OF YOU THAT I BELIEVE WAS PASSED OUT. FUND FOR THE ARTS HAS BEEN AROUND 71 YEARS AND HAS BEEN IMPROVING LOUISVILLE FOR ACCESS THROUGH THE ARTS. IN KENTUCKY LAST YEAR THROUGH WORK, 2.1 MILLION ATTENDEES AT ARTS EVENTS THIS YEAR, 855 LOCATIONS FOR ARTS EXPERIENCES, INCLUDING MORE THAN 160 COMMUNITY CENTERS, LIBRARIES, PARKS, AND HEALTH AND SENIOR CARE COMMUNITIES. EDUCATION IS A KEY PRIORITY OF THE FUNDS' EFFORTS. ARTS PARTICIPATION IS KEY FOR SUCCESSFUL STUDENTS. STUDENTS INVOLVED IN ARTS, WE KNOW, THE DATA SHOWS ARE FOUR TIMES MORE LIKELY TO BE RECOGNIZED FOR ACADEMIC ACHIEVEMENT. LAST YEAR WE MADE POSSIBLE 400,000 ARTS EXPERIENCES IN 450 SCHOOLS IN 81 COUNTIES. ARTS ARE A CRITICAL DRIVER OF ECONOMIC DEVELOPMENT. WE PROVIDED THAT SHEET IN FRONT OF YOU, AND JEFFERSON COUNTY ALONE, WE CONTRIBUTE \$10.7 MILLION TO LOCAL GOVERNMENT REVENUE. WE CREATE 17,000 JOBS AS A SECTOR, AND WE HAVE CALCULATED A \$460

MILLION ECONOMIC IMPACT IN JEFFERSON COUNTY ALONE. FOR THE CULTURAL PATH, WHICH WE'RE SUPER EXCITED ABOUT, AS YOU ALL KNOW, THE CULTURAL PATH PROVIDES FREE ACCESS TO ARTS AND CULTURAL INSTITUTIONS FOR CHILDREN OF ALL AGES, ENCOURAGING LIFELONG LEARNING AND DECREASING SUMMER LEARNING LOSS. LAST YEAR, 40,000 VISITS WERE MADE BY GREATER LOUISVILLE FAMILIES. THAT'S A 13% INCREASE OVER LAST YEAR. AND JUST TO POINT OUT, SINCE LOUISVILLE METRO GOVERNMENT AND FUND FOR THE ARTS TOOK OVER THIS INITIATIVE FOUR YEARS AGO, WE'VE SEEN DOUBLE-DIGIT PERCENT INCREASES IN PARTICIPATION BY FAMILIES THROUGH THE REGION, SO THIS PARTNERSHIP IS CLEARLY WORKING. OF THOSE VISITS, 74% WERE MADE IN JEFFERSON COUNTY BY JEFFERSON COUNTY CHILDREN. 45 OF THE 59 PARTICIPATING ARTS AND CULTURAL VENUES ARE JEFFERSON COUNTY, AND 96% OF PARTICIPANTS REPORTED THAT THE CULTURAL PATH MAKES THEM FEEL MORE CONNECTED TO THEIR COMMUNITY AND TO THEIR FAMILY. THE CULTURAL PATH IS CONNECTED IN TANDEM WITH SUMMER READING AT LOCAL LIBRARIES. WE WERE ABLE TO SHOW 158,000 BOOKS READ THIS YEAR BY STUDENTS IN JEFFERSON COUNTY. THE MURAL FESTIVAL, THE IMAGINE MURAL FESTIVAL, THE INAUGURAL MURAL FESTIVAL THAT WE DID TOGETHER, IN OCTOBER THE FUND FOR THE ARTS IN PARTNERSHIP WITH YOU AND LOUISVILLE VISUAL ART, WE LAUNCHED THE FIRST EVER MURAL FESTIVAL. SMOKETOWN WAS SELECTED AS THE RECIPIENT NEIGHBORHOOD DUE TO THE NEIGHBORHOOD'S DESIRE FOR MURALS. THROUGHOUT THE ARTIST SELECTION AND DESIGN PROCESS, NEIGHBORHOOD RESIDENTS

PLAYED A CRITICAL ROLE, PROVIDING THEIR INPUT ON HOW THEY WANTED THEIR COMMUNITY REPRESENTED. THE FUND FOR THE ARTS MATCHED \$100,000 INVESTED BY YOU, LOUISVILLE METRO, TO SELECT 13 LOCAL, NATIONAL, AND INTERNATIONAL ARTISTS TO CREATE 15 MURALS. THE MURALS HIGHLIGHT THE CITY'S LEAN INTO LOUISVILLE VISION, AS WELL AS THE NEIGHBORHOOD'S HISTORY AND HOPE FOR THE FUTURE. PROMINENT PAST AND CURRENT RESIDENTS ARE FEATURED IN SOME OF THE MURALS. ALL OF THE MURALS WERE CREATED OVER A THREE-WEEK PERIOD, SUDDENLY BRIGHTENING THE NEIGHBORHOOD'S CORNERS. A COMMUNITY CELEBRATION CLOSED THE FESTIVAL WITH FREE WALKING AND BUS TOURS, AS WELL AS MUSICAL AND PERFORMING ACTS THROUGHOUT THE DAY. THANK YOU, ALL, SO MUCH, FOR YOUR ONGOING PARTNERSHIP IN SUPPORT FOR THE FUND FOR THE ARTS. WE VALUE THAT VERY MUCH, AND THANKS FOR THE OPPORTUNITY TO BE HERE.

- >> PRESIDENT JAMES: THANK YOU, J.P., THANK YOU FOR

 EVERYTHING YOU ALL DO. [APPLAUSE] MADAM CLERK, ANY ADDRESSES

 TO COUNCIL?
 - >> CLERK: YES, SIR.
- >> PRESIDENT JAMES: PLEASE REFRAIN FROM USING PROFANITY OR MAKING DEROGATORY STATEMENTS TO COUNCIL MEMBERS. MADAM CLERK, PLEASE CALL THEM FORWARD.
 - >> CLERK: CECIL CALHOUN, WALLACE MCMULLEN.
- >> GOOD EVENING, I WOULD LIKE TO BEGIN TONIGHT BY APPLAUD
 THE COUNCIL. VOTING FOR THE RESOLUTION TOOK FORESIGHT AND

POLITICAL COURAGE. I AND MY COLLEAGUES APPLAUD YOU FOR HAVING THAT COURAGE AND PASSING THE RESOLUTION. PASSING THE RESOLUTION HAS SET GOALS FOR LOUISVILLE TO JOIN IN ADDRESSING THE CLIMATE CRISIS AND, HOPEFULLY, CREATE THE PATH FOR THE CITY TO SAVE MONEY AS IT MOVES AWAY FROM CONSUMING FOSSIL FUELS. BUT TONIGHT WE HAVE ONLY A GOAL. WE KNOW THE HARD WORK OF PASSING SPECIFIC POLICIES AND APPROPRIATIONS STILL LIES AHEAD. THOSE OF US WHO HAVE BEEN ACTIVE WITH THE 100% RENEWABLE GROUP, WE COMMIT TO CONTINUING TO WORK WITH COUNCIL MEMBERS WITH THE CITY OFFICE OF SUSTAINABILITY AND ADVANCED PLANNING AND WITH OTHER CIVIC GROUPS ON THE QUEST FOR POWERING OUR COMMUNITY WITH 100% RENEWABLE ENERGY. I EXPECT WE WILL BE HAVING MANY CONVERSATIONS ABOUT HOW TO FINANCE LARGE SOLAR INSTALLATIONS AND ABOUT HOW TO IMPROVE THE ENERGY EFFICIENCY OF METRO COUNCIL, AND ABOUT HOW TO MAKE OTHER CHANGES TO ADDRESS CLIMATE CHANGE. TONIGHT, I'M GOING TO HIGHLIGHT SOME OF THE EXCELLENT WORK THAT OUR OFFICE OF SUSTAINABILITY HAS DONE IN GATHERING CLIMATE CHANGE INFORMATION AND HOW IT WILL AFFECT US IN LOUISVILLE. I'M USING INFORMATION IN A FLYER THEY CREATED. MOST STRIKING IN THIS INFORMATION, PERHAPS, IS THE NUMBER OF DAYS PER YEAR WITH A TEMPERATURE OVER 90 DEGREES. IN THE 1970S, LOUISVILLE AVERAGED 24 DAYS A YEAR WITH OVER 90-DEGREE WARMTH. IN THE DECADE WE JUST EXPERIENCED LIVING THROUGH, 2010 TO 2019, LOUISVILLE AVERAGED 50 DAYS A YEAR WITH READINGS OVER 90 DEGREES. A DOUBLING OF DAYS PER YEAR OF

OVER -- I'M SAYING THIS WRONG. THE NUMBER OF DAYS WITH A TEMPERATURE OVER 90 DEGREES DOUBLED IN THAT TIME PERIOD, A DEFINITE INDICATION OF THE CLIMATE GETTING HOTTER. THE RANGE OF PEAK TEMPERATURES MAY INCREASE UPWARDS BY AS MUCH AS 14 DEGREES IN 2015, WHICH WOULD MEAN A DAYTIME TEMPERATURE OF 110 DEGREES. WHAT'S LOUISVILLE GOING TO BE LIKE WHEN IT'S 110 DEGREES OUTSIDE? HOW MANY DEATHS FROM HEAT STRESS WILL WE STRUGGLE WITH? THERE'S A BUNCH OF OTHER IMPACTS IN THIS FLYER, SUCH AS FLOODING, OVERWHELMING RAINSTORMS, INCREASED MENTAL ILLNESS AND DECREASED AIR QUALITY, BUT I'M SHORT IN TIME, SO I'M GOING TO LEAP TO ONE MORE CLIMATE IMPACT. VECTOR AND WATER-BORNE DISEASES, INCLUDING ZIKA AND DENGUE. THE WARMER WATER BODIES WE'RE GOING TO HAVE, INCREASING WARMTH IN THE OHIO RIVER, ET CETERA, INCREASE THE POTENTIAL FOR INCREASED INCIDENCE OF FORMERLY TROPICAL DISEASES. THESE PROJECTED HEALTH IMPACTS SCARE ME A LOT. SO THE POINT IS THE EXTREME WEATHER CAN KILL US AND MAKE LIFE VERY UNCOMFORTABLE, BUT WE CAN TAKE ACTION NOW TO MITIGATE OR AVOID THESE IMPACT. YOU'RE GOING TO BE CALLED ON TO MAKE DECISIONS WITH LONG LASTING EFFECTS. I URGE YOU TO CHOOSE TO ADDRESS CLIMATE CHANGE FORTH RIGHTLY AND AGGRESSIVELY. THANK YOU. [APPLAUSE]

- >> CLERK: DEBORAH O'GORMAN.
- >> HOW ARE YOU ALL DOING TONIGHT? MAY I? HOW ARE YOU ALL DOING? EVERY ONE OF YOU KNOW ME, BIG-MOUTH DEB. NOT EVERY ONE OF

YOU GOT A ENVELOPE WITH MORE INFORMATION. RIGHT NOW, IN THE UNITED STATES, ONE OUT OF EVERY 25 PEOPLE HAVE EPILEPSY. WE GOT 26 OF YOU ON THE BOARD, OR 27 OF YOU SITTING IN THIS ROOM. THAT MEANS AT LEAST ONE OF YOU MIGHT HAVE A SEIZURE AND HAVE EPILEPSY. KENTUCKY HAS OVER 200,000 PEOPLE WITH EPILEPSY. GUESS WHAT? THAT'S QUITE A BIT. THERE'S OVER 40 TYPES OF SEIZURES. AFTER YOUR FIRST PREGNANCY, THERE'S CALLED CATAMENIAL SEIZURES. AND I WON'T TELL YOU WHAT THE NAME MEANS, BECAUSE WOMEN ARE NOT DONE. MORE WOMEN ARE HAVING PROBLEMS THAN MEN. EVERYONE LOOKS AT THE BOTTOM OF THEIR SHOE, WHAT IS IT? RUBBER. WHY? BECAUSE THIS HERE IS EXACTLY WHAT THEY ARE TALKING ABOUT. ELECTRICITY GOES RIGHT TO OUR BRAIN, AND THE OZONE LAYER IS GONE, BECAUSE WE USE COAL. THERE'S OVER 40 TYPES OF SEIZURES. YOU'RE LOOKING AT BEAUTIFUL COMPUTERS RIGHT NOW. WHEN THEY ARE MADE OF HOMEMADE COMPUTERS THEY WERE GROUND ZONED, JUMPED TO OUR BRAINS. MIGRAINES, DEPRESSION, PARKINSON'S AND ALL. ANYONE TAKEN DANTALINE IN THEIR LIFE CAN SUE THEM, SUE, AND I HOPE YOU DO IT. I'VE GOT OVER 3,000 PEOPLE COME TO ME EVERY DAY. CALL ME. THING IS, I'M GOING TO SCHOOLS NOW, BECAUSE KIDS ARE AFRAID TO GO TO SCHOOL, KIDS GET TEASED. BOYS GET TEASED. MY MOM AND DAD SAY --BOYS GET TEASED, MOMMY AND DADDY GOING TO DRIVE YOU ON A DATE? IT'S NOT FAIR, PEER PRESSURE, THEN THEY WANT TO KILL THEMSELVES. WE GOT TO STOP THIS. EPILEPSY IS IN THE BIBLE. JOAN OF ARC, HARRIET TUBMAN. SHE WAS EPILEPTIC. THEY DIDN'T PUT THAT IN

THERE, DID THEY? EPILEPSY IS THE OLDEST DISEASE KNOWN TO MAN, AND WE'RE WORRIED ABOUT CORONAVIRUS? THEY ARE PUTTING COMPUTERS IN THE BRAIN. PEOPLE ARE NOT WEARING MEDICAL I.D.S. IF YOU LIVE IN INDIANA, DON'T GET WHAT WE GET. WE GOT THE BEST DOCTORS IN THE UNITED STATES. UNIVERSITY OF LOUISVILLE, SEE A DOCTOR. I'M NOT PUTTING NURSES DOWN, GO TO A NURSE, YOU DON'T GET THE MACARONI. YOU GET THE BOLOGNA FOR MEDICARE. MEDICARE IS WASTING MONEY ON NURSES. THEY ARE GOOD, SEE A DOCTOR. ONE LIFE, YOU HAVE ONE BRAIN. EVERY TIME I KISS SOMEONE, WONDER IF I'LL KISS ANYBODY TONIGHT. I DON'T KNOW, REMEMBER IT. I USED TO HAVE 200 A MONTH, NOW DOWN TO ZERO BECAUSE OF VNS. I NEED HELP TO HELP THE PEOPLE. ASKING FROM \$1 TO \$500 FROM EACH OF YOU. I HAVE A WEBSITE GOING UP. I'M GOING TO SCHOOLS, AND I'M GETTING PEOPLE HELP. ASKING MONEY FROM THE MEMBERS, BECAUSE THEY ARE BROKE AND THEY NEED HELP. IF THE MINIMUM WAGE GOES UP, OUR DISABILITY RATES ARE NOT GOING UP. THAT'S RIGHT. WE DO NOT GO UP ON DISABILITY. I RESPECT PEOPLE \$15 OR MORE. I KNOW TIME'S UP. ONE MORE SECOND. THE BLIND PEOPLE MAKE \$2,000 A MONTH UP TO OVER THE DISABILITY, BECAUSE THERE'S NO CURE. GUESS WHAT, WE'RE IN THE BIBLE AND THERE'S NO CURE FOR US. JOHN YARMOUTH AND I ARE WORKING ON THAT NOW. GOD BLESS YOUR DAMN GOOD WORK AND I'LL BE -- SORRY. GOD BLESS YOUR WORK. I WORKED FOR THE ELECTIONS 25 YEARS IN OSCAR MANOR AND THAT BUILDING IS COMING DOWN. GOD BLESS YOU, READ MY NOTES, GOT MY PHONE NUMBER. KEEP UP THE DAMN GOOD WORK AND WE LOVE YOU.

>> HELLO. THANK YOU FOR VOTING FOR THE RESOLUTION TO ACHIEVE 100% RENEWABLE ENERGY BY 2040. I'M HERE TO ASK YOU TO KEEP THE INITIATIVE ALIVE. EVENTUALLY, IT WILL PAY FOR ITSELF. 2020 PROMISES A TURNAROUND IN U.S. ENERGY SYSTEM. ALREADY LAST YEAR AMERICA REALIZED THAT EXISTING COAL CANNOT COMPETE AGAINST RENEWABLES. THE COST OF NEW SOLAR, PLUS STORAGE, WERE LOWER THAN NEW NATURAL GAS GENERATION. 302 COAL PLANTS ARE SCHEDULED TO CLOSE IN 13 STATES AND TERRITORIES, AND 151 CITIES COMMITTED TO 100% CLEAN ENERGY. THE FUTURE OF FRAC GAS IS UNCERTAIN, IN ADDITION TO BEING INCREASINGLY RECOGNIZED AS A MENACE TO THE CLIMATE ENVIRONMENT, AND MANY PLACES IN THE COUNTRY PORTFOLIO OF RENEWABLE ENERGY STORAGE AND EFFICIENCY PROVIDE BETTER PERFORMANCE THAN GAS AND COAL AT A LOWER COST. INVESTORS FINALLY REALIZE FRAC GAS DOESN'T BREAK EVEN. WE MUST FOCUS ON CLIMATE ACTION. FIRST, WE NEED MORE INVESTMENT. WE CAN MEASURE SUCCESS BY THE AMERICAN RENEWABLE INVESTMENT GOAL, THE CAMPAIGN TO PROMOTE \$1 TRILLION OF PRIVATE SECTOR INVESTMENT IN RENEWABLE ENERGY, AND GOOD TECHNOLOGIES THAT STARTED IN 2018 AND CONTINUE UNTIL 2030. ACHIEVING THE \$1 TRILLION 2030 OBJECTIVE WOULD MEAN THAT THE U.S. WOULD COME WITHIN STRIKING DISTANCE OF THE PARIS CLIMATE TARGET. IN THE FIRST YEAR OF THE CAMPAIGN, \$57 BILLION

INVESTED WAS THE CREDIBLE START, BUT WE NEED TO NEARLY DOUBLE THAT RATE OF GROWTH TO MEET OUR 2030 TARGET. SECOND, WE NEED GOOD POLICIES AND NEW INFRASTRUCTURE GOALS. S U.S. ELECTRICAL GRID IS ANTIQUATED. TO ACCOMMODATE ACCELERATED RENEWABLE GROWTH, WE NEED SMART POLICIES TO ENCOURAGE ADVANCED TECHNOLOGY AND ENERGY STORAGE IN AN EXPANDED AND MODERNIZED TRANSMISSION SYSTEM AND IN MORE RENEWABLE POWER. CONGRESS TOOK A STEP BACKWARDS WHEN IT CUT KEY CLEAN ENERGY TAX INCENTIVES. WE NEED TO GET RID OF THE CENTURY-OLD SUBSIDIES FOR FOSSIL FUELS, AMOUNTING TO MORE THAN \$25 BILLION A YEAR AND PHASE IN TAX CODE WITH INCENTIVES FOR RENEWABLE ENERGY. HERE'S WHERE WE, LOUISVILLE CITIZENS, COME IN. PROGRESS TOWARDS 100% CLEAN ENERGY ALONE WILL NOT DO THE JOB THE FUTURE OF THE PLANET DEMANDS. WE EXPECT AN ACCELERATION OF COMMITMENTS TO DECARBONIZE OUR ENERGY SUPPLY. I'M SUGGESTING LOUISVILLE STEP UP WORK ON THIS RESOLUTION, SO IT CAN SERVE AS A MODEL AND ASSIST OTHER CITIES IN THE COMMONWEALTH TO MOVE FAST IN THAT DIRECTION. COVINGTON, DANVILLE, BOWLING GREEN, HENDERSON, ONLY TO NAME A FEW, SHOULD BE GEARING UP TO FOLLOW LOUISVILLE, ONLY AS LOUISVILLE HAS BEEN TAKING CUES FROM CINCINNATI. THANK YOU. [APPLAUSE]

 PUBLIC LIBRARY REPRESENTING THE MIDDLETOWN LIBRARY. FIRST, LET

 ME THANK METRO COUNCIL FOR ALL OF THE LONG SUPPORT THAT YOU HAVE

GIVEN US FOR THE LIBRARY. ESPECIALLY THANK YOU TO MARKUS WINKLER AND ANTHONY PIAGENTINI -- PIAGENTINI, FOR THEIR STRONG SUPPORT OF THE MIDDLETOWN LIBRARY. LAST YEAR'S CLOSURE OF TWO BRANCHES DEALT A SEVERE BLOW TO THEIR COMMUNITIES, ALTHOUGH THE MIDDLEDOWN LIBRARY WAS REOPENED LAST NOVEMBER, ITS FOUR-MONTH CLOSURE TOOK A TOLL, AND IT HAS STRUGGLED TO OBTAIN EVEN A SEMBLANCE OF ITS FORMER SELF, AND THE SAME PROBLEM REMAINS. WHEN THE LEASE EXPIRES ON THE EAST GOVERNMENT BUILDING IN JUNE OF THIS COMING YEAR, THE MIDDLETOWN LIBRARY WILL EITHER NEED TO RELOCATE OR CLOSE AGAIN. ADEQUATE INTERIM SITES HAVE BEEN DIFFICULT TO FIND, AND MIDDLETOWN OWNED PROPERTY ON SHELBYVILLE ROAD TENDERED AS A POTENTIAL LOCATION HAS BEEN TO LATE 2022. OUR FERVENT HOPE IS BOTH LONG-TERM AND SHORT-TERM SOLUTIONS CAN BE FOUND. THE LIBRARY'S CURRENT LONG-RANGE PLAN, APPROVED BY METRO COUNCIL IN 2008, LISTED THE EXPANSION OF LIBRARY SERVICES IN MIDDLETOWN AMONG ITS FEW REMAINING GOALS AFTER THE CONSTRUCTION OF THE NORTHEAST REGIONAL LIBRARY. AND EAST END CITIZENS ARE PAINFULLY AWARE OF THE SHORTAGE OF CONVENIENTLY LOCATED LIBRARY FACILITIES IN THAT PART OF TOWN. ACCESS TO THE TWO NEXT CLOSEST LIBRARIES IS DIFFICULT, ESPECIALLY FOR USE AND FOR SENIORS WHO DO NOT DRIVE. PUBLIC TRANSPORTATION INVOLVES MULTIPLE TRANSFERS AND LONG WALKS. THERE IS ONLY ONE FULLY FUNCTIONING LIBRARY EAST OF HIRSHBORN PARKWAY, YET THE EAST END REPRESENTS THE GREATEST POPULATION GROWTH IN THE COUNTY IN RECENT YEARS AND CONTINUES TO GROW EXPONENTIALLY. AS THE LIBRARY BEGINS DEVELOPMENT OF THE NEW LONG RANGE PLAN, THE NEED FOR LIBRARIES, PLURAL, THROUGHOUT THE EAST END WILL LOOM LARGE. TO AVOID THE PROBLEMS IN MIDDLETOWN, METRO LOUISVILLE NEEDS TO BEGIN EARMARKING FUNDS FOR FUTURE PROPERTY ACQUISITION AND CONSTRUCTION IN THE GROWING EAST END BEFORE DESIRABLE LANDS BECOME UNAFFORDABLE OR ARE COMPLETELY BOUGHT UP. WE KNOW YOU MUST BALANCE REQUESTS FOR LEGITIMATE NEEDS, BUT LIBRARIES MUST MOVE TO THE TOP OF THE LIST FOR FUNDING. TIME AND AGAIN, STUDIES SHOW THAT THE VALUE OF LIBRARIES TO A COMMUNITY FAR OUTWEIGH THEIR COST OF OPERATION. THEY PROVIDE SAFE AND NURTURING PLACES FOR ALL AGES TOGETHER. THEY ARE CENTERS FOR LITERACY AND LEARNING. COMPUTERS THERE ARE USED TO SEEK JOBS, TO LEARN JOB SKILLS, AND IDENTIFY USEFUL COMMUNITY RESOURCES. MATERIALS AND ALL FORMATS ARE AN INFINITE SOURCE FOR EDUCATION AND ENJOYMENT, AND DURING TIMES OF ECONOMIC TURNDOWN, LIBRARY USAGE TYPICALLY INCREASES, RENDERING THEM EVEN MORE OF A COMMUNITY ASSET. MONETARY SUPPORT FOR THE LIBRARY SYSTEM LAGS BEHIND THE PROJECTIONS ADOPTED IN THE LONG RANGE PLAN BY SEVERAL MILLION DOLLARS A YEAR, PROFOUNDLY AFFECTING NEGATIVELY ITS ABILITY TO REACH ADEOUATE FUNDING LEVELS, STAFFING LEVELS, AND TO FUND THE PURCHASE OF LIBRARY MATERIALS IN THE BREADTH AND QUANTITY NEEDED. I URGE YOU TO INCREASE FUNDING FOR THE SYSTEM AS A WHOLE, AND ALSO FOR THE CONTINUANCE OF THE MIDDLETOWN LIBRARY IN SOME FORM. LIBRARY ACCESS IS AN

ESSENTIAL ELEMENT OF ANY HEALTHY COMMUNITY. THANK YOU. [

>> GOOD EVENING, I'M JACKIE GREEN. 107 WEST MARKET STREET. LAST WEEK, YOU RECEIVED A COPY OF THIS LETTER ADDRESSED TO THE MAYOR. THIS IS THE 17TH MONTHLY LETTER TO THE MAYOR FROM A COALITION OF CITIZENS AND ORGANIZATIONS. ALL 17 LETTERS ASK FOR IMMEDIATE ACTION SLOWING CLIMATE CHANGE. THESE 17 MONTHLY LETTERS LED TO MEETINGS WITH THE MAYOR AND HIS DECLARING PUBLICLY THE CLIMATE ENERGY. THESE LETTERS REFERENCE THE EPA'S FINDING THAT OUR TWO LARGEST SOURCES OF GREENHOUSE GASES ARE TRANSPORTATION AND ELECTRICAL GENERATION. LOUISVILLE IS FAILING TO REDUCE THE CARBON FOOTPRINT OF TRANSPORTATION GREENHOUSE GASES. IF WE AND OTHER CITIES DO NOT IMMEDIATELY DECREASE TRANSPORTATION GREENHOUSE GASES, WE RISK LOSING THE CLIMATE CRISIS WAR. IMMEDIATE ACTION THAT WE CAN TAKE TO SLOW CLIMATE CHANGE INCLUDES BUILDING NO NEW ROADS, SLOWING URBAN TRAFFIC, REDUCING TRAFFIC CAPACITY, CREATING DEDICATED BUS LANES, ELIMINATING SURFACE PARKING LOTS, ELIMINATING DRIVE-THRUS, CLOSING SOME URBAN STREETS TO DRIVERS, INCREASING SAFETY FOR PEDESTRIANS, AND INCREASING URBAN DENSITY. THE LEAST EXPENSIVE, MOST EFFECTIVE, MOST IMMEDIATE CLIMATE CHANGE SLOWING ACTION THAT METRO CAN TAKE IS TO DISCOURAGE DRIVING. I KNOW, THIS IS HERESY, THIS IS HERESY, BUT WE MUST CHALLENGE AND TRANSFORM THE

CAR CULTURE, THE CAR INDUSTRY, THE BUILT ENVIRONMENT, THE
BUSINESS PRACTICES, THE HYPERMOBILITY, THE FALSE FREEDOM AND
FALSE POWER REPRESENTED BY THE CAR. WE ARE SEDUCED AND ENSLAVED
BY THE PERSONAL AUTOMOBILE, AND IT WILL ULTIMATELY DESTROY US IF
WE FAIL TO DEFY IT. THIS IS HERESY. THIS IS TRUE, A CLIMATE
CRISIS TRUTH THAT DEMANDS YOUR IMMEDIATE, VISIONARY, AND
COURAGEOUS ACTION. YOU ALL KNOW HOW TO GET IN TOUCH WITH ME. WE
NEED TO TALK. WE NEED TO ACT. THANK YOU. [APPLAUSE]

>> SORRY, SORRY. OKAY. HELLO. I LIVE WITH MY FAMILY IN
DISTRICT 7, AND I'M HERE TO SPEAK TO YOU ALL THIS EVENING ABOUT
OUR CITY'S URGENT NEED FOR A SAFETY ZONE, WHICH WOULD PROTECT
EVERYONE WHO LIVES IN OR VISITS OUR CITY. I'VE LIVED HERE IN
LOUISVILLE FOR 16 YEARS, AND UPON MOVING HERE FOR SCHOOL HAVE
ZERO INTENTIONS OF STAYING IN KENTUCKY. HOWEVER, I QUICKLY FELL
IN LOVE WITH ALL THAT THE CITY HAS TO OFFER. IT'S A WONDERFUL
PLACE TO RAISE AND EDUCATE MY CHILDREN, HOWEVER, THERE IS A
SERIOUS PUBLIC SAFETY CONCERN THAT LMPD AND THIS COUNCIL ARE
NEGLECTING TO ADDRESS. A SAFETY ZONE IS ABSOLUTELY ESSENTIAL FOR
THE SECURITY OF EVERY PERSON. A NARROW BUFFER ZONE WOULD ALLOW
PATIENTS TO ENTER AND EXIT ANY MEDICAL FACILITY SAFELY AND WILL
GIVE LAW ENFORCEMENT A BRIGHT LINE TO KEEP THE PEACE, ALL WHILE
PROTECTING FIRST AMENDMENT RIGHTS. SIMILAR ORDINANCES HAVE
ALREADY BEEN PASSED AND ARE PROTECTING CITIZENS IN 34 CITIES

ACROSS THE COUNTRY. ACCORDING TO 2013 SURVEY, OVER HALF THE FACILITIES WITH BUFFER ZONES IN PLACE REPORTED A DECREASE IN CRIMINAL ACTIVITY, AND 75% OF RESPONDING FACILITIES WITH BUFFER ZONES SAID THAT ZONES IMPROVED PATIENT AND STAFF ACCESS. IN MY EXPERIENCE AS A CLINIC ESCORT, I OBSERVED FOLKS JUST TRYING TO WALK TO WORK BEING STOPPED AND HARASSED BY PROTESTERS. I ONCE WITNESSED A GROUP OF TEENAGERS ATTEMPTING TO WALK TO A COMIC BOOK CONVENTION CHASED AND SHOUTED AT. I WATCHED AS THEIR FACES TRANSFORMED FROM CONFUSION ABOUT WHAT THEY HAD STUMBLED UPON, TO FEAR AS THEY PICKED UP THEIR SPEED AND RAN INTO THE STREET TO ESCAPE THEIR HARASSER. EVERY SINGLE PERSON WHO BRINGS THEIR DOLLARS TO SPEND IN OUR CITY, TO STAY IN THESE NICE FANNY DOWNTOWN HOTELS, IS IN DANGER OF BEING ASSAULTED BY PROTESTERS AS THEY WALK TO AND FROM RESTAURANTS, CONVENTION CENTER. A SAFETY ZONE WOULD BE A TREMENDOUS BENEFIT TO ALL DOWNTOWN BUSINESSES. ADDITIONALLY, PROTESTERS ROUTINELY BLOCK THE SIDEWALK, DEEMING IT COMPLETELY IMPASSABLE FOR ANYONE TRYING TO WALK, CREATING AN UNSAFE ENVIRONMENT AS PEDESTRIANS REGULARLY HAVE TO WALK INTO THE ROAD TO AVOID PROTESTERS. THIS IS ALSO A BLATANT VIOLATION OF THE AMERICANS WITH DISABILITIES ACT, WHICH REQUIRES THAT ALL PUBLIC SIDEWALKS BE AT LEAST 36 INCHES AND FREE FROM OBSTRUCTION. AS A PARENT AND MEMBER OF THIS COMMUNITY, IT IS INCREDIBLY DISTURBING THAT THIS VIOLENCE AND VITRIOL IS GIVEN THE FREEDOM TO GROW IN OUR CITY. WE ALL KNOW THE SITUATION DOWN THERE IS DIRE WHEN INTROVERTS LIKE ME ARE WILLING TO STAND UP IN FRONT OF A GROUP AND SPEAK. EVERY SINGLE DAY THAT THIS COUNCIL NEGLECTS TO ADDRESS THIS VERY SERIOUS PUBLIC SAFETY ISSUE, YOU ARE CONDONING VIOLENCE AND HARASSMENT AND PUTTING OUR CITIZENS AT RISK OF INJURY. IT IS WELL PAST TIME TO ENACT A SAFETY ZONE THAT WILL GIVE LAW ENFORCEMENT THE CLEAR TOOLS NEEDED TO ENSURE THAT EVERY PERSON WALKING DOWN OUR SIDEWALKS IS SAFE. THANK YOU. [APPLAUSE]

AND MR. WINKLER AND NICOLE GEORGE AND 12 OTHER PEOPLE WHO VOTED

FOR THE 100% RENEWABLE ENERGY RESOLUTION. NOW, IMAGINE A

FOOTBALL COACH WHO SAYS THIS YEAR WE'RE GOING TO BLOCK, AND NEXT

YEAR WE'RE GOING TO LEARN TO TACKLE. AND THEN THE NEXT YEAR,

WE'RE GOING TO LEARN TO RUN THE BALL, AND THEN NEXT YEAR WE'RE

GOING TO LEARN TO PASS. YOU WOULD SAY TO YOURSELF, THIS IS NOT

COUNCIL NEEDS TO HAVE SEVERAL CONSIDERATIONS GOING AT ONCE IN

ORDER TO -- IF WE ARE GOING TO WIN THE CLIMATE GAME. IF WE

CONTINUE BUSINESS AS USUAL, THEN IT WILL BE A MATTER OF DECADES

BEFORE THE PLANET IS UNINHABITABLE. NOBODY WANTS THAT, SO NOW,

WHAT YOU CAN DO, HAVE MAYBE SEVEN OUT OF HUNDREDS OF THINGS THAT COULD BE DONE, BUT ARE YOU WILLING TO OPPOSE LG&E'S PERSISTENT ATTEMPTS TO OPPOSE ROOFTOP SOLAR? WE NEED RESIDENTIAL ROOFTOP SOLAR. LG&E CONTINUES TO STAND IN THE WAY OF THIS. I KNOW YOU'RE A LOCAL BODY, AND MAYBE THAT'S A STATE ISSUE, BUT ARE YOU WILLING TO GO TO BAT FOR THE PEOPLE OF LOUISVILLE AND FOR THE CLIENT? LG&E ALSO WANTS TO BUILD NEW PIPELINES. SCIENTISTS TELL US THAT WE NEED TO STOP BUILDING NEW FOSSIL FUEL INFRASTRUCTURE. ARE YOU WILLING TO GO TO BAT FOR THE PEOPLE OF LOUISVILLE AND THE CLIMATE SO THAT -- AND AT LEAST SPEAK IN TERMS OF A RESOLUTION SO THAT LG&E WILL STOP BUILDING NEW PIPELINES? ARE YOU WILLING TO WORK WITH US FOR A RATIONAL FOOD SYSTEM? OUR AVERAGE BITE OF FOOD COMES FROM 1,500 MILES AWAY. KENTUCKY AND INDIANA HAVE SOME OF THE MOST FERTILE GROUND IN THE NATION. WE SHOULD BE GETTING MUCH OF OUR FOOD HERE. WE COULD DO THAT, BUT IT TAKES SOME LEADERSHIP FROM LOCAL GOVERNMENT, AND MY FRIEND STEPHEN BARTLETT WILL SPEAK NEXT. ARE WE WILLING TO HAVE A RATIONAL TRANSPORTATION SYSTEM? THE AVERAGE CAR COSTS \$9,000 A YEAR. ONE OF THE ISSUES THAT WE'RE LOOKING AT, AND WE WILL BE BRINGING SPECIFIC PROPOSALS TO THIS BODY, HAVE TO DO WITH THE USE OF VACANT PROPERTIES AROUND THE CITY AND TRYING TO STREAMLINE AND MAKE IT EASIER FOR COMMUNITY PEOPLE, FOR SMALL-SCALE ENTREPRENEURS WHO WANT TO DO URBAN AGRICULTURE, AND OTHER PEOPLE WHO WANT TO TURN ABANDONED OR UNUSED URBAN LANDS INTO GREENSPACES THAT CAN BE MULTIPLE-USE LAND USE IN THE CITY. WE REALLY NEED MORE FOREST COVER. WE NEED MORE PEOPLE PRODUCING FOOD RIGHT HERE. I'VE BEEN TO COUNTRIES WHERE THEY'VE GONE THROUGH SEVERE ECONOMIC CRISES, AND I'VE SEEN WHEN HUNGER HITS, PEOPLE SUDDENLY GET MOVING, BUT WE NEED TO DO THIS BEFORE THE CRISIS HITS US. WE NEED TO HAVE BETTER ACCESS TO MORE LAND, AND WE ALSO NEED SOME KIND OF SUBSIDY FOR THE WATER, SOME KIND OF ARRANGEMENT, WHERE WE CAN GET CHEAPER WATER FOR URBAN AGRICULTURE. SO WE WILL BE COMING WITH THESE PROPOSALS. I THINK KURT MASON, I'VE WORKED WITH HIM, IS A GREAT EXAMPLE OF THE KIND OF WORK THAT WE NEED TO REALLY EXPAND AND PRODUCE. WE NEED MANY MORE SUCH PEOPLE DOING THAT WORK IN THIS COMMUNITY, SO THANK YOU VERY MUCH FOR YOUR ATTENTION, AND I LOOK FORWARD TO CONTINUING THIS DISCUSSION. THANK YOU. [APPLAUSE]

PARCELS OF REAL PROPERTY LOCATED AT 7709 PRESTON HIGHWAY, LOUISVILLE, KENTUCKY, AND DESCRIBED IN EXHIBIT A ATTACHED HERETO (PREMISES), AND THAT ARE OWNED BY JEFFERSON COUNTY, KENTUCKY, CAPITAL PROJECTS CORPORATION, AN ENTITY WHOLLY OWNED BY LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (METRO GOVERNMENT), AS SURPLUS AND NO LONGER NEEDED FOR A GOVERNMENTAL PURPOSE AND AUTHORIZING ITS TRANSFER. THE FOLLOWING LEGISLATION IS ASSIGNED TO THE PLANNING AND ZONING COMMITTEE: AN ORDINANCE RELATING TO THE ZONING OF PROPERTIES LOCATED AT 1231 AND 1241 DURRETT LANE CONTAINING APPROXIMATELY 25.57 ACRES AND BEING IN LOUISVILLE METRO (CASE NO. 19ZONE0080). A RESOLUTION REQUESTING THE PLANNING COMMISSION REVIEW THE TYLER TOWN CENTER PLANNED DEVELOPMENT DISTRICT WITH REGARD TO LIMITED USE CATEGORY 2. READ IN FULL.
