You are correct, our NDF funds went directly to Public Works for funding the emptying of the trash receptacles and Public Works paid from our funds the amount invoiced.

I have included Jeff Brown as our contact to help facilitate any question you might have form the Public Works side.

Please see the below messages from our office to TARC requesting the addition of 5 new stops be added to our collection agreement. Please let us know if Public Works requires any additional information to fund these. Can you also provide an accounting of the funding remaining from our NDF? For several months trash receptacles did not exist at many of the stops along Dixie Highway. I wish to ensure TARC/Public Works were not being billed for those stops while they were not being serviced.

John (or Jeff O'Brien),

I know you are out, so whenever you have an opportunity to answer I appreciate your response but no rush. We have several bus stops with newly added receptacles but without collection agreements therefore they are overflowing into Dixie Highway. We are trying to fund the collection of these new stops to address this concern. Can you verify if it is the intent to the maintenance agreement to service all trash receptacles or whether the possibility of only servicing BRT receptacles exists? We have been funding for the past few years under the impression once the maintenance agreement is in place then we would no longer need to fund via NDF. Thanks for your response.

I have done a little digging into the funding of this trash collection and would like to share my findings. In September of 2019 Mark Adams got an agreement signed between TARC and Public Works where Public Works would pay for the trash collection along Dixie at the original 13 locations. Since then we have not been using your NDF funds for trash collection. We have been invoicing PW directly. I believe this was done because of how much work it was to make the NDF funds available for us to use. That being said I am now trying to figure out what the process is for adding these new locations to this list now that the approval will not be going through the various Council members.

We are also in talks with the Dixie Hwy project team trying to figure out a long term solution for the trash collection along Dixie Hwy and at the BRT stations. It is our hope that all of the receptacles we have been talking about will be added to this larger Dixie Hwy agreement.

COLLECTION FREQUENCY:

To answer your questions first, I do not think any stop needs to be serviced more than once a week at this time. I believe our recent trash problems originate from receptacles that were newly added and have not been contracted for collection or were taken off the collection schedule as appropriated by our office due to the construction and removal of the receptacles, for a time. If we need additional collections we will cross that bridge later. If Councilwoman Fowler feels differently I hope she will chime in.

MATH FOR NEW COUNCIL APPROPRIATION TO FUND NEW STOPS:

Please see the below message to Cindi explaining that two of the stops are in D14 not D25. If Councilwoman Fowler is willing to fund I have provided the updated totals for each of our office given your math.

I believe the math for these stops needs to be reconsidered due to the previously attached appropriated NDF. We had previously funded all 13 of the original receptacles which included D25's Meijer and Kroger in last year's attached appropriation. So if we remove those two as "new" collection locations, that leaves D14 with 2 new stops and D25 with 3 new stops to fund.

I know that many of the original receptacles were not serviced during the construction as the receptacles were removed for many months. Can you please provide an accounting of TARC's current balance of the attached NDF? As you can see our offices funded a total of \$2,184.00 at the beginning of this fiscal year (July 1, 2019). If ALL receptacles had been serviced from July 1, 2019 until March 1, 2020, which we know has not happened due to construction, we would have expended: \$1,456.00 (= 13 stops x \$14 x 8 months), leaving \$728 remaining for the previously funded stops for the rest of the year. We should have much more than this remaining due to the construction and complete removal of trash receptacles.

From there, we need an additional \$420 to fund the newly added receptacles for 6 months, although we are based on a July 1 new fiscal year therefore any NDF funds appropriated now cannot be used for next fiscal year, July 1, 2020. Meaning we actually only have 4 months remaining for contracting, so the \$420 is actually closer to \$280 (5 New Receptacles x \$14.00 per month x 4 months).

So once we have an accounting of TARC's remaining NDF budget for March 1, 2020 – June 30th, 2020 we can determine the amount needed, if any, from our respective Council offices to fund the remaining balance \$280 - \$420 balance. Again, Hometown should not have been able to bill for collection of stops that did not have receptacles to empty for months in 2019. Therefore, it is my belief the remaining already appropriated NDF should cover the entirety of the \$280 - \$420 balance for the new stops this fiscal year.

Mitchell,

I appreciate all of your help and greatly appreciate you communicating with Kroger and Meijer but we have all been down this road many times before. I have stopped in and had each of these locations commit to us that

they are willing to empty the locations and not due to turnover and whatever reasons. I would reach out and visit again and again to remind them. It is much more efficient to fund them and contractually require the collection.

CM Yates funded the Meijer and Kroger stops in the NDF Appropriation to TARC. I know David and I would agree to fund the additional added Rapid Bus Stop locations to Hometown's contract, again to ensure efficiency and actual collection, including the McDonald's location. Business collection has not worked for our office as we get several complaints a week as witnessed over the past few weeks on the added stops / Meijer & Kroger stops that have not been collected as needed.

Please see the attached email detailing the TARC stops. I have copied and pasted the list provided on 7/31/19 below. I believe D14 added a TARC receptacle off Dixie Gardens or road near there that you represent on the map but was not included in this list:
