## ORDINANCE NO. <u>039</u>, SERIES 2020

AN ORDINANCE APPROPRIATING \$5,000 \$11,000 \$12,000 FROM NEIGHBORHOOD DEVELOPMENT FUNDS IN THE FOLLOWING MANNER: \$4,500 FROM DISTRICT 21; \$3,000 FROM DISTRICT 15; \$1,000 FROM DISTRICTS 13 AND 25; \$500 FROM DISTRICTS 3, 10, 12, AND 14; AND \$250 FROM DISTRICTS 1 AND 17, THROUGH THE OFFICE OF MANAGEMENT AND BUDGET, TO SOUTH LOUISVILLE COMMUNITY MINISTRIES. INC. ("SLCM") FOR **EXPENSES** ASSOCIATED WITH **FAMILIES HELPING FAMILIES** SUPPORTING SLCM'S EMERGENCY RENTAL ASSISTANCE (AS AMENDED).

BE IT ORDAINED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/JEFFERSON COUNTY METRO GOVERNMENT (THE COUNCIL) AS FOLLOWS:

SECTION I: The sum of \$5,000 \$11,000 is hereby appropriated from Neighborhood Development Funds in the following manner: \$4,500 from District 21; \$3,000 from District 15; \$1,000 from Districts 13 and 25; \$500 from Districts 3, 10, 12, and 14; and \$250 from Districts 1 and 17, through the Office of Management and Budget, to South Louisville Community Ministries, Inc. ("SLCM") for expenses associated with families helping families and supporting SLCM's emergency rental assistance.

**SECTION II:** The Council has determined the funds requested in this Ordinance will be expended for a public purpose.

**SECTION III:** This grant is subject to the Council's Policies and Procedures as adopted and effective at the date of passage of this Ordinance.

Section IV: This Ordinance shall take effect upon its passage and approval.
