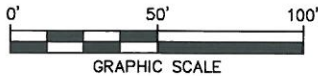

Description of road to be closed

Beginning at a point at the northeast corner of the Ghasem Properties, Inc tract of record in deed book 8451, page 598 in the Jefferson county clerk's office (hereafter referred to as "clerk's office"), said point also being in the north right-of-way line of Old Lagrange Road, thence with the perimeter of the road to be closed, S 57°05'54" E a distance of 12.99' to a point; thence with a curve to the right having a radius of 68.06' and a chord that bears S 27°21'42" W a distance of 7.53' to a point; thence S 34°34'13" W a distance of 104.86' to a point; thence S 35°10'37" W a distance of 54.23' to a point; thence S 34°23'22" W a distance of 137.36' to a point; thence S 33°47'50" W a distance of 82.78' to a point; thence S 34°46'32" W a distance of 8.27' to a point; thence N 75°00'50" W a distance of 13.80' to a point; thence N 33°07'20" E a distance of 56.49' to a point; thence N 33°07'20" E a distance of 41.76' to a point; thence N 34°20'59" E a distance of 131.74' to a point; thence N 34°20'59" E a distance of 2.05' to a point; thence N 34°57'20" E a distance of 167.21' to the point of beginning, containing an area of 5,656 square feet.
