### REQUEST(S)

Conditional Use Permit to allow a private institutional use

### CASE SUMMARY/BACKGROUND

The applicant is requesting a conditional use permit for a private institutional use. The main structure was used as a convent by another owner until two years ago. The applicant wants to convert the interior space of the building into offices and limited class space (possibly art studios). No exterior construction or site improvements are anticipated. There are parking spaces on site that can be utilized, but most users of the building will park in the Assumption parking lot and walk to the site utilizing the existing crosswalk across Tyler Lane. The existing residence on site will be used in some capacity related to the school (possibly offices or storage space).

### **STAFF FINDING / RECOMMENDATION**

There are five listed requirements. The proposal will meet items A., B., C., and D. Item E. will need to be discussed by the Board of Zoning Adjustment. Based upon the information in the staff report and the testimony and evidence provided at the public hearing, the Board of Zoning Adjustment must determine if the proposal meets the standards established in the LDC for a Conditional Use Permit.

### **TECHNICAL REVIEW**

There are no outstanding technical review items.

#### INTERESTED PARTY COMMENTS

A neighborhood meeting was held on February 11<sup>th</sup>, 2020 and at least five people attended.

### STANDARD OF REVIEW AND STAFF ANALYSIS FOR CONDITIONAL USE PERMIT

1. <u>Is the proposal consistent with applicable policies of the Comprehensive Plan?</u>

STAFF: The proposal meets all applicable policies of the Comprehensive Plan.

2. <u>Is the proposal compatible with surrounding land uses and the general character of the area</u> including factors such as height, bulk, scale, intensity, traffic, noise, odor, drainage, dust, lighting and appearance?

STAFF: When appropriately managed, the proposed use is compatible with surrounding development and land uses.

3. <u>Are necessary on-site and off-site public facilities such as transportation, sanitation, water, sewer,</u> <u>drainage, emergency services, education and recreation adequate to serve the proposed use?</u>

STAFF: The subject property is served by existing public utilities and facilities. Transportation Planning and MSD have reviewed the proposal.

# 4. Does the proposal comply with the following specific standards required to obtain the conditional use permit requested?

Private institutional uses, except for such uses specifically regulated elsewhere in this LDC, may be allowed in the R-R, R-E, R-1, R-2, R-3, R-4, R-5, and U-N zoning districts upon the granting of a Conditional Use Permit and compliance with the listed requirements:

A. Except in the R-R zoning district, all structures, except fencing, and all off-street parking shall be at least 30 feet from any property line adjacent to an existing residential use or residential zoning district. In the R-R zoning district all structures, except fencing, shall be at least 150 feet from any property line and all off-street parking shall be at least 30 feet from any property line. *The applicant has been informed of this requirement.* 

B. The applicant must demonstrate that the impact of the traffic generated by the use can be mitigated. *The applicant has been informed of this requirement.* 

C. Off-street parking not located within a driveway shall be located to the side or rear of the building(s). The number of required off-street parking spaces shall be determined by the Planning Director in consultation with the Director of Public Works based on the standards for the closest comparable use and on the particular parking demand and trip generation characteristics of the proposed use. *The applicant has been informed of this requirement.* 

D. All activities shall be in compliance with the Metro Noise Ordinance (LMCO Chapter 99). *The applicant has been informed of this requirement.* 

E. The Board of Zoning Adjustment may set hours of operation for the institutional use in order to minimize potential negative impacts on surrounding residential properties. *The applicant has been informed of this requirement.*

### 4. <u>Conditions of Approval</u>

- 1. The site shall be developed in strict compliance with the approved development plan (including all notes thereon). No further development shall occur on the site without prior review and approval by the Board.
- 2. The Conditional Use Permit shall be "exercised" as described in KRS 100.237 within two years of the Board's vote on this case. If the Conditional Use Permit is not so exercised, the site shall not be used for a private institution until further review and approval by the Board.
