Everyone,

Due to the scale of this project it will not be able to be completed any time soon unless it is fully funded. In my earlier email I misspoke. We can't provide a cost for installation as these signs are overhead. A project like this will be fabricated in our Sign Shop and Electrical Maintenance will conduct installations. If you would like a project estimate let us know and we will provide.

Due to limited resources, if we are going to conduct this project with our internal maintenance budget it will have to be done over a span of time based on budget, manpower and availability. The first intersections addressed will be along S 5th St as they have been determined to be in the worst condition. We will be able to fabricate one intersection this FY and continue in this fashion until the project is complete based on available resources. We will coordinate with EM once we move further in this effort.

Everyone,

By my estimation, this effort will be for a minimum of 23 signs (\$4,324). Does anyone have funding for this project? This is above and beyond the capabilities and intent of our annual budget which is largely for maintenance. We aren't equipped to conduct large scale projects like this has been within our budget. We have the inventory but it will exhaust a significant portion of what we currently have in stock which is all we have through this FY. Additionally, we have concerns regarding what next FY budget will be.

Please let me know if you have any questions. We are going to have to look closely at this types of projects in the future. We certainly want to help. We simply don't have a project driven budget. Without funding these projects cripple our ability to provide the service the road users and citizens need and deserve.
