>> THE REGULAR METRO COUNCIL MEETING ON MAY 28, 2020, WILL PLEASE COME TO ORDER. PLEASE RISE TO PLEDGE OF ALLEGIANCE OF THE FLAG. [PLEDGE OF ALLEGIANCE]

>> PRESIDENT JAMES: COLLEAGUES, SINCE OUR LAST MEETING ON MAY THE 14TH, WE HAVE LOST ANOTHER 33 MEMBERS OF OUR COMMUNITY. AS OF YESTERDAY, 124 LOUISIANANS HAVE DIED DUE TO COVID-19. AS OF YESTERDAY, 2,427 LOUISIANANS HAVE TESTED POSITIVE. THOSE NUMBERS ARE ESTIMATED TO BE LOWER THAN REALITY. WE NEED TO REMEMBER THAT THESE ARE MORE THAN NUMBERS. THESE ARE MOTHERS AND FATHERS, SISTERS AND BROTHERS, DAUGHTERS, SONS, AND FRIENDS. WE KNOW THAT MORE OF OUR FAMILY, FRIENDS, AND NEIGHBORS WILL BE AFFECTED BY COVID-19, AND WE KNOW THAT WE WILL LOSE MORE PEOPLE. WE WILL STAY STRONG AND COMMITTED AS WE FACE THIS CRISIS TOGETHER. I ASK EACH OF YOU JOIN ME IN A MOMENT OF SILENCE. [MOMENT OF SILENCE] THANK YOU. THE REGULAR MEETING OF THE LOUISVILLE METRO COUNCIL IS CONDUCTED THROUGH VIDEO CONFERENCE. SOME MEMBERS ARE PRESENT IN CHAMBERS, COUNCILMAN KRAMER AND COUNCILMAN FOX, AND OTHERS ARE ATTENDING VIRTUALLY. IF WE EXPERIENCE A DISRUPTION IN THE VIDEO FEED FOR ANY OF OUR VIRTUAL ATTENDEES, THE MEETING WILL BE SUSPENDED FOR FIVE MINUTES WHILE WE MAKE A REASONABLE ATTEMPT TO FIX THE ISSUE. WHILE THE MEETING IS SUSPENDED, NO ACTION WILL BE TAKEN. IF AFTER FIVE MINUTES, THE ISSUE WITH THAT MEMBER'S FEED CONTINUES, WE WILL RESUME THE MEETING, AND THE MEETING WILL CONTINUE AS LONG AS WE STILL HAVE

A QUORUM OF MEMBERS. IF WE EXPERIENCE ANY TECHNICAL DIFFICULTIES THAT AFFECT THE PUBLIC'S ABILITY TO SEE THE MEETING AS A WHOLE, WE'LL SUSPEND THE MEETING WHILE WE ATTEMPT TO RESOLVE THE ISSUE. WHILE SUSPENDED, ALL DISCUSSION ON PUBLIC BUSINESS WILL CEASE, AND NO ACTION WILL BE TAKEN. IF AFTER 20 MINUTES THE ISSUE CANNOT BE RESOLVED, THE MEETING WILL STAND ADJOURNED. ANY UNFINISHED OR PENDING BUSINESS WILL BE ADDRESSED AT THE NEXT MEETING OF THE COUNCIL. COUNCILMAN WINKLER HAS AN EXCUSED ABSENCE THIS EVENING. MADAM CLERK, WOULD YOU PLEASE CALL -- OH, THERE HE IS. WELCOME BACK. MADAM CLERK, PLEASE CALL THE ROLL.

>> PRESIDENT JAMES: THANK YOU VERY MUCH. MADAM CLERK, ARE THERE ANY ADDRESSES TO COUNCIL?

>> CLERK: YES, SIR.

>> PRESIDENT JAMES: PLEASE REFRAIN FROM USING PROFANITY OR MAKING DEROGATORY STATEMENTS TO COUNCIL MEMBERS. PLEASE BRING THEM FORWARD.

>> CLERK: MIKE GRAMIG. MR. GRAMIG?

>> YES?

>> CLERK: YOU CAN GO AHEAD, SIR.

>> OKAY, THANK YOU. MR. COUNCIL PRESIDENT, COMMITTEE CHAIRMAN, COUNCIL MEMBERS, AND CHIEF FREDERICK. AT THE BEGINNING OF FISCAL YEAR 2019-2020, AFTER THE SURPRISED CLOSING OF ENGINE COMPANY 11, CITIZENS FOR FIREFIGHTERS 20 WAS FORMED BY AN AD HOC GROUP OF NEIGHBORHOOD ASSOCIATION CITIZENS AND ACTIVISTS TO ADDRESS THE REDUCTION IN FIRE COMPANIES AND THE LEVEL OF EMERGENCY SERVICES IN THE URBAN SERVICES DISTRICT. THESE REDUCTIONS ARE CENTERED ON DISTRICT 8 AND INCLUDE MAJOR PORTIONS OF THE ADJOINING DISTRICTS. DISTRICTS 6, 9, 10, AND 26. OF COURSE, THIS ALSO AFFECTS THE EMERGENCY MEDICAL SERVICE DELIVERY IN THESE SERVING SERVICES DISTRICTS. THESE NEIGHBORHOODS HAVE SEEN THEIR EMERGENCY SERVICES HOLLOWED OUT OF THE CLOSING OF FOUR ADJOINING FIRE COMPANIES. CURRENT DISPATCHING OF EMERGENCY SERVICES ACROSS ALL OF THE URBAN SERVICES DISTRICT HAS BEEN ROUTINELY BUMPED UP FROM FORMER LEVELS OF UNITS TO INCLUDE EXTRA UNITS RESPONDING FROM MUCH FURTHER AWAY. AND THIS INCREASES THE RESPONSE TIME FOR ADEQUATE NUMBERS OF FIREFIGHTERS AND EMS TO OUICKLY AND SAFELY HANDLE EMERGENCIES OCCURRING IN THESE URBAN SERVICE DISTRICT NEIGHBORHOODS. OVER THE LAST TWO DECADES, BASICALLY, SINCE CITY-COUNTY MERGER, THIS AREA AND OTHER AREAS OF THE URBAN SERVICES DISTRICT HAVE SUFFERED OTHER FIRE COMPANY CLOSINGS. THE RE-ESTABLISHMENT OF ENGINE COMPANY 11 WAS THE ORIGINAL FOCUS OF OUR CITIZEN GROUP. LIFE HAS RADICALLY CHANGED SINCE NOVEMBER WHEN I WROTE AN OP-ED REGARDING BUDGET PRIORITIES AND PUBLIC SAFETY. OUR CITY AND ALL OTHER CITY AND STATE GOVERNMENTS NOW FACE A FISCAL CRISIS LIKE NONE EVER BEFORE EXPERIENCED. WE REALIZE THAT THE BUDGET PRIORITIES OF THE CITY ARE ALL ON THE TABLE, AND THAT THE REVENUE OUTLOOK IS CERTAIN TO BE VERY BLEAK. AND THIS CRISIS ENVIRONMENT, WE WANT TO RE-EMPHASIZE TO THE COUNCIL THAT THE FIRST PRIORITY OF GOVERNMENT

IS PROTECTION OF ITS CITIZENS. THIS MEANS THE PUBLIC SAFETY AND HEALTH MUST BE PRESERVED, ESPECIALLY IN TIMES OF CRISIS. AS AN EXAMPLE, WE ONLY HAVE TO LOOK TO THIS WEEK'S EVACUATION OF DOZENS OF COVID-19 PATIENTS FROM CLIFTON NURSING HOME BY MULTIPLE EMS UNITS. EMERGENCY SERVICES CAN BE OVERRUN VERY QUICKLY IN THIS ENVIRONMENT, AND SUFFICIENT PERSONNEL MUST RETAIN TO DEAL WITH FUTURE EMERGENCIES. IF YOU CANNOT AFFORD A SHORT CHANGE IN PUBLIC SAFETY IS ONE OF THEM. THANK YOU FOR THE OPPORTUNITY TO SPEAK ON THE ISSUE.

>> PRESIDENT JAMES: THANK YOU. STEVE MAGRE. MR. MAGRE, ARE YOU THERE?

>> I WAS FIGHTING WITH A FEW OTHERS, AS IT TURNED OUT, TO SAVE ENGINE NO. 11 ON RUBLE AVENUE. THE ACTION OF THE COUNCIL COLLUDING WITH THE ADMINISTRATION CAUSED ENGINE NO. 11 TO DIE A QUICK DEATH. FIRE STATION NO. 11 OPERATES NOW, IT DOES SO WITH NO AVAILABLE AERIAL EQUIPMENT, NO ENGINE FOR FIREFIGHTERS TO HOP ON OR OFF OF, AND IT HAS TAKEN ON A 50% REDUCTION IN ITS PROFESSIONAL FIREFIGHTING STAFF. THE REDUCED ABILITY TO HAVE FIRST RESPONDERS ON DUTY HAS BECOME A HAUNTING REALITY, PARTICULARLY HIGHLIGHTED A FEW MONTHS AGO. AND LIMITING THE CITY'S EMERGENCY RESPONSE TO COVID-19 WILL BE LESS THAN WHAT IT'S NEEDED TO BE IS VERY UNFORTUNATE. I LEARNED MY LESSON, AS WELL. I LEARNED MY ACTIONS AS AN ADVOCATE FOR WORKING FIREFIGHTER ISSUES HAD TO CHANGE. AND MORE CITIZENS NEEDED TO

BECOME INVOLVED TO ENSURE THIS ATTITUDE OF IT'S OKAY TO CUT THE FIRE DEPARTMENT BUDGET IS STOPPED. WITH THE HELP OF MIKE GRAMIG, AND MIKE, BY THE WAY, WAS A LONG-TIME BATTALION CHIEF, AND HIS STELLAR CAREER ENDED, HE WAS ASSISTANT FIRE CHIEF. AND, FRANKLY, IS A BRILLIANT PERSON. ALONG WITH A PERSON YOU ALL KNOW WELL AND HAVE GREAT RESPECT FOR THAT WORKS IN THOSE HALLS A LOT, BRIAN O'NEILL, OF LOCAL NO. 345. WITH THEIR HELP AND SUPPORT, THE REALITY OF THIS CITIZENS FOR FIREFIGHTERS 20 IS HAPPENING. WE ARE ON THE MOVE. GAINING A FULL FUNDING LEVEL FOR THE LOUISVILLE FIRE DEPARTMENT DEFINES OUR MAIN INTEREST. IN ADDITION, CCF-20 WANTS BUDGET WORDING THAT ENSURES A NEW RECRUIT CLASS IS BEING FUNDED. AND TO BE CRYSTAL CLEAR, WE DO NOT WANT ANY CUTS. THE CITY'S ANTHEM MUST REMAIN HEALTH AND SAFETY FIRST, AND THOSE DEPARTMENTS THAT DELIVER ON THIS MUST BE FUNDED FULLY. ABOUT A YEAR AGO, A COUNCIL PERSON ASKED ME, WHAT CITY SERVICES DO YOU CALL ESSENTIAL, STEVE? I BLURTED OUT IMMEDIATELY, "FIRE, POLICE, AND EMS." MY BELIEF HAS NOT CHANGED. MY ONLY HOPE IS I ASK EACH OF YOU THAT SAME QUESTION, YOU WOULD BLURT OUT THE SAME ANSWER, AND THERE WOULD BE NO M.O. THANK YOU.

>> PRESIDENT JAMES: THANK YOU.

>> CLERK: BRIAN O'NEILL. MR. O'NEILL, WE'RE READY WHEN YOU ARE.

>> GREAT. THANK YOU VERY MUCH. GREETINGS, AND I APPRECIATE THE OPPORTUNITY TO SPEAK TO YOU IN THE MIDST OF THIS CRISIS WE'RE FACING. AND YOU, OUR LOCAL LEGISLATIVE BODY, MADE LOCAL DECISIONS HOW TO DEAL WITH THE IMPACT AND RAMIFICATIONS OF THAT CRISIS. I WISH TO SPEAK IN SUPPORT OF MAYOR'S CONTINUATION BUDGET. IF WE'VE LEARNED ANYTHING FROM THIS PANDEMIC, I DO HOPE IT'S OUR ABILITY TO RECOGNIZE THE TRUE DEFINITION OF WHAT AN ESSENTIAL WORKER IS AND WHAT THE ABSOLUTE CORE FUNCTION OF GOVERNMENT SHOULD BE. THAT CORE HAS TO BE THE SAFETY OF THE PUBLIC, WHICH MEANS YOUR FIREFIGHTERS, POLICE, YOUR EMS. WE ALL KNOW THAT LOUISVILLE FACES A POTENTIAL BUDGET FALLOUT BECAUSE OF THIS PANDEMIC, AND THAT COULD MEAN THE SLASHING OF BUDGETS THROUGHOUT METRO LOUISVILLE. WE'RE NOT IMMUNE TO THAT. SUCH REDUCTIONS CANNOT BE MADE AT THE COST OF PUBLIC SAFETY. OVER THE LAST 20 YEARS, LOUISVILLE HAS CONTINUALLY REDUCED THE FIRE DEPARTMENT, WHILE OUR RESPONSE NUMBERS HAVE CONTINUED TO GROW. THERE ARE MORE FIRES, MORE EMERGENCIES, AND IT HAS COST LIVES IN OUR COMMUNITY. WE HAVE BEEN CUT TO THE BONE, AND WE'RE STARTING TO REMOVE EXTREMITIES, AND WE BEG OF YOU TO, PLEASE, DO NOT ASK US TO FURTHER DEVIATE BEYOND THE PARAMETERS OF HOW WE NEED TO STAFF FOR SAFETY. WE REALIZE THAT A VIBRANT COMMUNITY LIKE LOUISVILLE NEEDS PARKS. WE NEED POOLS. WE NEED LIBRARIES. WE NEED THE ARTS. BUT PEOPLE NEED TO BE SAFE WHEN THEY VISIT THOSE PLACES. AND THE FIRE DEPARTMENT IS THE CORE OF PUBLIC SAFETY. THERE ARE NO OTHER OPTIONS. THERE'S NOT A MENU WHEN IT COMES TO AN EMERGENCY. THERE'S JUST 911. THERE IS NO 912. THERE IS NO

COMPUTER PROGRAM OR TELEWORK SOLUTION THAT CAN LAY A HOSE LINE INTO A BURNING BUILDING OR REMOVE A TRAPPED VICTIM FROM A CAR WRECK. ONLY FIREFIGHTERS HAVE THE TRAINING AND EQUIPMENT TO DO THAT, AND WE NEED TO BE STAFFED PROPERLY SO WE'RE THERE TO DO IT. WE'VE BEEN WORKING TO GET THE HEROES ACT PASSED. WE ARE CONFIDENT THAT THERE WILL BE MORE PUBLIC SAFETY MONEY TO ASSIST OUR CITY. AND I ASK YOU TO PLEASE KEEP THAT IN MIND AS WE LOOK AT THE BUDGET. NOT ONLY IS PUBLIC SAFETY THE MOST BASIC RESPONSIBILITY OF GOVERNMENT, BUT IT IS PUBLIC SAFETY, YOUR FIREFIGHTERS, THAT ARE BRINGING EMERGENCY FUNDS TO LOUISVILLE IN THE FORM OF FEMA MONEY, CARES ACT, AND HOPEFULLY SOONER RATHER THAN LATER THE HEROES ACT. THE CARES ACT HAS BROUGHT \$144 MILLION TO LOUISVILLE, A ENWE'RE WORKING TO GET CLARIFICATION ON THE CITY'S ABILITY TO SPEND THAT MONEY ON FIRE, EMS, AND POLICE PAYROLL AS THE SECRETARY OF THE TREASURY, STEVE MNUCHIN, HAS I WANT -- INDICATED IT'S THERE FOR. IT WOULD BE A TREMENDOUS AMOUNT OF POLITICAL COURAGE, BUT THE TRUE ANSWER TO BRING A BETTER LEVEL OF SERVICE TO ALL CITIZENS OF LOUISVILLE AT A SIGNIFICANT SAVINGS IN THEIR TAXES WOULD BE A SINGLE FIRE DEPARTMENT WITH INTEGRATED EMS. LOUISVILLE IS APPROXIMATELY 400 SQUARE MILES WITH A POPULATION OF 1.3 MILLION. NASHVILLE IS 525 SQUARE MILES WITH 1.9 MILLION PEOPLE. WE HAVE MORE THAN TEN DIFFERENT FIRE AND EMS SERVICES WITH A TOTAL BUDGET THAT'S CLOSING IN ON \$200 MILLION. NASHVILLE HAS ONE FIRE DEPARTMENT

WITH INTEGRATED EMS, AND THEY DO IT FOR AROUND \$150 MILLION. WE KNOW THAT YOU'RE IN AN UNENVIABLE POSITION OF MAKING VERY DIFFICULT DECISIONS, WHICH AS I TELL OUR NEW FIREFIGHTERS, IT'S WHAT YOU SIGNED UP FOR. WE TRUST YOU. YOUR COMMUNITY TRUSTS YOU. YOUR FIREFIGHTERS ARE TRUSTING IN YOU. AND KNOW THAT AS YOU DELIBERATE, AS YOU SPEND TIME IN THE OFFICE, AS YOU SPEND TIME WITH YOUR FAMILY AND AT HOME, WHEREVER YOU ARE, WHATEVER TIME, YOUR FIREFIGHTERS, LOUISVILLE'S BRAVEST, ARE ALWAYS ON DUTY, ALWAYS STANDING BY, AND READY TO PROTECT LIVES AND PROPERTY. THANK YOU FOR YOUR TIME.

>> PRESIDENT JAMES: THANK YOU. COUNCILWOMAN MCCRANEY, DID YOU WANT TO SPEAK RIGHT NOW?

>> IT APPROPRIATE?

>> PRESIDENT JAMES: IF WE COULD WAIT UNTIL THEY FINISH, THAT WOULD BE BETTER. BUT IF IT'S SOMETHING YOU NEED RIGHT NOW, GO AHEAD.

>> NO, I CAN WAIT. LET ME JUST SAY WHILE I HAVE THE MIC THAT I CERTAINLY HEAR THE PASSION, AND I UNDERSTAND THE PASSION. AND I'M JUST AS PASSIONATE ABOUT THE SAFETY AND HEALTH OF THIS COMMUNITY. MY WAY OF LOOKING AT THE BUDGET IS CERTAINLY, WHEN IT COMES TO HEALTH AND SAFETY OF THIS COMMUNITY, IT'S FIRST AND FOREMOST. I DO HEAR YOUR PASSION AND FEEL IT, AS WELL. THANK YOU.

>> PRESIDENT JAMES: THANK YOU. MADAM CLERK.

>> CLERK: SAVANNAH TREBUNA. SAVANNAH, WE'RE HAVING A PROBLEM MAKING YOU A PANELIST. CAN YOU CHANGE DEVICES, POSSIBLY? I'M GOING TO GO DOWN THE LIST. PRANAD KANMADIKAR, ARE YOU THERE? YOU CAN BEGIN WHEN YOU'RE READY.

>> HELLO?

>> CLERK: YES, SIR, WE CAN HEAR YOU.

>> HELLO AND THANK YOU FOR ALLOWING ME TO SPEAK TODAY. MY NAME IS PRANAD KANMADIKAR, AND I'M A KENTUCKY REGIONAL DIRECTOR FOR THE BOARDING PROJECT, WHICH IS A NATIONAL BIPARTISANSHIP EFFORT TO ALLEVIATE INTERNATIONAL POVERTY. I'M HERE TODAY TO ASK THE COUNCIL MEMBERS AND THOSE LOCAL REPRESENTATIVES TO SUPPORT THE PASSAGE OF POVERTY-FOCUSED LEGISLATION AT THE FEDERAL LEVEL. THE CURRENT CORONAVIRUS CRISIS HAS DESTROYED SO MANY FAMILIES AND TAKEN SO MUCH FROM OUR ECONOMY, IT REALLY HIGHLIGHTED DISPARITIES WITHIN THE GLOBAL ECONOMY, AS WELL. IN FACT, WHILE MANY IN OUR CITY ARE ABLE TO STAY AND WORK FROM HOME, HUNDREDS OF MILLIONS OF POOR INDIVIDUALS FROM DEVELOPING COUNTRIES AREN'T ABLE TO DO SO FOR A VARIETY OF REASONS, INCLUDING THE FACT THAT THEIR ONLY SOURCE OF INCOME IS OFTEN DANGEROUS JOBS THAT BRING THEM INTO CONTACT WITH OTHERS. OUARANTINING SUCH COUNTRIES WITHOUT ECONOMIC RELIEF WOULD RESULT IN DISASTROUS CONSEQUENCES AND MANY ECONOMISTS PROJECT THAT AN EXTRA 500 MILLION PEOPLE WORLDWIDE MAY GO INTO POVERTY IF GOVERNMENTS DON'T ACT. IT IS IMPERATIVE TO FOCUS ON THE GLOBAL, AS WELL AS THE LOCAL

IMPLICATIONS OF THE PANDEMIC, AND SPECIFICALLY FORMULATE POLICIES TO HELP THE INTERNATIONAL COMMUNITY THAT'S BEEN DISPROPORTIONATELY IMPACTED, AS WELL AS OUR LOCAL COMMUNITY. ONE OF THESE POLICIES IS A SENATE BOUND GLOBAL HEALTH SECURITY ACT, WHICH WOULD FOSTER MORE INTERAGENCY COLLABORATION, WHILE EXPANDING GOVERNMENT EPIDEMIC AND PANDEMIC PREPAREDNESS FOR THE FUTURE. ANOTHER POLICY IS A PROPOSED ALLOCATION OF \$12 BILLION IN FOREIGN AID TO OTHER COUNTRIES' PANDEMIC RESPONSE EFFORTS. BOTH OF THESE BILLS ARE UNDENIABLY CRUCIAL TO STOP THE SPREAD OF THE CORONAVIRUS. BECAUSE OF THE FACT SOCIAL DISTANCING GUIDELINES AND ECONOMIC RESILIENCY IN COUNTRIES, THE VIRUS WILL SPREAD AND MANAGE TO REACH OUR COUNTRY, EVEN IF WE'RE ABLE TO FLATTEN THE CURVE. IT IS IMPORTANT TO NOTE SUCH FOREIGN AID DOESN'T MEAN LESS FUNDING FOR LOUISVILLE. IN FACT, THE MONEY THAT IS BEING PROPOSED IS ONLY A SMALL FRACTION OF OUR TOTAL BUDGET AND WOULD, IN FACT, IMPROVE OUR LOCAL ECONOMY THAT'S BECOME INCREASINGLY RELIANT ON FOREIGN EXPORTS. IF CONGRESS MANAGES TO PASS THE GLOBAL HEALTH SECURITY ACT, BOTH OUR COMMUNITY AND COMMUNITIES ABROAD WOULD BE BETTER SERVED AND BETTER ABLE TO TACKLE THE CURRENT CRISIS. FOR THESE REASONS, I STRONGLY REQUEST YOU SEND A LETTER TO REPRESENTATIVE YARMOUTH AND MCCONNELL AND PAUL AND ASK THEM TO SUPPORT THESE TWO CRITICAL PIECES OF LEGISLATION. PLEASE VISIT OUR WEBSITE FOR MORE INFORMATION, AND THANK YOU AGAIN FOR ALLOWING ME TO SPEAK.

>> CLERK: SAVANNAH TREBUNA. SAVANNAH, WE'RE READY WHEN YOU ARE.

>> OKAY, ALL RIGHT. SORRY ABOUT ALL THAT. THE DAYS FOLLOWING WERE MET WITH UNCERTAINTY AND FEAR OF THE FUTURE. THE DRASTIC SHIFT IN OUR DAILY LIVES IS UNLIKE ANYTHING EXPERIENCED IN THIS LIFETIME. FOR THE PAST TWO MONTHS, WE'VE STAYED HEALTHY AT HOME, WE WEAR MASKS IN PUBLIC, AND WE ADDRESS THE COUNCIL THROUGH A VIDEO CONFERENCE, HOPEFULLY. HOWEVER, ANTIABORTION PROTESTERS HAVE CONTINUED BUSINESS AS USUAL IN FRONT OF A & W WOMEN'S SURGICAL CENTER. THERE'S BEEN LITTLE CHANGE IN NUMBERS OF PARTICIPANTS AND NO SOCIAL DISTANCING OBSERVED. ON MAY 9TH, LOUISVILLE WAS STILL REELING FROM EXHAUSTED UNEMPLOYMENT OFFICES, GROCERY SHORTAGES, AND DRASTIC ECONOMIC DOWNTURN CAUSED BY ATTEMPTING TO FLATTEN THE CURVE. MEANWHILE, 54 PROTESTERS CROWDED THE SIDEWALK OF WEST MARKET STREET. VOLUNTEER CLINIC ESCORTS SINCE EARLY APRIL HAVE BEEN OBSERVING AND RECORDING PROTESTERS FROM THEIR CARS. I WAS OBSERVING THAT SATURDAY MORNING, ON MAY 9TH. I WATCHED PATIENTS FRANTICALLY TRYING TO GET TO THE ENTRANCE, WHILE PROTESTERS SWARMED AROUND THEM. THEY WERE DOING WHAT THEY USUALLY DO, INVADING PERSONAL SPACE, TOUCHING PATIENTS WITHOUT CONSENT, AND BLOCKING THE ENTRANCE TO THE CLINIC. THE LPD WATCHED FROM POLICE CRUISERS. NO RECOMMENDATION FOR SOCIAL DISTANCING, EVEN WITH THE LARGE NUMBER OF REPORTS MADE TO METRO 311. RECORDING TO SOME THAT REPORTED TO

HOTLINES, THE VERY HOTLINE THAT WAS SUGGESTED TO REPORT LARGE GATHERINGS BY THIS COUNCIL, SOCIAL DISTANCING IS NOT A MANDATE, JUST A SUGGESTION. ON MAY 16TH, 63 PROTESTERS WERE ON THE SIDEWALK. NO ACTION WAS TAKEN TO KEEP PEOPLE SAFE. IF YOU CAN'T ENFORCE SOCIAL DISTANCING, YOU HAVE THE POWER AND OPPORTUNITY TO PASS AN ORDINANCE THAT WOULD HELP KEEP THE PUBLIC SAFE ONCE AND FOR ALL. SO WITH THAT BEING SAID, IT IS PAST TIME TO INTRODUCE SAFE ZONE LEGISLATION. WE NEED A BRIGHT LINE THAT'S CLEAR TO ENFORCE, PROTECT THE PEACE, AND ENSURE THE SAFETY OF ALL PEOPLE ACCESSING CARE. COVID-19 HAS HIGHLIGHTED THE INACTION OF THIS COUNCIL, BUT THERE'S ALWAYS BEEN A PUBLIC HEALTH HAZARD AT 136 WEST MARKET STREET. IT WILL CONTINUE TO BE A PUBLIC SAFETY RISK WITHOUT A SAFETY ZONE. HOW MANY MORE UNPRECEDENTED CATASTROPHES DO WE HAVE TO LIVE THROUGH BEFORE PUBLIC SAFETY IS A PRIORITY TO THIS COUNCIL? IN A TIME WHERE INTRAPERSONAL SPACE HAS BEEN PROVEN TO BE NECESSARY FOR PERSONAL HEALTH AND SAFETY, IT'S ONLY STRENGTHENED THE APPARENT AND IMMEDIATE NEED FOR A SAFETY ZONE. NO PERSON ACCESSING CARE NEEDS TO COMPROMISE THEIR PERSONAL SPACE AND HEALTH ALONE. THANK YOU.

>> PRESIDENT JAMES: THANK YOU.

>> CLERK: PATRICIA RAMEY.

>> CLOUT IS A RELIGIOUS ORGANIZATION ACROSS THE CITY WORKING TO SOLVE COMMUNITY PROBLEMS AT THE SYSTEMIC LEVEL. ON THE SCREEN BEHIND ME ARE DOZENS OF CLOUT LEADERS IN SUPPORT OF OUR SPEAKER TONIGHT. THE PANDEMIC HAS EXPOSED HUGE CRACKS IN THE COMMUNITY. CONSIDER THE PEOPLE HAVING FLED IN SAFETY, WANDERING 40 YEARS IN THE DESERT FACING THE PROSPECT -- THEY WERE ADMONISHED TO FOLLOW IN GOD'S WAYS OF COMPASSION IN EGYPT. GOD SAID, I HAVE SET BEFORE YOU LIFE AND DEATH. BLESSINGS AND TRUTHS. CHOOSE LIFE SO THAT YOU AND YOUR DESCENDANTS MAY LIVE. WE IN CLOUT HAVE SIMILAR CHOICES. EITHER RETURN TO THE SAME BROKEN SYSTEM OR MOVE FORWARD FOR CITIZENS TO PRESERVE LIFE FOR ALL CITIZENS. THE CITY BUDGET PLAYS A CRUCIAL ROLE IN THIS. WE UNDERSTAND OPTIONS ARE GREATLY LIMITED BY THE PROJECTED LOSS OF REVENUE, BUT HOWEVER MUCH WE HAVE, IT IS CRUCIAL TO PRIORITIZE EACH BUDGET DOLLAR TO ENSURE PRESERVE LIFE. 72,000 FAMILIES IN OUR COMMUNITY CANNOT AFFORD HOUSES. INCREASING THAT NUMBER AND LIKELY WILL DRIVE MORE FAMILIES OUT ON TO THE STREETS. FOR OUR IS CITIZENS WITH MENTAL ILLNESS OR EVICTION, THE PANDEMIC IS A PERFECT STORM OF CONDITIONS. WE ARE HERE TONIGHT TO URGE YOU TO MAKE THREE THINGS YOUR TOP BUDGET PRIORITIES. FIRST, FUNDING FOR CRISIS STABILIZATION SERVICES FOR THE MENTALLY ILL AND ADDICTED. SECOND, FUNDING FOR SUPPORTIVE HOUSING FOR THAT SAME POPULATION. AND, THIRD, FOR THE WHOLE COMMUNITY, FULL FUNDING OF \$10 MILLION FOR THE AFFORDABLE HOUSING TRUST FUND. TAKE NOTE THE E-MAIL WE SENT EACH OF YOU TODAY URGING YOUR LEADERSHIP AND OFFERING OUR PARTICIPATION TO RESPOND TO THE TRAGIC KILLING OF BRIANNA TAYLOR. TO WORK WITH CLOUT AND OTHER COMMUNITY STAKEHOLDERS

TOWARDS STRONGER ACCOUNTABILITY IN THE USE OF FORCE BY LMPD. WE LOOK FORWARD TO WORKING WITH YOU IN THIS ADDITIONAL LIFE AND DEATH MATTER IN OUR COMMUNITY. THANK YOU.

>> CLERK: WILLIAM HARDISON.

>> GOOD EVENING, METRO COUNCIL. MY NAME IS BILLY HARDISON. I AM A LIFELONG LOUISVILLE RESIDENT AND BUSINESS OWNER, WE PRODUCE CONCERTS ALL OVER LOUISVILLE, INCLUDING PARISTOWN HALL, WHO WE EXCLUSIVELY BOOK, THEATER, WHERE WE WERE INSTRUMENTALLY INVOLVED. AND WE HAVE SERVED ON THE FRIENDS OF THE WATER FRONT BOARD SINCE INCEPTION. MANY OF YOU KNOW MY PARTNER, JOHN GRANT. I AM THE TALENT BUYER FOR THE SABA. IN ADDITION, I'M ONE OF THE OWNER/OPERATORS OF OUR COMPANY'S CROWN JEWEL ON IRISH HILL, WHICH WAS MANDATED TO CLOSE AND HAS NO REOPEN. OUR LAST SHOW WAS ON MARCH 11TH. I'M COMING TO YOU TODAY ON BEHALF OF THE 1500-PLUS MEMBERS OF THE MEMBER BUSINESSES HERE IN LOUISVILLE AND ANY OTHERS IN TOWN. WE ARE INDEPENDENTLY OWNED BUSINESSES OPERATING WITHOUT A BACKSTOP. WE HAVE NO CORPORATE LIFELINE TO CALL ON FACING A VERY STARK REALITY, ONE OF WHICH OUR FUTURE IS IN QUESTION. OUR CONTRIBUTION TO THE LOUISVILLE ECONOMY, OUR IMPACT ON TOURISM, AND CONTRIBUTION TO THE OVERALL OUALITY OF LIFE AND WORKFORCE RETENTION IS FAR REACHING. WE WERE THE FIRST TO CLOSE, AND WE'LL BE THE LAST TO OPEN. WE ARE LOOKING AT BUSINESSES THAT COULD BE CLOSED FOR 18 MONTHS OR MORE. WE'RE WORKING HARD IN WASHINGTON TO RECEIVE RELIEF. THAT COULD TAKE MONTHS. IN THE

MEANTIME, WE'RE INVOLVED IN LOCAL AND NATIONAL REOPENING TASK FORCES, INCLUDING HERE IN LOUISVILLE. BUT THIS WILL ALSO TAKE TIME AND MONEY. IN AN EFFORT TO SUSTAIN THROUGH THIS CRISIS AND HAVE THE RESOURCES TO READY OURSELVES WHEN THE TIME COMES, WE REOUEST FROM THE GENERAL FUND IN THE FORM OF GRANTS AND REIMBURSEMENTS. NO LESS THAN TEN WEEKS FROM THE WRITING OF THIS LETTER BEFORE CARES STIMULUS MONEY MAY BECOME AVAILABLE TO AFFECTED BUSINESSES. KNOWING OUR BUSINESSES WERE FAR BETWEEN 6,000 AND \$40,000 A MONTH TO STAY ALIVE AND NOT OPERATE, WE ARE REQUESTING AN APPROPRIATION OF A FUND TOTALLING \$250,000 TO BE GRANTED OR REIMBURSED FOR APPLICABLE EXPENSES FOR QUALIFIED BUSINESSES. RELATIVE TO BUSINESS QUALIFICATIONS. WE'LL WORK TOGETHER TO FUND NONPROFITS AND PRIVATE SOURCES FOR MATCHING FUNDS. QUALIFIED BUSINESSES MUST BE UNDER MANDATED CLOSURE BY THE STATE, EXCLUSIVELY FOR LIVE ENTERTAINMENT AT LEAST THREE TIMES PER WEEK ON AVERAGE AS OF JULY 1, 2019. QUALIFIED BUSINESSES MUST BE PRIVATELY AND LOCALLY OWNED AND NOT FRANCHISES. BUSINESSES MUST BE IN GOOD STANDING IN THE COMMUNITY. ADDITIONALLY, OR ALTERNATIVELY, EXPENSES MAY BE WAIVED BY THE CITY AND DEDUCTED FOR VENUES. I'VE LISTED EXAMPLES. THANK YOU FOR YOUR TIME.

>> PRESIDENT JAMES: THANK YOU.

>> CLERK: MR. PRESIDENT, THAT CONCLUDES THE ADDRESSES TO THE COUNCIL.

>> PRESIDENT JAMES: THANK YOU VERY MUCH, MADAM CLERK. COUNCILMAN PEDEN, I BELIEVE YOU REQUESTED A POINT OF PERSONAL PRIVILEGE.

>> YES, SIR. THANK YOU. AS I SIT HERE ON MY FRONT PORCH DURING THE MEETING, LOOK OUT THE YARD AND REALIZE THERE WAS A GROUP OF PEOPLE THAT WE FAILED TO RECOGNIZE TODAY. ALTHOUGH WE APPROPRIATELY MEMORIALIZED THE FOLKS WE LOST FOR COVID, THE OTHER GROUP OF PEOPLE WHO REACHED A GIANT MILESTONE IN THEIR LIFE ARE THE 2020 SENIORS. THIS IS WHAT MY DAUGHTER GOT FOR GRADUATING HIGH SCHOOL, A SIGN IN OUR FRONT YARD. BUT I BELIEVE THAT PERHAPS WE ALL PROBABLY RECOGNIZE, IF COUNCILMAN BLACKWELL OR KRAMER WOULD LIKE TO CHIME IN ON THIS, THESE GUYS HAVE LOST A LOT. YES, THEY HAVE A DIPLOMA IN HAND, AND, YES, THEY ARE ON THEIR WAY TO THE REST OF THEIR LIVES, AND EVEN UNCERTAIN COLLEGIATE OPTIONS FOR NEXT YEAR AND SO ON, BUT THEY'VE MISSED OUT ON A BIG CHUNK THAT THEY'LL PROBABLY NEVER GET BACK, AND PROBABLY DESERVE A RECOGNITION. AND A BIG ROUND OF APPLAUSE, AS WELL, AS A MOMENT OF SILENCE. I DON'T KNOW HOW TO GO WITH THAT. BUT IT'S A HUGE THING. I'VE WATCHED IT PERSONALLY AT THE HOUSE OVER THE LAST TEN WEEKS, AS SHE HAS COME DOWNSTAIRS AFTER SLEEPING UNTIL 3:00 IN THE AFTERNOON AND SAID, HEY, TODAY WOULD HAVE BEEN GRADUATION, TODAY WOULD HAVE BEEN PROM, TODAY WOULD HAVE BEEN THE BELL RIDE, AND ALL OF THOSE THINGS. IT'S KIND OF BEEN A BIG THING. YESTERDAY, WE HAD A PARADE THROUGH OUR

NEIGHBORHOOD, WHERE ALL OF THE GRADUATES AND OTHER PEOPLE MOVING ON RODE THROUGH THE NEIGHBORHOOD, AND IT WAS AMAZING THE OUTPOURING OF SUPPORT. AND I'M HOPING THAT IS GOING ON CITYWIDE, NOT JUST HERE. SO I WANTED TO RECOGNIZE ALL MEMBERS OF THE CLASS OF 2020, WHETHER HIGH SCHOOL OR COLLEGIATE. AGAIN, IF COUNCILMAN KRAMER OR BLACKWELL OR ANY OTHERS WOULD LIKE TO CHIME IN, IT WOULD BE APPRECIATED.

>> PRESIDENT JAMES: THANK YOU, COUNCILMAN. COUNCILMAN BLACKWELL, ANYTHING YOU WANT TO SAY THERE, DR. BLACKWELL?

>> I'M NOT SURE I CAN ADD MUCH TO IT THAT COUNCILMAN PEDEN DIDN'T SAY. CLEARLY, OUR GRADUATES LOST A LOT. I WILL SAY, THOUGH, IN LOOKING AT THEIR REFLECTIONS OF THAT, THEY DO RECOGNIZE ALSO THAT IT'S A PART OF THE COMMUNITY'S TOTAL LOSS. AND THERE REALLY DOES SEEM TO BE A SENSE OF WE'RE ALL IN THIS TOGETHER. WE LOST THAT PIECE OF IT, WHICH IS IMPORTANT AND CAN'T GET BACK, BUT OTHERS LOST IMPORTANT THINGS, TOO, INCLUDING, THEIR LIVELIHOODS AND SOMETIMES THEIR LIVES. BUT, YEAH, ABSOLUTELY, IT'S BEEN A VERY DIFFICULT TIME FOR THEM. IT'S BEEN A VERY DIFFICULT TIME FOR OUR TEACHERS AND OUR ADMINISTRATORS AS THEY PULL TOGETHER THIS AND TRY AS BEST THEY CAN TO MAKE IT AS SPECIAL AS THEY CAN, EVEN WITHOUT FACE-TO-FACE AND LARGE GATHERINGS. SO I AGREE WITH YOU 100%, THEY DESERVE WHICH EVER IT IS. I THINK IT COULD GO BOTH WAYS. I WOULD LEAN TOWARDS THE APPLAUSE. THANK YOU, MR. PRESIDENT. >> PRESIDENT JAMES: THANK YOU, SIR. COUNCILMAN KRAMER?

>> I DON'T KNOW I HAVE A LOT TO ADD TO THE CONVERSATION. I AGREE WITH BOTH OF MY COLLEAGUES. I WILL SAY THAT AS A TEACHER, ONE WHO MISSED SEEING SOPHOMORES FOR THE REST OF THE YEAR, THAT WAS TOUGH ENOUGH, KNOWING THEY ARE GOING TO BE BACK IN THE BUILDING NEXT YEAR MAKES IT A LITTLE BIT EASIER. FOR THE SENIORS, AS BOTH MY COLLEAGUES HAVE SAID, IT'S BEEN QUITE A CHALLENGE. I WILL SAY THAT AS IS ALWAYS THE CASE, AT LEAST FOR ME, I HAVE BEEN VERY MUCH IMPRESSED WITH THE WAY THAT OUR YOUNG STUDENTS AND THE STUDENTS RESPOND TO THINGS. WE HAD A STUDENT, A SENIOR, WHO WROTE A LETTER TO THE SENIOR CLASS REFLECTING MUCH OF WHAT BOTH OF MY COLLEAGUES HAVE SAID. WHAT A STRUGGLE IT'S BEEN TO WATCH AS THOSE DAYS GO BY THAT WERE SPECIAL DAYS, MILESTONE DAYS THAT WEREN'T CELEBRATED, BUT AT THE SAME TIME RECOGNIZING THAT WHILE THIS IS OUR STUDENTS' LOSS, AND AS HARD AS IT IS, IT'S A PIECE OF A MUCH GREATER LOSS. AND SO WHEN I GET FRUSTRATED AND WANT TO KICK THINGS AROUND THE HOUSE, I GO BACK AND READ THAT LETTER FROM A SENIOR IN HIGH SCHOOL WHO SHARED AN INCREDIBLE WISDOM FOR A YOUNG WOMAN HER AGE. I COULDN'T AGREE WITH MY COLLEAGUES MORE. IT IS A TOUGH TIME FOR THOSE FOLKS WHO ARE GRADUATING BOTH AT THE HIGH SCHOOL AND COLLEGE LEVEL, AND EVEN THE ELEMENTARY LEVEL, WHERE THEY ARE MOVING ON TO SOMETHING MUCH BIGGER.

>> PRESIDENT JAMES: THANK YOU. COUNCILWOMAN SEXTON SMITH.

>> YES, THANK YOU, MR. PRESIDENT. I WANTED TO PUBLICLY THANK COUNCILMAN PEDEN FOR SHARING HIS DAUGHTER'S ONE MORE GRADUATION EVENT WITH US LIVE FROM HIS FRONT PORCH. IT WAS VERY MOVING. I'M NOT SURE, BUT I THINK I MAY HAVE SEEN DOCTOR, PRESIDENT, MR. BLACKWELL, WIPE A TEAR FROM HIS FACE, I'M NOT SURE. I APPRECIATE YOU SHARING THAT WITH US. I CAN ONLY IMAGINE WHAT IT WOULD BE LIKE TO BE A CEO OF AN ORGANIZATION OF FINE YOUNG MEN THAT LOOK UP TO YOU AND COUNT ON YOU. SO I WANTED TO SAY TO ALL OF THE GRADUATES OF THE CLASS OF 2020, THIS IS ALL PART OF A MASTER PLAN THAT SURPASSES ALL UNDERSTANDING. AND YOU WILL BECOME THE FUTURE OF OUR WORLD, AND THAT IS PART OF THE PLAN. YOU WILL BECOME MORE RESILIENT THAN ANY OF US THOUGHT WE COULD EVER BE, BECAUSE YOU'RE MAKING THE MOST OF THIS SITUATION. YOU COULDN'T DECIDE HOW IT'S GOING TO HAPPEN, AND IT GOT PRESENTED TO YOU, AND I WANT TO THANK FOLKS, WHOEVER MADE THE DECISION, TO LIST THE NAMES OF THE HIGH SCHOOLS ACROSS THE TOP OF THE BUS, AND ON THAT BUS, THE NAMES OF ALL THE GRADUATES. I DID SEE ONE TODAY, AND TO COUNCILWOMAN DONNA PURVIS, I WANT TO TELL YOU, THE ACADEMY OF THE SHAWNEE PARK BUS LOOKED FABULOUS AS IT WENT BY. I BELIEVE THAT IS IN DISTRICT 5. AND IF IT'S NOT, I STAND CORRECTED. MR. PRESIDENT, THANK YOU FOR THE PERSONAL POINT OF PRIVILEGE TO RECOGNIZE THE WONDERFUL YOUNG GRADUATES OF THE CLASS OF 2020. THAT GOES TO WHATEVER YOU'RE GRADUATING FROM, BE

IT KINDERGARTEN, MIDDLE SCHOOL, HIGH SCHOOL, COLLEGE, WHATEVER THE CASE MAY BE.

>> PRESIDENT JAMES: THANK YOU, COUNCILWOMAN SEXTON SMITH. AND WITH THAT, I THINK WE SHOULD GIVE THEM A STANDING OVATION. THANK YOU. COUNCILWOMAN SHANKLIN.

>> THANK YOU, MR. PRESIDENT. I, TOO, WANT TO BRAG. IF YOU COULD SEE THIS PICTURE, IT TOOK US 14 YEARS, BUT WE GOT THERE. AND SHE WAS ONE OF THE VALEDICTORIANS, AND I AM SO PROUD OF HER. IT'S BEEN 14 YEARS, BUT IT WAS HARD WORK. SHE MADE IT.

>> PRESIDENT JAMES: THANK YOU, COUNCILWOMAN. THAT'S A REALLY GOOD BIRTHDAY PRESENT. ALL RIGHT. WE ARE EXPERIENCING SOME TECHNICAL DIFFICULTIES WITH COUNCILMAN YATES. I'M GOING TO HOLD THE MEETING FOR FIVE MINUTES AND SEE IF WE CAN MAKE RECONTACT WITH HIM.

REGULAR PLANNING AND ZONING COMMITTEE, MAY 19, 2020. REGULAR LABOR AND ECONOMIC DEVELOPMENT COMMITTEE, MAY 19, 2020. REGULAR PUBLIC WORKS COMMITTEE, MAY 19, 2020. >> CLERK: AN ORDINANCE AMENDING CHAPTER 35 OF THE LOUISVILLE METRO CODE OF ORDINANCES TO ESTABLISH AN ORGAN DONATION POLICY FOR LOUISVILLE METRO EMPLOYEES. READ IN FULL.

>> PRESIDENT JAMES: THANK YOU. MAY I HAVE A MOTION AND SECOND FOR APPROVAL? MOTION BY COUNCILMAN KRAMER, SECOND BY COUNCILMAN BENSON. THE ORDINANCE IS BEFORE US. IS THERE ANY DISCUSSION? COUNCILMAN SHANKLIN.

>> THANK YOU, MR. PRESIDENT. I DID TURN THIS OVER TO COUNCILMAN PIAGENTINI. [INAUDIBLE]

>> PRESIDENT JAMES: THANK YOU, COUNCILWOMAN. COUNCILMAN PIAGENTINI.

>> THANK YOU, COUNCILWOMAN SHANKLIN. THANK YOU, MR. PRESIDENT. SO I'LL CUT RIGHT TO THE CHASE HERE. I HAD A -- I HAVE A CONSTITUENT BY THE NAME OF BETH BURRBRIDGE, WHO A LITTLE OVER A YEAR AGO NOW JUST CELEBRATED HER ONE-YEAR ANNIVERSARY, WAS A LIVE KIDNEY DONOR, DONATED A KIDNEY TO A YOUNG MAN. THEY DID THE TRANSPLANT HERE IN LOUISVILLE. AND IT WAS JUST SORT OF, YOU KNOW, ONE OF THESE HAPPENSTANCE THINGS THAT HAPPEN WHERE SHE FOUND SOMEBODY THAT WAS ASKING FOR SUPPORT. SHE PRAYED ON IT WITH HER FAMILY, HER HUSBAND, YOU KNOW, FOUND OUT SHE HAD GOT TESTED, FOUND OUT SHE WAS A POSITIVE MATCH, AND QUITE LITERALLY SAVED THIS YOUNG MAN'S LIFE. I MYSELF, WHEN I WAS IN MY YOUTH, WHEN I WAS A YOUNG MAN, CAME WITHIN DAYS OF DOING THE SAME. SURGERY WAS CALLED OFF ABOUT TWO DAYS BEFORE THE TRANSPLANT WAS SUPPOSED TO HAPPEN, BUT HAD A VERY GOOD FRIEND OF MINE'S MOTHER WHO HAD BEEN ON DIALYSIS AND WAS RUNNING OUT OF OPTIONS AND NEEDED A DONOR. TURNED OUT I WAS A VERY, VERY CLOSE MATCH. UNFORTUNATELY, HAD TO BE CALLED OFF AT THE LAST SECOND DUE TO SOME HEALTH ISSUES OF THE WOMAN I WAS DONATING TO. THIS WAS MY FRIEND'S MOTHER. AND SO BETH HAS GONE ON A CAMPAIGN NOW, MS. BURBRIDGE, MY CONSTITUENT. AND IT STARTED WITH THE STATE. ACTUALLY, THE STATE LEGISLATURE SPONSORED BY MY STATE REPRESENTATIVE JERRY MILLER STARTED THIS, THIS LAST LEGISLATIVE SESSION, IT PASSED, WAS SIGNED BY THE GOVERNOR, AND NOW WE'RE LOOKING TO DO THE PRECISE SAME THING HERE AT THE CITY, WHICH IS TO BREAK DOWN THE BARRIER OF -- THE FINANCIAL BARRIER TO BE A LIVE DONOR, TO THOSE WHO WOULD GIVE THIS LIFE-SAVING PROCEDURE. IT IS VERY UNCOMMON. IT'S NOT A COMMONPLACE THING THAT LIVE DONATIONS ARE DONE. I THINK THERE MIGHT BE 100 STATEWIDE PER YEAR. RIGHT, THIS IS A VERY UNCOMMON SURGERY, BUT IN EVERY

SINGLE CIRCUMSTANCE, IT IS A LIFE-SAVING SURGERY. THE PROBLEM WAS, FOR EXAMPLE, IN BETH'S CASE, SHE HAD TO BE BACK AT WORK WITHIN DAYS AFTER HER SURGERY. IT WAS VERY PAINFUL. IT INCREASED THE RISK OF HER HAVING COMPLICATIONS POST-SURGERY, BUT SHE DIDN'T HAVE THE FINANCIAL MEANS TO TAKE A MONTH OFF OF WORK, WHICH IS WHAT IS RECOMMENDED. SO THE STATE'S ALREADY DONE THIS, AND WE'RE TRYING TO DO THIS WITH THE CITY HERE. AND THE REASON WE'RE BRINGING THIS OLD BUSINESS WAS TO INCREASE THE -- INCREASE THE KNOWLEDGE OF THIS ISSUE. WE'RE LOOKING TO, NOW THAT WE'VE DONE THIS IN THE STATE AND WILL DO THIS IN THE CITY, WE'RE LOOKING TO TAKE THIS TO PRIVATE INDUSTRY AFTERWARDS AND SEE IF WE CAN GET MORE ORGANIZATIONS TO SIGN ON TO THIS EFFORT. BUT WHAT THIS ORDINANCE WILL DO IS PROVIDE 30 DAYS OF PAID TIME OFF FOR ANY ORGAN DONATION, OR SEVEN DAYS OF PAID TIME OFF FOR ANYBODY THAT DONATES BONE MARROW. IF ANY EMPLOYEES IN METRO GOVERNMENT SIGN UP AND FIND OUT THEY ARE A MATCH TO BE AN ORGAN DONOR OR TO BE A BLOOD -- A BONE MARROW DONOR, THAT IT ELIMINATES THE RISK THAT THEY EITHER HAVE TO GO BACK TO WORK QUICKLY, OR THEY DON'T HAVE THE FINANCIAL MEANS TO TAKE OFF. THESE ARE THE RECOMMENDED TIMES THAT HEALTH PROFESSIONALS SAY THAT A LIVE DONOR SHOULD TAKE IN ORDER TO FULLY RECUPERATE. AND, REALLY, THE COST TO THE CITY IS TRULY DE MINIMIS. AS A MATTER OF FACT, EVEN OF THE THOUSANDS OF EMPLOYEES THAT WE HAVE, IF WE HAVE EVEN ONE OR TWO EMPLOYEES A YEAR THAT MAY QUALIFY FOR THIS,

IT WOULD BE QUITE DRAMATIC, BUT, AGAIN, WE'RE TALKING ABOUT ONE OR TWO LIVES SAVED. AND THE COST OF THE CITY IS NOT ACTUALLY A DIRECT COST. IT'S SIMPLY AN INDIRECT COST OF THEIR LABOR FOR 30 DAYS OR SEVEN DAYS. REALLY, DE MINIMIS IMPACT TO A CITY THE SIZE OF OURS, BUT A TERRIFIC EMPLOYEE BASE TO ENCOURAGE PEOPLE TO THINK ABOUT DONATION, TO THINK ABOUT WHAT THIS CAN MEAN FOR THE PERSON YOU'RE DONATING TO, AND TO ELIMINATE, TRULY ELIMINATE, ANY FINANCIAL BARRIER THAT COULD EXIST TO ENCOURAGE MORE PEOPLE TO DO THIS. SO IT'S SOMETHING WE WANTED TO BRING TO THE FOREFRONT HERE, GET THE MESSAGE OUT. AFTER THIS IS OVER, TO BE WORKING WITH BETH TO BRING THIS TO PRIVATE INDUSTRY, AND I KNOW COUNCILWOMAN SHANKLIN, WE'VE TALKED ABOUT BRINGING THIS AND ESCALATING THIS ISSUE AMONG CERTAIN DEMOGRAPHICS, FOR EXAMPLE. IT IS SOME OF THE BIGGEST NEED FOR LIVE ORGAN DONATIONS IS AMONGST THE AFRICAN-AMERICAN POPULATION, AND YET IT'S ALSO ONE OF THE AREAS WHERE YOU SEE THE LEAST AMOUNT OF DONORS. AND A LOT OF THIS COULD COME DOWN TO FINANCIAL CONCERNS. RIGHT, SO WE'RE JUST TRYING TO TAKE MORE AND MORE STEPS TO RAISE THE AWARENESS OF THE ISSUE AND ALSO TO ELIMINATE BARRIERS. SO JUST WANTED TO BRING THIS TO COUNCIL. HOPE TO GET UNANIMOUS SUPPORT FOR THIS. WANTED TO THANK COUNCILMAN SHANKLIN AND PRESIDENT JAMES FOR ALLOWING ME TIME TO SPEAK TODAY.

>> PRESIDENT JAMES: THANK YOU, COUNCILMAN. COUNCILWOMAN SHANKLIN.

>> AS MANY OF YOU PROBABLY KNOW, MY SON IS ON THE FIGHT OF LEUKEMIA, AND WE'VE BEEN TRYING TO GET A BONE MARROW DONOR FOR QUITE SOME TIME. OF COURSE, THERE'S NOT THAT MANY AFRICAN-AMERICANS THAT ACTUALLY, YOU KNOW, DO THAT. SO IF THIS HERE ORDINANCE -- REASONS THAT MAY NOT BE ABLE TO TAKE OFF WORK OR WHATEVER, AND IT WILL MAKE A DIFFERENCE. WE WEREN'T LUCKY ENOUGH TO GET A DONOR, BECAUSE THEY ONLY FOUND TWO PEOPLE THAT WOULD MATCH, AND THEY DIDN'T COME FORWARD, I GUESS THEY DIDN'T WANT TO TAKE OFF WORK. IT WILL MAKE A DIFFERENCE FOR PEOPLE THAT HAVE TO TAKE OFF OF WORK, LOSE MONEY, LOSE PATH AT WORK. HOPEFULLY, IT HELPS SOMEONE OUT. THANK YOU.

THIS IS A TELECOM COMPANY THAT HAS AN UNDERGROUND FIBER PRESENCE IN SOMETHING LIKE 21 OF THE METRO COUNCIL DISTRICTS. THEY DO NOT OWN ANY UTILITY POLES, NOR DO THEY PLAN TO INSTALL ANY POLES. THEY HAVE, ACCORDING TO AL ANDREWS, A CLEAN RECORD IN TERMS OF REPAIRING ANY DAMAGE THAT THEY'VE EVER DONE TO THE RIGHT-OF-WAY, SO THEY ARE IN GOOD STANDING WITH THE CITY. AND, REALLY, THE ONLY REASON IT'S ON OLD BUSINESS, I THINK, TONIGHT IS BECAUSE WE HAD TO MAKE SORT OF SOME TECHNICAL AMENDMENTS IN COMMITTEE. IF THERE ARE ANY QUESTIONS, I WOULD URGE MY COLLEAGUES TO VOTE IN APPROVAL. THANK YOU.

COUNCILWOMAN NICOLE GEORGE WORKED VERY DILIGENTLY ON. THIS IS IN HER DISTRICT. ONE OF THEM, BINDING ELEMENT NUMBER TWO WAS CHANGED TO REFLECT THE FULL PLANNING COMMISSION AND THE METRO COUNCIL WILL HAVE TO APPROVE THE FIRST DETAILED DEVELOPMENT PLAN. ONCE THAT IS DONE. AND THEN WE ADDED A BINDING ELEMENT NUMBER TEN THAT PROHIBITS OUTBOUND TRAFFIC TO HIGHWAYS. BINDING ELEMENT NO. 11 ADDRESSED THE FIRST DETAILED DEVELOPMENT PLAN AFTER REZONING WILL REOUIRE A TRAFFIC STUDY TO DETERMINE NECESSARY IMPROVEMENTS TO ADJACENT ROADWAYS. THE SCOPE OF THE TRAFFIC STUDY WILL BE DETERMINED IN CONSULTATION WITH METRO PUBLIC WORKS. IF THE TRAFFIC STUDY RECOMMENDS IMPROVEMENTS, THEN THE DEVELOPER WILL CONTRIBUTE \$100,000 TOWARDS THE COST OF IMPROVEMENT, AND THIS CONTRIBUTION SHALL ONLY BE ALLOWED FOR THE FIRST TWO YEARS AFTER CERTIFICATE OF OCCUPANCY. THIS IS IN COUNCILWOMAN NICOLE GEORGE'S DISTRICT, IF YOU WANT TO CALL ON HER.

>> THANK YOU, MR. PRESIDENT. THIS PARTICULAR PIECE OF PROPERTY IS LOCATED IN THE HIGHLINE NEIGHBORHOOD PLAN AREA. IN 2013, THE PROPERTY WAS RECOMMENDED AND IT WAS DOWN ZONED FROM R 6 TO R5A. THE APPLICANT HAS ASKED FROM A REZONING FROM R5B TO R8A. THE SITE HAS NONCONFORMING RIGHTS FOR THREE APARTMENT UNITS, BUT IT CURRENTLY HAS SIX UNITS IN THERE. IN FACT, ONE OF THE UNITS THEY ARE NOT REALLY SURE EVEN QUALIFIES AS A UNIT, BECAUSE IT TAKES 200 SQUARE FEET, ACCORDING TO STATE LAW, TO BE CONSIDERED A RESIDENTIAL UNIT. THE PLANNING COMMISSION RECOMMENDED A DENIAL ON THIS ZONING CHANGE, AND SO TONIGHT'S VOTE WILL BE TO UPHOLD THE PLANNING COMMISSION'S DENIAL OF THE ZONING CHANGE. AND THIS IS IN COUNCILMAN BRANDON COAN'S DISTRICT. I'M SURE HE WOULD LIKE TO ADDRESS US ON THIS. >> PRESIDENT JAMES: THANK YOU, COUNCILWOMAN FLOOD.

>> THANK YOU, MR. PRESIDENT. YEAH, IN FOLLOW-UP TO WHAT COUNCILWOMAN FLOOD SAID, THERE WAS AN AREA-WIDE REZONING IN 2013 FOLLOWING AN ORIGINAL NEIGHBORHOOD PLAN. AND SO THE PLANNING COMMISSION, AMONG OTHER THINGS, DETERMINED THAT THEY SHOULD SORT OF AVOID A SPOT UP-ZONING OF THIS ONE PROPERTY. IT WAS AGAINST THE NEIGHBORHOOD PLAN. THE NEIGHBORHOOD ASSOCIATION WROTE A LETTER IN OPPOSITION TO THE PROPERTY. I'M SORRY, IN OPPOSITION TO THE REZONING. LIKE COUNCILWOMAN FLOOD ALSO SAID, THERE WAS SOME QUESTION ABOUT WHETHER THERE WERE ENOUGH, YOU KNOW, ELECTRIC METERS FOR EACH OF THE SIX UNITS THAT ARE CURRENTLY THERE. AND SO ON BALANCE, THE PLANNING COMMISSION FOUND --GUIDELINES, RECOMMENDED THE DENIAL. IT'S WORTH NOTING THAT THERE ARE CURRENTLY, ALTHOUGH IT'S ONLY LEGALLY ZONED FOR THREE UNITS, SIX, YOU KNOW, QUOTE/UNQUOTE APARTMENTS. SO SIX PEOPLE LIVING IN THIS BUILDING. SO SOME CONCERN WAS EXPRESSED ABOUT, YOU KNOW, THE OPERATION OF US DENYING THE REZONING, SAYING THAT THEY CAN ONLY HAVE THREE UNITS, WHAT HAPPENS TO PEOPLE THAT LIVE IN UNITS FOUR, FIVE, AND SIX? AND SO, YES, THE ANSWER IS, YES, PEOPLE ARE GOING TO HAVE TO FIND SOMEWHERE ELSE TO LIVE. OBVIOUSLY, WE'RE CONCERNED THAT MAKE SURE NO ONE GETS KICKED OUT ON THE STREET OR LOSES A ROOF OVER THEIR HEADS. ANY TIME, ESPECIALLY DURING THIS KIND OF ELEVATED TIME OF PUBLIC HEALTH CONCERNS. SO I'VE

NOTIFIED THE DIRECTOR ABOUT OUR CONCERNS IN THIS REGARD, AND HE'S ASSURED US THAT CODE ENFORCEMENT AND ZONING ENFORCEMENT WILL WORK IN COORDINATION IF AND WHEN IT'S APPROPRIATE TO ENFORCE THE UNIT LIMITATIONS ON THOSE ZONINGS. SO MY CONCERNS FOR THE PEOPLE THERE, AND I'LL SAY THIS ALSO, THE LANDLORD WHO MAY BE LISTENING HAS EXPRESSED SOME REAL CONCERN, I TAKE IT AS HIS FACE VALUE, REAL CONCERN OF PEOPLE HAVING A ROOF OVER THEIR HEADS. I WOULDN'T EXPECT ANYONE TO BE KICKED OUT ON THE STREETS. SO WITH THAT ALL BEING SAID, I GUESS I'D URGE MY COLLEAGUES TO ACCEPT THE PLANNING COMMISSION'S RECOMMENDATION, AND SO VOTE YES IN DENIAL.
