

Brick columns to be farther apart (approximately 144"); brick to match brick on house as closely as possible. Overall height 72"

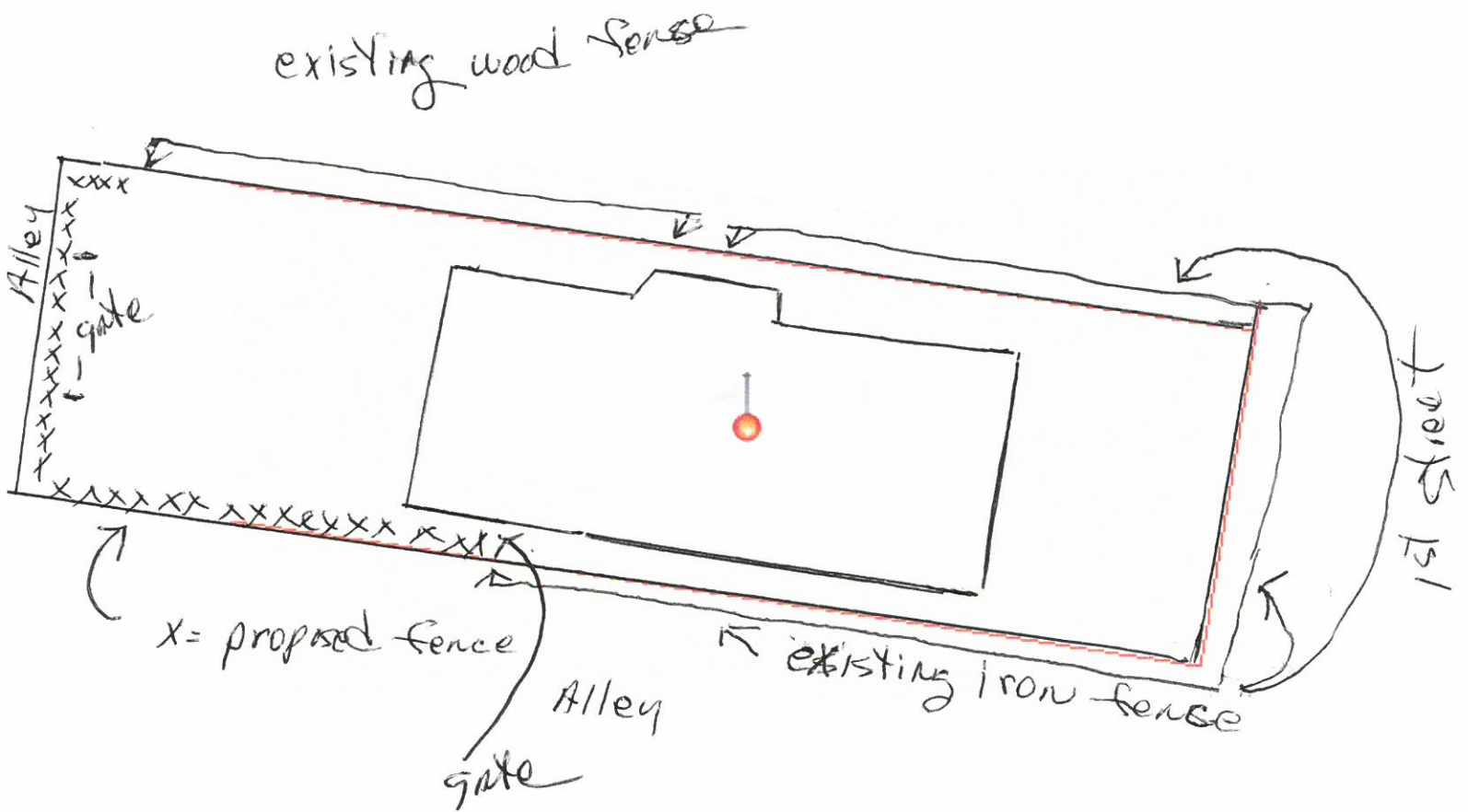
