Vice Chair George reminded everyone about the presentation on this topic at the last meeting. She asked for feedback or any questions from the Committee Members and Non-Committee Members on the proposed Police, Treatment, and Community Collaborative ("PTACC") plan. She stated that the proposal was also attached to the agenda and reviewed the components in the proposal.

Council Member Hollander stated that he had spoken to some providers in the community that help those with mental health and homeless issues and has found that one component the community does not currently have in place for people to call rather than calling the police regarding concerns. He also stated that it is important that the current providers understand that if PTACC is engaged it will not replace the current work being done and services being provided. Council Member Hollander also commented about the funds in the Budget for these services currently residing at the Police Department, and discussions with the Police Department about their plans for the use of the money and past plans used regarding deflection.

Committee Member Dorsey said she had more questions and would like to see the overall process flow and how it would fit in with the current system. She also wants to see how this would work with juveniles and had questions about a possible holding place, or housing, or intermediate facility.

Vice Chair George asked others to share if they know of any other models or entities that address the same issues that are being used across the country.

Committee Member Dorsey also asked whether an analytical review of the data regarding 911 calls and the providers available are part of the initial cost of the program. Vice Chair George mentioned the entity that is doing the full-scale review of the Police Department, which includes some data on the 911 calls, and Committee Member Dorsey asked if a description of that entity's analysis could be shared so that the work is not duplicated.

- Question regarding whether there was a community input component in the review of the Land Development Code ("LDC") revisions
- Confirmation that public engagement is part of the review process
- Question regarding the impact of changes to single-family zoning districts on Homeowner Associations ("HOAs"), and whether the HOAs can continue to have more stringent rules after the LDC is revised
- HOAs rules are related to deed restrictions, not the LDC, and it is not likely that current deed restrictions can be changed but, moving forward, the Council may be able to pass laws regarding the HOA deed restrictions
- Any LDC revisions adopted by the Metro Council would be recommended to the Planning Commission for adoption since they oversee all of Jefferson County, which includes the 12 suburban cities that have their own zoning authority
- What it is that makes Louisville unique compared to other cities as it relates to the diagnosis
