## 1. <u>0-273-20</u>

## AN ORDINANCE AMENDING THE louisville metro CODE OF ORDINANCES to EXPAND AND ENHANCE THE ABILITY OF the LOUISVILLE METRO government TO COMBAT GRAFFITI (amendment BY SUBSTITUTION).

A motion was made by Committee Member Flood, seconded by Committee Member Engel, that this Ordinance be untabled. The motion carried by a voice vote.

Council Member Piagentini spoke on two language changes in the Amendment by Substitution (1) How to define the word graffiti to be clear on not outlawing graffiti, but making known what vandalism is, and (2) the increase in fines structure.

A motion was made by Chair Coan, seconded by Committee Member Hollander, to amend this Ordinance by Amendment by Substitution (see attached document titled "O-273-20 V.3 CABS 081120 Graffiti Ordinance.pdf"). The motion to amend by substitution carried by a voice vote.

Chair Coan asked the question about impounding vehicles, and the release of them, if the owners gives written waivers on their right to appeal.

Robbie Howard, Jefferson County Attorney's Office, recommended they remove the language regarding when a person who is appealing the impoundment of a vehicle, who seeks to appeal the citation.

A motion was made by Chair Coan, seconded by Committee Member Engel, to amend the Ordinance as follows:

- Delete LMCO 131.15(B)4, which states:"4. Written waiver of right to appeal under §131.15 (C)"

The motion to amend carried by a voice vote.

Chair Coan asked questions about impoundment, penalties, and liens on vehicles.

- Research show people between the age 20-30 are more likely to engage in tagging activity

- There are professional taggers, who travel from one community to another
- Code and Regulations and the Louisville Metro Police Department are
- working together to focus on enforcing civil penalties for restitution
- The restitution collected will go to the Louisville Public Space Art Fund

Tony Parrot, Louisville Metropolitan Sewer District, stated; (1) technology that will let us have a better percent of solids in our bio-solids, (2) reduces the loading to a local landfill, (3) thermal hydraulics process that will allow them generated energy off the plant, and in the future generate product off the thermal hydraulics product for new assets. This will allow MSD to redo how solids are handled district wide, and reduce the cost of operation in the future.
