<u>SECTION 1.</u> That the Board Members of the Louisville and Jefferson County Landbank Authority, Inc. hereby authorize the sale of the following described property:

SECTION 2. That the Chairman of the Louisville and Jefferson County Landbank Authority, Inc., or his designee, is hereby authorized and directed to transfer the property listed herein in the manner provided according to KRS 65.370, to Sunshine Builders, LLC, to construct a single-family residence on each parcel, without further action by the Authority.

SECTION 3. That the Applicant shall maintain the Property in a manner consistent with the Codes and Ordinances of the Louisville/Jefferson County Metro Government ("Louisville Metro").

SECTION 4. That the Applicant shall obtain all necessary permits and approvals required by Louisville Metro and shall construct a single-family residence on each parcel within eighteen (18) months of acquiring the property.

SECTION 5. That the Applicant shall return the property back to the Authority should the Applicant fail to meet the requirements of Section 3 and Section 4 above; such requirements being included and recorded as a deed restriction which shall terminate on the date the Authority issues a Deed of Release and Satisfaction.
