This letter will serve notice that nonconforming use rights for a trucking company have not been established for the property located at 7614 Buena Vista Court. The subject property lies within the R-4 Single Family Zoning District. This decision is based upon information provided in the application and Develop Louisville files.

Staff did not receive or find documentation supporting the consecutive use of a trucking company. Staff did find documentation reflecting a single-family use on the property since the home was constructed. Additionally, there is no evidence of a trucking company being operated on site prior to the implementation of the zoning code.

Staff's conclusion can be appealed to the Louisville Metro Board of Zoning Adjustment pursuant to Kentucky Revised Statutes, Section 100.257 within 30 days.

This notice is to remind you that the City of Louisville requires a **City Truck License** for each truck, with a weight class over 10,000 pounds, that uses the City of Louisville streets. The license must be purchased by **May 1** each year, and must be placed on the vehicle's windshield.

Our records indicate that you purchased one or more such licenses for the license period that ended on **April 30, 2000** thus you will probably need to purchase new licenses. Vehicles that use the City streets five or less times during the year are exempt from the license. Additionally, under Kentucky law, vehicles owned by "common" or "contract" carriers are exempt.

If you need to buy a license, or have any questions, you may visit our office at **101 South 8<sup>th</sup> Street** or call us at **(502) 574-4860 from 8:30 am to 4:30 pm, Monday through Friday**. The amounts of the license fee varies according to the weight of the vehicle and are shown in the table below:
