The following was discussed:

- The year to date increase is 7.2% overall
- Emergency Medical Services payment shift is attributed to Suburban Emergency Medical Services taking more runs
- More people on Medicaid than 3 years ago
- Reduction in revenue with Waste Management
- Tow lot completely full, so reduction in revenue
- Positive to the 2020 fiscal year budget of approximately \$26 million to be carried forth
- Question whether Frankfort has giving any update on obligation of the Pension for the Senate Bill funding of 12% increase
- The small businesses that received grants are listed on the website along with the addresses
- The quarter tax revenues are up

The following was discussed:

- Staffing with Public Health and Wellness has expanded due to COVID-19
- Sub grant award from Metro United Way in the amount of \$2million for childcare and daycare's in Jefferson County
- Half of the \$2million is to provide personal protection equipment to over 480 providers, the other half is direct stipends to providers to help cover there operating cost
- Since March over 80 providers have had to close
- Sub grant award for Evolve 502 in the amount of \$735,000 to support Non-traditional Instructional hubs
- Evolve 502 will supply stipends to cover personal protective equipment, school supplies, cleaning supplies and meals
- There are about 50 Non-traditional instructional hubs
- Non-traditional hubs will be located in church's and community buildings
- The Non-traditional instructional hubs office contact is Ben Johnson
- Jefferson County Public School is providing substitute teachers, meals, snacks, chrome books, training modules for students, learning and enrichment for students and families, and data coordination to access student needs
- Non-profits can receive grant money from Evolve 502 if they submit the documentation required
- Metro United Way and Evolve 502 are federally funded though the CARES Act and have to report to Public Health and Wellness
- Public Health and Wellness is working with the Office of Globalization to start a new program to give sub awards to 6 different organizations that serve predominantly immigrants residents
- Next CARES Act meeting update will be December 3, 2020

Dewayne Clark and Eric Troutman, Louisville Metro Department of Corrections

- Metro Department of Corrections tested 3,893 inmates for COVID-9, 293 returned positive
- Currently 4 inmates tested positive
- 35 staff currently out self isolating for COVID-9 symptoms
- 66 staff vacancies
- When inmates stay incarcerated 45 days or longer in jail it cost the tax payers
- The ratio of how long inmates stay in jail is dramatic
- Question whether there is data on the amount of inmates that were released because of COVID-19
- Number of new state prisoners population has decreased due to COVID-19, once everything opens back up, the number of new state prisoners will be transferred from Louisville Metro Department of Corrections to state prison
- Question about the distortion of ratio of inmates in Metro Department of Corrections
- Metro Department of Corrections intake bookings from January to September of this year, 54% white inmates, 43% black inmates, 2% hispanic inmates, 1% other inmates
- Metro Department of Corrections inmates still remaining in custody as of October 15, 2020, 44% white inmates, 53% black inmates
- Community Corrections Facility closed May 3, 2020 because of COVID-19
- Budget for Community Corrections Facility is \$7.8 million
- Community Corrections Facility was for inmates that would be housed and released to go to work, school, and treatment, until Public Health ordered them close during the pandemic
- The bail project from New York, which helps lower level offenders with small bail amounts, pay bonds so they can be released
- Question about organization called Louisville Community Bail Fund stating they have bailed out \$50,000 and \$100,000 bails for accused murders and rapist, including murder suspect that was caught on video
- What percent of the 12,862 inmates that have been incarcerated this year needed to be detox when they arrived
- Question regarding how many of the 1,297 inmates that are incarcerated on a daily bases have needed \$500 dollars or less for bail
