LET ME SAY FOR MY COLLEAGUES AND THE PUBLIC, THESE ARE BY US GETTING TOGETHER, THE SIGNATURES ARE MYSELF PRESENTING AND DAVID

JAMES AND BOTH CAUCUS CHAIRS TO REFLECT THE ENTIRE COUNCIL, REPRESENTING ALL 26 OF US.

AGAIN THE TWO THINGS I WANT TO HIGHLIGHT BEFORE I READ THE PROCLAMATIONS, ONE BEING [INDISCERNIBLE].

FOR EXAMPLE, MAJOR GREGORY MENTORS YOUNG PEOPLE IN THE COMMUNITY BY COACHES.

HE'S A VOLUNTEER COACHES.

HE HELPS WITH PROBLEM SOLVING AND THINKING SKILLS THROUGH THE GAME OF CHESS.

HE VOLUNTEERS WITH KIDS TO WORK WITH YOUTH.

WHAT YOU SEE HERE IS -- IS -- IS MEN AND WOMEN THAT NOT ONLY PUT THEIR LIVES ON THE LINE BUT ALSO THAT ARE CONSTANTLY GIVING BACK.

IN THE LAST THING I'LL SAY BEFORE I READ THE PROCLAMATIONS AND TURN THE MIKE OVER TO THESE GENTLEMEN AND GIVE THEM A MOMENT TO SAY WHATEVER THEY LIKE IS THAT THESE ARE FAMILY PEOPLE, RIGHT? THEY HAVE PARENTS, SPOUSES, CHILDREN AND YOU KNOW WHEN -- WHEN THE PROTESTS WERE IN FULL SWING, THERE WERE NIGHTS, NOT BECAUSE OF PEACEFUL PROTESTERS OR THOSE THAT WOULD TAKE ADVANTAGE OF THOSE PROTESTS FOR VIOLENCE AND MAYHEM, THAT WE WERE GETTING MESSAGES FROM OUR COUNCIL PRESIDENT TO NOT BE IN THE BUILDING AND TWO HOME AND NOT STAY LATE, ET CETERA.

TO WHOM THESE LETTERS COME GREETING, COUNCIL HONORS AND AWARD DESROCHES A CERTIFICATE FOR OUTSTANDING COMMUNITY SERVICE AND HIS OUTSTANDING CONTRIBUTIONS AND SERVICE TO THE LOUISVILLE METRO POLICE DEPARTMENT IN THE COMMUNITY.

LOUISVILLE METRO COUNCIL HONORS MAJOR AUBREY GREGORY JR. FOR
OUTSTANDING COMMUNITY SERVICE AND OUTSTANDING CONTRIBUTION AND
SERVICE TO THE LOUISVILLE POLICE DEPARTMENT IN OUR COMMUNITY, WE
CONFER THIS.

HE SERVED IN THE MARINE CORPS AND HE SERVED AS PART OF PRESIDENTIAL COMPANY RETREAT, CAMP DAVID MARYLAND PROVIDING PROTECTION TO PRESIDENT CLINTON AND THE FIRST FAMILY.

YOU WANT CHANGE, I WANT CHANGE, I KNOW MAJOR GREGORY WANTS CHANGE.

HOW CAN WE CHANGE WITH [INDISCERNIBLE]?

WE HAVE TO BE THE CHANGE.

I KNOW WE GET PAID NICKEL A DIMES TO DO OUR JOB.

I'M NOT GOING TO GET INTO THAT, BUT THIS PAY RAISE WILL HELP. THEY DON'T HAVE TO WORRY ABOUT PAYING THEIR BILLS, THIS AND THAT, THEY'RE LOOKING AT THE PROBLEMS.

WHEN WE COME TO WORK THEY'RE GOING TO WORRY ABOUT FAMILY A THEN THEY'RE WORRIED ABOUT THE PEOPLE PROBLEMS ON THE STREET.

IN 2017, CORY BOYKENS MURDER, THEN JORDAN, 2019, DEWONTE. AND OTHERS AS WELL.

LET'S GIVE SOLACE TO THE FAMILIES THAT WILL EVER GET THEIR FAMILY MEMBERS BACK.

HOWEVER, I ALSO WANT TO SAY THAT THIS CONTRACT AS IT STANDS, IT DOES NOT PROVIDE A LOT OF THINGS FOR US, BUT IT DOES PROVIDE SECURITY, A WORLDWIDE EPIDEMIC SUCH AS COVID-19, NONE OF THE OFFICERS WERE AHEAD OFF.

WAITING FOR A RAISE, HONESTLY IT SHOULD NOT BE THAT MUCH OF A HASSLE.

VOTE NO TODAY AND SEND THIS BACK TO GREG AND ITS PEOPLE AND LET OUR COMMUNITY GET A LITTLE COMFORT.

EVER COMMUNITY IN LOUISVILLE.

GIVE THEM THE CONFIDENCE KNOWING THAT THE PEOPLE THAT WE ELECTED COULD [INDISCERNIBLE] US AS WE CRY OUT FOR ASSISTANCE DURING AN EMOTIONAL TIME.

ADDRESS THE COUNCIL BUT IT IS OUR POLICY THAT COUNCIL MEMBERS

MAY NOT BE CALLED OUT BY NAME, ESPECIALLY THREATENED WITH -
WITH REPRISAL, SOMEONE MAY CHOOSE TO RUN AGAINST THEM IN THE

CHAMBER.

COUNCILMAN TRIPLETT, I APOLOGIZE NOT FOR SPEAKING UP PREVIOUSLY. PLEASE RESPECT THE PROTOCOL.

>> PLEASE STICK TO THE PROTOCOLS ANNOUNCED EARLIER. >> ELY MCCALL.

>> GOOD EVENING I'M KELLY MCCALL AND I LIVE IN DISTRICT 17.
METRO MEMBERS, TONIGHT YOU WILL VOTE IF YOUR CONSTITUENTS WHO

BETTER PART OF THE YEAR HAVE BEEN WRITING LETTERS AND E-MAILS AND STREETS AND MARCHES AND RALLIES AND BEING SAFELY IN THE AREA OF COVID TO SHOW SUPPORT FOR POLICE REFORM.

LUCKILY WE KNOW YOU'RE NOT DEAF AND DO NOT INTEND TO IGNORE THE CRIES OF THE PEOPLE.

OUR COMMUNITY EXPECT CHANGE FROM YOU FOR YOU TO VOTE AGAINST THE SAME OLD POLICIES THAT SUPPORT POLICE BRUTALITY AGAINST ITS OWN CITIZENS.

CIVIL WAR ON ITS OWN CITIZENS.

TONIGHT YOU MUST VOTE NO AGAINST PASSING A COLLECTIVE BARGAINING AGREEMENT THAT HAS NOT BEEN NEGOTIATED IN GOOD FAITH BETWEEN THE MAYOR'S OFFICE AND THE FOP.

METRO COUNCIL ITSELF VOTED NO CONFIDENCE IN THIS MAYOR AND HIS POLICIES.

THEREFORE, VOTING TO RATIFY SOMETHING THAT YOU HAD NO PART IN NEGOTIATING WOULD BE A VOTE AGAINST YOUR OWN BEST IDEALS. ANSWERS TO SIMPLE QUESTIONS FROM THE METRO COUNCIL TO THE FOP AND THE COUNTY ATTORNEY'S OFFICE HAVE NOT BEEN READILY

AVAILABLE.

THE PARTIES INVOLVED IN CONTRACT NEGOTIATION CLEARLY SEEM TO BE RUBBER STAMPING OLD IDEAS AND THOUGHTS THAT HAVE GONE INTO THE POLICE CONTRACT FOR THE PAST DECADE, WITH ORIGINS THAT ARE NOT EVEN IDENTIFIABLE ANYMORE.

FOP PRESIDENT RYAN NICHOLS SAID THIS PAST MONDAY, THAT HE WOULD GO BACK TO THE NEGOTIATION TABLE IF THAT'S THE DECISION TONIGHT. THAT MUST BE YOUR DECISION.

OR OVERWORKING THEIR STAFF.

MAKE SURE THAT WE HAVE ENOUGH OFFICERS BECAUSE LADIES AND GENTLEMENS AND COLLEAGUES, IF WE'RE SCRAPPING THE BOTTOM OF THE BARREL, THEN WE'RE GOING TO HAVE PROBLEMS.

I KNOW THE COMMUNITY FROM WHAT I'VE HEARD, MOSTLY COMMUNITY DOES NOT WANT TO PASS THIS CONTRACT TODAY.

I DON'T KNOW IF THAT IS, BUT MOST CONVERSATIONS I HEARD.

I HAVE A DUTY TO ALWAYS TO WHAT I THINK IS IN THE BEST INTEREST OF THE COMMUNITY.

WE'RE FORCED TO HIRE THAT.

I CAN'T BELIEVE THAT'S THE BEST THING FOR THE COMMUNITY RIGHT NOW.

IF THIS PASSES AND THEY DO NOT COME BACK WILLING TO MAKE CONSESSIONS, I WON'T BE HERE.

I'LL BE IN THE STATE SENATE I BELIEVE THIS BODY WILL HOLD THEM ACCOUNTABLE FOR THAT.

THIS DEPENDS A LOT ON TRUST.

NEGOTIATE FROM THE STANDPOINT THAT WE'RE IN A STRONG POSITION AND IF I WAS WANTING TO GET THE BETTER OF A CONTRACT AND I WANTED TO BOND THEM OVER THE BARREL AND PUSH THEM FOR EVERY PENNY, YOU'RE RIGHT, YOU WOULDN'T GIVE THEM A PAY INCREASE. I THINK WE PUSH FOR CHANGE BY SENDING THIS TO THE MAYOR'S OFFICE FOR RENEGOTIATE WITH THE FOP.

I WANT TO GO ON RECORD AND SAY THAT I'M NOT BIASSED TOWARDS THE POLICE.

THEY HAVE A PURPOSE.

THEY HAVE A ROLE.

THE COMMUNITY NEED POLICING.

BUT WE CANNOT CONTINUE TO SEND A MESSAGE THAT IT IS OKAY FOR POLICING TO POLICE THEMSELVES AND THAT IT IS OKAY FOR THEM TO ABUSE THEIR POWER AS THEY HAVE DONE IN THE PAST, THE LAST TWO, THREE, FOUR, YEARS WE HAVE BEEN REMINDED OF SOME OF THE THINGS THEY'VE DONE TO SOME OF THE CITIZENS THROUGHOUT THIS COMMUNITY. IT HAS NOT BEEN GOOD AND THE CONTRACT, THE LANGUAGE IN IT, IT EXCUSES THE BEHAVIOR AND -- AND IS -- IT IS NOT SOMETHING THAT I CAN AGREE TO.

WE CURRENTLY HAVE AN OFFICER THAT WAS INVOLVED AND ESPECIALLY IN THE MURDER OF BRIANNA TAYLOR.

I WON'T IDENTIFY THAT PERSON BY NAME, BUT IT SEEMS LIKE HE CONTINUES TO [INDISCERNIBLE] THE COMMUNITY BY HIS ACTIONS.

I JUST FEEL LIKE WE -- WE GIVE THEM THE POWER TO CONTINUE TO USE AND ABUSE.

SO THIS CONTRACT IS NOT SOMETHING I'M HAPPY WITH.

AND I'M JUST -- I'M JUST GOING ON RECORD AND SAYING THAT I WILL NOT BE VOTING TO APPROVE THIS CONTRACT THIS EVENING. THANK YOU.

>> THANK YOU, COUNCILMAN.

COUNCILWOMAN GREEN.

>> THANK YOU, MR. PRESIDENT.

GOOD EVENING, COLLEAGUES.

WE APPRECIATE AND HONOR THE WORK OF OUR LAW ENFORCEMENT OFFICERS AND YOU HEARD ME TELL THAT MY 11-YEAR-OLD BLACK SON WHO IS LIVED LOUISVILLE ALL HIS LIFE WANTS TO BE A DETECTIVE.

HE LIVES IN AN ENVIRONMENT WHERE WE SPEAK ABOUT LAW ENFORCEMENT IN A POSITIVE MANNER.

WE UNDERSTAND THE SACRIFICE AND WE APPRECIATE YOU.

WE ALSO RECOGNIZE THAT THERE'S INCREASING [INDISCERNIBLE] FOR US

AND PERCEPTION BY THE PUBLIC WHO ARE DEMANDING TRANSPARENCY AND CRIMINAL JUSTICE REFORM AND THE REQUEST FOR POSITIVE INTERACTIONS WITH LAW ENFORCEMENT.

WE CAN PROTECT LAW ENFORCEMENT AND REPRESENT THE COMMUNITY.

THERE'S NOT ANYONE THAT BELIEVES THEY SHOULDN'T GET PAID MORE.

THIS IS NOT ABOUT PRO POLICE VERSUS ANTI-POLICE RHETORIC.

THIS IS THE FIRST POLICE CONTRACT THAT I'VE EVER SEEN SINCE I'VE BEEN ON THE COUNCIL.

LIKE MANY, I UNDERSTANDABLY HAVE HAD CONCERNS.

I SPOKE TO FOLKS THAT I THOUGHT WOULD KNOW BETTER.

I UNDERSTAND THE LABOR AGREEMENT DIDN'T TYPICALLY INCLUDE REFORM MEASURES.

EVEN IF WE DIDN'T INCLUDE THEM IN THE DOCUMENT, ON THEIR FACE, THERE'S ISSUES THAT NEED TO BE ADDRESSED.

COUNCILWOMAN DORSEY AND I HAD THE OPPORTUNITY TO SIT DOWN AND HAVE CONVERSATIONS WITH INDIVIDUALS FROM -- FROM -- FROM [INDISCERNIBLE] THE ORGANIZATION THAT IS TASKED WITH GOING REVIEW OF LPD.

WE WERE SHOCKED TO LEARN AND UNDERSTAND MANY ASPECTS OF THE DOCUMENT ACCORDING TO THIS IS NOT BEST PRACTICES.

HOW COULD IT BE THAT IT IS A TOP TO BOTTOM REVIEW IN THIS DEPARTMENT SAYING MANY ITEMS INSIDE OF THE CONTRACT ARE NOT BEST PRACTICES.

MY MIND REALLY WAS BLOWN.

SOME OF THE THINGS THAT CARL BELIEVED THE GREATEST AMOUNT OF CONCERN IS A PROVISION THAT REQUIRES THERE BE VIDEO OR OTHER UNMISTAKABLE EVIDENCE OF GUILT TO SUSPEND AN OFFICER WITHOUT PAY.

IT MAKES IT IMPOSSIBLE TO SUSPEND AN OFFICER.

THOSE THAT WE SPOKE WITH HAVE PROBLEMS WITH THE WORD UNMISTAKABLE.

THAT ALMOST GOES BEYOND A REASONABLE DOUBT.

THE STANDARD IN ADMINISTRATIVE HEARINGS IS BY PREPONDERANCE OF THE EVIDENCE.

WHY ARE WE REQUIRING THAT THERE BE BEYOND A REASONABLE DOUBT.

I GOT TO HANDLE SOMETHING REALLY QUICK, PLEASE.

- >> YES, MA'AM.
- >> COUNCILMAN PIAGENTINI.
- >> I THINK IT IS PROBABLY FITTING THAT WE HAVE -- WE HAVE AN ORDINANCE GETTING ITS FIRST READING AND TALKING ABOUT PAID PARENTAL LEAVE.
- SO THERE YOU GO, COLLEAGUES, I THINK YOU ALL KNOW WHERE I AM, WE HAD A LOT OF DISCUSSION ABOUT THIS.
- I WON'T REHASH IT.
- I HAD A WONDERFUL CONVERSATION WITH A COLLEAGUE OF MINE WHO -- WHO PROPOSED IT OR AT LEAST HAS OPPOSED.
- I DON'T KNOW HOW THEY'LL VOTE THIS EVENING BUT THEY HAVE A FEE

CONTRACT AND WE HAD A GREAT CONVERSATION AFTER THE -- AFTER THE RECENT LABOR MEETING.

WHAT I THINK MATERIALIZED THROUGH THE CONVERSATION, THIS IS COMING UP WITH COUNCILMAN GREEN AND MANY COMMENTS IS THAT WE AS A BODY WOULD BE HARD PRESSED TO FIND ANYONE OF US THAT DISAGREES WITH THE GOAL AND WHERE WE NEED TO BE.

WHERE THE DISAGREEMENT LIES IS TACTICS AND NOT STRATEGY, RIGHT? I DON'T KNOW ANYBODY HERE THAT DOES NOT WANT TO SEE FURTHER REFORMS RELATED TO HOW WE LEAD AND MANAGE THE LPD.

I SPOKE WITH THE CONSULTANTS AND MADE IT CLEAR THAT THEIR REVIEW SHOULD INCLUDE THINGS LIKE CONTRACTS AND TACTICS BUT ALSO LEADERSHIP OVER THE CIVILIAN LEADERSHIP OF -- OF LMPD WHICH I THINK WE'VE DONE -- WE'VE ALL SAID HAS BEEN LACKING IN THE PRIOR YEAR.

THE QUESTION IS SIMPLY, DO WE SEND -- IT IS A TACTICAL QUESTION, NOT A GOAL QUESTION.

FOR ME, THIS IS ANOTHER STEP IN A LONG SERIES OF STEPS TOWARD REFORM.

IT IS NOT GOING TO BE DONE IN MONTHS.

I DON'T KNOW IF IT IS COMPLETED BY NEXT YEAR.

NOT JUST FOR LMPD BUT THE WHOLE CITY.

WE WILL REFORM IF YOU WILL IMPROVING THE CITY, IMPROVING HOW WE DO THINGS.

HOPEFULLY ALL THE TIME.

ALL THE TIME.

BECAUSE I AGREE.

FROM JANUARY 1ST OR AS SOON AS THIS IS DONE, I WANT ALL PARTIES AT THE TABLE, PERIOD.

WE HAD HARD COMMITMENTS FOR BOTH PARTIES TO DO SO.

IF THAT COMMITMENT WASN'T THERE IT WOULD BE A DIFFERENT CONVERSATION.

MOST OF THESE REFORMS REQUIRE STATE LEGISLATIVE CHANGE FOR MANY. AND THAT IS NOT GOING TO HAPPEN UNTIL Q1 NEXT YEAR AND WON'T BE SETTLED UNTIL Q2 NEXT YEAR.

WE HAVE TEN MONTHS BEFORE WE SEE HOW THAT NETS OUT.

WITH A 17-PERSON -- THIS TREND WASN'T HAPPENING.

WHEN I JOINED I LOOKED AT THE RECRUIT CLASS TREND.

WE WENT FROM OVER THE PAST TWO YEARS MAYBE A NINE TO TEN PERCENT ATTRITION RATE TO A 40, 50 PERCENT ATTRITION RATE.

THAT WAS RELATED TO -- TO PAY -- TO PAY COMPENSATION AND ALTERNATIVE CHOICES THAT PEOPLE HAVE, SUCH AS WORKING AT AMAZON, WHO NOW OFFERS 15 DOLLARS AN HOUR TO PICK AND PACK GOODS WITH ZERO EXPERIENCE.

THAT ANNUALLY IS ONLY ABOUT 4,000 DOLLARS LESS PER YEAR THAN THE STARTING OFFICERS COMING OUT OF THE ACADEMY.

THAT'S COMPLETELY UNSUSTAINABLE.

WE'RE LOSING MORE THIS MONTH THAN WE GAIN THREE TIMES PER YEAR.

AT THAT RATE, WE WILL BE DOWN TO NOT 150 OFFICERS TO 250, 300 OFFICERS BY NEXT SUMMER.

WE'RE ALREADY EXPERIENCING HOMICIDES.

EVEN WITH THE -- WITH THE WOMEN THAT WE PUT TRUST IN TO TURN THIS DEPARTMENT AROUND, AND WHO I MET WITH PERSONALLY AND I HAVE -- I HAVE AN INCREDIBLE AMOUNT OF TRUST IN, THAT'S OUR NEW CHIEF, YVETTE GENTRY SAID THIS IS WHAT WE NEED FOR REFORM. REFORM INCLUDES GREAT POLICE OFFICERS.

SO I'M JUST GOING TO CLOSE AND I JUST WANT TO CORRECT SOMETHING TOO.

I KNOW THAT CHAIRMAN YATES, I DON'T KNOW IF IT IS THE MAJORITY. THERE'S LOTS OF PEOPLE THAT DON'T WANT TO SEE THIS PAST.

LOTS OF PEOPLE THAT WANT TO SEE THIS PASS BECAUSE THEY KNOW WHAT THE -- WHAT THE THREAT COULD BE IF WE DIDN'T.

TO SUM UP, I -- I -- I WANT TO SAY I HOPE YOU JOIN ME IN APPROVING THIS CONTRACT.

BUT THAT DOES NOT MEAN JUST LIKE MY COLLEAGUES SAY, IF THEY VOTE AGAINST IT, DOESN'T MEAN THEY'RE ANTI-POLICE.
AGREE.

IF I VOTE FOR THIS IT DOESN'T MEAN WE'RE ANTI-REFORM AND WILL CONTINUE ALONGSIDE OF YOU TO COMPLETE THE GOALS AND OBJECTIVES. I APPRECIATE EVERYBODY'S WORK ON THIS.

ALL OF THE THINGS BROUGHT UP, BECAUSE WITHOUT YOU BRINGING THAT UP, IT GETS SWEPT UNDER THE RUG AGAIN.

GREAT CONVERSATION, GREAT DEBATE.

I WANT TO TELL YOU HOW MUCH I APPRECIATE IT.

I WILL VOTE YES, BECAUSE TACTICALLY I THINK WE WILL BE WORSE OFF IF WE DON'T.

I HOPE YOU JOIN US.

THANK YOU VERY MUCH COLLEAGUES, APPRECIATE IT.

>> THANK YOU COUNCILMAN.

WE GO BACK TO COUNCILMAN GREEN.

THANK YOU MR. PRESIDENT, MY SIX WEEK OLD CO-WORKER.

I APOLOGIZE FOR THAT.

AS I WAS SAYING AND FOR US TO PUT SOMETHING AND LANGUAGE ADDED IN A CONTRACT THAT REQUIRES ALMOST BEYOND A REASONABLE DOUBT EVIDENCE ON AN OFFICER TO BE SUSPENDED WITHOUT PAY IN THIS CLIMATE, IT IS NOT SOMETHING THAT I UNDERSTAND AT ALL. THERE ARE OTHER PORTIONS IN THERE REGARDING TRANSPARENCY. WE UNDERSTAND THAT IT IS AN ISSUE ABOUT YOU HAVE TO SWEAR OUT A

WHY IS THAT IN THERE?

COMPLAINT.

AGAIN, IN THIS CLIMATE IF WE DON'T USE THE POWER THAT WE HAVE, THE RESOURCES AT OUR DISPOSAL TO GET NOT ONLY THE BEST CONTRACT FOR OUR -- OUR LAW ENFORCEMENT INDIVIDUALS BUT ALSO FOR OUR -- OUR CITIZENS.

COUNCILMAN PIAGENTINI BRINGS UP A POINT.

IT MAY BE CATASTROPHIC.

MY HEART GOES OUT TO OUR -- OUR LAW ENFORCEMENT OFFICERS AND I DON'T WANT ANYBODY TO THINK THAT A NO VOTE MEANS IF YOU DON'T THINK -- YOU DON'T CARE ABOUT POLICE OFFICERS.

HOWEVER, BARGAINING AND COLLECTIVE BARGAINING MEANS WE GOT TO GIVE A LITTLE BIT TO GET A LITTLE BIT.

I WOULD ENCOURAGE THE FOP TO BE WILLING TO GIVE A LITTLE BIT, PUT SOME SKIN IN THE GAME.

WHEN YOU SAY THAT YOU WANT AND THAT YOU ARE ACKNOWLEDGING AND HOPING FOR REFORM, PUT SOME SKIN IN THE GAME AND HELP US BE ABLE TO -- TO MAKE THIS COMMUNITY FEEL LIKE -- THAT WE'RE ALL IN THIS THING TOGETHER BECAUSE RIGHT NOW, IT FEELS LIKE IT IS US AGAINST THEM AND A SITUATION THAT IS A VERY VERY UNCOMFORTABLE POSITION TO BE IN.

SO I WILL BE VOTING NO FOR THIS CONTRACT.

THIS WILL GIVE THE ADMINISTRATION AND THE FOP AN OPPORTUNITY TO SIT DOWN AND PUT TOGETHER A -- A CONTRACT THAT IS REFLECTIVE OF BEST PRACTICES.

WE IN THE CITY OF LOUISVILLE DON'T WANT TO BE AN OUTLIER AND FOR US TO HAVE A CONTRACT THAT IS NOT COM MISS RAT OF WHAT IS GOING ON AROUND THE COUNTRY.

THANK YOU, MR. PRESIDENT.

>> THANK YOU, VERY MUCH, MR. PRESIDENT.

FIRST OF ALL, I AGREE REFORMS IN THE POLICE DEPARTMENT NEED BE TO DONE.

WE STARTED SOME OF THOSE.

SOME OF THE SUPPORTS.

I'M GOING TO TAKE MY COLLEAGUES ON A HISTORY LESSON.

THROUGH FUNDING.

AND PASS LEGISLATION AND THE LAW.

YOU KNOW BY CONTRACT, WE'LL NEGOTIATE CONTRACTS.

AND 36 OF US, WE CAN'T -- WE CAN'T [INDISCERNIBLE].

I DON'T KNOW ABOUT THE PRESIDENT.

THE POLICE OFFICERS BECAUSE OF THE ACTIONS OF VERY FEW ARE BEING VILIFIED.

WHEN THOSE TROOPS RETURNED OVER TO THE OTHER SIDE OF THE WORLD, THEY RETURNED TO OUR SHORES, WE TREATED THEM [INDISCERNIBLE] OF ACTIONS OF A FEW.

WE DO THAT WITH OUR POLICE OFFICERS.

THEY'RE TAKING RISKS.

MR. PRESIDENT, SOME WOULD GO FROM THAT.

[INDISCERNIBLE] DIDN'T COME BACK.

THEY MAKE SACRIFICES.

WE ARE LEGISLATORS AND THESE ARE OUR EMPLOYEES.

I THINK WE OWE IT TO THEM, BASED ON THE [INDISCERNIBLE], BASED

WHAT WE WERE TOLD AT FIRST WAS -- WAS STATE LAW DOESN'T ALLOW THAT.

WE LEARNED THAT'S NOT REALLY TRUE.

THE PRESIDENT OF THE FOP SAID, STATE LAW ALLOWS IT.

IT IS STATE LAW.

THEN WE WERE TOLD BY THE ADMINISTRATION, WE HAVE NEVER DONE THAT.

AND BECAUSE LMPD HAS NEVER DONE THAT WE DIDN'T THINK WE COULD DO THAT.

THIS IS NOT A TIME TO CONTINUE DOING WHAT WE HAVE ALWAYS DONE. I'M AFRAID THE CONTRACT APPROVED TONIGHT WILL CANDIDATE TO BE EXTENDED WITH ALL OF THESE PROVISIONS AND FOR THAT REASON I'LL BE VOTING NO.

WE FINALIZED A CONTRACT BY 12-31-20 SO WE CAN ATTRACT AND RETAIN THE BEST POLICE OFFICERS AND HOLD THEM FULLY ACCOUNTABLE IF THEIR JOB PERFORMANCE.

TWO PARTS THIS.

NOBODY IS ARGUING OVER THE FIRST PART.

BE ABLE TO ATTRACT AND RETAIN THE BEST POLICE OFFICERS.

IT IS A RED HERRING, NOBODY IS QUIBBLING OR ARGUING FOR DIMINISHMENT OF SALARY IN ANY WAY.

THE ONLY DISCUSSION IS WHETHER THERE'S ANY WORK DONE TOWARDS THE HOLD THEM FULLY ACCOUNTABLE FOR THEIR JOB PERFORMANCE PART.

>> WE'RE HAVING THIS DEBATE, DISCUSSION AND OBVIOUSLY A HISTORIC NIGHT IN AMERICA AND IN OUR CITY.

HIT REAL OUR -- OUR COUNTRY AS A WHOLE ON THE BRINK OF TRANSITION OF POWER AND THAT SORT OF THING.

THE ONLY WAY WE'RE COMING TOGETHER AS A COUNTRY TOMORROW OR THE

DAY AFTER, AND AS A CITY, IS IF WE START TO UNITE ON THINGS. WHICH MEANS WE CAN'T BE POLARIZED AND THERE CAN'T BE WINNERS AND LOSERS IN ANY OF THESE INDIVIDUAL ACTIONS.

YOU HAVE TO DO SOMETHING WHERE THERE'S COMPROMISE.

A WIN WHERE THEY GET SOMETHING THEY WANT.

I CAN SPEAK SPECIFICALLY TO THE CLAUSES IN THE CONTRACT, OR THE PROVISIONS THAT I FIND OBJECTIONABLE.

WE'VE DONE THAT BEFORE.

WE'VE DONE THAT IN COMMITTEE.

SOME OF THEM AS MENTIONED ARE -- ARE ALREADY PART OF STATE LAW. THEY'RE WRITTEN IN THE POLICE OFFICER'S BILL OF RIGHTS WHICH IS FIRST, REASONS DOES NOT NEED TO BE RESTATED AGAIN HERE.

ONE OF THE IMPORTANT REASONS IS THERE'S BEEN TALK ABOUT GOING BACK TO THE KENTUCKY ASSEMBLY AND CHANGE THAT STATE LAW.

IF IT STILL REMAINS IN THE CONTRACT AFTER THE LAW IS CHANGED THEN THOSE -- THEN IT IS -- THEN WE KEEP -- THEN -- THEY SAY IN THE CONTRACT REGARDLESS OF WHETHER THE LAW CHANGES.

THAT'S PARTICULARLY IRONIC, I SUPPOSE WHERE AGAIN, I THINK THIS IS THE SECOND MEETING IN A ROW I REFERENCED THE LETTER FROM THE GENERAL ASSEMBLY THAT HE SENT IN SEPTEMBER ASKING THE LEGISLATURE IN FRANKFURT TO AMEND KRS673 TO INCREASE ACCOUNTABILITY INCLUDING ALLOWING PUBLIC OFFICIALS SENDING INTERNAL CASES.

USE SUBPOENA POWER.

AND OFFICER INVOLVED SHOOTING AND REVIEW ALL AND MAKE THESE CHANGES.

I DO NOT WANT TO VOTE NO ON POLICE CONTRACT.

AND I DON'T THINK THAT ANYBODY IN THE COMMUNITY WANTS TO VOTE NO.

I THINK EVERYBODY WANTS TO VOTE ON A FAIR CONTRACT THAT PAYS AND REWARDS THE MEN AND WOMEN IN OUR DEPARTMENT ADEQUATELY FOR THE RISKS THEY TAKE EVERY DAY.

SOMETHING THAT HOLDS THEM FULLY ACCOUNTABLE FOR MISCONDUCT WHICH IS SOMETHING THAT ONLY APPLIES TO VERY FEW PEOPLE.

WE HAVE A SYSTEM THAT PROTECTS MISCONDUCT THAT IS HARMFUL TO EVERYBODY.

I THINK I HEARD IT INSINUATED FROM OTHER PEOPLE THAT I THINK THE BEST POSSIBLE OPTION TONIGHT WOULD BE TO TABLE THIS.

ALLOW THE ADMINISTRATION AND THE FOP TWO WEEKS, THEY'RE WORKING EVERY DAY IF THEY NEED TO TO GO BACK AND LOOK AT THESE SPECIFIC CLAUSES THAT WE IDENTIFIED AND CAN IDENTIFY FOR THEM AND BRING US BACK SOMETHING THAT THE ENTIRE COMMUNITY CAN BE PROUD OF TO VOTE YES ON BEFORE THANKSGIVING.

OTHERWISE, IF WE'RE FORCED TO VOTE ON THIS CONTRACT AS IS TONIGHT I'LL BE A NO VOTE.

- AND I ALSO WANT TO THANK THE COMMUNITY MEMBERS AND NEIGHBORS WHO REACHED OUT TO ME IT -- TO EXPRESS THEIR CONCERNS FOR OR AGAINST.
- I'M CONVINCED THAT THIS IS THE PATH THAT WILL BRING ABOUT LASTING AND IMPACTFUL CHANGE AND IT IS REALLY HOW YOU DEMOCRACY WAS DESIGNED, RIGHT, WHICH WAS TO BRING ABOUT INTENTIONAL CHANGE, EVEN WHEN IT FEELS MORE THAN WHAT IT SHOULD BE.

WE HAVE A TREMENDOUS AMOUNT OF RESPECT FOR EVERYONE HERE AND THEIR POSITION.

AND FOR EVERYONE WHO HAS BEEN FIGHTING FOR JUSTICE.

I HAVE A TREMENDOUS AMOUNT OF RESPECT FOR OUR POLICE OFFICERS, OUR EMTS AND OUR FIREFIGHTERS AND FIRST RESPONDERS.

I WOULD REMIND EVERYBODY WHO IS WATCHING THAT -- THAT THE POSITION OF -- OF US VERSUS THEM IS NOT A POSITION THAT BENEFITS ANYONE.

WE CAN AND I DO SUPPORT BOTH OF OUR POLICE OFFICERS AND THE CALLS FOR REFORM.

I WOULD SPECULATE IT IS NOT THE CONTRACT THE ADMINISTRATION WOULD WRITE.

THE PROBLEM IS WE DON'T HAVE CONTROL OVER THE VAST MAJORITY OF THESE ISSUES.

THOSE ISSUES ARE DRIVEN BY STATE LAW.

ALMOST ALL REFORMS ARE CODIFIED IN STATE LAW.

IT IS A FACT THAT WE'RE LOSING OFFICERS AT A SIGNIFICANT RATE. A RATE AT WHICH WE CANNOT REPLACE THEM.

IT IS ALSO A FACT THAT WE NEED IT PAY OUR OFFICERS BETTER AND THE CITY IS BETTER OFF WHEN THEY'RE MEMBERS OF THE COMMUNITY THAT THEY SERVE.

>> THESE MEN AND WOMEN DESERVE MUCH MORE THAN WHAT WE'RE OFFERING.

THEY DESERVE MORALE, THEY DESERVE CULTURE, THEY DESERVE HERE, THEY DESERVE [INDISCERNIBLE], IT IS MORE THAN PAY.

I WON'T REPEAT WHAT -- WHAT MY COLLEAGUES SAID, I POINT OUT THAT YOU KNOW, WE HEARD FROM BOTH SIDES TONIGHT, I THINK REALLY VALID POINTS AND EVEN SOME FOLKS WHO -- WHO THANK YOU, AND THEY DON'T THINK THIS IS A CONTRACT THEY CAN SUPPORT, THEY MADE VERY IMPORTANT -- IMPORTANT POINTS ABOUT -- ABOUT -- ABOUT THE IMPORTANCE OF -- OF OF GETTING POLICE OFFICERS THAT -- THAT ARE ARE HERE FOR ALL OF THE RIGHT REASONS AND CAN AFFORD TO DO THE WORK THAT THEY DO.

AGAIN, I APPRECIATE MY COLLEAGUES AND I WON'T REPEAT EVERYTHING THAT HAS BEEN SAID.

I DO WANT, THOUGH, TO CORRECT ONE BIT OF INFORMATION THAT IS OUT THERE, I HEARD IT IN THE -- IN THE PUBLIC SAFETY COMMITTEE OR THE LABOR COMMITTEE.

I WAS NOT A MEMBER, I DID JOIN THE COMMITTEE FOR THE DISCUSSION. AND THERE'S -- I THINK -- IF I UNDERSTOOD CHIEF GENTRY AND I THINK I DID, I TRIED TO RECUPERATE AND MAKE SURE I UNDERSTOOD IT.

THE QUESTION WAS, AND THE POLICE CHIEF, SEND AN OFFICER WITHOUT PAY.

THE ANSWER THAT SHE GAVE WAS YES.

AS THE INTERIM CHIEF SHE HAS THE AUTHORITY TODAY AND -- AND WITH THIS NEW CONTRACT WILL CONTINUE TO HAVE THE AUTHORITY TO SUSPEND POLICE OFFICERS WITHOUT PAY.

THE -- THE WORDING IN THE CONTRACT SIMPLY SAYS, NOTHING IN THE

CONTRACT IS SIMPLE.

THE WORDING SAYS A POLICE OFFICER CAN'T BE SUSPENDED WITHOUT PAY DURING THE INVESTIGATION.

IF THERE'S -- IF AN OFFICER HAS BEEN ACCUSED OF SOMETHING THAT -- THAT IS INAPPROPRIATE THAT OFFICER WOULD BE SUSPENDED WITHOUT PAY, THAT SUSPENSION CAN'T TAKE PLACE UNTIL AFTER THE INVESTIGATION HAS FINISHED AND OR IF THE BEHAVIOR WAS SO EGREGIOUS THAT THE INVESTIGATION WOULD BE SO OBVIOUS THAT THE -- THAT THE WAY YOU WOULD DEFINE THE LEVEL OF EGREGIOUSNESS IS PRETTY STEEP.

SO THIS IS -- TO SUSPEND AN OFFICER WITHOUT PAY IS VERY DIFFICULT TO DO UNTIL AFTER AN INVESTIGATION IS DONE AND -- AND -- AND [INDISCERNIBLE] DETERMINED TO HAVE THAT -- THAT BE A LEGITIMATE, LEGITIMATE CONSEQUENCE.

AGAIN, I WANT TO MAKE SURE FOLKS DON'T MISUNDERSTAND.

- IT DOESN'T MEAN THEY CAN'T BE SUSPENDED WITHOUT PAY.
- IT MEANS WHILE THE INVESTIGATION IS ONGOING, THE OFFICER CAN'T BE SUSPENDED WITHOUT PAY.
- IF IT TURNED UP WITH THE POLICE BELIEVES IS THE CASE, THAT OFFICER CAN BE TERMINATED OR WHATEVER OTHER DISCIPLINARY ACTIONS ARE AVAILABLE.
- SO, I WANT PEOPLE TO UNDERSTAND, IT IS NOT A -- IT IS NOT A PROHIBITION, IT IS SIMPLY PROTECTING AN OFFICER DURING AN INVESTIGATION, THE SAME AS WE ALL WOULD BE PROTECTED.
- >> THANK YOU.
- >> COUNCILWOMAN MCCRANEY.
- >> THANK YOU MR. PRESIDENT, WE HEARD A LOT BEFORE WE ALSO HEARD FROM THE COMMUNITY.
- COLLEAGUES, WE HAVE POWER, MORE -- MORE IMAGINABLE THAN MOST PEOPLE KNOW.
- I WOULD HOPE THAT WE WOULD USE OUR POWER TO DO WHAT IS RIGHT FOR THIS COMMUNITY.
- WITH THAT SAID, I UNDERSTAND ONE OF MY COLLEAGUES SAID THAT -THAT WE AS A COLLECTIVE BODY PUT FORTH A RESOLUTION TO -- TO ASK
 THE MAYOR'S OFFICE TO PUT TOGETHER A CONTRACT FOR THE POLICE
 DEPARTMENT.

THEY BEEN WITHOUT THIS CONTRACT FOR TWO OR MORE YEARS.
TWO MORE WEEKS OR THREE MORE WEEKS IS NOT GOING TO HURT THEM.
WE NEED TO DO WHAT IS RIGHT BY THIS COMMUNITY AND BY THE POLICE OFFICERS.

SEND THIS BACK FOR RENEGOTIATION.

WITH THAT SAID, MR. PRESIDENT, I WOULD LIKE -- I WOULD LIKE -- I MOVE TO TABLE THIS ISSUE.

- >> THANK YOU COUNCILWOMAN.
- WE HAVE A SECOND BY COUNCILMAN.
 - >> POINT OF ORDER, PLEASE.

- >> YES, SIR.
- >> IT IS NOT DEBATABLE.
- >> IT IS POINT OF ORDER.

CAN WE GET CLARITY WHAT WE'RE VOTING FOR.

IN OTHER WORDS IF WE TABLE IT, LIKE NORMALLY YOU TABLE SOMETHING, DEBATE IT AND THEN ET CETERA.

>> SERVICE SECONDED BEFORE I COULD FINISH.

WHAT IS YOUR PLEASURE.

>> IF WE TABLE IT, AND -- AND RENEGOTIATIONS HAVE BEEN SOMETHING, ANYTHING CHANGES FOR THE CONTRACT.

LET'S ASSUME FOR A SECOND THE CONTRACT GETS ALTERED,

REGROESHIATED SIGNED BY THE MAYOR AND VOTED BY THE FOP LET'S SAY FOR TWO WEEK'S FOR ARGUMENT'S SAKE, COULD THIS RESOLUTION -- CAN THIS RESOLUTION BE AMENDED WITH THAT CONTRACT OR NOT?

MY QUESTION FOR ASKING, IF NOT, THEN TABLING IT IS REALLY DOESN'T MAKE ANY PROCEDURAL SENSE.

WE SHOULD JUST VOTE AYE OR NAY, IF WE CAN'T AMEND IT, THEN TABLING MAKES SENSE BECAUSE YOU WOULD AMEND WITH A NEW CONTRACT. I'M TRYING TO CLARIFY WHAT THE LEGAL ABILITY IS WITH TABLING AND AMENDING A RESOLUTION FOR A LABOR CONTRACT.

>> THANK YOU.

WE'RE GOING TO DO TWO THINGS.

WE'RE GOING TO ADDRESS THAT AND WE'RE GOING TO ADDRESS COUNCILWOMAN MCCRANEY.

WERE YOU FINISHED?

>> I WAS NOT, BUT I'M WILLING TO HEAR FROM THE COUNTY ATTORNEY'S OFFICE BEFORE I FINISH.

>> OKAY.

THANK YOU.

COUNTY ATTORNEY, DID YOU -- COULD YOU ADVISE ON THE QUESTION FROM COUNCILMAN PIAGENTINI.

>> I'M WITH THE COUNTY ATTORNEY'S OFFICE.

IF YOU GIVE ME A MINUTE, I WILL CONSULT AND ADVISE.

IF THE CONTRACT IS RENEGOTIATED -- WHEN THE -- WHEN THE LEGISLATION IS PAYABLE IT MIGHT BE ACCOMPANIED BECAUSE YOU CAN

ONLY VOTE UP OR DOWN ON THE CONTRACT THAT IS APPROVED BY -- BY -- BY THE -- BY THE PARTIES TO THE CONTRACT.

>> THANK YOU.

I WANT TO MAKE SURE I UNDERSTAND WHAT YOU'RE SAYING. SO IF WE TABLE THIS, IT WOULD BE TABLED.

THE CITY WOULD -- WOULD RENEGOTIATE, COME TO AN AGREEMENT, THE MEMBERS OF THE FOP VOTE ON IT.

THE MAYOR SIGNS IT AND IT WOULD COME BACK TO THE COUNCIL FOR APPROVAL, THE RESOLUTION WOULD BE TABLED AND WE WOULD NEED TO DO AN AMENDMENT BY SUBSTITUTION.

THE VOTE ON THAT?

IS THAT WHAT YOU'RE SAYING?

TO SEE WHETHER THEY RENEGOTIATE.

THE PEOPLE THAT DECIDE ARE THE PARTIES TO THE CONTRACT, FOP AND MAYOR'S OFFICE.

THEY COULD COME BACK TO YOU AND SAY WE'RE ABLE TO GET FURTHER, PLEASE CONSIDER TABLING THIS.

YOU COULD TABLE THIS AND PASS THE CONTRACT THAT IS BEFORE YOU TODAY.

I LIKE IT MOVE FORWARD WITH MY TABLE AND THE ACTUAL -- I WAS GOING TO ACTUALLY PUT A TIME FRAME ON IT BUT I DON'T THINK I WILL.

I JUST WANT TO TABLE -- TABLE THE ISSUE.

SO I UNDERSTAND THE PROCESS IS REALLY JUST TABLING.

>> JUST FOR PRACTICE PURPOSES WHAT WOULD HAPPEN IS THEY WOULD TWO BACK TO NEGOTIATE WITH -- WITH THE ADMINISTRATION, IF THEY MADE CHANGES OR -- OR IF THEY -- IF THEY CAME TO A -- A SUCCESS WITH THE CHANGES THEY WOULD MAKE.

THAT WOULD HAVE TO BE RUN BY THE MEMBERSHIP AND THE MEMBERSHIP WOULD HAVE TO VOTE ON IT.

AND USUALLY THEY TAKE ABOUT FIVE DAYS TO DO THAT VOTING.

SO THAT -- THAT -- THAT IS THE BASIC TIMELINE.

THEN THERE'S THE TIMELINE OF WHATEVER IT TAKES BETWEEN THE FOP AND THE CITIES.

>> THANK YOU MR. PRESIDENT, I WAS NOT GOING TO SPEAK TONIGHT AND MADE MY POSITION CLEAR MONDAY AND I FELT THIS WAS A ONE SIDED DEAL.

WE WERE ABLE TO ACHIEVE ON THIS DEAL THE INCREASE IN PAY.

WE COMPLETELY NEGLECTED THE COMMUNITY'S NEEDS FOR ACCOUNTABILITY.

THIS IS THE DRIVING POINT THAT I WANT TO ADDRESS WITH COUNCILMAN KRAMER SAID.

AND IT WAS ABOUT -- IT WAS ABOUT TO -- TO SUSPEND AN OFFICER DURING THE INVESTIGATION AND IT MAKES IT SOUND CLEAN AND SIMPLE. BUT I WANT IT REMIND THIS COMMUNITY AND THIS COUNCIL THAT NEARLY TWO YEARS AGO A YOUNG BLACK MAN WAS BEING PULLED OUT OF HIS CAR. THAT INVESTIGATION TO MY UNDERSTANDING IS STILL ONGOING. FOR TWO YEARS NOW YOU.

IF WRONG WERE FOUND, THE END RESULT IS THAT PERSON POTENTIAL MY IS STILL DRAWING THEIR PAY FOR TWO YEARS.

THAT'S A STICKING POINT HERE, WHEN WE HEAR THIS ACCOUNTABILITY ISSUE.

YOU KNOW, ACCOUNTABILITY ISSUE, WHY IS IT WE HAVE TO GIVE SO MUCH PROTECTION TO OFFICERS.

I SAID MONDAY, ESSENTIALLY 30,000 OFFICERS IS [INDISCERNIBLE] TWO FOR EVERY THOUSAND OFFICERS.

THE CONCERN IS THAT THE TWO OR THREE COULD DO DAMAGE IN THE

COMMUNITY.

THAT'S DEMAND FOR ACCOUNTABILITY AND WE'RE NOT GIVING IT TO THEM.

THE NO VOTE IS THE SAME AS TABLING.

WE'RE SAYING GO BACK TO THE TABLE, WE'LL GIVE YOU THE PAY INCREASE.

BUT COME TO US WITH SOME ACCOUNTABILITY.

I THINK IT IS A SHAME ON BOTH PARTIES PART.

THE ARGUMENT IS GIVE US MORE PAY FOR OFFICERS FOR WHAT THEY DO. THEY WERE ALLOWED TO DO THAT BUT THEY WERE WRONG TO NOT ALSO WANT TO INCLUDE ACCOUNTABILITY.

ADMINISTRATION WAS WRONG, IN LIGHT OF THE FACT THAT WE WERE WILLING TO GIVE THE PAY RAISES.

I WANT TO BRING UP THE REMINDER THAT DURING A PENDING INVESTIGATION, THE RIDICULOUS BEHAVIOR WITH INVESTIGATIONS, THEY DRAG ON FOREVER.

I DON'T KNOW WHY.

THIS IS SOMETHING WE CAN'T AFFORD.

REMEMBER THAT YOUNG MAN, THEY'RE PULLING ME FROM THE CAR.

- >> MR. PRESIDENT I WAS GOING TO SPEAK ON THE MOTION ON THE TABLE WHICH HAS BEEN STRUCK DOWN AND IT IS MOVED AT THIS POINT.
 - >> THANK YOU COUNCILMAN YATES.

COUNCILWOMAN DORSEY.

- >> MR. PRESIDENT, I WANT TO MAKE ONE LAST STATEMENT FOR TODAY AND I'M GOING TO CLOSE MY MOUTH.
- I REMEMBER WHEN THIS -- WHEN THIS ALSO -- THIS UNREST STARTED.
- I HEARD ABOUT A REPORT THAT WAS WRITTEN BACK IN 1968, CALLED THE TURNER REPORT.

THE NUMBER ONE THING ON THE TURNER REPORT WE DISCUSSED IN EQUITY MEETINGS IS POLICE REFORM.

TODAY WE SIT AS A COUNCIL AND WE'RE DEBATING WHETHER OR NOT WE PUT REFORMS.

WE'VE BEN WAITING FOR THIS SINCE 1968.

WE LOOK AT THAT REPORT AND MANY OF US AND MY COLLEAGUES WERE LOOKING AT THE REPORT AND SAYING HOW IS IT WE DID NOT PRIORITIZE.

YOU CAN'T UNDERSTAND HOW EVERY SINGLE AFRICAN-AMERICAN ON THIS COUNCIL HAS VOTED NO AND YOU LOOK AT THAT REPORT AND AND FROM 1968, NOT AFRICAN-AMERICANS BUT A NATIONAL COUNCIL AND MAKES POLICE REFORM AS THE NUMBER ONE THING TO IMPACT RACIAL RELATIONS IN THIS COUNTRY.

IN 1968, WE'RE STILL WAITING.

THE METRO COUNCIL TODAY YOU'RE ASKING US TO WAIT LONGER. THAT HURTS.

THAT'S WHY WE'RE FIGHTING.

YOU STILL TELL US TO WAIT.

WE'RE -- LET ME TELL YOU WHAT HAPPENS WHEN HOPE IS BURIED. IN AMOUNT OF MONEY WILL SAVE A CITY OR CHANGE A CULTURE WHEN YOU BURY HOPE AND YET AGAIN, WE TELL PEOPLE WHO HAVE BEEN WAITING FOR -- FOR [INDISCERNIBLE] TO WAIT.

SO TODAY YOU GET TO DECIDE, YOUR OWN REPORT, YOU GET TO CHOOSE WHETHER YOU VOTE IN THE 60S AND WHETHER WE DO THE SAME THING THAT HAPPENED THEN, WHETHER WE TAKE THE REPORT.

WELL WE HAVE THINGS TO PRIORITIZE.

IN THE 60S THE SAME THING WAS HAPPENING.

WE TOLD -- WE HAD POLICE FIRST.

LOOK AT THE HISTORY.

WE'RE STILL WAITING FOR IMPLEMENTATION OF THAT REPORT.

CHALLENGE YOURSELF AND THINK OUTSIDE THE BOX.

IT IS NOT EASY.

I'M TELLING YOU AS A BLACK WOMAN, I'M STILL WAITING AT 35 FOR WHAT MY GRANDMOTHER WAS WAITING FOR.

WE HAVE A CHANCE TO CHANGE THAT TONIGHT.

I IMPLORE YOU.

THAT'S IT.

>> THANK YOU.

COUNCILWOMAN GREEN.

>> MY FRUSTRATION, I HAVE EXTREME AMOUNT OF FRUSTRATION IN THE WAY THE CONTRACT WAS NEGOTIATED IN LOUISVILLE, KENTUCKY IN 2020. WE'RE SEATED IN GROUND ZERO OF WHAT IS HAPPENING IN THIS COUNTRY AND -- IN TERMS OF THE CRIES FOR REFORM, THE DEMAND FOR JUSTICE, THE CRIES FOR ACCOUNTABILITY AND WE HAVE AN ADMINISTRATION THAT -- THAT -- THAT NEGOTIATED A CONTRACT THAT DIALLED US BACK EVEN FURTHER.

I WOULD SAY TO THE PEOPLE THAT ARE LISTENING, THE PEOPLE WHO ARE OUTSIDE, AND THE PEOPLE WHO ARE AGITATED.

THAT TELLS YOU EVERYTHING THAT THIS CITY THINKS ABOUT YOU. IT TELLS YOU EVERYTHING THAT THIS CITY THINKS IN TERMS OF -- OF WHAT VALUES ARE AND WHAT IS IMPORTANT TO YOU AND MY COLLEAGUE'S POINT OF TELLING US TO WAIT, WE TRY TO DO IT THE RIGHT WAY. YOU HAVE CONVERSATIONS.

YOU BEG, YOU HOPE, YOU PLEAD THAT THERE ARE GOING TO BE -- TO BE MOVEMENT FORWARD.

AND THEN WHEN YOU DON'T GET THE RESPONSES THAT YOU ARE JUSTIFIED AND THAT YOU ARE DUE, THEN PEOPLE WONDER WHY PEOPLE ARE SO ANGRY.

WHY DO PEOPLE PROTEST AND KEEP SHOWING UP?

WHY ARE THEY MAD?

THEY'RE MAD BECAUSE -- BECAUSE YOU'RE EXPRESSING PEOPLE TO CONTINUE TO BE POLITE AND TO JUST TAKE THE QUALMS THAT THIS CITY IS WILLING TO THROW AT US.

SO THE TIME IS UP FOR -- FOR PROMPTS.

WE DESERVE A SEAT AT THE TABLE AND WE EARNED TO HAVE A HEAD AT THE TABLE.

WE'RE NOT ACCEPTING CRUMBS ANYMORE.

DO NOT BE SURPRISED WHEN THE CONSTITUENTS TELL YOU EXACTLY WHAT THEY THINK AFTER THIS VOTE.

THANK YOU.

- >> THANK YOU, COUNCILMAN GREEN, COUNCILMAN SHANKLIN.
- >> WHO IS THIS, MR. BRUNER AND [INDISCERNIBLE] IN MY HEAD.
- I WENT TO THE DOCTOR TODAY, ANYTIME I GO TO THE DOCTOR HE LOVES TO TALK POLITICIAN.

THERE WAS THE POLICE CONTRACT AND HE SAID I DON'T UNDERSTAND WHY THEY'RE STILL GETTING PAID, HE SAID I LOOK AT THE TEACHER THAT MOLESTED A BOY, AND THEY MOVED HER TO ANOTHER POSITION FOR A YEAR, STILL GETTING HER PAY.

IF IT WAS A BLACK PERSON, THEY WOULD BE IN JAIL.

HE LOVES TO TALK POLITICS AND HE KNOWS WHAT IS GOING ON.

I JUST WANTED TO BRING THAT OUT.

THANK YOU

- >> THANK YOU, COUNCILWOMAN SHANKLIN.
- >> THANK YOU MR. PRESIDENT AND MY COLLEAGUES AND YOUR WELL THOUGHT AND INFORMED AND WELL RESEARCHED COMMENTS THIS EVENING. AS I LISTEN TO MY COLLEAGUES AND MY RIGHTS THAT WOULD BE COUNCILWOMAN DORSEY.

IF SHE BROUGHT US THE 1968 REPRESENT, I WANT TO BRING YOU UP TO DATE BECAUSE IN KENTUCKY, THE ONLY PRIVATE ACCU IN THIS ENTIRE COMMONWEALTH HAS PUT FORWARD THE TURNER REPORT, 2.0 AND PRESIDENT KEVIN WAYNE COSBY IS WORKING IN TANDEM WITH GOVERNOR BRASHEAR ON THIS VERY SUBJECT.

THEY DID IT.

THEY UNDERSTAND IT.

SO I TOO AM IN FULL SUPPORT OF PAY.

WE GOT IT WRONG IN THE CONTRACT.

I DON'T THINK THE PAY SCALE IS IN THE CONTRACT.

I DON'T MIND SAYING THAT STRAIGHT OUT TONIGHT.

BECAUSE IF YOU LOOK AT THE INCREASE IN 35,000 TO 45,000, FOR EVERYONE LISTENING THAT IS NOT ON THE COUNCIL OUT THERE, A PORTION OF THAT IS THEIR UNIFORM ALLOWANCE THAT GOT ROLLED INTO THAT.

- SO I THINK THAT NEEDS TO BE CONSIDERED.
- SO THE PERCENTAGE PAY INCREASE IS NOT AS STRONG AS IT SHOULD HAVE BEEN, GIVEN THE FACT THAT WE'VE BEEN OPERATING ON AN EXTENDED CONTRACT SINCE 2018.
