Monique Williams, Office of Safe and Healthy Neighborhoods, gave a presentation.

The following was discussed:

- THRIVE Program is designed for young black men to engage in the civic leadership positions and public engagements in the community
- Youth engagement happens within the youth implementation team locally and at a national level
- The THRIVE Program grant does not continue through Fiscal Year 2022
- The THRIVE Program is funded between Louisville and Lexington
- Violence prevention is focused on families and intervention
- Primary prevention is where the Office Of Safe & Healthy Neighborhoods is focusing on getting the community
- Initially there were 10 students in the THRIVE Program, 4 have graduated and 2 employed with Metro Government and the other 2 are seeking jobs outside of Metro Government
- The Office of Safe & Healthy Neighborhood's faith based program promotes peace
- Most of the young men in the THRIVE program have experienced tremendous drama in their lives
- Question whether there is data comparing the homicide rate with other cities
- The pandemic has caused economic instability and may have alot to do with the stress and rise in the number of homicides
- Civil unrest is also one of the reasons that there is so much stress within the city
- Geographic areas are focused on, with the money being distributed and it may not cover the entire city
- Reduction has been seen in the geographic areas that were focused on
- Group Violence Intervention looks at the actual shooters and those who are at risk and focuses in that area
- Social cohesion and social connections are huge for the Office of Safe & Healthy Neighborhoods to move forward
- No funds have been allocated for on the ground work for the Office of Safe & Healthy Neighborhoods to get re-enforcement
- There has to be more sufficient investment into the prevention of violence
- Question whether there have been spikes in violence in the geographic areas
- The 3 geographic areas that have been focused on in Louisville are 2 in the Russell neighborhood and 1 in the Shawnee Neighborhood

- Question whether \$750,000 will be needed as initial funding for Group Violence Intervention Program to see success
- Group Violence Intervention has provable outcomes in multiple cities
- Question whether there is partnership with Jefferson County Public Schools who knows who the delinquent kids are in middle and high school levels

- Additional expenses for the cost of printing ballots, security, absentee ballots and absentee ballots processing center and people to work at the voting locations
- Budgeted \$525,000 for election and over the budget this year
- Over 400 people were hired to work the voting locations with estimated \$90,000 cost

- Question regarding what would be the optimum outcome for improvement with this program
- Question regarding whether there will be a collective impact as a group by including Office of Youth Development, Goodwill and Urban League working together
- Partnering with University of Louisville and the University of Kentucky to do research to come up with measures on how to make the biggest impact
- Question whether the program will identify what could have been done in the past to prevent the Youth from getting into trouble
- Question whether there is a realistic time frame for good outcomes
- Question whether anyone has identified the number of opportunity youth in our county and the system involved youth, whether that be juvenile justice system or the foster care system
- Question whether Office of Youth Development is prepared to evaluate the actual number of individuals that have benefited from this expenditure, not youth that have already benefited from programs in place
- The youth involved in this program are between the ages of 16 and to 24
- The youth involved in these services are defined as connected and they are no longer defined as opportunity youth
- Opportunity youth are not in school nor are they working

The motion carried by a voice vote and the Resolution was sent to the Consent Calendar.
