WHEREAS, Mr. Ray. A. Barker, Sr. is a child of God and has been a member of Green Street Baptist Church since he was a child;

WHEREAS, Mr. Barker served his country as a Marine with the United States Marine Corp.;

WHEREAS, Mr. Barker served Louisville, KY as a police officer for over twenty (20) years with the Louisville Metro Police Department and as a corrections officer;

WHEREAS, Mr. Barker is better known as "Sir Friendly 'C' the Rapping Cop;"

WHEREAS, Mr. Barker has worked in the community with youth and young adults in promoting his anti-drug and anti-violence message for thirty (30) years with his non-profit organization- Sir Friendly "C," Inc.;

WHEREAS, Mr. Barker was an original member of the police band, Street Heat.

WHEREAS, Mr. Barker was named one of the Top Ten Cops in the Nation.

WHEREAS, Mr. Barker was a motivational speaker at many churches, organizations and schools and has received numerous awards, certificates and plaques, such as the Bell Award and Medal of Valor, for his acts of kindness;

WHEREAS, Mr. Barker is still active in the community serving on the Executive Kentucky Lottery Board, working with the organization Man Up, and speaking, singing and hosting different events:

WHEREAS, Mr. Barker continues to help people behind the scenes with new business ideas, struggles with school or home, or helping people find employment; and

WHEREAS, Sir Friendly "C," Inc. participated in the Kentucky Derby Pegasus Parade for thirteen (13) years collaborating with Mrs. Anita Neil- founder and artistic director of the Lanita Rocknettes School of Dance;

NOW, THEREFORE, BE IT RESOLVED BY THE LEGISLATIVE COUNCIL OF THE LOUISVILLE/ JEFFERSON COUNTY METRO AS FOLLOWS:





# Retired LMPD officer 'Sir Friendly C' holds peaceful rally to bridge gap between generations

Ray Barker organized a peaceful rally Saturday in Jefferson Square Park to allow baby boomers and young people to get to know one another.

LOUISVILLE, Ky. (WDRB) -- A retired Louisville Metro Police officer is making it his mission to unify a community and pave a path forward for change.

Ray Barker created his "Sir Friendly C" persona while speaking to local students as an LMPD officer in the 1990s. As Sir Friendly C, Barker used rapping to encourage students to say no to drugs and resist violence in their community.

"I knew if I went in their schools as Officer Barker they wouldn't give me the time of day," Barker said.

Sir Friendly C has retired, but Barker has become a community activist. On Saturday, he organized a peaceful rally in Jefferson Square Park to allow baby boomers and young people to get to know one another.

"I want to unify the generations," Barker said. "I want them to listen to us and, as you can see, I'm listening to them."

Speakers, both old and young, discussed current issues at the forefront of recent protests in Louisville — systemic racism and calls for police reform.

Barker wanted to use his voice Saturday to speak up for good police officers but also call out what he feels needs to change.

"I'm going to represent all the good police officers that do their job and lay their life on the line for these kids," Barker said. "Police need to get back to being the police in their community and not being afraid to have the human factor, the humanity. They may live in another neighborhood, but the folks that they police are people just like them. ... And, if you give them respect, they will give it back."

Barker believes the community can build a better future together by listening to one another.

"No matter what the problem is, love is the answer," he said. "Unifying the generations will cause a quicker and better response."

### WHO IS SIR FRIENDLY 'C'?

HE IS A NATIVE BORN LOUSIVILLIAN NAMED RAY A. BARKER SR. RAY WAS ALWAYS NOTED AS A LEADER. AS A YOUNGSTER, HE RECEIVED THE 1972 YMCA BOY OF THE YEAR AWARD FOR BEING INSTRUMENTAL IN HELPING YOUTH. YOU CAN FIND THIS PICTURE DISPLAYED AT THE YMCA ON 10TH AND CHESTNUT STREET TODAY. AFTER GRADUATION HE ENLISTED INTO THE MARINE CORPS.

IN 1981, HE BECAME A JEFFERSON COUNTY CORREDTIONAL OFFICER. HE WAS LATER AWARDED THE 1987 INTERNATIONAL CORRECTIONAL OFFICER OF THE YEAR BECAUSE OF HIS PROGRAM HE CREATED FOR THE INMATES WHILE EMPLOYED. 1988 HE BECAME ONE OF THE TEN TOP POLICE OFFICERS IN THE UNITED STATES.

TODAY SIR FRIENDLY "C" SERVES AS A LAW ENFORCEMENT OFFICER IN LOUISVILLE, KENTUCKY. SIR FRIENDLY "C" IS MARRIED AND A FATHER OF FOUR CHILDREN. IF ASKED, HE WOULD SAY THAT DURING HIS ROOKIE YEARS,HE SAW THE NEED THROUGH MY OWN CHILDREN'S EYES TO INCORPORATE MUSIC AND EDUCATION INTO A MOTIVATION, EDUCATION PROGRAM. THROUTGHT THIS REVELATION, SIR FRIENDLY "C" WAS CONCEIVED. SIR FRIENDLY "C" IS A CHARACTER DEVISED IN 1989 TO REACH CHILDREN FROM HEAD START TO SECONDARY SCHOOLS. FROM THIS CONCEPT SIR FRIENDLY "C" INC CURRENTLY SERVES COMMUNITES IN KENTUCKY, INDIANA, AND TENNESSEE. EDUCATIONAL SCHOLARS, RECREATIONAL CENTER DIRECTORS AND COMMUNITY LEADERS EXPRESS STRONG SUPPORT FOR HIS INNOVATIVE IN SCHOOL AND AFTER SCHOOL PROGRAMS.

### HOW DOES HE PROMOTE THE MESSAGE

IN MAY OF 1999, HE ORGANIZED FORY PARTICIPANTS FROM TWENTY ORAGANIZATION INCLUDING YOUTH AGENCIES, SCHOOLS, CHURCHES, TO SPEAK AT THE STATE CAPITOL TO VOICE THEIR CONCERNS AND SOLUTIONS TO THE VIOLENCE THAT HAS PLAGUED OUR COMMUNITIES.

IN MARCH OF 1998, HE ORGANIZED 58 ORAGANIZATINS FROM CHURCHES, SCHOOLS, FAMILIES POLICE OFFICERS, AND BUSINESSES TO COME TOGETHER AND MARCH AGAINST DRUGS AND VIOLENCE IN THE COMMUNITIES.

IN NOVEMBER 1997, HE CONDUCTED A 61-HOUR PRAYER AND FAST VIGIL IN VICTORY PARK AT 22ND AND KENTUCKY. THE 61 HOURS SYMBOLIZED THE 61 HOMICIDES WE HAD IN THE CITY OF LOUISVILLE.

IN SUMMER OF 1996, HE INITIATED A YOUTH PROGRAM THAT TAKES 40-50 AT RISK YOUTHS ON AN OUT-OF STATE RETREAT FOR A WEEK DURING SUMMER.

IN SEPTEMBER OF 1995, HE STARTED A FESTIVAL ENTITLED F.U.N. FEST. ACRONYM FOR FAMILY UNITED NEIGHBORHOODS. THE PURPOSE OF THE FESTIVAL IS TO BRING JOBS TO THE COMMUNITY FOR THE ADULTS AND GOOD CLEAN FUN FOR THE CHILDREN.

IN OCTOBER OF 1994, HE MADE NATUIONL NEWS WITH HIS 18-MI. WALK WHILE BEING SHACKLED.. THE SHACKLES REPRESENTED THE DRUGS AND VIOLENCE IN OUR COMMUNITIES. THE WALK REPRESENTED NO DRUGS/NO VIOLENCE, SETTING GOALS AND ACHIEVING THEM.

IN AUGUST OF 1993, HE STARTED A PROGRAM CALLED"THE THRILLER IN THE VILLA." IT TAUGHT YOUTHS TO USE THEIR ENERGY IN A POSITIVE MANNER BY EXPLORING THEIR NATURAL TALENTS.

IN 1992, HE STARTED A NON-PROFIT ORGANIZATION ENTITLED SIR fRIENDLY "C" INC. PRIMARY FOCUS IS TO MOTIVATE YOUTH, ENCOURAGE POSITIVE BEHAVIOR THROUGH POSITIVE ALTERNATIVES.

IN AUGUST 1991, HE AGREED TO BE THE LEAD VOCALIST FOR A POLICE ROCK-N-ROLL BAND THAT DELIVERS A SAY NO TO DRUGS AND VIOLENCE MESSAGE.

IN SEPTEMBER 1990, HE DEVELOPED AN ONGOING PROGRAM
CALLED, OPERATION: CONSCIOUS. THIS PROGRAM CAN BE FOUND IN
PUBLIC, PAROCHIAL, AND PRIVATE SCHOOLS IN KENTUCKY, TENNESSEE, AND INDIANA.

IN THE FALL OF 1988, HE DEVOLOPED A CHARACTER NAMED SIR FRIENDLY "C". HIS VISION WAS TO MAKE POLICE OFFICERS MORE APPROACHABLE. HE HAD FOUR OBJECTIVES:

1.SAY NO TO DRUGS AND VIOLENCE
2.BUILD GOOD SELF ESTEEM
3.MAKE LEARNING FUN
SHOW THAT POLICE OFFICERS CAN BE YOUR FRIEND.
