Hi there Ms. Fried,

In looking back through our correspondence a few months back, I can see where we talked about wanting to participate in the Brightside program in FY21, and I described that in prior years that we had

split some of the cost with D-10 (as one of the sites borders both districts). However, I did not see where I received a response and/or quote for the coming year, so no action was taken on our side. I very well could be missing something, however.

Dr. Shanklin would still like to participate if possible, and in fact, we are working to schedule a meeting through Ms. Lorri Roberts right now after she reached out to us; this meeting is to cover updates and an end-of-year review. Will funding be a part of this discussion? Additionally, do you know if D-10 already provided funding for FY21? Again, we typically work with them with regards to Brightside funding, but I haven't heard anything from them about helping to fund some of this, and I figure that I would if they were going ahead with funding.
