SPECIAL DISCUSSION: CARES EXPENDITURES AND PROGRAMS -- DANIEL FROCKT AND MONICA HARMON

Daniel Frockt and Monica Harmon, Office of Management and Budget gave updates on CARES expenditures and CARES II.

The following was discussed:

- The Office of Management and Budget has routinely submitted a report to the Committee regarding expenditures, program expenses, public safety wages and Metro Public Health and Wellness employee wages.

- The use of CARES funds has freed up personnel expenses and allowed Louisville Metro to have some revisions from salaries and possible encumbrances.

- The outlook for the Office of Management and Budget is to close out the funding/expenditures from the CARES funds and begin to determine spending for CARES II monies.

- The overall aim for the \$22.9 million CARES II monies is to allocate funds for eviction/rental and utility assistance to the Resilience and Community Services and Metro Housing departments.

- The departments are reviewing guidelines for compliance in preparation to receive funds.

- There was a discussion that Louisville Metro will receive additional funding from the State after CARES II funding is exhausted.

- There was a discussion on the local Coronavirus Relief funding that was originally expended from the Louisville Metro pension mitigation funds. The 2.7 million in funding was allocated to Metro Resilience and Community Services.

- There is a detailed breakdown expenditures noted in the report.

- There were several questions regarding how the CARES II monies will be divided and distributed for eviction/rental assistance and utility assistance.

- There was a discussion regarding use of CARES II funds for eviction/rental assistance and utilizing funds via utility partnerships such as LiHEAP for utility assistance.

- There was a discussion regarding food insecurity and addressing community needs.

- There was a discussion regarding the manner and prioritization of expending funds by the designated deadlines.

- There were several questions regarding the expected total amount of rental assistance funds that Louisville Metro will receive. The estimation is that the funds will be determined based on the pro rata share of Louisville Metro's population.

- There was a discussion regarding addressing the community needs in relation to mortgage assistance gaps.

- There were several questions regarding reimbursable funds from CARES monies.

- There were several questions regarding eviction assistance follow up. There was a discussion on available resources such as the Office of Housing Eviction Diversion Court, assistance programs for landlords, as well as, programs at Neighborhood Place agencies.

- There were questions regarding how to gauge the demand for assistance, workforce staffing and turnaround times in process applications.

- There was a request for a breakdown on how many applications for eviction assistance are pending and how many have been completed.

- The new eviction prevention programs under CARES II will begin on February 15.

- There were several questions regarding whether landlords have accepted the eviction assistance.

- There were several questions regarding statistics on evictions pre-COVID versus post-COVID.

- CARES funds were used during 2019 to fund personnel and resources within Metro Public Health and Wellness, however, those funds expired in December of 2020.

- This fund allocation is intended to aid Metro Public Health and Wellness from January to March when additional CARES or Federal funding may be available.

- The funds used for this allocation are carryforward funds which are offset monies from personnel salaries that the CARES funds covered.

- The CARES funding allowed Metro Public Health and Wellness to utilize additional staff to address community needs and target resources.

- The CARES funding has allowed the agency to expand contract tracing, testing, and outreach in the most vulnerable areas.

- The carryforward funding will aid in vaccination efforts, patient data collection, and coordination software.

- There was a discussion regarding care packages that are sent to recovering COVID-19 patients. The care packages are a tool for contact tracing and sharing quarantine guidance.

- There was a discussion regarding Evolve 502 aiding individuals with child care who have been impacted by COVID-19.

- There were several questions regarding how many call tracers are employed through Metro Public Health and Wellness.

- There are approximately 380 to 400 that are contractors through Lacuna Health. There are also 10 to 15 contractors that perform disease investigation and data management.

- There were several questions regarding whether these funds can be used for in-district COVID-19 testing centers.

- There was a discussion that these costs may be covered under Metro Public Health and Wellness. Members interested in holding a COVID-19 testing center should contact the agency first to utilize all viable resources and partnerships.

- There were several questions regarding whether the expenditures are reimbursable from CARES II monies.

- There was a discussion that these monies are not reimbursable, but may be reallocated prior to the funding expiring.

- There were several questions regarding eligibility requirements for receiving Non-Traditional Instruction (NTI) assistance. Residents in need of Non-Traditional Instruction (NTI) may contact Evolve 502.

- There was a discussion regarding Louisville Metro pursuing FEMA funding.

- There was a discussion regarding the contents and cost of the COVID-19 care packages.
