I do remember this one. My recollection was focusing on the left side where it was closest to residential with a residential scale privacy/separation fence at the property line, and some trees appropriate for that side setback that could grow up above the fence line – on the new project side – that would help visually buffer that big wall. Also on that left wall the use of higher quality siding (like Hardi board, not vinyl) with nice detailing around the windows and eaves. This elevation looks like it has a lot more brick with "punched openings" for windows which looks industrial to me. Maybe drop the brick down to the first story only with siding above. Again the intent would be to soften this tall wall facing over and into the adjacent residential parcels.

Overall, though the design was okay, maximizing the setback on the left side was ok, and the front elevation was ok. As a structure in the traditional form district, detailing on the front is money well spent on integrating into the neighborhood streetscape.
