• Change-in-Zoning from R-4, single-family to R-6, multi-family residential

 Waiver of Land Development Code, section 10.2.4 to reduce 15' LBA to 5' LBA along north property line

Detailed District Development Plan

CASE SUMMARY

The proposal calls for 16 multi-family residential units across 4, 2-story structures with parking, detention, and amenity area. The subject property is located on Hines Court one parcel removed from Heafer Road, which connects the subject site to La Grange and N. English Station Roads. TARC service is available via route #31 servicing the nearby business park, Shelbyville Road and Downtown. Berrytown Park is located across Heafer Road from the subject site. A sidewalk will be extended from the subject site to Heafer Road to provide accessibility from the site to Berrytown Park along Hines Court.

STAFF FINDING

The proposal conforms to the land use and development policies of Plan 2040. The subject site and proposed district are appropriately located with connection to nearby services, amenities, and employment opportunities. Safe connectivity to the subject site from Heafer Road will be extended by the applicant along Hines Court which allows for greater access to the nearby public park and transit.

STANDARD OF REVIEW FOR ZONING/FORM DISTRICT CHANGES

Criteria for granting the proposed form district change/rezoning: KRS Chapter 100.213

- 1. The proposed form district/rezoning change complies with the applicable Land use and Development policies of Plan 2040; **OR**
- 2. The existing form district/zoning classification is inappropriate and the proposed classification is appropriate; **OR**
- 3. There have been major changes of an economic, physical, or social nature within the area involved which were not anticipated in Plan 2040 which have substantially altered the basic character of the area.

STAFF ANALYSIS FOR CHANGE IN ZONING

The Following is a summary of staff's analysis of the proposed rezoning against the Land Use and Development Policies of Plan 2040:

The site is in the Neighborhood Form District

The Neighborhood Form is characterized by predominantly residential uses that vary from low to high density and that blend compatibly into the existing landscape and neighborhood areas. High-density uses will be limited in scope to minor or major arterials and to areas that have limited impact on the low to moderate density residential areas.

The Neighborhood Form will contain diverse housing types in order to provide housing choice for differing ages, incomes and abilities. New neighborhoods are encouraged to incorporate these different housing types within a neighborhood as long as the different types are designed to be compatible with nearby land uses. These types may include, but not be limited to, large lot single family developments with cul-de-sacs, traditional neighborhoods with short blocks or walkways in the middle of long blocks to connect with other streets, villages and zero-lot line neighborhoods with open space, and high density multi-family housing. The Neighborhood Form may contain open space and, at appropriate locations, civic uses and neighborhood centers with a mixture of uses such as offices, retail shops, restaurants and services. These neighborhood centers should be at a scale that is appropriate for nearby neighborhoods. The Neighborhood Form should provide for accessibility and connectivity between adjacent uses and neighborhoods by automobile, pedestrian, bicycle and transit.

Neighborhood streets may be either curvilinear, rectilinear or in a grid pattern and should be designed to support physical activity for all users and invite human interaction. Streets are connected and easily accessible to each other, using design elements such as short blocks or bike/walkways in the middle of long blocks to connect with other streets. Examples of design elements that encourage this interaction include narrow street widths, street trees, sidewalks, shaded seating/gathering areas and bus stops. Placement of utilities should permit the planting of shade trees along both sides of the streets.

The subject property is vacant, and the proposal will bring new development. The proposed district is appropriately located in a mixed-density area adjacent to multi- and single-family development. The proposed higher intensity district is located along TARC route #31. Connectivity to an arterial and primary collector roadway, as well as employment centers nearby is provided. Route #31 serves the nearby business park, Shelbyville Road, and Downtown. Activity centers for services and amenities are located nearby at Shelbyville Road and Old Henry Road. The Ford KTP is also nearby. The siting of the district further reduces travel time to essential services, employment, and amenities in the area and throughout Louisville Metro. It was also necessary that a safe connection from the subject site to Heafer Road be provided. The proposed zoning district will be accompanied by sidewalk connectivity to Heafer Road.

STANDARD OF REVIEW AND STAFF ANALYSIS FOR WAIVER

(a) The waiver will not adversely affect adjacent property owners; and

STAFF: The waiver will not adversely affect adjacent property owners as structures are located on the opposite side of the property and all required plantings and screening will be provided..

(b) The waiver will not violate specific guidelines of Cornerstone 2020; and

STAFF: Guideline 3, Policy 9 of Cornerstone 2020 calls for the protection of the character of residential areas, roadway corridors and public spaces from visual intrusions and mitigate when appropriate. Guideline 13, Policy 4 calls for ensuring appropriate landscape design standards for different land uses within urbanized, suburban, and rural areas. Areas will be protected by the required plantings and screening, and no structures are proposed in the area of encroachment.

(c) The extent of the waiver of the regulation is the minimum necessary to afford relief to the applicant; and

STAFF: The extent of the waiver of the regulation is the minimum necessary to afford relief to the applicant as the site is narrow and all other requirements have been accommodated without relief.

(d) Either:

(i) The applicant has incorporated other design measures that exceed the minimums of the district and compensate for non-compliance with the requirements to be waived (net beneficial effect); **OR**

(ii) The strict application of the provisions of the regulation would deprive the applicant of the reasonable use of the land or would create an unnecessary hardship on the applicant.

STAFF: The strict application of the provisions of the regulation would create an unnecessary hardship on the applicant as it would result in a decreased area of land available for the proposed development which provisions housing. All other matters of the LDC have been accommodated on the development.

STANDARD OF REVIEW AND STAFF ANALYSIS FOR DETAILED DISTRICT DEVELOPMENT PLAN

a. The conservation of natural resources on the property proposed for development, including: trees and other living vegetation, steep slopes, water courses, flood plains, soils, air quality, scenic views, and historic sites;

STAFF: The conservation of natural resources on the property proposed for development, including: trees and other living vegetation, steep slopes, water courses, flood plains, soils, air quality, scenic views, and historic sites will be conserved as the site does not appear to adversely impact or contain these features. Tree canopy and outdoor amenities will be provided. A public park is nearby.

b. The provisions for safe and efficient vehicular and pedestrian transportation both within the development and the community;

STAFF: Provisions for safe and efficient vehicular and pedestrian transportation within and around the development and the community will be provided as the applicant has agreed to extend the public sidewalk across an adjacent site's frontage to connect with Heafer Road. This allows for safe connections to the nearby park and transit.

c. The provision of sufficient open space (scenic and recreational) to meet the needs of the proposed development;

STAFF: The provision of sufficient open space (scenic and recreational) to meet the needs of the proposed development will be provided as recreational amenities will be provided.

d. The provision of adequate drainage facilities on the subject site in order to prevent drainage problems from occurring on the subject site or within the community;

STAFF: The Metropolitan Sewer District has approved the preliminary development plan and will ensure the provision of adequate drainage facilities on the subject site in order to prevent drainage problems from occurring on the subject site or within the community.

e. The compatibility of the overall site design (location of buildings, parking lots, screening, landscaping) and land use or uses with the existing and projected future development of the area;

STAFF: The proposal is compatible within the scale and site design of nearby existing development and with the form district's pattern of development as the rendering displays sensitivity to the public roadway and adjacent residential uses through doors and windows which face the road. The proposal provides for 2-story structures consistent with the area.

f. Conformance of the development plan with the Comprehensive Plan and Land Development Code. Revised plan certain development plans shall be evaluated for conformance with the non-residential and mixed-use intent of the form districts and comprehensive plan.

STAFF: The proposed development plan conforms to Plan 2040 and the Land Development Code, except where relief has been requested and justified. It is sited appropriately for its intensity, and connectivity to parks, employment, services, and amenities is available.

REQUIRED ACTIONS

- RECOMMEND to the Louisville Metro Council that the Change-in-Zoning from R-4, single-family residential to R-6, multi-family residential on property described in the attached legal description be APPROVED or DENIED
- APPROVE or DENY the Waiver of Land Development Code, section 10.2.4 to reduce 15' LBA to 5' LBA along north property line
- APPROVE or DENY the Detail District Development Plan





 - The development plan must receive full construction approval from Louisville a. Metro Construction Review, Louisville Metro Public Works and the Metropolitan Sewer District.
 - Encroachment permits must be obtained from the Kentucky Transportation b. Cabinet, Bureau of Highways.

CASE SUMMARY

The subject property is located on Hines Court one parcel removed from Heafer Road, which connects the subject site to La Grange and N. English Station Roads. TARC service is available via route #31 servicing the nearby business park, Shelbyville Road and Downtown. Berrytown park is located across Heafer Road from the subject site. The proposal calls for 12 multi-family residential units across 4, 2-story structures.

STAFF FINDING

The proposal generally conforms to the land use and development policies of Plan 2040. The proposed district is appropriately located in a mixed-density area and remains consistent with the pattern of the neighborhood in provisioning for alternative forms of housing. Sidewalk connectivity across the LMHA property to the south raises some concerns with respect to safe connectivity and this issue will need to be discussed as the project progresses.

Route #31 serves the business park, Shelbyville Road, and Downtown. Activity centers for services and amenities are located nearby at Shelbyville Road and Old Henry Road. The Ford KTP is located nearby as well. Berrytown Park is also nearby.

Heafer Road provides sidewalk connectivity; However, Hines Court does not connect to Heafer via walks as the LMHA property was not required to provide sidewalks at the time of construction along Hines Court. Consideration should be given to off-site sidewalk construction to connect the project to Heafer Road and subsequently the public park.




