That the Chairman of the Louisville and Jefferson County Landbank Authority, Inc., or his designee, is hereby authorized and directed to transfer the properties listed herein in the manner provided according to KRS 65.370, to CrossRoads Missions, Inc., to construct a single-family residence on each parcel, without further action by the Authority.

SECTION 3. That the Applicant shall maintain the Property in a manner consistent with the Codes and Ordinances of the Louisville/Jefferson County Metro Government ("Louisville Metro").

SECTION 4. That the Applicant shall obtain all necessary permits and approvals required by Louisville Metro and shall construct a single-family residence on each parcel within eighteen (18) months of acquiring the Property.
