**University of Louisville Belknap Academic Building – New Facility, Louisville, Kentucky**

**Project Manager** for this \$58M new construction facility collaborating with over 14 consultant teams and University administrators. Facilitating excellent communication is the key to keeping the Owner's desires at the forefront of the design and the consultants on time and budget.

**Speed Art Museum – Master Plan, Renovation and Addition, Louisville, Kentucky**

**Project Manager**, working with WHY Architecture, was entrusted with the responsibility to add to, renovate and clarify the museum building and obtain LEED certification for the resultant structure. These efforts have updated the facility to current museum standards. This multi-phased, internationally recognized and award-winning, \$50M building expansion project has achieved LEED Gold® status.

The outcome of this master plan provided a comprehensive understanding of the highest and best use of all of the church facilities and properties. This master plan provided a roadmap for improvements in proper sequence with cost estimates.

**Kentucky State Capitol – Master Plan, Frankfort, Kentucky**

**Project Manager** for this master plan effort. Christopher led a team of both national and local consultants that would identify and address the issues of the building's current state and plot a course for future improvements. This master plan has been the basis for the restoration of the Capitol, Capitol Annex, Executive Office Building, and a new service tunnel between the facilities.

**Louisville Slugger Baseball Stadium/Brinly Hardy Warehouse – Renovation, Louisville, Kentucky**

**As Project Architect**, Christopher collaborated with HNTB Architects to convert this structure that encompasses more than 62,000 sf and houses 22,000 sf of restaurant and future retail space. The KNBA teams primary responsibility was the restoration of the historic train depot, while HNTB Architects was primarily responsible for the design of the ballpark.

**Artek Lofts – New Condominiums, Lexington, Kentucky**

**Principal-in-Charge** for this 37,400 sf building that responded to the historic streetscape with appropriately scaled infill-two and three story loft units. The siting of the units created a central courtyard area between the new buildings.
