Louisville Metro's Land Development Code Reform

With the support of Mayor Greg Fischer, Metro Council and the Planning Commission, the Office of Planning & Design Services is carrying out a complete review of the Land Development Code (LDC) to identify and address land use regulations and policies that have inequitable impacts on Louisville Metro residents.

The groundwork for this review began with the adoption of our 20-year comprehensive plan, Plan 2040, the release of the Housing Needs Assessment and the completion of the Advancing Equity Report. These three documents focus on ensuring equity in housing, removing barriers for affordable housing, and investing in communities impacted by redlining, a practice where minorities were denied loans and insurance. In addition, the effort is informed by a diagnostic report completed in July 2020 by Berkley-based architecture and urban design firm Opticos Design, which provides housing and related land use recommendations.

The reform process will consist of four procedural phases:

- 1. Identifying the issues and barriers that need to be addressed**
- 2. Developing recommendations**
- 3. Drafting recommendations**
- 4. Adopting recommendations**

Planning & Design Services will seek assistance from residents, neighborhood and community groups, nonprofit organizations, other Louisville Metro Government divisions, outside agencies and other stakeholders to draft any recommended policies and amendments to the Land Development Code.

Staff has developed a public engagement plan and strategies to ensure that this effort includes the voices of the entire community, especially those community members who have been adversely impacted by development practices and land use policies. Staff is solicit ideas and participation by reaching out to interested groups and through social media, fliers and newsletters, webinars and videos, and a hotline.

In addition, Planning & Design Services will host a series of three community meetings in late October, and following the conclusion of the meetings, recommendations will be forwarded to the Planning Commission and Metro Council for review and consideration. Due to the complexity of some issues, recommended LDC amendments will be staggered, with some recommendations to be considered within a few months and others taking up to two years.

The Planning Commission will serve as the oversight committee for the process. After staff has concluded the public engagement process and drafts the recommendations, the Commission will make formal recommendations to Metro Council and other legislative bodies that having zoning authority in Jefferson County. Members of the public can attend any Commission meeting and speak during the public hearing(s).

LAND DEVELOPMENT CODE REFORM RECOMMENDATIONS

January 2021

The recommended changes to the Land Development Code are based on the public engagement sessions conducted in October and December of 2020, as well as research conducted by Planning and Design Services staff. Feedback from the community established three main topics of concern for the reform: housing, environmental justice, and simplifying the regulations and processes dictated by the Land Development Code.

The proposed amendments have been organized into three phases according to the estimated longevity of completion with the starting point being the passing of the resolutions in August 2020. These timeframes are not final and are subject to change.

Continued engagement from the community throughout the phases is a vital component of the reform process. Below each chart is a link to a survey where feedback may be provided. Review of 200ft Buffer in EZ-1	✓ Environmental Justice	Review how the 200-foot requirement (restriction on M-2 and M-3 uses within the EZ-1 when within 200 feet of residential zoning) functions.






