Here are my comments on the activities in the 1/6 and 1/13 IARC reports.

- **20-CAT3-0017 1400 Cecil Avenue Jay Lockett**
 - A portion of the Louisville Loop is being built along this property boundary on Southwestern Parkway and Algonquin Parkway
 - 5-3709 Olmsted Parkways CMAQ (Southwestern Parkway & Algonquin Parkway) Shared Use Path, federal grant funds
 - It is currently finishing Final Design and ROW phase
 - Construction scheduled for summer 2021
 - John Swintosky is Metro project manager
