WHEREAS, the Legislative Council of the Louisville/Jefferson County Metro Government (the "Council") has considered the evidence presented at the public hearing held by the Louisville Metro Planning Commission and the recommendations of its Staff as set out in the minutes and records of the Planning Commission in Case No. 20ZONE0060; and

WHEREAS, the Council wishes to allow the applicant an opportunity to present the Planning Commission with an amended proposal without being required to go back through the entire rezoning process or being inhibited by the 2-year rule; and

WHEREAS, the Council further wishes for this review to include a good faith effort by both the property developers as well as the Metro planning staff and commission to find acceptable solutions to address some of the concerns previously stated; and

WHEREAS, hearing and decision requirements contained in KRS Chapter 100 are currently suspended per Senate Bill 150(9)(a) due to the ongoing COVID-19 related state of emergency; and

WHEREAS, this suspension of relevant deadlines by the State legislature affords both the Planning Commission and Metro Council ample time to consider this case; and

<u>WHEREAS</u>, the Council requests the Planning Commission address this matter expeditiously so that there is no undue delay at this late stage of the process; and

WHEREAS, in the interest of time, the Council recommends the Planning

Commission hear this matter at one of its regular meetings with the case not to be called

before 6:00 p.m.; and

WHEREAS, the Council will make a final decision on the zoning when the Planning

Commission has completed this second review whether the recommendation is to rezone

or maintain the existing zoning.
