### **Summary of the Project**

We intend to use the space as a full-time STR.

- We anticipate 61% annual occupancy based on the last 3 years of data from Airbnb and Vrbo.
- The demand is forecasted to be steady throughout the year. The highest occupancy rates will be May October.
- We will install exterior security cameras and a noise monitoring system by Noise Aware.
- We screen all guests before accepting their reservation request.
- Our house rules will stipulate "no parties".

### **Questions or Concerns**

- How do you screen the guests?
  - We interview them about why they are coming.
  - We don't allow local rentals as people who are from Louisville who are renting the space are at higher risk to use the house for a party.
  - o We read their reviews to see if other hosts recommend them.
  - Airbnb and Vrbo do a pre-screening which requires 3 forms of ID to authenticate that the guest is who they say they are.
  - Our security cameras, which are highlighted in our listing, have been an effective deterrent to guests who have mischievous intent.
- Will the listing have self-check-in?
  - Yes, especially during COVID

- We have smart locks with individual codes for each guest. The guest codes are only active during their specific reservation.
- We use the exterior cameras to verify that the group size is as expected.
- Shelby shared that noise and potential parties are a concern of theirs but, she is glad to learn that we will have pre-screening, house rules and noise monitors to prevent issues.
- Zach asked if we would like them to notify us if there is a problem.
  - Yes, you have our phone #. We hope you don't need to call us but, please do if there is any concern or issue.
  - We are only 18 minutes away.
- Are you open to longer term stays?
  - Only 30 days or less.
  - We will have a 3-day minimum stay requirement on the weekends so, we anticipate most stays will be 3-4 days.
  - We want to maintain our identity as a short-term rental.
- Do you have a cleaning crew who will come in after guests check out? Who can we expect to see coming and going?
  - I (Lisa) plan to do the laundry myself and will likely be the first one to enter after guests leave.
  - We have found a cleaner who will come in to clean & reset the space. She is an experiences STR cleaner.
  - Mark or I will probably come in before a new guest checks in to drop off clean linens in the owner's closet and set out a hospitality basket.
- Shelby says they may reserve our place when their family comes to town to visit them.
